

Meet criminally insane narcissist Devra Patton West and her two accomplices in Racketeering and Murder Dr. Julio E Williams MD and Geoffrey Reynolds CPA.

That murder is used by Patton West to enforce a strict code of secrecy is not in doubt. Her ex-husband, Jack West, told the whistleblower in 2002 that those who opposed his then wife had a habit of dying suddenly. When combined with Geoffrey Reynolds false pleadings to a Montana court amounted to a \$10,000,000 extortion scam designed to silence the whistleblower. Thus allowing Patton West to resurrect her criminal racketeering business model in Arizona without the inconvenient truth of her criminal past being available to the public via the internet.
- Reynolds is currently employed by [McSwain & Co](#) accountants in Olympia WA. We hope that Reynolds, a pathological liar, does not have access to confidential client files.
- The ongoing campaign of intimidation / attempts at murder of the whistleblower by Patton West which Williams & Reynolds remain totally complicit in as they have both received, over the past 5 years, some 500 plus emails from the victim about this matter.

For the past ten years, Patton West has been targeting the spiritual community in Sedona & Scottsdale AZ. She is currently calling herself 'Rishi Devra' and her website and Facebook pages want us to believe that she is 'The Mother of Ten Thousand Suns' and a 'divine' being who has been preparing to lead humanity for thousands of years. She also claims that, as an instrument of mercy, she is able to cure cancer for a six figure sum.

These idiotic claims of 'divinity,' along with her claims to be able to cure cancer, are totally endorsed by Dr. Julio E Williams MD. Williams has supplied Patton West with several [fake testimonials](#) in spite of being totally aware of her criminal past as set out in detail below in this bulletin. Williams is a willing accomplice in racketeering.

Williams is a 20 year member of Patton West's cult / criminal gang and it is our strong belief that a pathological liar like Williams, should not be stood over an unconscious patient wielding a scalpel. Several reviews at this [web address](#) refer to Williams as being corrupt, no good, a dangerous physician and an idiot. One [review](#) describes Dr. J E Williams MD as a 'dangerous physician' and that he was 'run out' of two Texas hospitals. The review goes on to say, "if you see him run the other way." Why would [Essentia Health in Fargo ND](#) risk everything by employing someone so corrupt and dishonest?

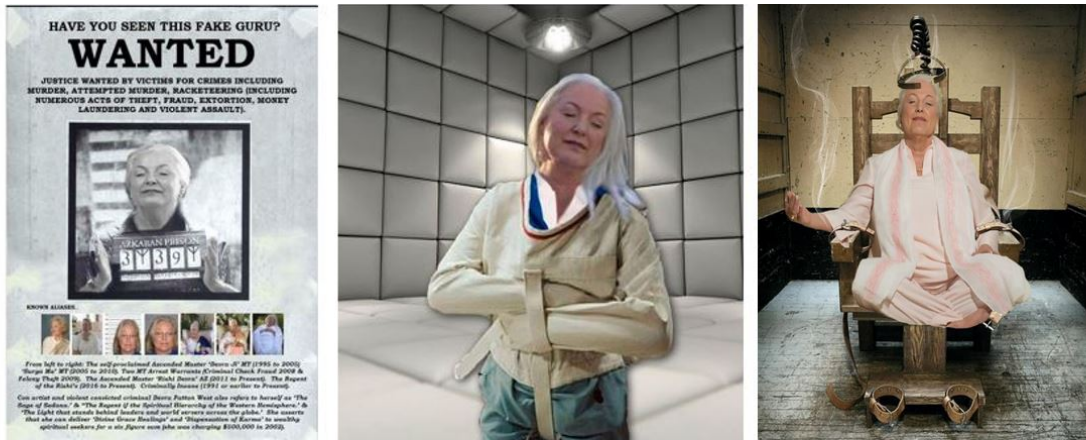



Above: The same criminal racketeering business model that Patton West used in Montana (1995 to 2010) is now being used in Arizona (2010 to present day). Patton West, a criminally insane narcissist and suspected serial killer, embeds herself like a parasite in the Sedona spiritual community. Using a totally fake persona built on lies and propaganda Patton West waits for the prey to wander into the kill zone. Like a Hollywood production it takes millions of dollars to fund this illusion. The claims made on her current website are either the result of someone who is criminally insane or the result of a 'master criminal' who, having gotten away with murder for 30 years, believes herself to be totally beyond the reach of the law. For this reason, in a previous [bulletin](#) we suggested to the Arizona AG's office and the Coconino County government that Patton West's mental health should be assessed as a matter of urgency as there is little doubt that she represents a huge and present danger to the public.



We stated in another [recent bulletin](#) that one of President Trump's first executive orders was directed at child traffickers, pedophiles, those committing treason and those committing crimes against humanity. If found guilty, these criminals would have their assets forfeited and depending on the severity of their crimes face execution. We believe that after 30 years of racketeering with scores or hundreds of victims across multiple states, with several or more suspected murders, Patton West would be a candidate for the death penalty for crimes committed against humanity.

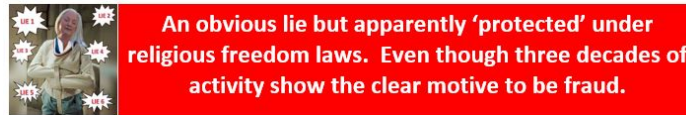

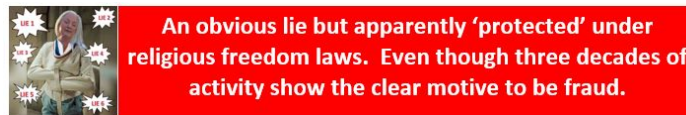
What follows are overt bare faced lies that Patton West assumes are 'protected' by religious freedom laws even though the obvious motive is fraud. Anyone challenging her version of reality, is targeted for intimidation and or murder. Remember that in 2005, Dr. Julio E Williams MD posted a [statement](#) on Patton West's website wherein Williams staked his honor and credibility on defending Patton West's personal integrity? Fifteen years later and after all her crimes in Montana mentioned above, Dr. Julio E Williams is still 'marketing' Patton West to the public as a minor deity. He does this while at the same time (along with Geoffrey Reynolds) remains complicit in Patton West's ongoing attempts to intimidate and murder Watson.

3. [As the light that stands behind leaders and world servers across the globe.](#) Fact. Patton West is a pariah amongst real service to other entities. If she were involved with any 'leaders' or 'world servers' you can bet that she would shamelessly use their names images on her website. The fact is, that like her other claims that she was "[holding open the gates of time](#)" and that "[the Christ gave her two doctorates in person](#)" it is all lies and propaganda.



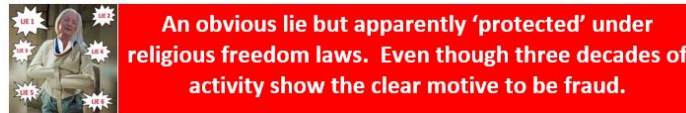
4. [As a planetary regent, her auspicious presence offers the rare opportunity for private mentoring and audiences for initiates world servers and spiritual protégées.](#) Fact. This is all bullshit. In reality, these lies and the accompanying propaganda are used by Patton West to attract potential victims into the 'kill zone.' Once the wealthy amongst attendees to her 'private sessions' have been identified, they are targeted for fraud and or extortion. Review this posting made by Patton West of "[Sacred Sundays](#)" to be held at the home of senior cult member, Dr. Julio E Williams MD. Victims are made ill by Patton West using her [secret weapon](#) and then asked to pay six figure sums to be cured. Patton West was charging \$500,000 for this 'service' in 2002. Listen what Patton West's [personal assistant](#) had to say about this.



5. [As an instrument of mercy she offers the phenomena of divine grace healing \(and dispensation of karma\).](#) Fact. There is nothing divine or graceful about Patton West. On the contrary. Patton West is a vicious and cruel psychopath and quite possibly a serial killer. Here are four examples of Patton West's violent assaults upon members of her cult or cult member's children. Dr. Pat Cole MD repeatedly hit over the head with the heel of Patton West's shoe until blood ran down the victim's blouse. The [Whitefish Pilot](#) newspaper has details.

Susannah Felder partially scalped by Patton West after Susannah questioned Patton West about an \$80,000 donation Patton West stole from the charity she later bankrupted. Read what witness / charity board member [AJ White](#) had to say. Beatrice McGuire had part of her ear ripped off after calling out one of Patton West's lies in front of an audience of scores of attendees to one of Patton West's gatherings. As witness [Debra Coffey](#) points out, the victim needed plastic surgery for her injuries. Then there is [Ingrid Smith's](#) six year old son who was assaulted by Patton West.

Then there is the murder of student [Lisa Swidler](#), who was silenced to stop her going to the police about crimes she witnessed against other cult members.



6. The Rishi Collection. Fine Art, Sacred Heirlooms and Antiquities. Fact. After Patton West's charity was [struck off](#) for fraud in January 2004, and with several lawsuits against her, she defrauded the charity out of its largest single asset; a property worth \$1,250,000 (as valued in 2002). This asset's ownership was transferred to a private trust fund she had set up for herself and her eldest son, Rob Meador. The purpose of the trust fund was to hide the asset from her creditors which did not work, as in 2008, a judge arranged for the sale of the property at a [Sheriff's Sale](#) to force Patton West to pay for \$2,000,000 worth of court fines and interest that she owed her creditors. Also in 2004, Patton West stole \$4,000,000 in art work and valuables owned by the charity, which like the property, were largely funded by public donation. When questioned about the art work and valuables in court under oath in 2009, Patton West denied their existence stating that they were lost or stolen or carted away. Whether Patton West should be committed to a mental asylum or tried for crimes against humanity and then, if found guilty, executed is for the authorities to decide. We hope they will make that judgment call sooner rather than later! What is certain is that Patton West has been operating her criminal racketeering business model (a cult disguised as a quasi-religious organization) right under the authority’s noses for thirty years. So far, she has only operated in three western states NM, MT and currently AZ, because she believes that those states do not have the resources to police or prosecute ‘white collar’ crime. Accordingly Patton West, enforcing a strict code of secrecy with her secret weapon, has been able to operate her cult as though it were a medieval fiefdom with her passing her own laws and punishing those who do not follow her edicts. To be clear, inside Patton West’s cult / sphere of control, state and federal laws do not apply and certainly did not apply in Montana, as a mountain of evidence shows.

Patton West is not shy about declaring to those trapped inside her cult what their role is (see below) even to the point of telling them in writing that their ‘financial withhold’ must be corrected.

We described above what happened to the whistleblower after he was recruited for her 2001 to 2005 'save the world' scheme, which was centred around changing banking towards a more altruistic model for the good of all the common folk. According to one cult member who goes all the way back to 1991, there have been many of these projects but none of them ever come to fruition or amount to anything. The projects are never meant to succeed but are merely a focus for the members of the cult to fund raise around. In every instance since 1991, the money raised, much of it bullied out of the pockets of cult members, goes to fund Patton West's luxurious lifestyle or is secreted abroad into offshore bank accounts or is converted into jewels or precious metals. When the whistleblower, John Watson went public about this, Patton West, working with senior cult members Williams & Reynolds tried to murder Watson to silence him.



Above: Narcissist occult thief Patton West who believes that she is a god on a mission to save humanity. In fact she stated (see above) on one of her websites that she had been preparing to guide humanity for thousands of years. In reality she sees herself as a superior being whose right it is to prey on the herd. The herd being anyone who swallows her lies and propaganda.

Many of the victims inside the cult are ordinary folk i.e. employees suckered into taking up [fake career opportunities](#), a scam she is currently working in Arizona, or students to her non-accredited school for occult studies. However, these 'small fry' provide her with enough money to fund her lifestyle costs, the real wealth comes when she lands a big fish i.e. reels in a wealthy target. One may ask why those in her cult remain captive? Why don't they escape? There are many answers; what follows are two.

1. They have been subject to classic CIA brainwashing and conditioning which involved breaking the targets will and then rebuilding them as obedient droids who submit to the will of the guru. Ex- cult member, Debra Coffey, explained how this worked in a [statement](#) she gave to the whistleblower John Watson. 2. Most cult members have given up all their friends and outside interests and much of their capital, so have nowhere else to go.

What we are going to do now is follow the path of one of Patton West's big fish / wealthy victims from recruitment into the cult, how she was used and abused by Patton West and then how she was spat out the other side of the meat grinder after outliving her usefulness. That victim is Dr. Patricia Cole MD.

Dr. Patricia Cole's journey through the meat grinder (Patton West's criminal racketeering business model marketed to the public by her, Julio E Williams & Geoffrey Reynolds as 'world service / global awakening).



Above: The path taken by Dr. Pat Cole MD has been taken by scores or hundreds of victims of theft, fraud, extortion and mental and physical abuse. Before entering the 'meat grinder' Dr. Pat Cole, an alleged Whirlpool heiress, was worth \$1.5 million. After being spat out the other side she was \$50,000 in debt and allegedly filing for bankruptcy. She was lucky to escape with her life.

Circa 1991 to 2004. We do not know much about Dr. Pat Cole's association with Patton West prior to 2005. According to a [letter](#) passed to the Flathead police department in 2007 by Cole's friend Rebecca West (no relation to Patton West) Patton West was abusing her employees and students in New Mexico prior to 1995. We have more evidence pointing towards Patton West's psychopathy from two other independent witnesses. The first statement comes from [Jeremy Samuelson](#) who worked with Jack West before he was 'overwhelmed' by Patton West. According to Jeremy, Jack & Devra West defrauded him out of \$10,000. The second statement comes from [Satya](#) who attended the '[Robert Jaffe School for Energy Mastery](#)' at the same time as Patton West, between 1990 & 1991. Satya described Patton West as a manipulative delusional psycho / sociopath, who defrauded her out of \$6,000! Satya goes on to say that, and I quote, "Patton West is a powerful and charismatic personality as most psychopaths are, and it is very tragic that she abuses her power to abuse and victimize others." End quote.

All the evidence since 1991 shows that Patton West has used her power and knowledge of the occult to feather her own financial nest at the expense of everyone she has met since.

Circa 2005. In 2005, according to [court records](#), Patton West was seeking funding for a medical Spa she hoped to build as a high end resort. Long story short, after putting up \$650,000 Patton West found out to her cost that she, one of the biggest con artists alive today, had herself been conned out of her deposit by Edmund E Wilson & Walter L Ross. We do not know where the \$650,000 deposit came from but we can assume that Patton West acquired the money via 'donations' from cult members or a combination of donations and loans taken out by herself and or cult members on her behalf. Clearly, this period of time for Patton West was not a happy one as she was the defendant in at least a couple of lawsuits and maybe several. One of which was launched in 2003 by John Watson after he was defrauded by Patton West, and the other by Essex Ventures which in 2008 would result in a judge ordering Patton West to sell her assets at a [Sheriff's Sale](#) to force her to pay her creditors \$2,000,000 in court fines and interest. Back to Dr. Pat Cole MD. In 2005 Dr. Pat Cole MD was put to work twice by Patton West as a favourable ‘witness’ in two of her legal disputes. Remember by 2005, Dr. Cole had completely submitted to Patton West’s will having had her spirit totally broken. This meant Cole was unable to resist any directives that Patton West gave her, however illegal or immoral they might be. What follows are two examples. In the first instance Dr. Cole, along with Dr. Cornell and Dr. Williams, were all persuaded to sign a document authored by Patton West which was then published on Patton West’s website for the benefit of the cult rank and file members. The document was basically a character assassination of John Watson, who was in the process of suing Patton West for fraud. Clearly, the document was authored by Patton West but endorsed by all three physicians. They claimed that Patton West was a Messianic figure trying to save the world, so how dare John Watson interfere with her work by suing her for fraud! 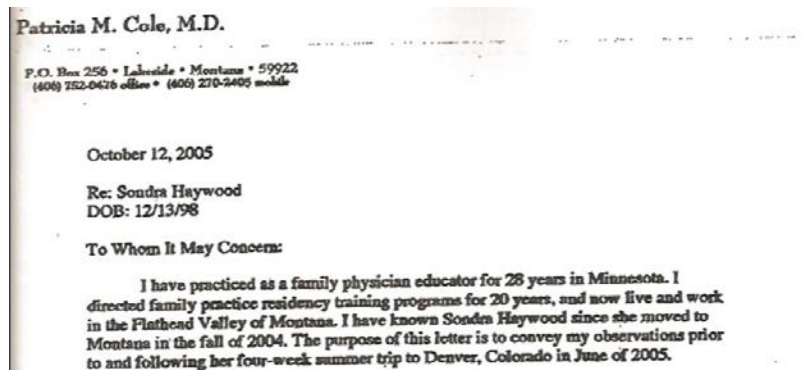
Above: Three apparently intelligent physicians persuaded by a psychopath to defame a total stranger. Dr. Cornell immediately came to her senses and left the cult. Dr. Cole was brutalized and nearly bankrupted in 2006. Dr. Williams remains to this day a willing accomplice in racketeering and murder and continues to market Patton West to the public as a “wellspring of divinity.”

Apart from John Watson’s fraud lawsuit, Patton West was dealing with a custody case involving her porn loving, wife beating son, Chris Haywood. You may recall earlier, that Patton West stole \$80,000 from her charity to pay for her son’s legal fees. Ex-board member [AJ White](#) goes into detail about the theft of that money and Patton West’s attempt to scalp one of her female employees for mentioning the missing money! Suffice to say, that Patton West has attempted to [SUBVERT](#) every single court case she has ever been involved with (20 to 30 at a guess) by targeting victims and hostile witnesses with her [secret weapon](#). The child custody case that her son and his ex-wife, Kendall Haywood, were fighting at the time was no exception. How does one get custody of an infant female child away from its squeaky clean mother to someone with an FBI record for forgery, substance abuse and traffic violations? Simple. You make the son look a better option to the court than the mother.



Above: How does a wife-beating, porn-loving husband gain custody of an infant female child from an all American Apple Pie sweet wife? Simple, if you mother is an occult master. Target the son's wife day and night with occult attacks until she thinks she is going crazy. Then the mother brings in a female doctor, a member of her cult, to diagnose her as such.

So, in the months leading up to the child custody court hearing Patton West, using her secret weapon, relentlessly day and night, targeted her daughter-in-law Kendall with occult 'under the radar' attacks until the poor girl sought psychiatric help because she could not understand why she could not sleep, why she had constant migraine headaches, partial paralysis of the limbs, severe pains in her kidneys etc. etc. You can go [here](#) to find a list of the violent attacks that the whistleblower and his family have endured for 13 plus years, as Patton West continues to try to hide her criminal past from the public in Arizona. At the custody hearing, Patton West wheeled in Dr. Pat Cole MD as a 'professional' witness knowing that Cole would deliver to the court a damning statement about Kendal Haywood on behalf of Patton West. It is quite distressing to read Dr. Cole's statement to the court knowing that most of it is probably a pack of lies, probably authored by Patton West herself and signed off by Dr. Cole. Kendall lost her daughter to Patton West's son and only two short years later, he was back in court trying to get custody of a second female child by his second wife, Jamie Haywood. Patton West tried the same strategy again. We know this because when Jamie sent an [email](#) to the whistleblower the day before the custody court hearing on July 12 2007, she actually mentioned that she and her baby were a target of occult attacks by Patton West. Jamie even mentioned these attacks while giving her [testimony](#) in court.



So let us do a ‘body count’ of those alleging they were the subject of occult attacks by Patton West. You have **Kendal Haywood** in 2005, relentlessly targeted until she thought she was going mad. You have daughter-in-law number two, **Jamie Haywood**, attesting to being on the receiving end of occult attacks in the run up to the second child custody hearing in July 2007. At the same time, Patton West is targeting her ‘business partner’ **Dr. Pat Cole MD** to try to get her to withdraw her assault charge against Patton West. You also have **Rebecca West** (no relation to Devra West) who happens to be Patton West’s office manager, also under attack by Patton West, who hopes to get Rebecca West to withdraw her hostile statement witnessing Patton West’s assault on Dr. Pat Cole. At the same time, you have **John Watson** and his family under attack by Patton West because he was suing Devra West for fraud and additionally because he had a website up sharing information like this, which shows Patton West to be a criminally insane predator. Finally, you have Patton West’s neighbor at the time, **Michelle Fetveit**, who attests to being targeted after getting into a water dispute with Patton West.

How many other murders have there been since 1991?

This may explain why in 2005, [Mike Hendrickson](#) defrauded out of \$200,000, chose to walk away empty handed. It may explain why in 2005, [Dave Kushner](#) defrauded out of \$30,000, chose to walk away empty handed. This may explain why after [Marion Cantwell](#) was kidnapped, held captive (falsely imprisoned), was beaten and had tens of thousands of dollars extorted from her, why she never went to the police. In Marion’s case, she was actually told that if she went to the police she would be murdered. Given that **Lisa Swidler**, a witness to the crimes committed by Patton West against Kushner and Cantwell, died suddenly and mysteriously in 2005 after trying to leave the cult, one cannot blame Hendrickson, Kushner and Cantwell from walking away empty handed. The alternative was to become a victim of murder or, as in the case of the whistleblower John Watson, attempted murder followed by a 13 year campaign of occult violence directed at him and his family, which has been ongoing since December 2006.

Circa 2006. This was not a good year for Dr. Pat Cole MD, and while we do not condone her defamation of John Watson or her acting as a false witness for Patton West in the matter of the child custody case involving Kendall Haywood’s infant daughter, one could say that in 2006 karma was a bitch to Dr. Pat Cole MD.

We started off earlier by saying that Patton West was herself defrauded out of \$650,000 in 2005 by a couple of con men; hence the money grabs from Hendrickson, Kushner and Cantwell in 2005, along with the murder of Lisa Swidler to stop information about these crimes leaking outside the cult. If we go back to January 2004, we also find that after John Watson's intervention, Patton West's charity was struck off for fraud.



Patton West's response to this set back was to steal the charity's main asset, a property worth \$1,250,000, which she put in a personal trust fund for herself and her eldest son, Rob Meador. She also stole \$4,000,000 worth of assets, which like the property, were largely paid for by public donations, and put them in a lock up where they remained hidden for ten years reappearing in Arizona in 2014, after the statute of limitations on theft had expired. All of this has been dealt with at length elsewhere. The point being, that sometime in 2004 Patton West ceased to be Victor MT's resident guru calling herself the Ascended Master Devra Ji, relocating a hundred miles north to Flathead Lake MT and became the Ascended Master Surya Ma. Instead of admitting to her cult that she was a criminally insane narcissist, who was heavily in debt and facing bankruptcy for the second time, she told her mailing list in a lengthy [missive](#) that her discomfort was due to her ascending from the 5th dimension to the 7th dimension (you cannot make this stuff up). Here is a small excerpt.

➡ My shift from fifth dimensional being, to seventh dimensional being is rapidly reshaping my "immediate personal world" if one might frame this shift in personal/impersonal terms. The shift is actually a shift into greater impersonality and yet also greater sense of Self within the Great Self.

She goes on to state that when she moves north to Shamballa (Flathead Lake MT) that she can only take 12 disciples and only those who are prepared to commit 66% of their net worth to her!

You will find the truth in the quiet sanctuary of your hearts of which I speak. You will also find the gateway to abundance which is God's love, as you make your way through the fiery demand of Truth.

For now, I will only say that there are none of you who are as yet fulfilling the standards of criteria for passage into the domain that the Masters will be anchoring at the Shamballa Sanctuary. As yet most of you are in the 30% to 40% range of balance of truth with me. You must fulfill balance of truth with me as well as with the ashram. Shirley and Lisa are approaching the 60% "wonder mark" and I hope will soon anchor a solid 66% exponential factor for both requirements. I remind you that at 66% the wheel turns, and the manner and timing of manifestation "time jumps" and this includes the truth of abundance. It is for this reason that I have been required to step out of the group energetic. I am in a time jump that is the reflection of my light and this is not to be disturbed by negative thought form. There can be no sacred manifestation in lower time. I can not succeed through co-creation with miasma. I can co-create with the to varying degrees with the Trusted Disciple. This increases as you increase your light.

Unfortunately for Dr. Pat Cole MD, she was one of the disciples who volunteered to move to Shamballa and in so doing, had agreed to give up 66% of her net worth. However, Patton West's financial situation was so desperate that she was not willing to wait for Cole to transfer her wealth to her in a civilized manner. So she set about beating it out of Dr. Pat Cole MD. Sometime early in April 2006, and after a series of premeditated assaults, the police were called and Patton West was charged with assault. Patton West would spend two years trying to intimidate Cole into withdrawing her complaint and also targeted witnesses like Rebecca West, in the hope of getting her to withdraw her witness statement. The contents of Rebecca West's harrowing email to the whistleblower of March 2007, entitled '[Help Me](#)' makes it absolutely clear that Patton West has a revolving door policy to employees whereby they recruited, given 90 days to join her cult as low paid or no paid slaves or be fired before Patton West has to pay employment insurance. Below are two excerpts from Carlida Finch's Statement of Fact to the authorities.

What steps did you take to remedy the situation prior to your separation?

At this point, I did nothing. I had already been the subject of Dr. West's anger and had overheard her striking her "disciple" Dr. Patricia Cole, witnessed the continual denegration of Dr. Cole by Devra. Per Devra and Dr. Cole Devra was destroying Dr. Cole's ego in Dr. Cole's quest for "enlightenment" I have documentation re an assault made on Dr Cole by Devra, though I did not see the assault, I did see the bruises. I could not see any way to remedy this situation.

The process of destroying one's ego can better be described as 'breaking' the person, so that they become totally obedient to the authority figure; in this case, psychopath Devra Patton West. Patton West's motives for mentally and physically abusing Dr. Cole MD, was not to help Dr. Cole become enlightened, but to soften her up so as to facilitate the extortion of Cole's entire net worth.

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

As indicated above, Patton West was overheard talking about the murder of Dr. Pat Cole MD remarking that, as an enlightened being, she could as easily live in a 6' X 6' jail cell as in a \$6,000,000 mansion. Of course being criminally insane, it would not occur to Patton West that enlightened beings do not commit murder. Several members of the cult were present at the time of the assault on Dr. Cole. As Debra Coffey makes clear in her [statement](#) to the whistleblower, these 'sessions' are organized with the specific intention of breaking the will of the targeted individual. So shocked were they at the degree of brutality used by Patton West, that it caused great unease amongst the rank and file members, as maybe one of them was next on the list to be 'enlightened.' A few days later on April 17 2006, Patton West issued a written statement to her entire cult mailing list. The statement contained an admission that the assault did occur and that it was severe but sought to justify the assault by asserting that Dr. Cole MD was a Nazi in the WWII death camps in another lifetime, therefore, the beating was not only appropriate but long overdue! She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. 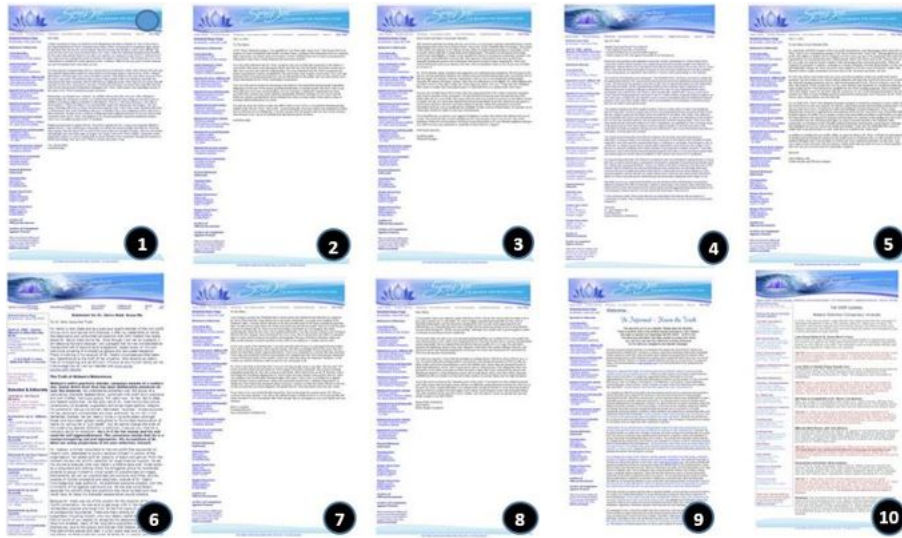

If the names Geoffrey Reynolds CPA & Julio E Williams MD sound familiar, that is because these two scum bags also conspired with Patton West in 2007 to murder the whistleblower, John Watson, after he went public about the cult's activities in Montana. At this point we would like to share several data points with the reader as proof positive that Dr. Julio E Williams MD is a pathological liar and remains to this day a willing accomplice in racketeering and murder.

Was this a down payment on the \$2,000,000 he promised Patton West so she could fight John Watson's fraud lawsuit?

4. As explained above when the Whitefish Pilot newspaper article was published Williams posted two statement of denial even though he had received his copy of her written admission of guilt sent to him 15 months earlier on 17 April 2006.

5. On August 9 2007 senior cult member Geoffrey Reynolds announced Watson's murder and also announced a campaign of occult 'under the radar' violent intimidation against Watson, his wife and children. Dr. Julio E Williams MD has received over 500 emails from Watson (with copies going to Reynolds) complaining about the ongoing campaign of attempted intimidation. Williams has so far refused to pass them on to the police hoping that Patton West may yet still be able to 'silence' Watson.

6. Dr. Julio E Williams MD continues to supply Patton West with an endless supply of dishonest 'testimonials' whose only purpose is to entice and entrap more victims.

When the 2007 murder plot failed, Patton West, Williams and Reynolds waited patiently to put Plan 'B' into operation. Even though both Williams and Reynolds were directly involved in Patton West's plan to murder Watson and her subsequent attempt to bankrupt him into silence, both seem unafraid that they or she will ever be called to account for their crimes. Reynolds even announced Watson's impending murder to the press on August 9 2007. He stated, in what he thought was an 'off the record' conversation with the reporter, that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him and his family. What Patton West did was launch a campaign of occult (hidden from view) violent attacks against Watson and his family which 13 years later are ongoing.
