

Subject: Is Rishi Devra AKA Patton West criminally insane or just a vicious and resourceful criminal.

Dear FBI, IRS, Arizona AG's Office & Sedona Police Dept.,

Is Patton West criminally insane or just a vicious and resourceful criminal / suspected serial killer?

It is clear from 30 years of evidence that Patton West is not a guru and that her 'World Service' propaganda is a disguise for a criminal racketeering business model. Let us review some of the evidence which clearly shows she has to be one or the other. In early 2002 while holding a seminar in Montreal Patton West was called out in a lie by one of her students Beatrice McGuire. Patton West's response was to viciously attack Ms. McGuire in front of tens of witnesses. The attacks resulted in part of Ms. McGuire's ear being partially ripped away from her head which required plastic surgery to fix. Witness Debra Coffey described the attack in [a statement](#) she gave to the whistleblower.

Patton West got a letter from Ms. McGuire's lawyer demanding reparations. Long story short Patton West, in a [letter to Beatrice](#) asserted that her recollection of the events was different from Beatrice's (in spite of 30 plus witnesses), but agreed to pay for Beatrice's medical bills. After the whistleblower John Watson announced he was going to sue Patton West fraud she demanded a private meeting with him in the hope of dissuading him from going to law. For his own protection Watson recorded the meeting with a digital tape recorder. During the meeting held in March 2003 the whistleblower mentioned Patton West's crazed attack on Beatrice McGuire to which Patton West denied the assault and [asserted that Beatrice McGuire was mentally ill](#).

When Watson asserted that he was promised wages and shares for his work Patton West [agreed all of that was true but added that she did not see herself writing out a check for what she owed him](#). Watson sued Patton West for fraud and got judgment against her in 2008. Watson put up a website about Patton West's crimes in Montana in 2006. Patton West's response to both these actions was to unsuccessfully attempt to murder him. Watson's impending murder was announced (1) & (2) to the press by senior cult member [Geoffrey Reynolds CPA](#) just days before her failed attempt on Watson's life. In early April 2006 Patton West viciously assaulted Dr. Pat Cole MD as part of a campaign of violence whose objective was to extort \$1.3 million from Cole. The assault was so severe that the police were called. On April 17 2006 Patton West sent a lengthy missive to her entire mailing list; it was entitled [The Law of Severity on the Path to Purification](#). In that missive she admitted assaulting Dr. Pat Cole MD and admitted the assault was severe there was no mention of the \$1.3 million she successfully extorted from Dr. Cole. In court on July 12 2007 Patton West was asked by counsel whether she had assaulted Dr. Cole to which Patton West [replied No, No way No how No!](#) Coincidentally on July 12 2007 the [Whitefish Pilot](#) newspaper published an editorial focusing on Patton West's assault on Cole and covering several other crimes being committed by Patton West in Montana at that time.

Murder as a Weapon.

In 2005 student [Lisa Swidler](#), witness to serious crimes committed by Patton West against students Kushner and Cantwell, was murdered by Patton West to keep her quiet. The fear of being targeted for murder is why [Mike Hendrickson](#) did not go to law after being defrauded out of \$200,000 in 2005. Why [Dave Kushner](#) did not go to law after being defrauded out of \$30,000 in 2005. Why [Marion Cantwell](#) did not go to law after being kidnapped, falsely imprisoned and the victim of extortion in 2005. Fraud victim turned whistleblower [John Watson](#) became the victim of a murder plot after he went public about Patton West's crimes in Montana.

A murder every now and again helps to keep other victims in-line.

There are scores of victims of organized crime and, according to Patton West's ex-husband Jack West, multiple murders. How long are the authorities going to ignore this? No wonder Patton West believes she is a God and scum like [Reynolds](#) & [Williams](#) believe they are never going to be called to account for being [willing accomplices in racketeering and murder](#).



In 2002, while employed as a business consultant for Patton West's 'charity,' the whistleblower discovered that Patton West had diverted an \$80,000 donation away from the charity to pay for her son's legal fees.

Days before the whistleblower reported the fraud to the authorities Jack West took the whistleblower aside and made the following statement, and I quote, "Those who opposed my wife have a habit of dying suddenly." End quote.



MOTIVE, MEANS & OPPORTUNITY.

Motive. In a [civil lawsuit](#) brought by the SECURITIES & EXCHANGE COMMISSION (Civil No.: 2:13-cv-00188) it shows that Patton West had to raise \$650,000 by September 2005 as a deposit to obtain several million dollars to fund a Spa Complex she hoped to build in Montana. Patton West did not have that money but she did have a weapon that allowed her to defraud and extort money from the members of her students and employees. We maintain that Patton West robbed, defrauded and extorted money from Watson, Kushner, Cantwell and Hendrickson and several others to raise the \$650,000 she needed. We believe Patton West murdered student [Lisa Swidler](#), a witness to some of these crimes, to keep her quiet.

Means. After acquiring occult (hidden) knowledge, while attending [The Robert Jaffe School for Energy Mastery](#) between 1990 & 1991, Patton West has had the ability to cause illness, injury and death – remotely. Patton West, a dangerous psychopath, has for 30 years used this ability as a weapon to feather her own financial nest at the expense of everyone else she meets.

Opportunity. Shortly after leaving The Robert Jaffe School for Energy Mastery in 1991 Patton West formed a personality cult around herself. Patton West, a criminally insane narcissist, wants everyone to believe that she is a deity on a mission to lead humanity. Anyone who dissents or opposes her becomes a target and, because she runs her criminal business model as a cult, she insists on total secrecy. The code of secrecy combined with a weapon that makes it impossible to link her to an assault or murder is why she has remained at large for 30 years. This also explains the willingness of scum Williams & Reynolds to become complicit in racketeering and murder. They believe there is no downside for them even though multiple victims like Rebecca West (no relation to Patton West) refer to the use of an occult weapon being used against them as a means of silencing their opposition. In a harrowing email to the whistleblower entitled '[Help Me](#)' Rebecca West asks for help to deal with Patton West's use of Shamanic witchcraft.

The victims mentioned above are the tip of the iceberg. Patton West may turn out to be one of America's most prolific killers. A killer so confident in her ability to evade justice that she has members of her cult, Geoffrey Reynolds CPA, announce the victim's murder ahead of time. On the same day Reynolds announced Watson's impending murder to the press he also announced that a campaign of violent intimidation would be launched against Watson and his family. This campaign continues to this day and is evidenced by some 500 plus emails sent by Watson to cult / gang members Williams & Reynolds. Whether Patton West criminally insane or just a vicious and resourceful criminal / suspected serial killer is yet to be determined. 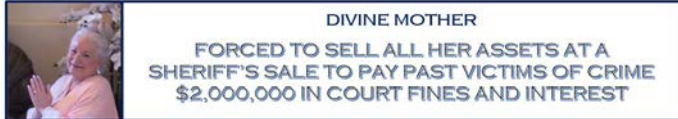

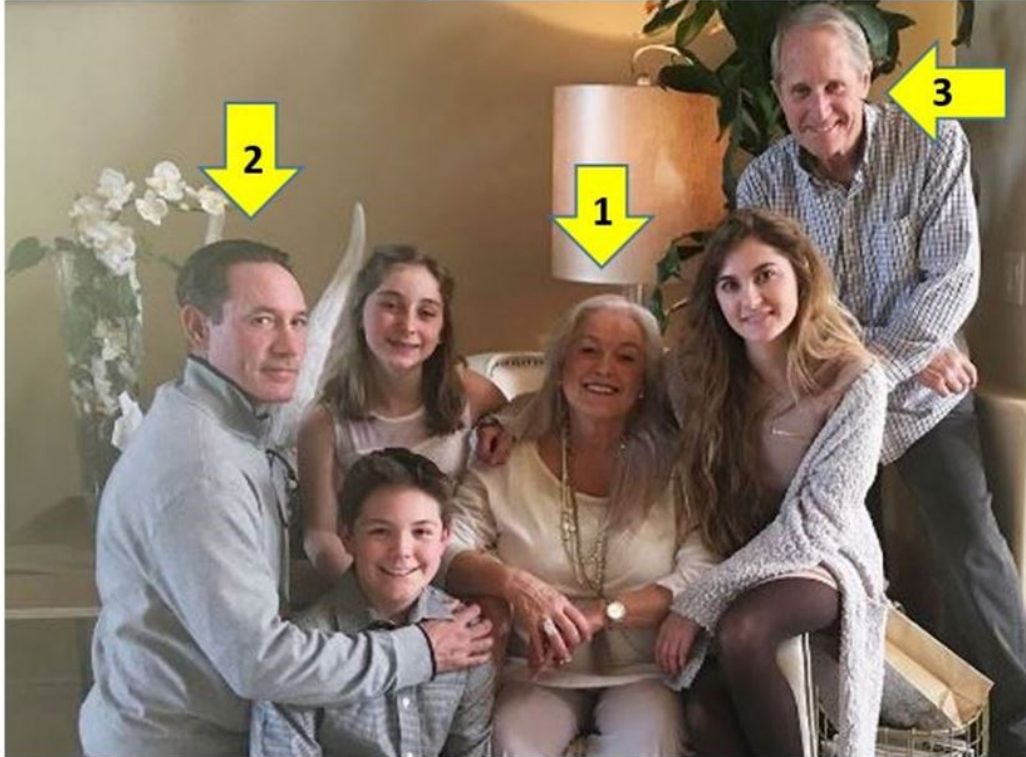

The Patton West family is a CRIME FAMILY just like the TV series the Sopranos.

Patton West's business model involves theft, fraud, extortion and murder. However, Patton West has a huge advantage over Tony Soprano in that the weapon she uses to facilitate theft, fraud, extortion, intimidation and murder, is not recognized as a weapon by legal statute. This explains why Patton West is still at large after 30 years of organized crime. As with the Mafia, 'if you mess with the dough, you gotta go.' Which is why when fraud victim John Watson went public with information like you are reading now, she conspired with Geoffrey Reynolds and Julio Williams to murder Watson. Patton West was so certain that the murder of Watson would succeed, and that she would not be held accountable, she instructed Reynolds to announce Watson's impending murder to a local newspaper a week before she made her failed attempt on Watson's life.

To understand Jack West's role in Patton West's criminal racketeering business model, I would suggest the reader review the following four documents; all of which show Jack West to be a pathological liar.

1. After discovering John Watson's website in 2007, Jeremy Samuelson wrote to Watson via [email](#). In the email, Samuelson referred to Jack West as his land partner, a timid man with little experience. He goes on to say that she overwhelmed him and was soon running him. Though now divorced, Patton West is still very much 'running' Jack West. Samuelson loaned Devra and Jack West \$10,000 and was never repaid. Samuelson knew them back in the 1970's & 1980's. They have been robbing, defrauding and extorting money ever since that time.
2. [AJ White's](#) statement about the 2001 assault on Susannah Felder (featured above) shows how Jack West lied about what actually happened and in so doing, suggested that the victim, who was partially scalped, was to blame for the assault. All the victim did was ask Patton West why she was stealing \$80,000 to pay for Chris Haywood's (see (2) above) legal fees, which had nothing to do with the charity.

3. When giving evidence at the fraud trial in 2007, involving his then wife, Patton West, and John Watson, Jack West told the court that Watson forced him to write [the letter](#) to the Immigration and Naturalization Service (INS) proving Watson was employed by Patton West. Watson's lawyer stood up and asked Jack West if he realized that to falsify a statement to the INS could result in 10 year jail sentence. Jack West withdrew his lie.

4. Jack West was totally aware and directly involved in theft, fraud and extortion. He was totally aware of the overt and covert violence administered to countless victims in New Mexico and in Montana, to force them to 'donate' their wealth to fund Patton West's luxurious lifestyle. As the photo above shows, he is still involved in the crimes being committed in Arizona. After Patton West was found guilty of assaulting Dr. Pat Cole MD and, after Patton West was found guilty of defrauding John Watson (who had turned whistleblower and put up a website dedicated to Patton West's crimes) three newspaper articles were published about these lawsuits. In response to the stories published by the [Whitefish Pilot](#), [Bigfork Eagle](#) and the [Ravalli Republic](#) newspapers, Jack West posted a lengthy statement on behalf of his then wife. The Truth of Watson's Malevolence

Watson's entire psychotic slander campaign smacks of a modern day, Salem Witch Hunt that has been deliberately plastered all over the Internet.

In 2007, just before being convicted for fraud, convicted for assault and just before being the recipient of two arrest warrants, pathological liar Jack West made the following statement about his wife:-

"She remains utterly free of wrongdoing and as ethically virtuous as any human being can be."

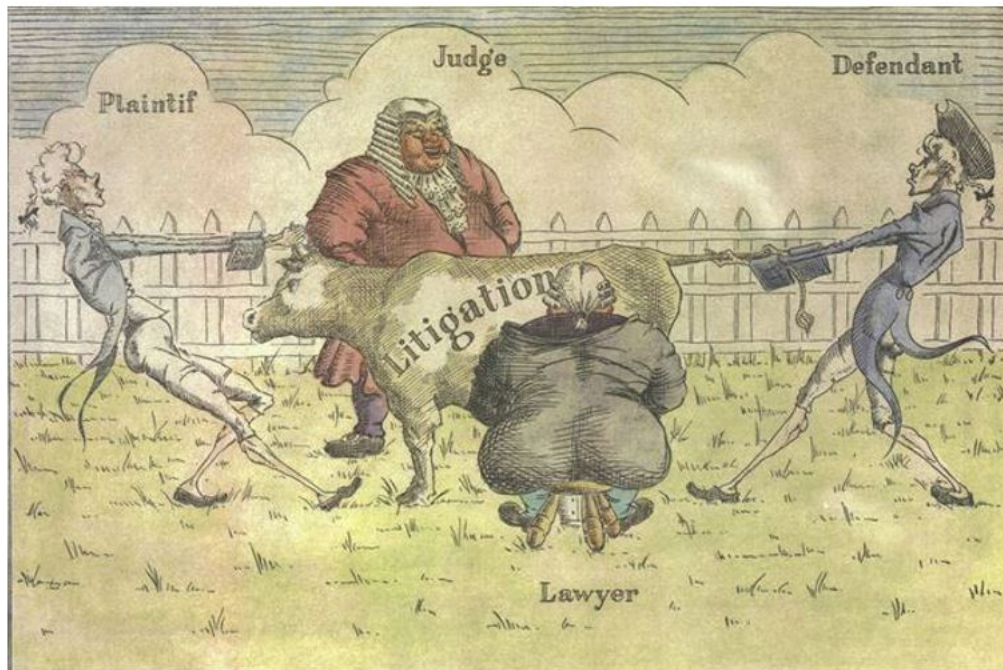

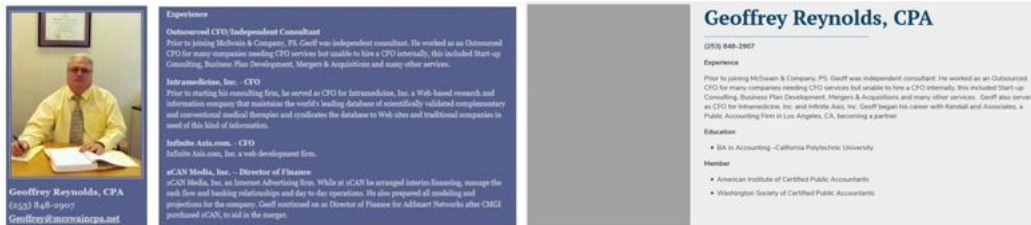

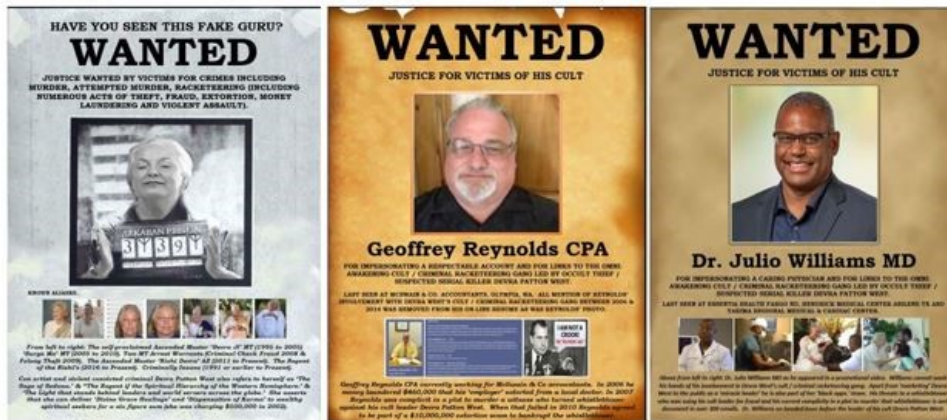
