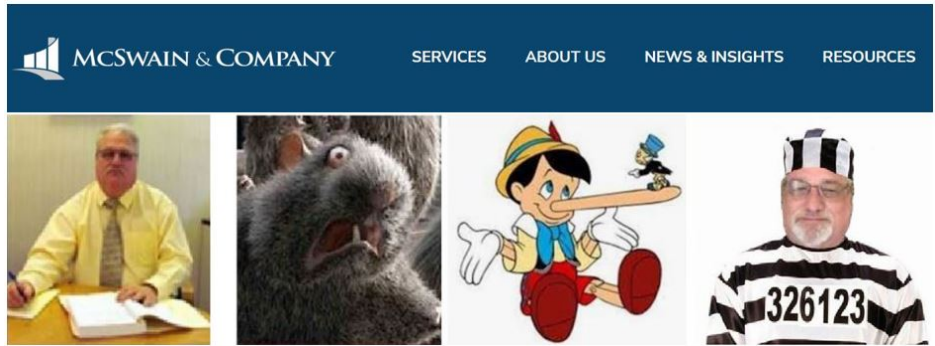

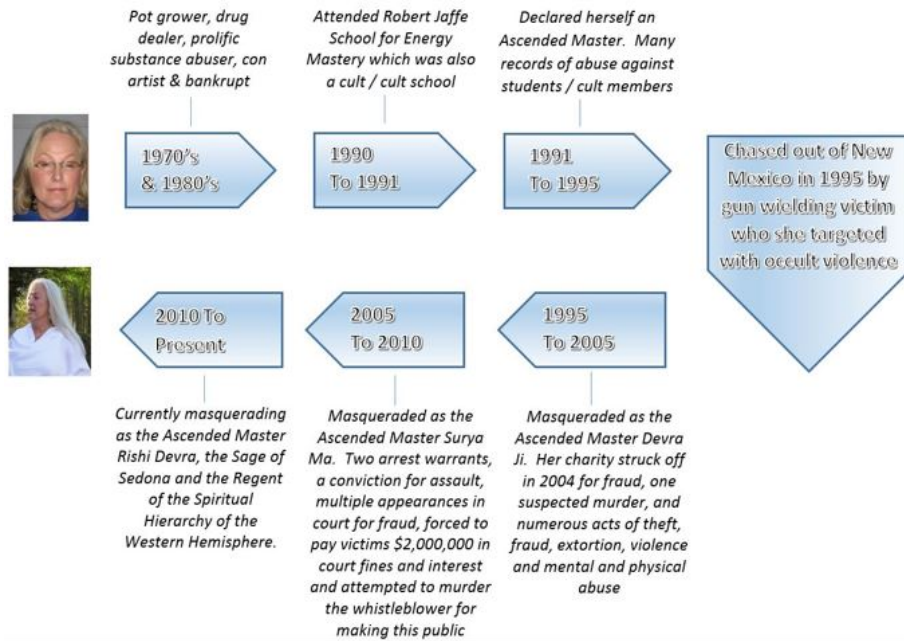

Students to her unaccredited school for occult studies are expected to join her cult from day one. Employees, attracted from all over the USA by false / fraudulent [careers opportunities](#) find out upon arrival that there was a ‘mistake’ about their promised salaries which are dropped by 20% on day one. During the next 90 days, they are pressured into joining Patton West’s cult. Some agree to do so because they burned their bridges before travelling across the USA only to take up their new position and find out on arrival, that Patton West’s corporation is a front for a cult / criminal racketeering gang. Those who refuse to submit to her will and join her cult are summarily dismissed before 90 days expires, as after that time, Patton West would be forced to pay employment insurance. Since we are cataloging Geoffrey Reynolds’ involvement in Patton West’s cult / criminal racketeering gang between 2006 & 2014, let us describe for the reader what was happening around Geoffrey Reynolds during the first days of his employment which commenced in September 2006.

Employee Rebecca West (no relation to Patton West) details in a harrowing email sent to the whistleblower in March 2007, entitled '[Help Me,](#)' how 30 employees had come and gone within a 10 month period. Rebecca also details some of the criminal acts being perpetrated by Patton West toward her, Dr. Pat Cole MD and several other employees. Employee Carlida Finch, in a [statement](#) she made to the authorities in 2006, explains how she was given the choice to either join Patton West's cult or be fired. Carlida also explains in her statement to the authorities, how she overheard Patton West talking about murdering her business partner Dr. Pat Cole MD.

Carlida Finch overheard Patton West saying that she did not care if she murdered Cole because as an 'enlightened' being she could just as easily live in a 6' X 6' jail cell as in a \$6,000,000 mansion! We will now detail two serious crimes that Patton West committed BEFORE Reynolds commenced his employment with her in September 2006.

AUGUST 2002 JOHN WATSON – DEFRAUDED BY PATTON WEST.

In addition to recruiting employees to non-existent jobs in the hope of forcing them into her cult, Patton West also uses the same strategy with business consultants. In 2002 Patton West recruited business consultant John Watson for a 6 month project which involved setting up several for-profit and non-profit corporations. Realizing that Watson was not going to join her cult, she simply refused to pay him the wages and shares that she had agreed to pay at the outset. Long story short, in March 2003 Watson announced he was going to sue Patton West for fraud. Above: You have to ask yourself why an apparently intelligent physician and thoracic surgeon would involve himself in a dispute between two people one of which (John Watson) was a total stranger to him. The explanations are few. Either he was / is mentally ill or a willing accomplice in Patton West's cult / criminal racketeering gang. This is for a criminal court to decide.

And, using her [secret weapon](#), she mounted a campaign of violent intimidation against Watson, his wife and children. Additionally, Patton West and the members of her cult posted a dozen or more [defamatory statements](#) about Watson on her website as part of a campaign to demonize Watson (for wanting justice).



NOTE: When Reynolds joined Patton West's employ / cult / criminal racketeering gang in September 2006, Patton West's dispute with Watson was by then four and a half years old. Coming from California, Reynolds could not possibly know what existed until he was fully briefed by Patton West after taking up his position in September 2006.

In August 2007, Patton West attempted to murder John Watson in the same way she had murdered one of her students, Lisa Swidler, two years earlier in 2005. For his part, Geoffrey Reynolds announced Watson's impending murder to the Montana press while he was being interviewed on August 9 2007. When the murder plot failed, Patton West waited until 2010 to put Plan 'B' into operation, at which time she conspired with Reynolds and Williams to bankrupt Watson into submission.

Again, what I want you to take away from this is that Patton West ADMITTED her guilt.

Business partner of Victor Guru wins lawsuit

The former business partner of a self-styled spiritual guru in Victor was awarded nearly \$800,000 on Thursday in a civil case in Ravalli District Court.

Judge Jeff Langton awarded John Watson \$730,000 in compensatory damages and about \$46,000 in attorney fees and costs, but denied his request for \$300,000 in punitive damages.

Watson, a British native who now lives in Canada, sued Devra Patton West in 2003 for breach of contract, fraud and unjust enrichment.

The case was heard in Ravalli County because West's home and business operations - the Divine Unity Foundation and the Sacred Archives Institute - were in Victor, where Watson also lived.

Langton entered a default judgment against West, who calls herself Surya Ma, on July 16 after she failed to show up for a number of court hearings and to respond to court deadlines.

West did not attend Thursday's hearing. Her business manager, Geoff Reynolds, attended but declined to comment and said West would not comment.

Above: Patton West did not attend court, instead, she sent her business manager Geoffrey Reynolds CPA who declined to comment. Reynolds no doubt heard the recording on Watson's website of Patton West admitting she had defrauded Watson.

Within 24 hours of the above newspaper article appearing, Patton West posted the following statement on her website.

Millennia Mind Dispute with John Watson:
Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Above Patton West denies she is guilty of fraud and calls the court's verdict a "technical error." After failing to murder Watson or intimidate him she accuses him of threatening her. She accuses Watson of mounting an extortion scam against her.

In her posting above, Patton West says that, “no business contact between Dr. West and John Watson ever existed.” If that is the case, how does she explain [a letter from her husband Jack West](#) to the Immigration and Naturalization Service (INS) confirming Watson’s employment and salary? How does she [explain business cards and stationery](#) for Watson? How does she explain the [personal guarantee](#) Watson & Patton West were both asked to sign by the Cactus Design Agency? And why, if there was no business relationship, would Patton West [write to her lawyer](#) asking him to end that ‘non-existent relationship? Again Patton West’s mantra is, “It does not actually matter what is true.”

DR. PAT COLE MD – MULTIPLE VIOLENT ASSAULTS & EXTORTION.

In January 2004, Patton West’s charity ‘The Circle of Divine Unity,’ was [struck off the Montana charity register](#) after John Watson reported that Patton West was defrauding the charity out of hundreds of thousands of dollars donated to the charity by the public. Ex-board member [AJ White's statement](#) explains how Patton West stole an \$80,000 donation to fund her son’s legal fees. AJ White’s statement also explains how, when employee Susannah Felder mentioned this to Patton West, she viciously assaulted Susannah ripping clumps of hair from the victim’s head.

Have we said that Patton West is criminally insane?

Following the charity’s removal from the register, Patton West was forced to move from Victor MT to a new location at Lakeside MT some 100 miles north.

Though close to bankruptcy for the second time, Patton West put on a brave face and informed the members of her cult that any discomfort she was feeling was not due to her financial problems or the fact she was being sued by several victims. Instead Patton West asserted in a missive she sent to her entire mailing list that her discomfort was due to her moving from the 5th dimension to the 7th dimension! Patton West went on to describe the move north as a move to Shamballa, and because of the rarified vibrations at the new location, she was only able to take 12 disciples with her. Presently, the balance of truth between myself as Master Teacher and the group has yet to be fulfilled, demonstrated and anchored. No less that 66% fulfillment of Truth in Balance between disciple and Master Teacher on the part of no less than twelve persons can serve as my container. There is no preconceived idea as to who these twelve persons will be. Purity of heart, mind and purpose in service to the Master Teacher’s work and thus the work of the Ashram as assigned by Brotherhood of Light will be the determining factor.





Dr. Pat Cole, a wealthy physician and allegedly a member of the Whirlpool family was one of the 12 disciples who agreed to commit 66% of their net worth to Patton West so they could accompany her to Shamballa. Long story short, Patton West got tired of waiting for Dr. Pat Cole to transfer the contents of her bank account into Patton West’s bank account. Patton West, using several members of her cult in strategy outlined by student Debra Coffey [here](#), mounted a campaign of violent intimidation against Dr. Cole with the intention of intimidating Cole into handing over her money to Patton West.

Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

 Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.





Above: Patton West the only 'spiritual' teacher on the planet who uses abuse, violence and a hammer (to break bones) to propel students towards enlightenment. That said she may only use that technique against the wealthy students whose bank accounts and possessions she is trying to liberate – in the name of enlightenment of course!

One morning in early April 2006, Patton West went too far and after a particularly vicious assault, involving Patton West repeatedly hitting Cole over the head with the heel of her shoe until blood ran down the victim's blouse, the police were called and Patton West was charged with assault.

Those present at the assault were so horrified, that Patton West thought it best to issue a statement to her entire mailing list in which she sought to justify the assault on Cole. Below is an excerpt from a missive Patton West sent out to her mailing list on April 17 2006 entitled '[The Law of Severity on the Path to Purification.](#)'

The Law of Severity on the Path of Purification

Response to the Call of Master Surya Devi for Review

April 17, 2006 From Master El Morya of the Shamballa Counsels

At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be

Above: The above is more evidence that Patton West is either criminally insane or a ruthless cold calculating criminal. Either way she needs taking off the streets and locking up. In response to the violence she meted out to Dr. Pat Cole MD, while extorting \$1.3 million from her, Patton West speaks to the voices in her head and asks them for a review of her actions.

In the subheading above Patton West, while pretending to ask long dead Ascended Master El Morya to review her actions, gets the response she wants! Below here is an excerpt from the first paragraph:-

*At no time has **Surya Ma's intentions** been rooted in anything other than the **highest of grace** despite the seeming severity that was meted.*

One would argue that repeatedly hitting someone over the head with the heel of their shoe until blood ran down the victim's blouse would not be described by a sane person as behaving with "the highest of grace." But Patton West is criminally insane, so we must make allowances! However if one reads the paragraph at which the red arrow is adjacent to, it is obvious to the reader that Patton West is admitting that she is admitting the assault. Patton West goes on to justify the assault by asserting that Cole was a Nazi in the WWII death camps in another lifetime. No mention of the \$1.3 million that Patton West was in the process of extorting from Cole. Maybe Cole owed that to Patton West from another lifetime.

What I want you to take away from the above excerpt is that Patton West ADMITTED her guilt.

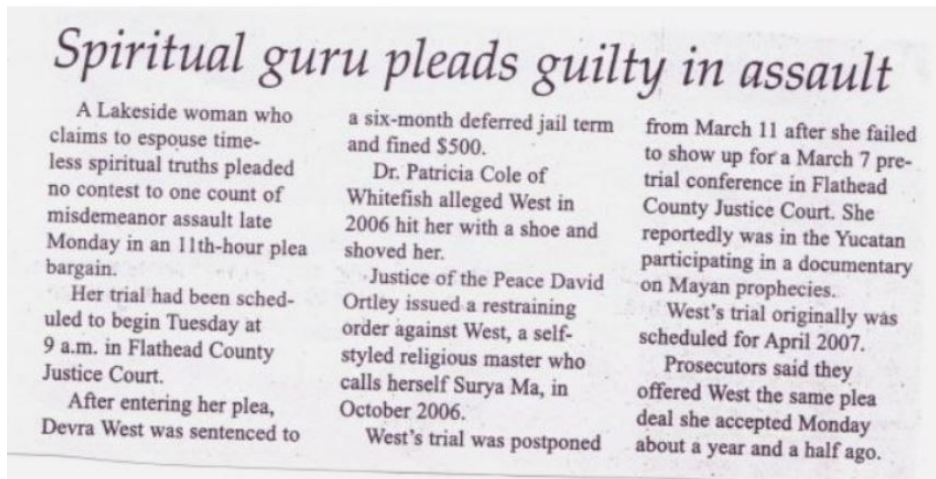


Reynolds joined Patton West's employ / cult / criminal racketeering gang in September 2006 some 5 or 6 months after Patton West had assaulted Dr. Past Cole MD. Some 5 to 6 months after the police were called and Patton West was charged with assault.

When questioned about the assault in court on July 12 2007, Patton West vehemently denied the assault. Below is an excerpt of her testimony. You can review all of it by going [here](#) and scrolling to Page 29.

7 Q. Isn't it true that there is currently pending

Patton West spent the two years between being charged with assault and being convicted with assault, targeting Cole and the hostile witnesses, in a vain attempt to get Cole to drop the complaint and the hostile witnesses to recant their statements. However in April 2008, Patton was found [guilty of misdemeanor assault, fined \\$500 and given a 6 month suspended prison sentence](#). No mention of the estimated \$1.3 million Patton West successfully extorted from Cole! Patton West did not even turn up to court to hear the verdict.



However within 24 hours of the above newspaper article appearing, Patton West posted the following statement on her website.

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

What I want you to take away from the above excerpt is that Patton West ADMITTED her guilt.

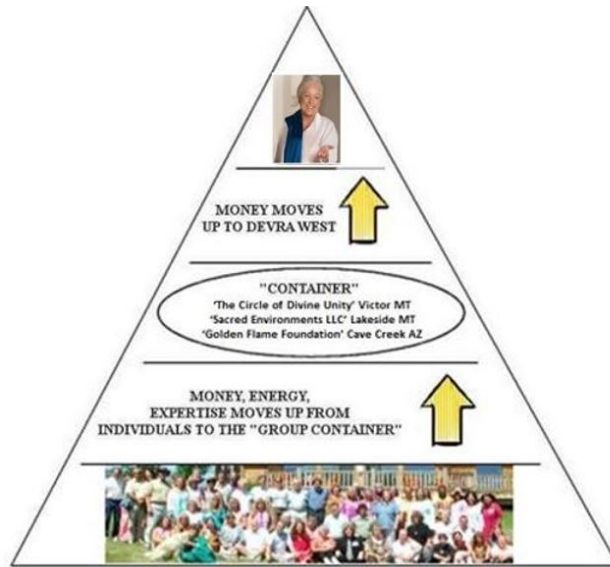
IN SUMMARY – TWO CRIMES, TWO VICTIMS WATSON & COLE AND TWO ADMISSIONS OF GUILT FROM PATTON WEST. REYNOLDS WOULD 'TAKE UP ARMS' AGAINST BOTH VICTIMS ON PATTON WEST'S ORDERS!

1. John Watson. Was defrauded in August 2002 and was constructively dismissed that same month. Watson responded by issuing a lawsuit against Patton West for fraud and unjust enrichment. This crime occurred four years and one month before Reynolds took up his position with Patton West in September 2006.

2. Dr. Pat Cole MD. Was viciously assaulted as part of a campaign of violence used by Patton West to force Cole to give up her entire net worth to Patton West, which is exactly what happened. Patton West successfully extorted \$1.3 million from Cole which included forcing Cole to sign over her home worth \$750,000. The assault that resulted in the police investigating occurred early April 2006 i.e. 5 months before Reynolds took up his employment in September 2006.

**REYNOLDS 'EMPLOYMENT' / MEMBERSHIP OF
PATTON WEST'S CULT / CRIMINAL RACKETEERING
GANG BEGAN IN SEPTEMBER 2006**

After putting up his own website in 2006 to counter the lies and propaganda posted about him on Patton West's website, Watson started to receive correspondence from several other victims of Patton West's 'World Service' cult / criminal racketeering gang. These victims wanted to add their experiences to that of the score or so of other victims of crime at Patton West's hands during her incarnation as 'Devra Ji' between 1991 & 2004 and as Surya Ma between 2005 and 2007. Perhaps the most important person to correspond with Watson during this time circa 2007 was Rebecca West, no relation to Patton West, Rebecca being Patton West's then office manager and a good friend to Dr. Pat Cole MD who was supposed to be Patton West's business partner. However, as the image below depicts, Patton West does not have 'partners' she has victims. Her 'save the world' schemes are used to attract funding and energy from 'service to others' type people who are then 'processed through her cult, robbed, defrauded, become the subject of extortion and then spat out when their usefulness to Patton West was ended. Cole and Watson were just two such victims. There are scores or hundreds!



Above: Patton West's 'business model' was / is a well-oiled criminal conspiracy hidden inside a cult which to all outward appearances looked like a quasi-religious organization with charitable aims. In reality members of her cult were under constant pressure to fund-raise and make personal donations to Patton West. None of the money went to the 'noble' causes espoused by the charity. All of it went into Patton West's pocket to fund her lavish lifestyle that included a mansion, servants and a cook.

I think it important to share, in their entirety, the contents of two emails that Rebecca West sent to John Watson in March 2007, as to do so achieves two goals.

1. It demonstrates to the reader the total chaos that existed inside Patton West's cult. And demonstrates in large measure, the cruelty of Patton West towards her employees. This is especially important as Patton West is currently masquerading as 'Divine Mother' in Arizona, where she is targeting spiritual seekers in Sedona, just as she did in Montana and New Mexico before that.

2. It demonstrates the disposition of Geoffrey Reynolds who, by March 2007, had only been in Patton West's employ for approximately six months, but by then had fallen totally under her control. To the point where he was ignoring the serious crimes being committed by Patton West against her own employees. We suspect that Reynolds became totally compliant to Patton West's wishes, however illegal or immoral, after being duped into loaning her his life savings of \$300,000. Rebecca West asserts as much in the two emails we are going to review.

I am going to highlight the sections of the email that refer to Geoffrey Reynolds CPA in yellow. Additionally, where Rebecca mentions the 'finance controller' I'll put [GEOFFREY REYNOLDS] in brackets to make it clear who she is referring to. There is a single comment about Dr. Julio E Williams MD giving Patton West \$100,000 which is highlighted in blue.

Here is the first email that fraud and mental and physical abuse victim Rebecca West sent to John Watson.

Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them.

I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

I have written her a letter that I have been hesitant on sending her, as I know it will create a wave of violent behavior and I have little to protect myself. My only safety net per law enforcement is to write a "Letter of No Contact" and mail it. If she stalks me, and I have this letter in hand, law enforcement will respond and then maybe the Judge will order a "no stalking order" against her! I have been hiding in my home for many days now, afraid to go anywhere. This whole situation has been a horrible drain on my relationship with my partner, as he is having a very difficult time trying to understand what I am going through. In fact most "men" think it is no big deal, "if she comes after you "you can kick her ass!", what are you so afraid of?" This attitude is pervasive and includes her current finance controller [GEOFFREY REYNOLDS CPA], whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates me before, during and after work, and advises if she comes after me, I should just kick her ass!

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available. Again the crux is finding a law firm willing to take the case without a hourly payment of services. With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her.

I am aware that the only person still financially supporting Devra (the finance controller is out of money), is Dr. Julio Williams and he gave her \$100,000 last week. Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through.

Tanmayo's (Coca-Cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [GEOFFREY REYNOLDS] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000. You can see that I, Dr. Cole and many others have much to lose and confidentiality between us is very important. I tried to talk to Dr. Cole about you and she feels you took your case too far...I will not pass judgment until you show me otherwise and beg of you to realize the vulnerable position I am in by living only 5 miles from her!

I am more than willing to talk to your Attorney to support the situation, all I ask is for your assistance in attempting to get my hard earned monies owed me through the MT ST Wage and Labor Board. I am aware there are several other former employees that filed claims with the MT ST Wage and Labor Board and any documentation or advice to support me in this endeavor would be greatly appreciated.

I know that unless the \$30M comes in this week, [that GEOFFREY REYNOLDS fraudulently applied for] the Naka Shela Retreat Center is lost to foreclosure along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his wife Jamie, and their newborn and 7-year daughters living upstairs. Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month.

*I just spoke with the finance controller [GEOFFREY REYNOLDS] this morning, and he is telling me that unless I talk to Devra today, I can forget about the monies owed me. I reminded him that a missing paycheck and overtime are due me even if she calls it a "Bonus" and that several other people have taken her to the labor board and I would be no different. I have asked him to lay me off and to explain to her the repercussions of not paying me before I am forced to file a claim. I also told him I had no intentions of talking to her as I had already sent her a letter requesting the monies owed me, before I would be willing to talk to her. She responded a couple days ago by sending an e-mail to my private address where she stated she would not read my letter. It is obvious that she is afraid of me or she would have fired me already!
I know too much, am a local resident, and have worked extensively with local law enforcement as a former Administrator of Emergency Services.*

Dr. Cole and I are very afraid, but this does not preclude me from standing up for what is right even if I lose my life over it! Until last week Dr. Cole thought she was all alone and was happy just to have a normal life again. Upon contacting her for the first time last week, (since the court hearing last November), she realizes and accepts the fact that there are many other victims, including myself and it is unfair for her not to come forward in an effort to stop Devra from continuing her deceit and corruption of innocent people. Unfortunately, it always comes back to a money issue and the fact that she has hidden her assets in her home which is about to be foreclosed on. (This very much alarms me as this may be the only way to get some of the money back to those she has robbed).

I have followed the \$30M CPEA funding issue closely [that GEOFFREY REYNOLDS fraudulently applied for] and although the monies are earmarked for a 3-Tier Business Plan to develop Spas is the very way to pay off her debt to all of us. If she thought for a moment that she could buy her way out would do so in a heartbeat even though she vindicates herself through the Masters as needing to prove she has done nothing wrong. According to the Masters, Dr. Cole and all the others got their due punishment and their reputations need to be destroyed in the interest of saving ourselves from their evil.

I know that I can never be in the same room with her again, due to her ability to read my mind. I am not sure how she does this and would greatly appreciate any light you can shed on her abilities. I must continue filling out a job application, so I will end for now. You can trust me and I pray you will do the same for us by keeping this information confidential. We are awaiting an answer from the Attorneys as to whether they will take this case without monies being paid up front. If not, would Jennifer Lint be willing to take our cases based on the additional 30+ people who have suffered? She must have a wealth of knowledge due to the many years of her involvement. It is too bad she quit working for you, and if it would help for me to talk to her, I would be willing to do so, but at this point only if the local attorneys are unable to do so, (we will know tomorrow).

If you align with Hendrickson's Attorney instead, would he be willing to help us? I have the ability to bring to you 30+ former employees and with your 40 former students/employees statements maybe we can stop her! Devra checks your website daily so be careful for our sake. In addition, she has her computer technician check your site daily and at this point he has turned coat, although he has been my friend for 25 years! This only goes to show everyone how powerful her web of influence has on people!

Comments on the above email.

1. Clearly, Reynolds is ignoring the crimes being committed right under his nose by Patton West against Rebecca West, Dr. Pat Cole and others. According to Rebecca, West and Reynolds told her that she could forget about the pay and overtime she is owed unless she 'talks' to Patton West that day. This is illegal. Either the money is owed or it is not.

To get an understanding of how Patton West treats her employees, read the [statement](#) fellow employee Carlida Finch gave to the Labor Board as part of her complaint about Patton West. In Carlida's case, she was told that she must either agree to become a member of Patton West's cult or she would be fired. Like Rebecca West mentioned doing, Carlida sought [help from the authorities](#). However, most applications to the labor board or to the courts failed because Patton West would get the members of her cult to make false witness statements on her behalf at the hearings.

2. Rebecca mentions the \$30 Million CPEA funding that had been applied for. This grant money was fraudulently applied for, because any application made by Geoffrey Reynolds CPA to the government would not have told the truth about the directors or owners of the corporation applying for the grant money. Patton West may use corporations as fronts for her criminal activities but even a cursory glance at the underlying facts, would reveal that any directors were directors in name only and that Patton West, hiding from view, made all the decisions.

Prepared financial projections and developed strategy for five, ten, fifteen and twenty years of operation, and crafted business plan. Working in secondary financial markets, secured \$30M in wrap loans with no expenditure of company equity.

We shall prove via many examples of dishonesty, that Reynolds is a pathological liar and should never be employed in a position of trust.

4. Early on in the above email, Rebecca makes the following comment:-

This attitude is pervasive and includes her current finance controller [GEOFFREY REYNOLDS CPA], whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates me before, during and after work etc.

It is clear from the above that Reynolds, having loaned Patton West \$300,000, was totally under her control and therefore unable to act in anyone's interests other than his own! To be absolutely clear, Reynolds was watching Rebecca West and others being subject to mental and physical abuse right under his nose and doing nothing about it!

Here is the second email that fraud and mental and physical abuse victim, Rebecca West, sent to John Watson.

Dear Mr. Watson,

I checked your website and am grateful that it is still up and running. Just the other day, I was attempting to show the Fire Chief here in town (very good friend of mine) your site and it was not coming up after several attempts. The IT Tech (used to be my 25 yr. friend) who is currently employed by Devra is working diligently at burying your website with metatags etc. The last I knew, the non-profit Attorney Karl Rudbach was attempting to serve you with papers in order to shut down your site.

I received partial payment for my massive overtime hours but is far short of what she owes me and also does not include my credit rating damages, telephone charges, etc., etc.. My meeting yesterday with the Finance Controller [GEOFFREY REYNOLDS] was to discuss my unemployment issues as he had agreed to put me into a lay-off status, but has since reported to the State that I voluntarily quit! He recently treated a former employee as laid-off after Devra threw a book at her and then fired her. The companies owe large sums of money for WC, and ST, and Fed payroll taxes and was the reason he secretly laid-off Wendy Stuart, without confirming this choice with Devra first. He was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the fourth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He said that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job.

To clarify, I have not worked for Devra since Feb 23rd was on sick leave until March 6th, and promised lay-off status on this same date. I am forced to spend time sending documentation to the State Unemployment Office and would appreciate any advice you may have or letters you or others may be willing to submit on my behalf. In addition, I will now be going to the State Wage and Labor board with my complaint for wages due me.

I will act upon the advice of an attorney before proceeding with posting to your website. Thank you for being there and standing up for what is right against a serial tyrant, she has and continues to abuse me and others!

Comments on the above email.

1. In the above email from Rebecca West, she alleges that Reynolds lied about her employment status by telling the labor board that she had voluntarily quit. In the second highlighted paragraph, Rebecca states that Reynolds was trying to protect his CPA license and pretends that he did not see employee Wendy Stuart get hit by a large three ring binder that Patton West threw at her.
2. Rebecca also told Reynolds (for the fourth time) that she had been slugged by Patton West three times in the back. The physical and verbal abuse is all part of the brainwashing and conditioning designed to 'break' the target's will on the way to making them a subservient low paid / no paid slave. Spiritual leader has plans for healing center in Whitefish

A self-styled clairvoyant and spiritual healer from Lakeside who claims the Osprey House on Angel Point as a future VIP spa faces criminal charges stemming from an alleged assault on a Whitefish doctor. [\[1\]](#)

Devra Patton West's goal of opening a series of healing spas -- including one in Whitefish -- has been stalled while she fights allegations ranging from black magic to fraud, extortion and breach of contract. [\[2\]](#)

A temporary restraining order against West, who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, requested protection. Cole was the director for one of West's ventures, The Sacred Archives Institute. [3] They worked together for several years. In her statement to the county sheriff's office, Cole claims West abused her verbally and physically.

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. [4]

Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." [5]

Photos taken after the alleged beating were submitted to the sheriff's office.

When the Pilot asked about Cole's claims, West said her attorney advised her not to comment on the misdemeanor charge. A hearing for a jury trial is scheduled for later this month. [6]

An author and speaker, West claims she recognized her clairvoyant and healing gifts at age six when she began "interacting and communicating with archangel Michael," according to her book "The Christ Heart." [7]

West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. [8]

She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said. [9]

According to her biography, West went back to school at age 38 after raising her children. She graduated from the College of the Redwoods in 1994 with degrees in social science and humanities. [10]

After graduating, she founded the Divine Unity Foundation and the Sacred Archives Institute in Victor, Montana. [11] The institute was charged with organizing and recording her ongoing monthly "transmissions" -- channeled telepathic messages that come at 3 a.m. from a group she calls the Ascended Masters, some living, some not. They include Master Jesus, Buddha, St. Francis of Assisi, Confucius, Zoroaster, Mohammed and Babaji. [12]

Michael and Lori Hendrickson, of Colorado, worked with West in Victor and paid off a promissory note for West's foundation in 2005 to prevent foreclosure. They are now suing West, the Sacred Archives Institute, West's husband and Dr. Cole for breach of contract, claiming West moved the money out of the foundation to a personal trust. [13]

Here in the Flathead, West ran into problems over several properties where she lived. On June 1, she was evicted from a \$2 million Lakeside waterfront home when she failed to pay a second \$50,000 down payment. She then moved into another Lakeside with her son and daughter-in-law. "All she got out of the house was her cat," said Larry Phillips, a Realtor with Land Rush Realty. [14] When asked about the eviction, West said a few weeks away from home were worth the trouble. She claims to be negotiating a better deal on the property due to a water rights dispute. [15] According to court documents, West is behind in payments on the second home. The issue has not yet been resolved, according to one of the homeowners, Larry Brazda. [16]

A third Lakeside property -- the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her." [17]

One more lawsuit dogs West's plans to move forward with healing retreats in Lakeside and in Whitefish at the former North Valley Hospital site. Her former business consultant and stockholder in Millennia Mind, John Watson, is suing her for fraud, constructive termination and breach of contract. Watson claims he was not paid for the services he provided, including setting up stock in Millennia Mind. [18]

"She told me the Masters decided they didn't want stock, out of the blue, no discussion, and that was that," Watson said. "She is an evil and dangerous woman." According to Watson, when he demanded payment and threatened to sue, West psychically attacked him and his family by sending migraine headaches from Lakeside to their home in Nova Scotia. [19]

Watson created the Web site www.universalteachings.com, where he accuses West of a host of offenses ranging from extortion to black magic. "Our attorney told us to just let him hang himself with the Web site," West said when asked why she allows the Web site to continue. West has filed a libel suit against Watson, but he said he has not yet been served. [20]

LET US ANALYZE EACH NUMBERED POINT.

[1.] Devra West was charged with assault in April 2007; on April 17 2007 she wrote a long missive entitled '[The Law of Severity on the Path to Purification](#)' to her cult mailing list within which she admitted to assaulting Dr. Cole MD, admitted that the assault was severe but stated that the assault was administered with grace. She went on to say that the beating was long overdue as the victim was a Nazi in the WWII death camps in another lifetime! No mention of the \$1.3 million she extorted from the victim.

[2.] The allegations that West uses black magic / occult knowledge, more specifically West's use of Shamanism which she admits to being a practitioner of in this news article, to intimidate her victims comes from multiple sources. West's office manager [Rebecca West](#) (no relation to Devra West) wrote a harrowing email to the whistleblower in March 2007 wherein she states, and I quote:-

*"I need support in how to deal with her **shamanic witchcraft**. Can you tell me more?"*

Then there is West's then daughter-in-law [Jamie Haywood](#) who became a target of occult attacks after she decided to divorce Devra West's porn loving wife beating son and seek custody of their infant daughter. Then West's neighbor [Michelle Fetveit](#) became the target of occult attacks after getting into a water dispute with Devra West. The whistleblower has, at the time of writing, been the subject of these attacks for 11 years. All these victims had one thing in common, they were all at one time in dispute with Devra West. Devra West, a pathological liar, ridicules the victims claims relies on the fact that the even if the authorities believed the victims, there is nothing they could do as the weapon is not recognized as a weapon by legal statute.

This was made clear when in July 2007, as after the above news article was printed, both Dr. Cole MD, and several favorable witnesses to her assault by Devra West, came under a campaign of constant 'under the radar' occult attacks from Devra West whose aim was to intimidate the victim and friendly witnesses into withdrawing their statements to the police. Several victims phoned the Flathead police who took their claims seriously enough but stated that as the 'weapon' being used to commit the violent assaults was not regarded as a weapon by legal statute there was nothing the police could do. They did suggest that the victims launch a lawsuit against Devra West based on 'intent to cause harm.' There are now so many victims that a criminal investigation would unravel countless examples of 'intent to cause harm' against scores of victims.

[3.] After Devra West's charity 'The Circle of Divine Unity' was [struck off for fraud](#) in November 2003, Devra West changed the name of the operating company / business container for her racketeering scam from the 'Sacred Arts Institute' to the 'Sacred Archives Institute' this allowed her and her students (cult members) to continue to refer to the organization as S.A.I.

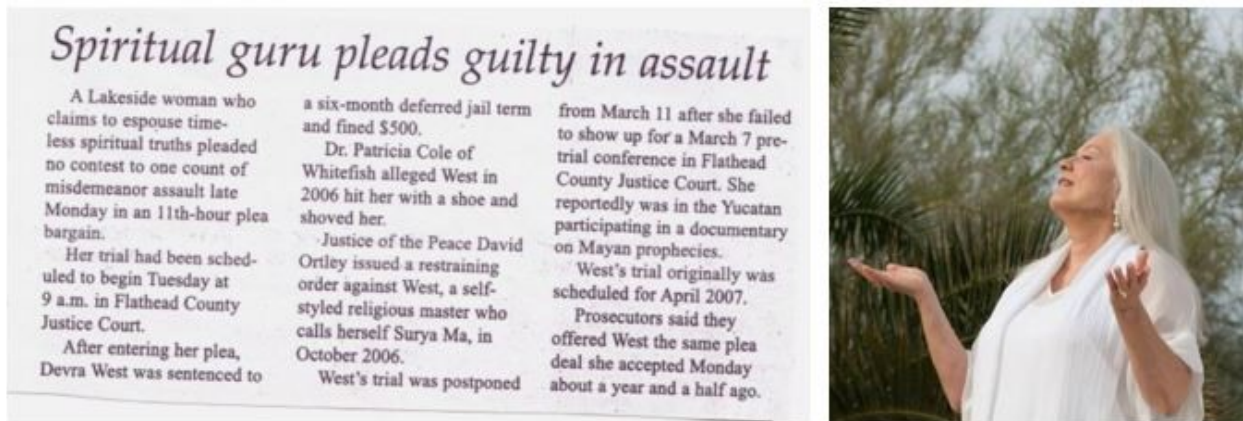

[4.] Yes, because West's knowledge of the occult acquired between 1990 & 1991 (see what fellow classmate [Satya](#) had to day about her including the fact she was defrauded out of \$6,000) allows her to commit murder and have those murders appear as though the victim died of natural causes.

In the mind of a deeply disturbed psychopathic person / personality being able to commit murder with zero consequences for the murderer equates to 'spiritual authority.' Here is clarification by WFP from Richard Hanners, the editor of the Whitefish Pilot newspaper, in response to a letter from the cult claiming that Devra West had not ever admitted her guilt therefore she not be described as being 'found guilty' as described in the news article!

The April 24, 2008, Whitefish Pilot contained the following article.

Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain. Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court. After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500. Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006. West's trial was postponed from March 11 after she failed to show up for a March 7 pretrial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies. West's trial originally was scheduled for April 2007. Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago. I was not working at the Pilot that week. I went to see my father in Washington. After I returned, the publisher, Tom Kurdy, asked me to run a clarification. He wrote the clarification and e-mailed it to me. This is what ran on May 1, 2008:

A headline in the April 24 issue of the Pilot said that Devra West had pleaded guilty in an assault case in Flathead County Justice Court. West actually entered a no-contest plea, as noted in the story. The Associated Press Stylebook says that when a defendant enters a no-contest plea, "it means that he is not admitting guilt but is stating that he will offer no defense. The person is then subject to being judged guilty and punished as if he had pleaded guilty or had been convicted." Because imposition of the sentence was deferred, the charges will be dropped in six months and expunged from West's record.

Devra West posted a statement on her website within days of the above appearing in the press denying that she had been found guilty of assault, stating that the authorities had dismissed the charges and expunged the details from the records and then proceeds to accuse the victim of the very crimes she committed against Dr. Cole MD! Another example of Devra West and her cult trying to convince the public that their lies and propaganda are their truth!

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

[7.] Devra West asserts that she communicates with the 'Ascended Masters' but in reality, these 'transmissions' are just more lies and deceit created out of the mind of a dangerous psychopath for one purpose only - to forward her own self-aggrandizing agenda. In this way, the ['The Law of Severity on the Path to Purification'](#) was penned to justify the vicious attack on Dr. Cole while extorting her entire net worth and ['Financial Form Building'](#) was another deceit designed to whip the members of her cult into increasing their fund raising efforts on her behalf. Here is a short excerpt from one of those missives.

For now, I will only say that there are none of you who are as yet fulfilling the standards of criteria for passage into the domain that the Masters will be anchoring at the Shamballa Sanctuary. As yet most of you are in the 30% to 40% range of balance of truth with me. You must fulfill balance of truth with me as well as with the ashram. Shirley and Lisa are approaching the 60% 'wonder mark' and I hope will soon anchor a solid 66% exponential factor for both requirements. I remind you that at 66% the wheel turns, and the manner and timing of manifestation 'time jumps' and this includes the truth of abundance. It is for this reason that I have been required to step out of the group energetic. I am in a time jump that is the reflection of my light and this is not to be disturbed by negative thought form. There can be no sacred manifestation in lower time. I cannot succeed through co-creation with misaim. I can co-create with the to varying degrees with the Trusted Disciple. This increases as you increase you light.

The above sits alongside her assertion that the [Christ gave her two doctorates in person](#). And that she [is single handedly holding open the gates of time](#). And that the more money her 'students' (cult members) gave to her [the closer to God they would be](#).

[8.] There is little doubt that Devra West has been trained in Shamanism at the 'Robert Jaffe School for Energy Mastery' for instance and perhaps elsewhere.

[9.] "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," This is not the kind of statement that a 'world server' or service to self-entity would make but is the kind of statement that a deeply disturbed psychopathic egomaniac would make. The only heart surgeon likely to go anywhere near Devra West, is senior cult member and disgraced heart surgeon Dr. Julio Williams MD, who in addition to funding her criminal racketeering criminal operation continues to deceitful and dishonest testimonials on her website, in the hope of attracting new blood / victims to the cult.

[10.] While being deposed by the whistleblower's lawyer in 2003, Devra West was asked to provide copies of her degrees from College of the Redwoods but failed to do so saying they were destroyed in a flood in New Mexico. Devra West's ex-husband Jack West confided in the whistleblower in 2002 that Devra West's education ended with her high school diploma.

[11.] Devra West forgot to mention her stint as a pot grower, a small time con-artist and the fact that her jewelry business went bankrupt or the fact that one of her victims chased her Jack West and their young daughter out of New Mexico in the middle of the night with a large loaded gun! Follow this link to read what [Jeremy Samuelson](#) had to say about Devra West in the 1970's and 1980's, including the fact that he was defrauded out of \$10,000.

As the news article makes clear, Devra West was being evicted from two rental properties in quick succession and as the [Bigfork Eagle](#) newspaper article (to be dissected below) makes clear, she also had a lien against her for unpaid employment insurance! I think it is safe to say that Devra West was not a billionaire at the time of the above news article or her appearance in court on 12 July 2007.

[17.] A central part of the giant fraud / racketeering scam was that Devra West and her cult presented her to the public as a 'divine being,' a spiritual teacher and successful businesswoman. At the time the news article was published in July of 2007, Devra West was heading for bankruptcy for the second time. However, one of the ways she and the cult created the illusion that she was successful, was to fraudulently misrepresent other people's property as belonging to her. As the news article above states, for two years Devra West used images of Robert & Tabby Ivy's multi-million dollar home in her brochures and on-line describing it as her own variously referring it to her 'Montana Abode' or the 'Abode of the Master's.'



Next door to this image would be a gushing testimonial from senior cult member Julio Williams MD who, knowing full well that the leader of his Satanic Coven was penniless and in debt, still played his part in the criminal / racketeering business by 'marketing' her to the public as the god's gift to the planet! Here is a link to Dr. Julio Williams' [statement](#) as posted next door to the image above. Here is a link to another [statement](#) posted on Devra West's latest website by this 'liar for hire' - this made in 2014 promoting 'Rishi Devra' and asking for funds for the 'Divine Feminine.' Here is a link to [another posting](#) on her website wherein Williams has rented a property next to his cult master's and is inviting victims to attend a 'Sacred Sunday with Rishi.'

[18.] The whistleblower successfully sued Devra West for fraud and got [judgment](#) against her in 2008. Here is a link to the [Ravalli Republic](#) news article. Along the way, he was defamed repeatedly by Devra West from her website, either directly or by forcing cult members to publish defamatory statements on her website like [this one](#) by cult members Williams, Cole and Cornell in 2005. She also forced some of her employees on pain of being fired, to write totally false statements against the whistleblower that she intended to use in court against him. One of those employees was Anandra George, who later [wrote to the whistleblower's lawyer](#) retracting her false statement. He was threatened by Julio Williams MD who apart from using an expletive in [his email](#) stated that he was making \$2,000,000 available for Devra West's legal fees.

In July 2007, and after causing the two news articles to be published about Devra West's criminal activities, the whistleblower became the subject of a campaign of occult attacks that continues to this day and was the subject of a murder attempt by Devra West who intended the same outcome for him as she achieved with Lisa Swidler just two years earlier in 2005. [20.] When the whistleblower turned up for court in 2010 to see how much he was going to be awarded for winning his lawsuit against Devra West for fraud, he was served for defamation by both Devra West and her stooge / accomplice / liar for hire Geoffrey Reynolds CPA. Gambling correctly that, because he had emigrated to Nova Scotia Canada in 2005 that he would not be able to defend the case, both West and Reynolds told a pack of lies to the court. Trial scheduled in Lakeside assault case

A Lakeside woman who claims to communicate with long-dead religious masters will face a jury trial Sept. 18 in Flathead County Justice Court on misdemeanor charges she assaulted a Whitefish doctor. A temporary restraining order against Devra Patton West, a self-styled guru who calls herself Surya Ma, was issued by Judge David Ortleby last October after Dr. Patricia Cole, of Whitefish, requested protection. Cole claims West assaulted her in April 2006 and again in October 2006. [1.]

Speaking for West, Geoff Reynolds claims the charges are untrue. He said photos of the first alleged assault were taken on a different date, and the bloody clothing in the photos resulted from Cole falling down a stairs at her Cherry Creek condo in Lakeside, not from an assault. [2.] Reynolds, who is a financial adviser for West, said he has worked as an accountant in Los Angeles, where he dealt with well-known personalities. He is helping West raise several hundred million dollars to purchase and develop three properties around Flathead Lake for VIP spiritual-healing spas. [3.]

The man who took the photos, however, tells a different story about the alleged assault. He came from out-of-state and was sharing the condo with Cole while he attended sessions with West. He said he was meditating when Cole appeared wearing a bloody sweatshirt. [4.] The man said they cleaned some of the blood off Cole's scalp and then took photos so Cole, as a doctor, could see her injuries and decide how to treat the wound. Cole said West hit her on the head with a shoe, the roommate said. [5.]

Cole said she first came to Montana from Minnesota to attend spiritual sessions at Naka Shela, West's facility in Victor, from 2002 through 2004. She moved to Montana to live in 2005 with the idea of combining West's spiritual teachings with medical knowledge. Cole eventually assumed management positions with several of West's for-profit and not-for-profit operations. [6.] As business fell in Victor and the Naka Shela property was foreclosed, West moved her business north to Lakeside. [7.]

Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843. [8.]

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute. Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees. [9.]

Reynolds claims that several people have been stirring up trouble by publishing untrue allegations against West. He points out that former office manager Rebecca West, who is no relation to Devra West, was denied benefits by the Montana Department of Labor and Industry because she was unable to prove a hostile environment existed at Surya Enterprises Unlimited.

Rebecca West claimed she left her job because she was afraid for her safety and did not want to become a victim of physical abuse by Devra West. But hearing Officer Peggy Harper found "the evidence does not establish verbal, emotional or spiritual abuse." [10.] Rebecca West won two earlier hearings and has appealed Harper's decision.

Reynolds also claims John Watson, a former business consultant for Devra West who now in lives in Nova Scotia, has been spreading false allegations about Devra West by e-mail, phone calls and his Web site, www.universalteachings.com. [11.]

Devra West has filed a libel suit against Watson, but Watson said he has not yet been served. Reynolds said West is also trying to get Watson's Internet-service provider to take down Watson's Web site, noting that its URL is very similar to West's, www.universalteachings.org. [12.]

Both Cole and Rebecca West say they have been interviewed several times by agents from the Internal Revenue Service, which they say is investigating West's businesses.

LET US ANALYZE EACH NUMBERED POINT.

[1.] Devra West admitted the assault in her missive to the cult entitled '[The Law of Severity on the Path to Purification](#)' posted on April 17 2006. Devra West in spite of the subsequent denials and attempts to derail the investigation was eventually convicted of misdemeanor assault, fined \$500 and given a six month suspended jail sentence.

[2.] Reynolds, like West, is a pathological liar. [10] It is hard for anyone to get justice against Devra West because not only does she have her secret occult weapon to use against those who oppose her, she also has a ready supply of 'liars for hire' who are prepared to make false statements against victims in court, at employment tribunals, and from her websites. As to whether working for employment with Devra West was a hostile and dangerous environment, the assault on the three women listed above, including Dr. Cole MD, speaks volumes. The testimony of employee [Carlida Finch](#) to the labor board speaks volumes, as do [Rebecca Wests emails](#) to the whistleblower. Below is an excerpt from Carlida's 'Statement of Fact' to the labor board in 2007.

Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. [11.] While being interviewed by the [Bigfork Eagle](#) news reporter Geoffrey Reynolds, in what he thought was an off the record conversation, let it be known that Devra West planned to murder the whistleblower. Reynolds said that he expected the whistleblower would be dead within 12 months or in jail for retaliating to what Devra West intended to do to him. The reporter, Constance See, took the threat seriously enough to report it to [John Nielson](#), an IRS criminal investigator looking into Patton West's finances at the time.

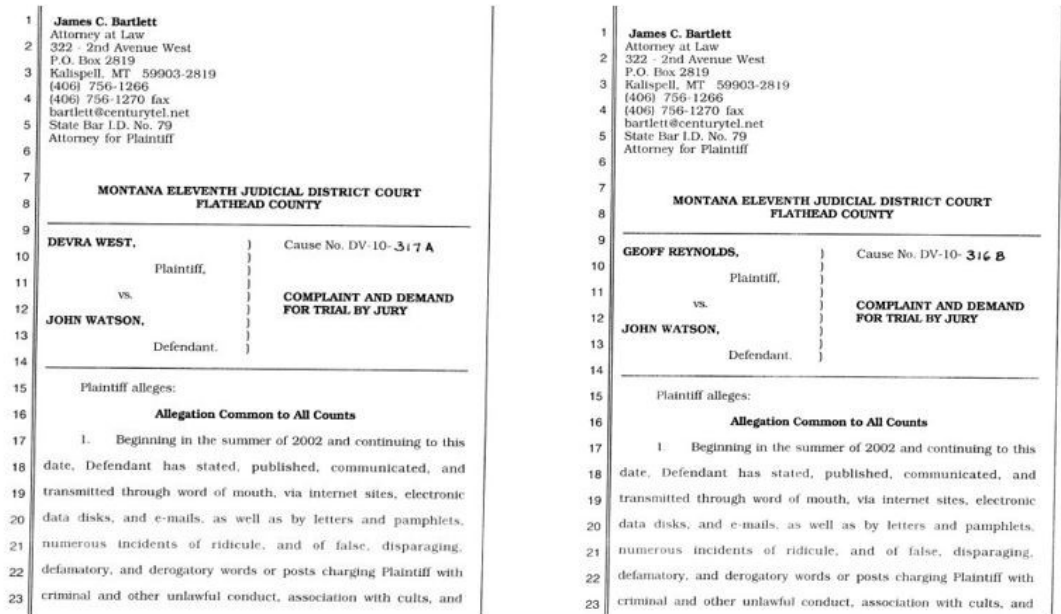
Both Constance See & John Nielson are real people and both will repeat what they heard when this matter goes to trial.
