

RISHI DEVRA – 31 YEARS OF **DOMESTIC TERRORISM** IN THREE WESTERN STATES. SEVERAL SUSPECTED MURDERS, ONE WELL DOCUMENTED ATTEMPTED MURDER.

At the time she was calling herself the Ascended Master 'Devra Ji.' Since then she has changed her name twice to 'Surya Ma' and, after being forced to leave Montana, to 'Rishi Devra.'



CULT / GANG MEMBER DR. JULIO E WILLIAMS MD – As a willing accomplice in racketeering and domestic terrorism, I, Julio Williams, have faithfully supported my cult / gang leader by supplying her with a series of [fake and dishonest testimonials](#) including one where I describe my cult / gang leader as a, “Virtual wellspring of living divinity.” When fraud victim turned whistleblower, John Watson, went public about the cult / gangs criminal activities in Montana, I wrote a [threatening email](#) to Watson in an attempt to derail his lawsuit against my cult leader. A lawsuit [he won](#) in 2008. I also pledged \$2M of my personal fortune to bury my cult / gang leaders criminal past in Montana and New Mexico. My funding of organized crime / domestic terrorism resulted in the internet being swept clear of all information about my cult / gang leader’s criminal past. As a result, she was able to reincarnate herself in Arizona with a new name, new fake bio and offer miracle cures for cancer which I, Julio E Williams MD, a physician and cardiac surgeon, was happy to endorse. Not only did I endorse these acts of fraud / extortion, I actually provided [my own home as a venue](#) for these crimes to take place. I am aware of my cult gang leader’s ongoing attempts to murder / intimidate Watson, his wife and children (see below Reynolds’ announcement about this). I have received over 500 emails from the victim about the ongoing campaign by my cult / gang leader to silence Watson. However, it is my hope that his murder occurs before the FBI etc. get involved.



CULT / GANG MEMBER GEOFFREY REYNOLDS CPA – After joining Patton West’s cult / criminal racketeering gang in Sept 2006, I, Geoffrey Reynolds, took to crime like a duck to water. After fraud victim turned whistleblower, John Watson, went public in 2006 by putting up a [website](#) and causing three newspaper articles [\(1\)](#), [\(2\)](#) & [\(3\)](#) to be created about the cult / criminal gang’s activities, I knew my finest hour had arrived. In support of Patton West, I announced Watson’s [impending murder](#) to a local newspaper reporter a week before Patton West made a failed attempt on Watson’s life. In the same conversation with the reporter, I also announced a campaign of violent intimidation against Watson, his wife and children. Though this was some of my [finest work](#), other contributions to the cult / gang’s activities include the fraudulent application of \$30M in government grants, making [false statements](#) to court as part of a \$10M extortion scam, telling lies about Patton West’s assault on Dr. Pat Cole MD and publishing four false statements [\(1, 2, 3 & 4\)](#) that sought to vilify a local newspaper for telling the truth about the cult / gang’s activities.

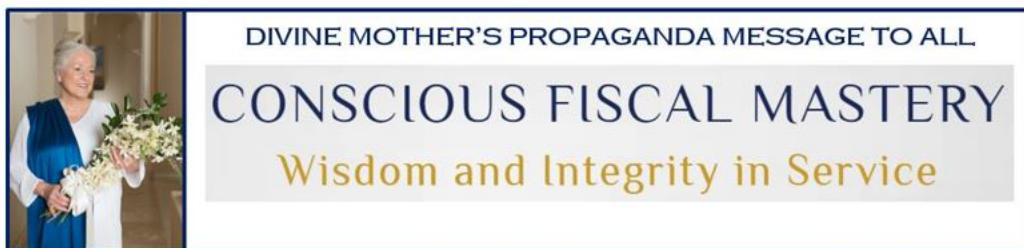

Clearly, Jack West and Corrine Coffin must know that Patton West is not a guru and not a 'world server.' Both of them know that her numerous 'save the planet' schemes are just schemes that the public and the sheeple in her cult focus on while raining millions of dollars that are never applied to the causes espoused by Patton West. After 31 years of fundraising millions of dollars, Patton West has NOTHING to show her thousands of donors.

Clearly, both Jack West and Corinne Coffin are aware of the multiple arrest warrants, the conviction for assault and Patton West's many visits to court as the defendant in fraud related lawsuits? 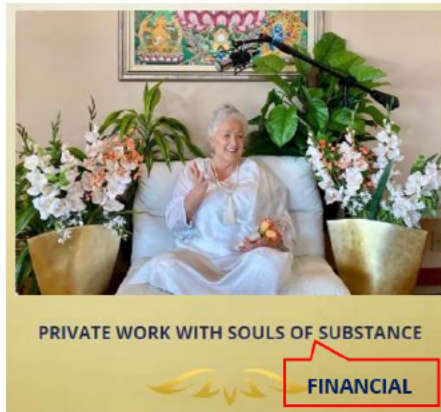

Convening the supra genius of the enlightened state of embodied mastery, she leads a new era for world service, that sets a new standard for prospering all spectrums of world betterment.

2. What was once, but a shimmer of hope and aspiration, is now divine destiny becoming manifest.

1. As a “regent of the spiritual hierarchy” etc. This is just bullshit like her assertion that she is [The Regent of the Masters](#) (i.e. above Jesus Christ), [The Western Regent](#) (spiritual overlord to the western hemisphere), [The Mother of Ten Thousand Suns](#), [The Mataji](#), [Divine Mother](#), she has been preparing [to lead humanity for thousands of years](#), is [holding open the gates of time](#) and who received her two doctorates [from the Christ in person](#) etc.

2. Five years from now, Patton West will be recognized as one of America’s most vile and despicable villains. A ruthless and cold blooded criminal who, using her occult hidden knowledge has robbed, defrauded extorted money from, and mentally and physically abused countless victims. Then, there are the several suspected murders her ex-husband, Jack West, maintains she is guilty of. This, confirmed by the whistleblower John Watson who Patton West tried to murder in 2007.

We suggest you also review several statements (1), (2) & (3) provided by Rebecca West. (no relation to Devra West) and [Carlida Finch's](#) testimony. There is a clear record of mental and physical abuse being meted out to employees and students alike as Patton West uses CIA mind control tactics to break the targets will as a prelude to brainwashing and controlling them to become low paid or no paid slaves. This is part of Patton West's true legacy.

Anyone going public about her crimes immediately becomes a target of defamation, dirty tricks, occult hidden violence and if they persist murder. In May 2002 Jack West, Patton West's then husband and a senior member of her cult, told Watson that those who opposed his wife had a habit of dying suddenly. In 2005 a young mother of two children under the age of ten died suddenly after trying to leave the cult. We believe she was murdered to keep her quiet. Similarly after John Watson was defrauded and chose not to go 'silently into the night with his tail between his legs like most victims, he too was ear marked for murder. Murder so common place that Reynolds actually felt comfortable announcing the murder a week in advance of Patton West's attempt on Watson's life!

PART OF HER LEGACY OF MURDER FROM MONTANA...

In a March 2003 meeting to discuss their difficulties Patton West told the whistleblower John Watson, and I quote, [“It does not matter what is actually true.”](#) If she can persuade her cult and the public that her lies are their truth. She also told Watson that she felt [“f*cked up the arse”](#) because he had decided to sue her for defrauding him. A lawsuit [he won in 2008](#).

She made these comments after [agreeing with Watson that she had defrauded him](#) but did not see herself writing out a check for what she owed him! You can hear Patton West say this in her own voice because Watson recorded the conversation. After John Watson put up a website in 2006 to counter Patton West lies and propaganda and caused three newspaper articles (1), (2) & (3) to be published in 2007 & 2008 Patton West's criminal racketeering business model was dead in the water in Montana because no one believed the 'divine being' bullshit anymore.

In response to Watson going to law and going public Patton West decided to murder Watson. She even had cult member Geoffrey Reynolds announce Watson's murder to the local press on August 9 2007. When the murder plot failed Patton West tried to bankrupt Watson into silence in 2010 by launching multiple frivolous lawsuits against him whose objective was to outspend him in civil court. Joining Patton West in her conspiracy against Watson were two senior members of her cult Dr. Julio E Williams MD & Geoffrey Reynolds CPA. Both were total strangers to Watson but both were totally under Patton West's control. Both Williams & Reynolds willingly agreed to risk all by being complicit in Patton West's attempts to murder Watson. Suffice to say that both were very aware of Patton West's ability to murder with impunity (so far) and both assumed there would be no consequences for their actions. Clearly publishing all this information was motive enough for Patton West to want to murder Watson. Williams & Reynolds had no 'dog in the fight' and yet both decided to risk everything to do Patton West's bidding.

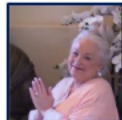

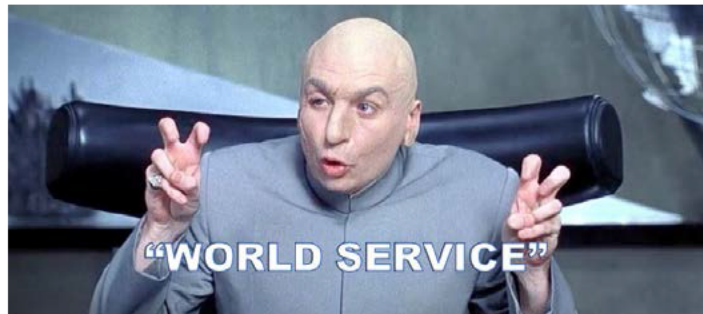

One of scores of victims of organized crime that passed through the meat grinder (see below) that Patton West calls 'World Service' was a business consultant John Watson. After being defrauded in 2002 Watson launched a lawsuit against Patton West in 2003 which he won in 2008. Along the way, and to counter the lies and propaganda being posted online by Patton West, Watson put up a website of his own. Above: Attract the sheeple with promises of enlightenment. Brainwash and condition them into submitting to the will of the ~~Master-Abuser~~ sorry 'Divine Mother' and then harvest them like a farmer harvests his livestock. Victims are forced to empty their bank accounts into Patton West's bank account to fund her 'good causes' which for the past 30 years has been herself!

In 2002 Patton West's then husband Jack West told the whistleblower that, and I quote, "Those who opposed my wife had a habit of dying suddenly." End quote. The use of the word 'those' implies more than one and these comments were made in 2002 – twenty years ago! Watson thought nothing of it at the time but in 2005 Patton West murdered one of her students Lisa Swidler a young mother of two children under the age of ten. Lisa was murdered to stop her going to the police after she witnessed two serious crimes being committed against two other students by Patton West. Since these extra judicial killings appear to be deaths resulting from 'natural causes' there is no way of knowing how many victims have been 'silenced.' For the same reason it is impossible to link the extra judicial killings to Patton West because legal statute does not recognize the occult (Shamanism) as a weapon. So Patton West murders with impunity (so far) and demands that those trapped in her cult use their wealth to fund her luxurious lifestyle.



Above: Patton West masquerades as a guru believing her lies are protected by 'religious freedom' laws. Behind the façade is a cold blooded killer who, for 31 years, has robbed, defrauded and extorted millions from scores of victims in three western states.

Above: Lisa Swidler was murdered in 2005 to stop her going to the police. In 2005 Marion Cantwell was kidnapped, falsely imprisoned, beaten and only released after Marion agreed to 'donate' tens of thousands of dollars to Patton West from the recent sale of her home. Upon release Marion was told if she went to the police she would be murdered. In 2006 Dr. Pat Cole MD was slated for murder according to fellow employee Carlida Finch who overheard Patton West planning Cole's murder. Cole was allowed to live after several severe beatings and after agreeing to donate every cent she had, estimated at \$1.3 million, to Patton West. After being defrauded and being subject to a campaign of lies and defamations by Patton West Watson went public via a website in 2006 and caused a series of newspaper articles to be published in 2007 & 2008 about Patton West's criminal activities in Montana.

ONE 'SUCCESSFUL' MURDER OF LISA SWIDLER. TWO THREATENED MURDERS OF CANTWELL & COLE. ONE ATTEMPTED MURDER OF WATSON. ALL IN A THREE YEAR PERIOD BETWEEN 2005 & 2007!

Given that murder was used regularly by Patton West to 'silence' dissent it came as no surprise that Patton West would decide to murder John Watson. After all his website and the three newspaper articles he caused to be published had rendered her criminal racketeering business model dead in the water in Montana. Before Patton West and the cult could relocate to Arizona they had to force down Watson's website and 'cleanse' the internet of Patton West's criminal activities in Montana & New Mexico.

As demonstrated above murder was used regularly by Patton West to silence her critics. However never in the past had she publicly announced, in advance, her intention to murder someone. In doing so, she and her accomplice Geoffrey Reynolds left behind a 'paper trail' of their intentions.



On August 9 2007, while being interviewed by the Bigfork Eagle newspaper reporter Constance See, senior cult member and accomplice in racketeering and murder, announced Watson's impending murder. In what he thought was an 'off the record' conversation Reynolds stated that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him, his wife and children. Constance See took the threat seriously enough to share it with an IRS criminal investigator who at the time was investigating Patton West's activities. Two credible witnesses to add to the testimony of countless other victims of financial and violent crimes.



When the 2007 murder plot failed Patton West had to wait three years before implementing Plan 'B' which was to launch multiple frivolous (without merit) civil lawsuits against Watson in the hope that he could not afford to defend them. Enter senior cult member Dr. Julio E Williams MD who in addition to writing expletive laden threatening emails to Watson in January 2007 pledged \$2,000,000 of his own money to outspend Watson in court. Quite a commitment from someone who was a total stranger to Watson but like Reynolds totally under Patton West's control.

THIS IS WHAT CRIMINALS DO IF THEY CANNOT INTIMIDATE OR MURDER YOU THEY 'BUY' THE RESULT THEY WANT BY OUTSPENDING THEIR VICTIMS IN COURT!

Having forced down the whistleblower's website in 2010 Patton West, Geoffrey Reynolds and Dr. Julio E Williams were free to relocate their criminal racketeering business model to Arizona. Upon arrival, Patton West changed her name to Rishi Devra, adopted several fake titles and accolades.

Above: The images above are evidence that Patton West is mentally ill and or criminally insane. Patton West's behavior clearly indicates a narcissistic personality disorder and gives us all an insight into the delusional fantasy world she exists within.

Her [website](#) is full of this bullshit but no mention of her 'criminal' past. Because the TRUTH is bad for business. For 31 years Patton West has masqueraded as a guru while using occult knowledge to leverage her criminal racketeering business model. Countless acts of theft, fraud, extortion occasioned with violence and, according to her ex-husband, several murders.



THE ABODE OF THE MASTERS.

A big part of the fraud is portraying herself as a wealthy business woman. On our webpage entitled '[Abode of the Disasters](#)' we explain how, using other people's money, Patton West sets herself up in a mansion and surrounds herself with artwork and statuary most of which is the ill gotten gains of three decades of theft, fraud and extortion. However, on three occasions over the past 20 years, Patton West has been evicted from expensive rental properties for non payment of rent.

Last December, Patton West was evicted from a rental property in Arizona after running up \$80,000 in rent arrears. Her current whereabouts are unknown but we hope it is something like this....



NEWS FLASH!

- In another repeat of history witnesses allege that Patton West is in the process of being charged with stealing **artwork and valuables** from a victim in Sedona AZ. Patton West likes artwork and collectables because along with [jewelry](#) and precious metals they are easy to hide from the authority. Much of her ill-gotten gains never goes near a bank.
- Witnesses allege Patton West is being investigated for **fraudulently applying** for and receiving Covid Emergency Relief Funds and using those funds to pay off her rent arrears of \$80,000. This was achieved by persuading a brainwashed 'follower' to empty her disabled mother's bank trust fund into Patton West's account. **This called embezzlement.** The follower is now destitute and her mother is in a home.

Now that the truth about Patton West's criminal past has started to flood the internet again Patton West has increased the size and frequency of the lies she posts on-line in an effort to drown out the truth. Let me give you two examples of how Patton West attempted to drown out the truth in Montana.

In April 2008 Patton West was found guilty of assaulting her business partner Dr. Pat Cole MD. The following newspaper article announces her conviction for assault.



Within days of the above announcement, Patton West issues the following statement from her website...

Court Rules to Dismiss Bogus Assault Case:

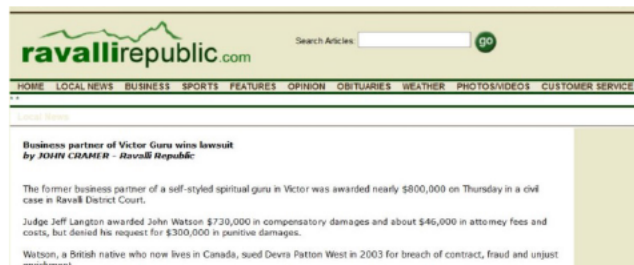
All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

The above statement is a total pack of lies but like all the other lies before and since they go unchallenged by the authorities. The case was never dismissed. Patton West goes on to accuse Cole of trying to entrap her when in reality Patton West successfully extorted \$1.3 million from Cole after a series of vicious assaults designed to 'soften' her up.

Within days of the above announcement Patton West issues the following statement from her website...

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. TWO REAL ARREST WARRANTS.

In Montana Patton West was the subject of at least two arrest warrants one for [criminal check fraud](#) and one for [felony theft](#).

And yet recently, after details of her criminal past in Montana started showing up, Patton West began to assert in online postings that she had obtained an 'International Arrest Warrant' against John Watson. Let's just pause a minute. There were two real arrest warrants issued against Patton west in Montana now Patton West says she has obtained an arrest warrant against John Watson. This would be the same John Watson she has defrauded, tried to murder and tried to bankrupt so he could not share details of her criminal past with the public in Arizona. Below are some excerpts from [her webpages](#) announcing Watson's international arrest warrant.

Lies are not Patton West's main weapon. Violence and the threat of violence and murder are her main weapon. Patton West's use of occult knowledge allows her to deliver pain, suffering and murder across distances with total plausible deniability. But for the fact that stooge / accomplice Geoffrey Reynolds announced Watson's murder in advance nobody would be any the wiser. As it is both Reynolds and Williams (both total strangers to Watson) have left a 'paper trail' linking them with Patton West's conspiracy to murder Watson.
