If one visits Real Raw News website, one can see that military tribunals are being held at GITMO for those accused of treason, crimes against humanity and child trafficking. Former CNN host and convicted pedophile, Brian Stelter was, according to the Real Raw News website, hanged to death at Guantanamo Bay on Friday 23 September, just hours before the facility locked down in preparation for Hurricane Ian. Stelter was not the first to be executed at Gitmo and will not be the last. While we do not wish to minimize Stelter’s crimes, we have to ask why Patton West has not been hauled off to Gitmo? According to her ex-husband, Patton West was guilty of multiple murders prior to 2002. How many murders has she committed over the last two decades? We know about the murder of one of her students, Lisa Swidler in 2005, and let us not forget the one well documented attempted murder by Patton West of a fraud victim who went public about Patton West’s crimes. For decades, Patton West has run rings around the court with her lies, the intimidation of victims and witnesses and her ability to mobilize false witnesses from her cult to testify on her behalf. This has made it impossible for victims to get justice through the civil courts. In reality, Patton West's crimes are so serious she (and her accomplices) should join those in GITMO and be tried by a military tribunal.

We are going to send copies of this bulletin to the Navy JAG lawyers at Gitmo in the hope that they will send a team to pick this psychopath up. The past three decades have shown that the civil courts are impotent against this career criminal.

Below are some examples 'World Service' from Patton West's time in Montana.

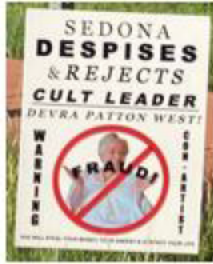


Above from left to right: A 2007 arrest warrant for [Felony Theft](#). God knows who she is praying for but it is certainly not her business partner Dr. Pat Cole MD who Patton West [viciously assaulted](#) while successfully extorting \$1.3 million from the victim. Patton West got away with a [\\$500 fine and a 6 month suspended prison sentence](#). A 2008 arrest warrant for [criminal check fraud](#). Far right the 2008 notice of a [Sheriff's Sale](#) at which all of Patton West's known assets were sold to pay past victims of crime \$2,000,000 in court fines and interest. Most of Patton West's assets were hidden in a lock up and not declared to the court or her creditors. Patton West was chased out of New Mexico in the middle of the night in 1995 by one victim wielding a loaded gun. In 2010 Patton West was forced to leave Montana after fraud victim and whistleblower John Watson (whom Patton West tried to murder) successfully sued her for fraud, put up a website and caused three newspaper articles to be published. Every time she moves she changes her identity and her fake bio / life story.

Recently Cult Watch USA met with two IRS agents to deliver a package about Patton West's criminal activities since arriving in Arizona. I am told this package majored on Patton West's most recent crimes chiefly her defrauding the government out of Covid Relief Disaster Funds and her embezzlement of the trust fund belonging to the mother of one of her followers. We are also informed that a new police report is being filed against Patton West (and her only remaining slave Lalita) for elder abuse.

Cult Watch USA know exactly where Devil West is living. Apparently Patton West is living in a 2,000' apartment which we are told is being paid for by the remainder of the 'Covid Loan.' One of CW USA's operatives placed several banners in the front yard of the apartment building where Patton West resides. The whole neighborhood has been plastered with these banners I suspect everyone in the neighborhood knows who she is and where she is living. Copies of the banners have been placed at the stores she visits, the restaurants she visits and where she gets her nails done. Additionally posters have been sent out to realtors and landlords locally giving them details of recent eviction, rent arrears and criminal activity. I am surprised that she found someone willing to rent an apartment to her. I wonder how long it will be before this pariah / parasite chooses to move on to fresh hunting grounds. Assuming she is not arrested before she has the chance to flee the country to avoid prosecution?

WHY DID PATTON WEST MURDER ONE OF HER STUDENTS IN 2005?



Question: In 2005 Patton West, then masquerading as the Ascended Master 'Devra Ji,' murdered one of her long term students, disciples, cult members Lisa Swidler. Why was it necessary to 'silence' Lisa Swidler a young mother of two small children under the age of ten?

Answer: Lisa was murdered to stop her going public or going to the police. Lisa witnessed Patton West defrauding student Dave Kushner out of \$30,000. Lisa was also aware that Patton West had kidnapped, held captive, beaten long term student Marion Cantwell until Marion gave up part of the sale proceeds of her home to Patton West. Upon release Marion was told that if she went to the police she would be murdered!



Victim [Dave Kushner](#) gave an audio statement to the whistleblower in which he describes how he was defrauded by Patton West. Dave Kushner also gave a lengthy statement about [Marion Cantwell's](#) ordeal. Marion's ordeal was further corroborated by another witness. Murder is common place in the cult as was made clear by Patton West's ex-husband Jack West who in 2002 told the whistleblower that those who opposed his wife had a habit of dying suddenly. Murder within the cult is also a salutary lesson to others in the cult who might be tempted to go public or go to the police. Also in 2005 long term student [Mike Hendrickson](#) was defrauded out of \$200,000 this is mentioned briefly at the very end of this email sent to Watson by one of Patton West's employees. Fearing for his own life Hendrickson chose to walk away empty handed.

Why did the Police & FBI fail to investigate Lisa's murder?



Because Lisa's murder (and other extra-judicial killings by Patton West) all appear to the coroner as 'deaths by natural causes.' Patton West's use of occult knowledge allows her to murder with impunity (so far). Her entire fake paradigm is built on her ability to visit pain, suffering and murder upon those who oppose her. Lisa Swidler was 'successfully' murdered but the attempt to murder John Watson in 2007 failed.

How many others have been murdered over the past three decades or been the subject of countless domestic terror attacks?

Meet the senior cult / gang members who have knowingly aided, abetted and funded Patton West's criminal activities for, in most cases, decades we are referring to ex-husband [Jack West](#), [Dr. Julio E Williams MD](#) and [Geoffrey Reynolds CPA](#).

MURDER SO COMMON PLACE THAT VICTIMS NAMES ARE MADE PUBLIC TO THE LOCAL PRESS IN ADVANCE. AS WAS THE CASE WITH FRAUD VICTIM TURNED WHISTLEBLOWER JOHN WATSON.

Victim No. 1 - Dr. Pat Cole MD – Patton West's business partner and long term cult member.



Patton West viciously assaulted Dr. Pat Cole MD on a number of occasions as part of the process of extorting \$1.3M from Cole. During one of the assaults Patton West repeatedly hit Cole over the head with the heel of her shoe until blood ran down the victims' blouse.

Patton West was overheard by another employee stating that, because she was an enlightened being, she did not care about murdering Cole because she, Patton West, would be just as comfortable in a \$6M mansion as in a 6' X 6' jail cell!

Patton West was convicted of assaulting Cole in 2008.



Dr. Cole MD was one of scores of victims who joined Patton West's cult on the promise of 'enlightenment.' As Patton West's [website](#) shows this is the approach currently being used by Patton West as she targets the spiritual / metaphysical community in Sedona AZ. The [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers go into detail about the assault by Patton West on Cole. Here is a link to the press announcement of Patton West's conviction for assault. Fearing for her life and being brutalized daily, Cole signed over her home to Patton West (worth \$750,000) and paid \$436,000 to Patton West for an 'internship' and for 'therapy.' In a statement given to the [Bigfork Eagle](#) newspaper Geoffrey Reynolds admits money laundered the \$436K through Patton West's business as 'normal' business receipts!



Above: Had the authorities interviewed some of the scores of victims of organized crime over the past three decades, they would have learned that Patton West's success as a career criminal, murderer and suspected serial killer, was made possible by her use of occult knowledge. After outstaying her welcome in New Mexico and Montana, Patton West is now 'working' Sedona Arizona.

Victim No. 2 – John Watson – Patton West's business partner and business consultant.



After being defrauded out of pay and shares business consultant John Watson successfully sued Patton West for fraud and won that lawsuit in 2008. Along the way Watson put up his own website and caused three newspaper articles to be published about Patton West's criminal activities in Montana. This eventually led to the cult leaving Montana.

In January 2007 Watson received an expletive laden email from senior cult member Dr. Julio E Williams MD an obvious attempt to intimidate Watson into dropping his lawsuit against Patton West. In August 2007 senior cult member Geoffrey Reynolds CPA announced Watson's impending murder to the local press. A week later Patton West made a failed attempt on Watson's life.



John Watson joined Patton West as a consultant in January 2002 leaving after being defrauded in August 2002. After Watson launched a fraud lawsuit against Patton West in 2003 he became the victim of countless [defamations](#) at the hands of Patton West and the senior members of her cult. In December 2006 Watson and his wife and children became the victims of a campaign of [occult violence](#) directed at them by Patton West. In August 2007 [Geoffrey Reynolds](#), in addition to announcing Watson's impending murder by Patton West, also announced a campaign of occult 'under the radar' violence against Watson, his wife and children which is ongoing to this day some 15 plus years later. Watson and his family are not the only victims of this form of intimidation / violence as evidenced by [the harrowing statement](#) given by Rebecca West (no relation to Devra West). In addition to affirming the use of an occult weapon by Patton West against many of her victims Rebecca also affirms that, at the time of writing, Patton West was committing multiple serious crimes against her employees.

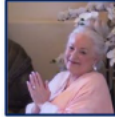

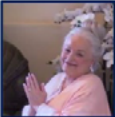

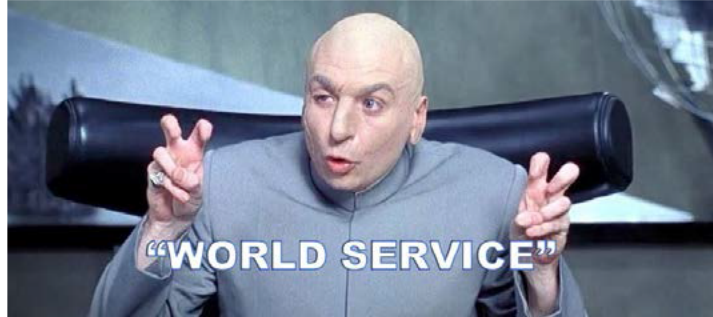

Whether Patton West is criminally insane or venally evil one thing we can be sure of is that she is a [pathological liar](#). During the last 31 years she has changed her name and physical location several times. She was called '[Devra Ji](#)' in New Mexico and Victor MT. In 2005, after her charity was struck off for fraud, she relocated to Lakeside MT calling herself '[Surya Ma.](#)' After multiple visits to court as the defendant in fraud related lawsuits, a conviction for assault and being the recipient of three negative newspaper articles Patton West was forced to leave Montana for Arizona. Arizona being the third western state she has targeted since declaring herself and Ascended Master in 1991. Upon arrival in Arizona in 2010 Patton West changed her name again this time to '[Rishi Devra.](#)' At each new location Patton West creates a new [fake biography](#) and portrays herself via her [website](#) and Facebook pages as a wealthy business woman.

In reality Patton West is an ex-bankrupt and her criminal racketeering business model would have died a death decades ago but for the financial support given by her wealthy disciples / cult members. Financial support given even though the long list of crimes detailed above occurred during their association with Patton West's cult / criminal gang.



Above: Two of the most prominent donors (funders of organized crime and domestic terrorism) are Dr. Julio E Williams MD and Brazilian heiress Corinne Coffin AKA Tanmayo.

Two prominent donors, **Dr. Julio E Williams MD** and **Corinne Coffin** are both disciples and long term members (two decades or more) of Patton West's cult. While we are 100% certain that Dr. Julio E Williams MD knew that Patton West was a dangerous psychopath, a murderer and suspected serial killer it is unclear whether Ms. Coffin, who resides in Brazil, knew exactly what the millions she 'donated' was being used for. Ms. Coffin certainly knew that business consultant John Watson had been defrauded in 2002 as they were both partners in Millennia Mind at the time. Ms. Coffin was certainly aware of the content of the website Watson put up in 2006 detailing many of Patton West's [crimes](#) which remained up until 2010. We are certain that Ms. Coffin was aware of Patton West's many changes of name and location over the past 20 years or so. It is uncertain, during a criminal trial for racketeering and domestic terrorism, whether a plea of ignorance will be accepted as a defense. What we do know for sure is that as far back as 2007 Ms. Coffin's son was very angry that his inheritance was being given to Patton West.

According to [documents](#) obtained from the Arizona government both Williams & Coffin remained officers of Patton West's corporation until 2021. This makes them jointly and severally liable for the many crimes that Patton West committed while they were on Patton West's board of directors. In addition to the contents of Watson's old web site taken down in 2010 both Williams and Ms. Coffin must have been aware of contents of the two websites put up about Patton West's criminal activities several years ago. Websites that remain up and which detail Patton West's multiple visits to court as the defendant in fraud related lawsuits, her two arrest warrants, her conviction for assault and the forced sale of her assets at a [Sheriff's Sale](#) in 2008. All three websites, the one taken down in 2010 and the more recent [Omni Awakening](#) and [The Rishi](#) make it very clear that for decades it has been obvious that Patton West was a career criminal and a vicious and dangerous psychopath. So why did Williams & Coffin remain part of Patton West's criminal racketeering business model until 2021? That's for the courts to decide!

AN IMPORTANT PART OF THE MASSIVE DECADES OLD FRAUD IS PATTON WEST PRESENTING HERSELF TO THE PUBLIC AS A WEALTHY SUCCESSFUL BUSINESS WOMAN. HERE ARE THREE EXAMPLES.....

ABODE OF THE DISASTERS NO. 1 (1995 to 2004)

While operating her criminal racketeering business model in Montana, Patton West represented herself to the public as a wealthy business woman. It was all illusion and all a massive fraud. Between 1995 to 2004, Patton West operated her cult / criminal racketeering business model out of compound in Victor MT. During this time, she was calling herself the Ascended Master [Devra Ji](#). Two of her most memorable statements from this period of time were that she was [single handedly holding open the gates of time](#) and that her two (fake) doctorates were awarded to her [by the Christ](#) in person.

Here are some images from circa 2002 when she was calling herself Devra Ji.....



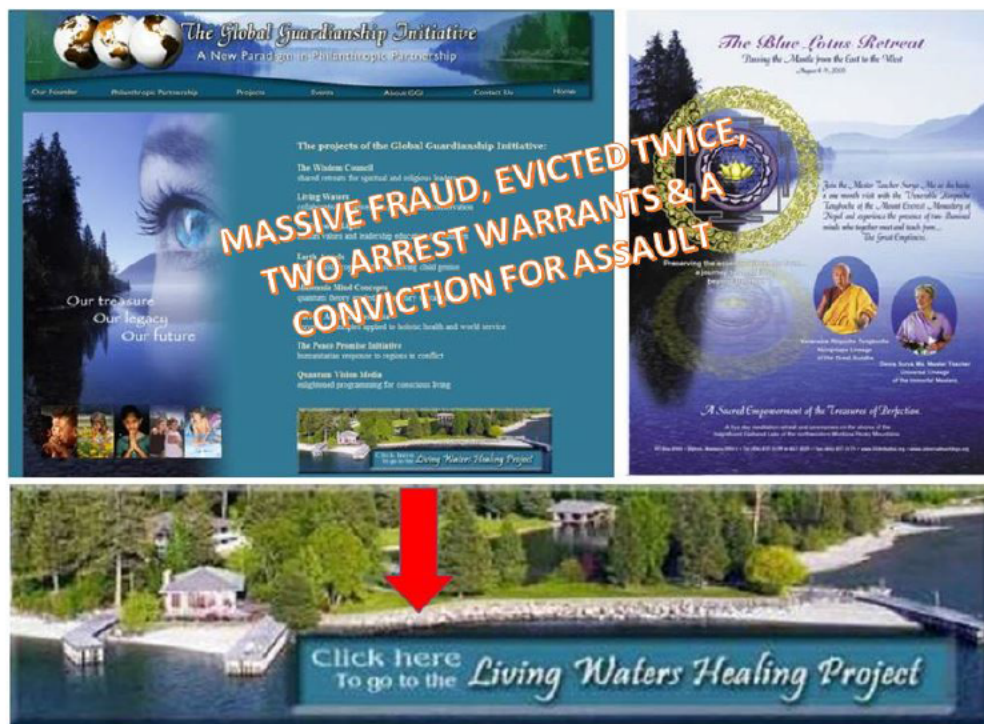
Above center: The class of 2002. Members of her cult were routinely bullied and mentally and physically abused. CIA mind control tactics were used by Patton West to 'force' students and employees to submit to Patton West's will and then after they became 'compliant' each were 'harvested' for their money and for their energy. The public thought that the cash donations were being used to pay for Na Ka' Shela (above left) the property owned by the charity. In reality most of the money was going into Patton West's pocket to fund her luxurious lifestyle. Many of the individuals featured above were the victims of theft, fraud, extortion and violent assault. One victim was kidnapped and held captive and beaten until she agreed to make a large 'donation' to Patton West out of the proceeds of her home which she had recently sold.

In August 2002, Patton West made the mistake of defrauding a business consultant who reported her crimes to the authorities. As a result her charity, 'The Circle of Divine Unity' was struck off the MT charity register in January 2004 and the IRS launched a criminal investigation into Patton West's activities. Patton West, a career criminal, responded by doing the following:-

1. Ordering members of her cult to [shred](#) all the incriminating documents.
2. By an elaborate scheme of [fake loans](#) Patton West stole the charity's property (worth \$1,250,000 in 2004) and put it in a personal trust fund for her and her eldest son Rob Meador. In 2008 a judge broke the trust and ordered that the property be the subject of a [Sheriff's Sale](#) and sold at auction to pay past victims of crime \$2,000,000 in court fines and interest.
3. Patton West stole \$4,000,000 worth of artwork and valuables belonging to the charity. Put the items in a lock up and then moved them to Arizona in 2014 where some were sold at auction, [some sold from her website](#) and others used as props to give the illusion that she is a successful business woman instead of a violent and resourceful career criminal.
4. Instead of declaring that she was close to bankruptcy (for the second time) Patton West declared that she was moving her operation from Victor MT to Shamballa. Shamballa being Flathead Lake MT just 1000 miles north of Victor MT. Being cash strapped she also announced that she could only take 12 disciples to Shamballa and only those prepared to commit [66% of their net worth](#) to her. Having moved to Shamballa (Lakeside MT) Patton West, complete with a new name [Surya Ma](#) and new fake bio / life story wasted no time creating her latest 'save the planet' fraud / extortion scam. The above image (top one of the two) were posted on Patton West's website and used to illicit donations from the public. In reality the 'Living Waters Healing Project' did not exist other than in the mind of Patton West. The multimillion dollar lakeside property being featured in the enlarged bottom image belonged to Robert & Tabby Ivy who repeatedly, over a two year period, asked Patton West not to use images of their home in her brochures and on her website. Go [here](#) to read the couple's comments as given to the Whitefish Pilot newspaper reporter. Patton West fraudulently used images of the Ivy's property to appear wealthy.

The lies and the fraud did not end there as when in court in July 2007, in answer to a question, Patton West declared that her business interests were ['billion dollar'](#) concerns.

Patton West made that statement while being evicted from two rental properties in quick succession and while having a lien against her for \$2,287 in unpaid employment insurance. The [Bigfork Eagle](#) newspaper gives details.

During Patton West's tenure at 'Shamballa' Patton West racked up no less than two arrest warrants, a conviction for assault and was forced to sell all her assets, (those she had not hidden from creditors) at a Sheriff's Sale to pay past victims of crime \$2,000,000 in court fines and interest!

Then there was her multiple appearances in court as the defendant in other fraud related lawsuits (see above for a short list of some of those lawsuits). Throughout this period [Dr. Julio E Williams MD](#) had his [biography](#) posted on her website using his perceived respectability as a physician to draw in more victims. At the same time as Williams was misrepresenting Patton West as the next Messiah Williams he sent a threatening [expletive laden email](#) in an attempt to intimidate fraud victim turned whistleblower John Watson into dropping his fraud lawsuit against Patton West. These crimes are the tip of the iceberg most [crimes](#) go unreported because the victims, mainly employees and members of her cult, were too afraid to go to the police or to court.

One of the lawsuits Patton West lost during this time frame was the fraud lawsuit that business consultant John Watson brought against her in 2003 and [won in 2008](#). From 2003 to 2008 Watson was the subject of countless defamatory [statements](#) authored by Patton West and posted on her website. Watson was the victim of threats, [false witness statements](#) (that Patton West pressured her employees and students to write), and was the subject of a campaign of intimidation by Patton West (which is ongoing). In August 2007 Watson was the subject of a failed murder plot by Patton West which senior cult member Geoffrey Reynolds [announced](#) a week in advance to a news reporter while being interviewed by the [Bigfork Eagle](#) newspaper. Her numerous visits to court, Watson's website and the three newspaper articles published by the [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#) newspapers rendered Patton West's criminal racketeering business model dead in the water in Montana. In response Patton West and the senior members of her cult criminal gang moved to Arizona in 2010.

ABODE OF THE DISASTERS NO. 3 (2009 to 2009)

By 2008 Patton West's criminal racketeering activities in Montana ('World Service') had racked up three negative newspaper articles ([Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#)), Patton West had made dozens of appearances in court as the defendant in fraud related lawsuits, was the recipient of two arrest warrants and a conviction for assault. Also in 2008 Patton West was the subject of a [Sheriff's Sale](#) at which she was forced to sell all her assets (those not hidden from her creditors) to force her to pay past victims of crime \$2,000,000 in court fines and interest. This left Patton West temporarily without a permanent address. Not wishing to speculate we have relied on a statement Patton West gave the whistleblower's lawyer while being deposed' in October 2009. In addition to the revelation that Patton West was living in a caravan rent free in the back of Reynolds' garden, Patton West makes it very clear on multiple occasions that Geoffrey Reynolds was the 'money man.' Patton West has a long history of directing responsibility for her crimes on to her minions. The statement Patton West gave on October 9 2009 to Watson's lawyer makes it very clear that Reynolds is being set up to take the blame for controlling the finances in what is obviously a series of corporations fronting organized crime. It is clear from other documents and witnesses that Reynolds was totally aware that Patton West was a career criminal, a murderer and a suspected serial killer. Remember Reynolds had announced Watson's murder to a local newspaper one week before Patton West made a failed attempt on Watson's life just two years earlier in August 2007.
