


As mentioned above Dr. Julio E Williams MD & Ms. Coffin have been a disciples for more than two decades and both were fully aware of the crimes committed by Patton West in New Mexico and Montana. Jack West has been involved for forty years and Reynolds for eight years between 2006 & 2014. All the above named were well aware of:-

- 1. The long list of WELL 'DOCUMENTED FACTS' (see above list of crimes committed by Patton West in Montana).
- 2. Both were well aware that upon arrival in Arizona in 2010 Patton West awarded herself several fake titles and accolades. See 'WELL DOCUMENTED BULLSHIT' above.
- 3. Both were well aware that the 'Regent of the Great Masters' is a pack of lies and propaganda whose purpose is to facilitate fraud and extortion. See 'MORE BULLSHIT' above.

And yet both Williams & Coffin continued to fund Patton West's criminal activities to the tune of millions of dollars until 2021.

Both knowingly funded organized crime, racketeering and hundreds of domestic terror attacks. Indeed both were directors / officers of Patton West's front company 'OMNI INSTITUTE FOR DIVINE SCIENCES' until 2021.



What Williams & Coffin maybe do not realize is that while they were directors / officers of Patton West's 'front' company they were / are jointly and severally liable for any crimes that Patton West committed during their tenure! Ditto Reynolds during his tenure between 2006 & 2014. Jack West was a willing accomplice for forty plus years!

4. GEOFFREY REYNOLDS CPA. Why would Geoffrey Reynolds CPA, a total stranger to John Watson, announce Watson's impending murder to a local newspaper reporter while being interviewed by the Bigfork Eagle newspaper on August 9 2007? When the 2007 murder plot failed why would Reynolds double down on his lies and treachery and make a totally false statement to a Montana court in 2010 as part of a \$10M extortion scam orchestrated by Patton West? It is clear that Reynolds' pleadings to the court were not his but an exact copy of Patton West's pleadings. If Reynolds joined Patton West's cult / criminal gang in September 2006 how could he have been 'defamed' by Watson between 2002 & 2006? He couldn't have been. Reynolds is a pathological liar who would sell his wife and children if the price was right.

5. <u>DR. JULIO E WILLIAMS MD</u>. Dr. Williams has been a disciple, student, accomplice of Patton West's since the year 2000 and remained so until 2021. In 2005 Williams posted a <u>statement</u> on Patton West's website in response to fraud victim John Watson's decision to sue Patton West for defrauding him a lawsuit Watson won in 2008.



I, Julio Williams MD have been a long time student of Surya Ma (now calling herself the Ascended Master Rishi Devra) and I stake my honor and credibility on defending her personal integrity and establishing the truth.

Statement by Dr. Julio Williams posted on Devra West's website March 23 2005.

Since Williams remained disciple of Patton West's between 2000 and 2021, it is clear that Williams has no honor or credibility. Why would Williams, a total stranger to Watson, send an expletive laden <a href="threatening email">threatening email</a> to Watson in January 2007? Why would Williams pledge \$2M of his own fortune to fund Patton West's legal fees so as to block Watson's and other victim's lawsuits against Patton West? This <a href="document">document</a> from an employee of Patton West's evidences a \$100,000 payment to Patton West in early 2007. This payment was made shortly after Patton West viciously assaulted Dr. Pat Cole MD and months before Patton West was convicted of that assault. Why in 2018 would Williams propagate the <a href="lies posted online">lies posted online</a> by Patton West that her two\* defamation lawsuits against Watson (which Williams Funded) were about cyber-crime? Why would Williams post a <a href="statement">statement</a> online that totally misrepresents the injunction that Williams' money 'bought' for Patton West? Williams knows that the truth is bad for his cult leader's business (theft, fraud and extortion) so in addition to attempting to quash the truth about Patton West's crimes, Williams also posted a series of fake, idiotic <a href="testimonials">testimonials</a> on her website. (\*Reynolds pleadings were a copy of Pattonb West's hence the two defamation lawsuits brought against Watson but funded by Williams.

6. CORINNE COFFIN AKA TANMAYO. Corinne Coffin had been a disciple / student of Patton West's going back to the 1990's. Ms. Coffin is a Brazilian heiress, who has been funding Patton West's activities for decades. The whistleblower John Watson, worked with Patton West as a 'business consultant' between January 2002 to August 2002. During that time, Watson was aware that Ms. Coffin had given one of her credit cards to Patton West, which Patton West used to fund many of her day to day expenses. This seemed odd to Watson as at the time, as there were capital controls on the outflow of monies from Brazil? Allegedly, much larger sums of money were passed to Patton West from Brazil via an intermediary in New York. During the Spring of 2002, Watson and Coffin ended up being selected by Patton West as busines 'partners' (directors and shareholders) in Millennia Mind Inc. Below are copies of the business cards that a Colorado design agency created for that project.



Up until that time, Watson believed that he was working for a respectable charity and that the charity's finances were all above board. While setting up for-profit and non-profit corporations for Patton West, Watson discovered that Patton West and her then husband, Jack West, were using the charity's bank account as their personal accounts. When Watson brought this to the attention of Patton West, explaining that if any large donors to her charity were to take her seriously they would need to see proper sets of accounts showing the charity's finances. Fearing that she was going to lose access to hundreds of thousands of dollars a year from donations, Patton West made up totally false grounds which she used to constructively dismiss Watson. This resulted in the Watson being defrauded out of shares and pay.

Patton West's personal secretary, Barbara Costantino, shared a <u>written statement</u> with Watson in which she made clear that every time someone challenges or opposes Patton West's crimes, Patton West gets rid of them and then manufactures a totally false narrative about the departing individual to cover up her crimes.

Ms. Coffin at the start of this project in the Spring of 2002, confided in Watson that she was glad he was onboard, as she did not trust Patton West to use the \$1.000,000 she was going to donate for the purpose the money was intended for. Unfortunately, after Watson was gotten rid of by Patton West, Ms. Coffin swallowed all of Patton West's lies about his departure and went ahead with the project without Watson's involvement. Here is a <u>document</u> evidencing payments totalling nearly \$750,000 to Patton West. Long story short, not only did Ms. Coffin ignore the crimes committed against Watson in 2002, but in the following two decades continued to turn a blind eye to scores of other <u>serious crimes</u> committed against cult members (employees and students), the IRS and the State and Federal Governments.

Why would Geoffrey Reynolds CPA announce the impending murder of a total stragner to a local newspaper? Why would Reynolds make a totally false statement to a Montana court about a total stranger? Why would Dr. Julio Williams MD send a threatening expletive laden email to a total stranger, whose obvious intention was to intimidate that stranger into dropping their lawsuit against patton West? Why would Williams pledge \$2m of his own fortune to destroy the life of a total stranger? Why would Corinne Coffin fund Patton West's criminal operation to the tune of millions of dollars over two or more decades, knowing that NONE of the money went to the fake causes Patton West espoused? Why would all three risk their reputations, their wealth and even their freedom for a criminally insane4 narcissist?

The answer to all these questions is obvious. Reynolds, Williams & Coffin were all sneior members of Patton West's cult / criminal racketeering gang and all three knew what was going on and were all willing accomplices.

But first, let us list some of the many criminal acts by Patton West that did not result in their leaving her cult / criminal racketeering gang. In other words, they were all willing accomplices in those crimes.

The long list of serious crimes committed in New Mexico and Montana did not bother Williams, Reynolds, Ms. Coffin or her exhusband, Jack West. Even though these crimes included the suspected murder of student, Lisa Swidler, in 2005. Evidence from employee, Carlida Finch, that Patton West was planning Cole's murder (while extorting \$1.3 million from her). Even the well documented defrauding of John Watson, the subsequent attempted murder of John Watson. Even the subsequent attempt to bankrupt John Watson into silence by using Williams' money to mount multiple frivolous lawsuits (without merit) and Reynolds' lies with the obvious objective of outspending Watson in court. Patton West's two arrest warrants, one for felony theft and one for criminal cheque fraud did not bother them. Patton West's vicious assault on her business partner, wherein Patton West repeatedly hit Cole over the head with her shoe until blood ran down the victim's blouse, did not bother them. Patton West's 2008 conviction for assaulting Dr. Pat Cole did not bother them. Even the countless acts of cruelty by Patton West towards the rank and file members of her cult, did not bother them. - In another repeat of history, witnesses allege that Patton West is in the process of being charged with stealing artwork and valuables from a victim in Sedona AZ. Patton West likes artwork and collectables, because along with <a href="mailto:jewelry">jewelry</a> and precious metals, they are easy for her to hide from the IRS and others. Much of her ill-gotten gains never goes near a bank.
- Witnesses allege that Patton West is down to her last 'follower' having destroyed several marriages (divide and
  conquer) and bankrupted at least one family. This was achieved by persuading a brainwashed 'follower' to empty her
  disabled mother's bank trust fund into Patton West's account. This is called embezzlement. The follower is now
  destitute and her mother is in a home.

The long term members of her cult / criminal racketeering gang as shown above, do not give a damn about the scores of crimes committed by Patton West against ordinary folk (peasants). So stealing artwork, defrauding the IRS, and embezzlement of funds from a follower's mother's trust fund, is not going to bother any of them.

However these two issues do.

- Patton West accountants allegedly reported her criminal activities to the IRS. Patton West probably owes tens of
  millions of dollars in back taxes to the IRS, local taxes in AZ, NM & MT.
- Witnesses allege Patton West is being investigated for fraudulently applying for and receiving hundreds of thousands of dollars of Covid Emergency Relief Funds for non-existent employees. Patton West used some of those funds to pay off her rent arrears of \$80,000. Patton West also used some of the Covid Disaster Relief funds to pay for her \$8,000 a month hotel bills. Recently, Patton West moved into a modest condo whose rent is also being paid for out of the funds she defrauded the US government out of.

The IRS can spend a million dollars to recover one hundred dollars in unpaid taxes. The US government, both state and federal, can spend millions of dollars prosecuting guilty of fraud. Unlike the case of John Watson and many others, who having been defrauded or been the victim of theft or extortion, Patton West cannot bully or intimidate state governments, federal governments or the IRS. Patton West, as in the case of Watson and other victims, cannot launch a campaign of lies, violent intimidation or threaten to murder members of the government or the IRS.



Decades of theft, fraud and extortion occasioned with violent assaults, terror attacks and murder. As long as Patton West's activities did not directly affect Williams, Reynolds, Coffin and Jack West, they were quite content to allow Patton West to prey on the rank and file members of the cult. However, Julio Williams, Geoffrey Reynolds, Jack West and Corinne Coffin, all realise that racketeering, domestic terror attacks and murder against ordinary folks is one thing but taking on the IRS or US government is quite another matter.


