I want to bring to your attention some recent news regarding Corinne Coffin. Ms. Coffin was [featured](#) in the Netflix series "Captive" where she told her story of being kidnapped and held for [\\$20 million ransom](#) in Brazil.



Having clearly identified Ms. Coffin, I would now like to share some more recent news about Ms. Coffin that the public may not be aware of. For two or three decades, Ms. Coffin has been a senior member of a US based cult / criminal racketeering gang headed by self-appointed 'Planetary Regent' Devra Patton West. In addition to being a senior member of Patton West's cult / criminal racketeering gang for decades, Ms. Coffin has also financed the cult / gang's criminal activities to the tune of millions of US dollars.

Patton West was chased out of New Mexico in 1995 by one gun wielding victim, who realized that the police were impotent when dealing with a career criminal of Patton West's calibre. In 2010, Patton West was forced to leave Montana after being the recipient of two arrest warrants, a conviction for assault and after several appearances in court as the defendant, in mainly fraud related civil lawsuits. Patton West was also the subject of a Sheriff's Sale to force her to pay past victims of crime \$2,000,000 in court fines and legal fees. Ms. Coffin must have been aware of all of the criminal activities carried out by Patton West in New Mexico and Montana but continued to fund her activities after Patton West moved to Arizona right up until 2021!

Upon arrival in Arizona in 2010, Patton West changed her name yet again, awarded herself a raft of [fake titles and accolades](#) and continued with her 'tried and tested' business model. Patton West is a criminally insane narcissist, who presents herself online via her website as a [minor deity who can deliver enlightenment and 'divine grace healings'](#) for large six figure sums of money. In reality, Patton West is a vicious psychopath, a murderer and a suspected serial killer. There are many parallels between Patton West criminal activities and that of the Brazilian criminal 'John of God' AKA Joao Teixeira de Faria. Murder is used by Black Magicians to silence their critics. And why not? as the extra judicial killings appear to the authorities as deaths caused by 'natural causes.' This means the deaths cannot be tied back to those responsible for the killings and, being psychopaths, they continue to murder with impunity. Even if the cult / gang announce the murders in advance (see below)! One victim of fraud at Patton West's hands was told in 2002 by her then-husband, Jack West, that and I quote, "Those who oppose my wife have a habit of dying suddenly." In 2005, a young mother of two tried to leave Patton West's cult after witnessing a series of very serious crimes. The victim, Lisa Swidler, died suddenly and mysteriously. In 2006, Patton West was overheard by employee [Carlida Finch](#) talking the murder of her business partner Dr. Pat Cole MD. Cole was given a reprieve as after several beatings, she 'donated' her entire net worth to Patton West amounting to \$1.3 million. This included Cole vacating and handing over the deeds to her home! In 2007, one of Patton West's senior cult members Geoffrey Reynolds, announced the impending murder of fraud victim turned whistleblower, John Watson, and put up a website dedicated to exposing Patton West's activities in Montana. The threat was real and an attempt was made, but on this occasion, it did not succeed.

While, there is no evidence that Patton West is involved in raping her victims, there is 100% commonality in the weapon both use to subdue their victims. We are talking about the use of the occult AKA Black Magic.

Below are two excerpts from the [article Be Scofield published](#) on May 21 2023. Nicholas was Lalita's husband. Note in the second excerpt how Patton West manipulates Lalita into striking her husband.

"It sounded like she was being crucified," Nicholas said. She "screamed for five minutes" and her "spine contorted," he told me. "Her eyes rolled back in her head, fluttering. She was convulsing uncontrollably. Her fists were clenched tightly."

"Lalita smack him," the Rishi said during a later episode before Nicholas left. Lalita walked across the room and slapped Nicholas, "wide swing, open-handedly across the face," many times. Nicholas had been sitting in the middle of the room shaking intensely from the Rishi relentlessly screaming at him. "I was debilitated and felt helpless while being hypnotized under her sorcery," he told me. "My sight had become pixelated with dark blurred vision and it felt I was in a trance." Then the Rishi began attacking him (Nicholas). "She ran over to me and began to beat me, clobbering me with all her might, both fists to each side of my head at least 8-10 times, until she had no more energy left to deliver another blow."



LALITA JORDAN IS NOW DEAD!

Below is an excerpt from the [memorial posted](#) by Cult Watch USA for Lalita Jordan.

How Devra Took Over Lalita and Implanted an Entity in Her Devra Patton West screamed continuously for 10 minutes, screaming, "Stare Into Its Yellow Eyes, Hold Your Glance With It, Lalita!" as Lalita was implanted, accepting an entity into her being, followed by Devra diabolically completing her entity implant procedure, by pounding Lalita once in the heart chakra, leaving her unconscious on the floor. This is an example of the common word jugglery, bait and switch entity implant tactic Devra uses on her victims right before many try to cut ties and run. Apparently, Ms. Coffin was OK with that level of criminality and continued to fund Patton West's criminal activities for decades to the tune of millions.

While acting as a business consultant in 2002, the whistleblower was informed by Patton West's bookkeeper, Cheryl O'Brien, that Ms. Coffin partially funded Patton West's criminal activities in two ways. The first was that she left one of her credit cards with Patton West which she 'topped up' every month after Patton West emptied it. Secondly, if large sums of money were needed, Ms. Coffin passed the funds through an intermediary in New York. Apparently there were 'capital controls' in place at the time, hence the need to go through an intermediary.

Ms. Coffin's son was not happy that his mother's fortune was being given away to Patton West as evidenced by a phone call he made to Patton West's office demanding she pay all the money back. Tanmayo's (Coca-Cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000.

This document was obtained from Patton West's bank account in 2007, as part of the discovery process during John Watson's (the whistleblower) fraud lawsuit against Patton West [which he won in 2008](#). The \$743,196.51 is probably a fraction of what Ms. Coffin has given to Patton West to fund her criminal activities. Ex-board member of Patton West's charity, AJ White, gave a statement to the whistleblower attesting the cruelty meted out by Patton West to students and employees alike. The first is that Patton West stole and \$80,000 donation from Ms. Coffin which was intended for the charity. The \$80K was stolen so that Patton West could fund her son's legal fees in a divorce / child custody case. Secondly, when Susannah Felder, one of Patton West's employees questioned Patton West about the stolen monies, Susannah was viciously beaten and partially scalped by Patton West. And yet, as the following document shows Ms. Coffin remained closely involved with Patton West until 2021. Indeed, Ms. Coffin is shown on recent corporate filing documents (see below) as the Treasurer of the 'OMNI INSTITUTE FOR THE DIVINE SCIENCES.'

Ms. West will need to find a new 'Statutory Agent' as Lalita Jordan is now DEAD!

The 'OMNI INSTITUTE FOR THE DIVINE SCIENCES' is the current 'front company' for organized crime. For a list of the 'front companies' used by Patton West in Montana (and there were many) please review the [Bigfork Eagle](#) newspaper article which in addition to sharing some of the many crimes being committed, also lists several front companies many of which were involuntarily dissolved.

Here is an excerpt from that article. *"Out of six businesses mentioned in West's literature only one remains active and in good standing with the Montana Secretary of State office – Sacred Environments. Two were never registered – Divine Unity Foundation and Millenium Mind Institution. Two were involuntarily dissolved – Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked Sacred Archives Institute.*

All of this occurred during Ms. Coffins' tenure – apparently not a problem.

So in conclusion, Ms. Coffin has had a PROVABLE decades long relationship with career criminal, thief, fraudster, extortionist, murderer and suspected serial killer, Devra Patton West. So why did she distance herself from the self-appointed Planetary Regent in 2021?

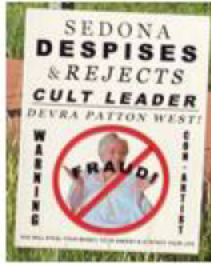
