In 2008 & 2009, within two years of the Whitefish Pilot newspaper article being published in 2007, and while Williams' biography was still posted on Patton West's website, Patton West was the subject of two arrest warrants (one for criminal check fraud and one for felony theft). Patton West was found guilty of assaulting Dr. Pat Cole MD was fined \$500 and given a 6 month suspended jail sentence.
