1. [The truth does not actually matter.](#) *(If Patton West can convince the public that her lies are their truth!)*
2. [Yes I dispose of people like Kleenex.](#)
3. [My agreements are worthless.](#)
4. [Yes I defrauded you but I do not see myself writing out a check for you.](#) (An admission she defrauded Watson)
5. [If you sue me I will get so down and f*cking dirty huge expenses coming out of your pocket not mine because cult members like Dr. Julio Williams MD will fund my legal costs.](#)

In respect of item 5 above. Patton West did get down and dirty and responded to the fraud lawsuit Watson won against Patton West in 2008 by issuing two defamation lawsuits against Watson (for telling the truth about her criminality in Montana). One of the defamation lawsuits launched against Watson was by Patton West herself, and the other by Geoffrey Reynolds CPA, a senior member of Patton West's cult and a total stranger to Watson. The plan was to use the two defamation lawsuits (whose legal costs were funded by senior cult member Julio Williams MD) to outspend Watson in court using hundreds of thousands of dollars given by senior cult member, Dr. Julio Williams MD.

Patton West, Reynolds and Williams all assumed that Watson would not be able to defend himself in court due to the high costs of legal fees and the cost of travelling back and forth to the USA from Canada or the UK. This turned out to be what happened. Watson did not turn up to defend the TRUTH, so Patton West was awarded a summary undefended judgment against Watson. Part of Patton West's legal 'victory' was acquiring an injunction which she needed to prevent Watson from telling the truth about future activities. Armed with the 'gagging' order she desperately needed, Patton West and her cult moved their activities to Arizona in 2010. Where with a new name, new fake bio / life story, and with a raft of new fake titles and accolades, Patton West proceeded to repeat what she had done in New Mexico & Montana i.e. commit crimes on an industrial basis some of which are currently under investigation.

Now let us back up our claims by providing documentary EVIDENCE in chronological order....

1. In January 2007, just as Watson was about to win his fraud lawsuit against Patton West he received the following email message from Dr. Julio E Williams MD. Williams was a senior member of Patton West's cult / criminal racketeering gang and one of her largest 'donors' i.e. funders of organized crime. This is what Williams had to say to Watson.

If what you are after is money (and /or the Victor property) it is going to take a lot of your own personal money to try and get it. I have personally allocated Two million dollars for Dr. West defense and legal expenses.

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down. Mr. Watson, You will have your date in court. You fuck with me and you will meet your match.

Julio E. Williams, MD

Readers should note that Williams was a stranger to Watson. Their common ground was that Watson had worked for Patton West as a business consultant for 6 months in the year 2000 and Williams joined Patton West's cult in 2000. It is unlikely that Watson and Williams had ever met, yet it is a testimony to how brainwashed and conditioned Williams had become that in 2007 he would pledge \$2,000,000 of his own money to defend a career criminal like Patton West against a stranger. But this is not the first time Williams chose to go out on a limb for Patton West against a stranger. Back in 2005, as Watson's lawsuit was gathering pace against Patton West, Williams posted the following propaganda piece on Patton West's website.

I, Julio Williams MD have also been a long time student of Surya Ma and I stake my honor and credibility on defending her personal integrity and establishing the truth. I am proud to serve on the Board of Directors of the Global Guardianship Initiative.

Williams posted the above statement alongside [similar messages](#) from two other cult members, Jennifer Cornell (who left the cult shortly afterwards) and Dr. Pat Cole MD, who was viciously assaulted by Patton West in Spring 2006. Patton West was later convicted of that assault. As you can see above, Williams staked his honor and credibility defending the personal integrity of Patton West. Between 2006 and 2009, Patton West was the subject of multiple arrest warrants, a conviction for assault, was convicted of defrauding John Watson and was the subject of a Sheriff's Sale to force her to pay past victims of crime \$2M in court fines and interest. Clearly, Williams has no honor or credibility. In case anyone doubts this, then please review these three webpages (1), (2) & (3) dedicated to showing that Williams is a willing accomplice in racketeering and domestic terrorism.

2. On August 9 2007, and while being interviewed by the Bigfork Eagle newspaper, Reynolds speaking on behalf of his 'employer' Patton West, announced Watson's murder and a campaign of intimidation to be directed against Watson, his wife and children. What Reynolds actually said was, and I quote, "Watson will be dead within 12 months or in jail for reacting to what Patton West is going to do to his wife and children." End quote.



And here...



Approximately a week after making the above statement to the Bigfork Eagle news reporter, Patton West made a failed attempt on Watson's life just as Reynolds predicted. It should be noted that the same [secret weapon](#) that Patton West used in her attempt to murder Watson, has also been used daily against Watson, his wife and children since December 2006. The objective being to 'silence' Watson once and for all, either by intimidating him directly or via his wife and children or murdering him. Neither worked.

3. In October 2008, Watson won his fraud lawsuit against Patton West. Here is a link to the [judgement](#) and here is a link to the [court award](#). This is just one of many **LEGAL DEFEATS** suffered by Patton West as she was to result in her being forced to leave Montana in 2010, just as she had been forced to leave New Mexico in 1995.

4. Up until this point, Patton West had not bothered to defend herself against Watson's lawsuit believing that he would give up in the face of the intimidation against him and his family. When that did not happen, Patton West organized 'Plan B' which put simply, was to outspend Watson in court so as to 'silence' him for good where intimidation and murder plots failed. This is what criminals do if they cannot murder you they take you to court and 'buy' the result they want. As stated earlier in this paragraph, Patton West had not spent any money on her defense believing that intimidation or murder would make the problem go away.

In item (1.) above we showed Williams' email to Watson wherein he pledged \$2M to fund Patton West's legal fees against Watson and other victims.

In March of 2007, Watson received an email from Patton West's then office manager, Rebecca West (no relation to Devra West). Within the harrowing email entitled '[Help Me](#)' Rebecca confirmed that Dr. Julio Williams MD had begun following through on his pledge to fund Patton West's legal fees by donating \$100,000. Go to Page 2 Paragraph 2 of that [email](#) to read Rebecca confirm the 'donation' of \$100,000 by Williams. So armed with a \$100K from Williams, Patton West appealed the judge's decision which led to an appeal hearing in October 2010, at which Patton West and her stooge Reynolds, served Watson for defamation. The truth is an absolute defense against defamation but only if you can afford a lawyer and in Watson's case, only if you can afford to travel to the USA to defend the truth.

Watson, on the heels of fighting a 7 year lawsuit with associated costs, could not afford to defend against Patton West's lies and so Patton West's (and her stooge Reynolds' lies) were not contested. As a result Patton West and her stooge Reynolds were granted summary judgment. Consequently, Patton West received the injunction she desperately needed so that she could relocate and operate her cult / criminal racketeering business in Arizona. Without worrying about the inconvenient truth of her activities in MT & NM contradicting her lies, BS and propaganda.

Patton West's stock in trade is lies. As shown at the beginning of this bulletin, Patton West is not shy about admitting this. In her conversation with Watson in March 2003, Patton West told Watson that, and I quote, "It does not matter what is true." If she, Patton West, can convince the public that her lies are truth. So now let us see how Patton West chose to represent her fake 'victory' to the public. Before we start, it is important to remember what this is all about.

1. Watson puts up a website containing court documents and newspaper articles that show beyond doubt that Patton West is a career criminal. 2. Patton West tries to silence Watson with a campaign of intimidation and a failed murder plot. 3. When that fails, Patton West 'buys' the law she needs and in the process, obtains the injunction that a) stops Watson commenting on the TRUTH and b) in the absence of Watson being able to comment Patton West concocts a pack of lies whose objective is to represent Patton West's (undefended by Watson) win in court as something it is not.

In other words, having bought Watson's 'silence' (with Julio Williams' money) Patton West portrays her 'victory' not as outspending Watson in court after he won a fraud lawsuit against her, but instead as the result of an independent investigation by a judge into a cyber-scams. Furthermore, Patton West adds insult to injury by saying it is a victory for all women? Duh! This coming from a psychopath that viciously assaulted her female business partner [Dr. Pat Cole MD](#), ripped part of the ear off student [Beatrice McGuire](#) (who called Patton West out on her lies in front of scores of witnesses). Patton West also partially scalped her employee [Susannah Felder](#) after Susannah found Patton West had stolen \$80,000 (to fund her son's legal fees) from the charity and called Patton West out on it.

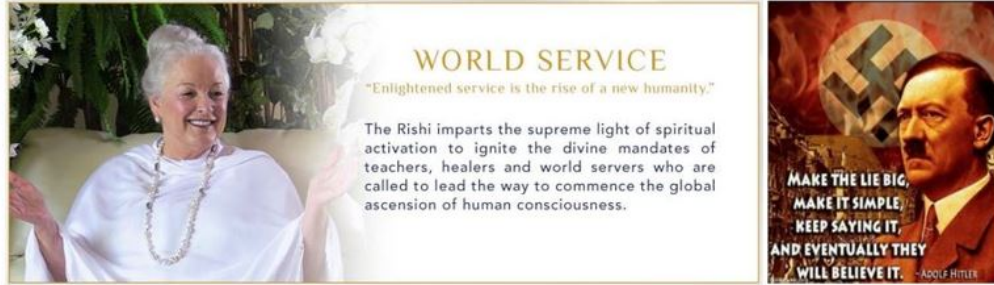

Again, Watson has never been in trouble with the police and the only two lawsuits he has been involved in were the fraud lawsuit he launched and won against Patton West and the defamation lawsuits launched by Patton West against him which he did not defend because of the costs involved. This matter was never about a cyber-scam involving Watson, as Watson's website posted the truth about Patton West's criminality and the 'extortion' Patton West alludes to was the award that the judge gave him after finding Patton West guilty of defrauding Watson! In respect of Watson's win in court against Patton West, she responded by posting the following on her website..

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Patton West refers to Watson winning a fraud lawsuit against her as a “technical error.’ The Master liar goes on to say that there was never any business dealings between herself and Watson. 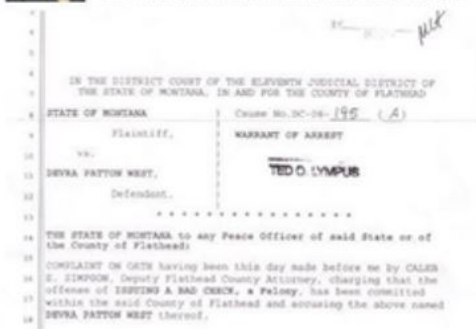
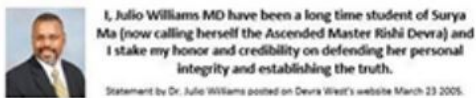
The lies are endless. Similarly, after Patton West was found guilty of assaulting her business partner Dr. Pat Cole MD, Patton West posts the following statement on her website...

Court Rules to Dismiss Bogus Assault Case:
 All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole’s direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole’s misguided attempt to entrap Dr. West was a ploy motivated by Cole’s need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Here is a link to several idiotic, deceitful 'testimonials' from Williams who knew that Patton West was a career criminal. The first two 'testimonials' were 'from' ex-employee Susannah Felder and ex-cult member Dave Kushner. 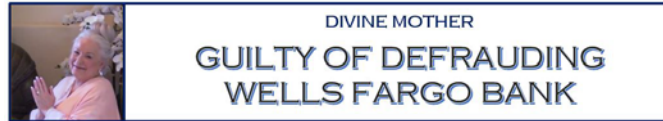

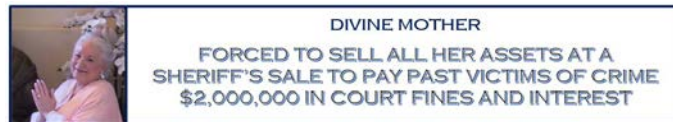
