MORE ON MULTIPLE MURDERS BY PATTON WEST...

In 2002, while the whistleblower John Watson was working as a business consultant for Patton West her then husband Jack West warned Watson that those who opposed his wife had a habit of dying suddenly. The warning came after Watson discovered the massive financial fraud being perpetrated by both Patton West and Jack West. Watson did not take his warning seriously at the

time. However three years later in 2005 Lisa Swidler, a long term cult member / student / and teacher at Patton West's school for occult studies, died suddenly under mysterious circumstances.

Upon further investigation a motive, on the part of Patton West, for the murder of Lisa Swidler was discovered. In 2005 Patton West was swindled out of \$650,000 by con artists Wilson & Ross. Where Patton West got the \$650,000 to invest is another matter but losing those funds left Patton West scrambling for money. In the same year, 2005, Patton West decided to 'harvest' whatever wealth she could get from her cult. That year 'students' Dave Kushner was defrauded out of \$30K, Mike Hendrickson defrauded out of \$200K and Marion Cantwell kidnapped, held captive and beaten until she gave up part of the sale proceeds of her house. Marion was told that if she went to the police she would be murdered. So Patton West had MOTIVE for defrauding members of her cult. The occult [secret weapon](#) Patton West uses to intimidate and murder those who 'oppose' her is not regarded as a weapon under legal statute so not only did Patton West have MOTIVE she had OPPORTUNITY.

THINK ABOUT IT...

Patton West acquired occult (hidden) knowledge during her 18 months of study at the 'Robert Jaffe School for Energy Mastery.' Upon ending those studies in 1991 she declares herself to be an Ascended Master. In 1995 she is chased out of New Mexico at the point of a gun by one victim who realised that the police / law courts were impotent against such a dangerous and evil psychopath. She and her cult relocate to Montana. In 2002 Jack West tells the whistleblower John Watson that those who oppose his then wife have a habit of dying suddenly. The word 'those' implies 2 or more. Let us run with just two murders / extra judicial killings between 1991 & 2002. In 2005 Lisa Swidler was murdered by Patton West. In 2007 business consultant John Watson was supposed to have died at Patton West's hands. That brings the total of murders / extra judicial killings to four. So between 1991 & 2007 = 16 years there were a minimum of 4 murders / extra judicial killings. Between 2007 & present day = 17 years. Given 4 murders in the 16 years between 1991 & 2007 it is reasonable to assume that there would have been an average of another 4 murders making 8 murders / extra judicial killings over the last 33 years. Because these deaths appear to the authorities as 'death from natural causes' none of these murders have been investigated. We suspect there are many more than 8 murders. Why would senior cult member Geoffrey Reynolds so confidently announce Watson's murder ahead of time to a local news reporter if he was a) not confident it would happen and b) confident that the murder of Watson would not be linked to Patton West.

Multiple murders are going to be hard to prosecute however there are tens or scores of victims who were not murdered but were made ill or injured by Patton West's occult weapon. Two that come to mind are Tanya Hurley. Who just days after posting these two emails (1) (2) on the whistleblower's website ended up in hospital with damage to her internal organs. The victim that comes to mind is Diane Stoner who upon leaving the cult in 2003 downloaded a scores of files from Patton West's computer and gave those files on a thumb drive to the whistleblower. Within days of the files being uploaded on to the whistleblower's web site Diane ended up in hospital with a serious injury. John Watson has 17 years of such attacks and is ready to share what he knows with the FBI and Police forces of Montana and Arizona. Dr. Pat Cole MD, Patton West's supposed business partner, was told by Patton West that she, Patton West, had the spiritual authority to "take her out." Being insane Patton West does not need 'motive' for the violence or murders. We aim to make it clear that she has 'opportunity.'

NONE OF THIS WAS INVESTIGATED. APPARENTLY MONTANA WAS / IS STILL THE 'WILD WEST' AND IT IS THEREFORE DIFFICULT TO PROSECUTE ORGANIZED CRIME. HAD PATTON WEST OPERATED IN NEW YORK SHE WOULD HAVE BEEN JAILED DECADES AGO!

When Watson, defrauded out pay and shares in 2002, went public and put up a website in 2006 Geoffrey Reynolds CPA, a senior member of Patton West's cult, announced in August 2007 that Watson would be dead within 12 months. Shortly after making that statement a failed attempt was made on Watson's life by Patton West. Another failed attempt was made on Watson's life in October 2023. Why would Reynolds so confidently state that Watson would be dead within 12 months? We suspect that Patton West shared details of previous murders with Reynolds giving Reynolds the confidence to make the statement. That Patton West has murdered in the past and on several occasions and gotten away with it explains her belief that she is now a minor deity and dresses accordingly.

FBI POLICE TAKE NOTE. The attacks against Watson continue but he is still alive and ready to testify as are Kushner, Hendrickson & Cantwell and countless other victims of theft, fraud, extortion, embezzlement and violence. Additionally Patton West has been busy this last decade or so since arriving in Arizona after being forced out of Montana and New Mexico. Patton West is currently under investigation for a multitude of crimes committed recently including the alleged defrauding of the US government out of \$500K in SBA Loans. Recently all the senior members of her cult / criminal racketeering gang [Julio Williams](#), [Geoffrey Reynolds](#), [Corinne Coffin](#) and [Jack West](#) have tried to put distance between themselves and Patton West. They all understand that, in respect of the \$500K Patton West obtained for non-existent employees, that the US government, unlike ordinary victims, can spend unlimited resources to prosecute crime.

These bulletins are being sent out with the objective of persuading the authorities to launch a serious criminal investigation into Patton West's activities over the past 32 years in three western states NM, MT & AZ. Given 32 years of Racketeering and Domestic Terrorism across multiple states that investigation should be held under R.I.C.O. statutes.

BACK TO WILLIAMS. Let us cut to the chase. Dr. Julio E Williams had been, for two decades, a senior member of a cult / criminal racketeering gang led by dangerous psychopath Devra Patton West. Williams only decided to distance himself from Patton West in 2021 after Patton West defrauded the US government out of \$500K in SBA loans. 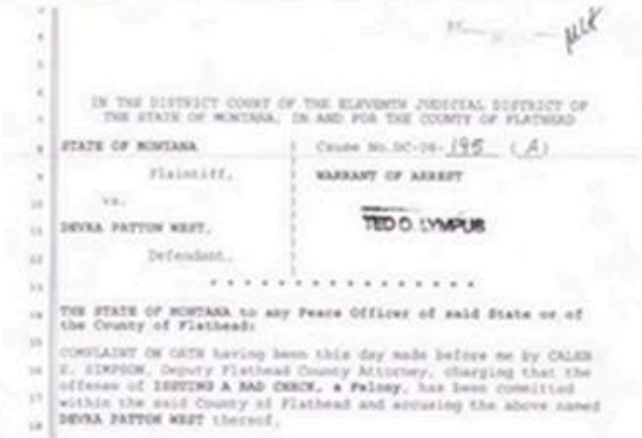

Spiritual guru pleads guilty in assault

A Lakeside woman who claims to expose time-less spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11½-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

Biography



Julio Williams, MD

A gifted cardiothoracic surgeon, Doctor Williams graduated Cum-Laude from Madre & Maestra Catholic University in the Dominican Republic. During his training as a medical student, his rotations for "social medicine" involved treating the poor and disadvantaged in the city slums and the Sierra Mountains of the Caribbean Islands, and as a result he felt drawn to the holistic concept of medicine.

"Because economic and cultural influences were so obviously at play, I could not help but view the patients not only as the disease process they exhibited, but also from the holistic causative stand point: the Bio-Psycho-Social triad that allows us to access the root cause of the disease process. This early experience of medicine in an underdeveloped country awakened within me the sensitivity for serving those in need. From the day that I graduated I have perceived medicine and health care as a God given right belonging to all of humanity."

Dr. Williams then completed his residency in general surgery at Albert Einstein College of Medicine and Bronx-Lebanon Medical Center in New York city, during the peak years of the Aids epidemic, and he shares, "This was a trying time emotionally and a time of enormously hard work, however I was a witness to the evolution of medicine and the disease process. I also had the privilege of working in scientific research for a year with Dr. Stanley Levenson, professor Emeritus of Surgery at the Albert Einstein College of Medicine, who is considered to be a pioneer in wound healing research. Reading about the great minds of early science was mandatory prior to engaging our actual work project, and this inspired a keen interest in the work of Louis Pasteur, Dr. Dubois among others. But what I remember the most about Dr. Levenson was the wisdom he passed to us as surgeons, residents, and students, as he shared the stories of his exodus from Russia as an orphan Jewish immigrant travelling a post holocaust Europe and coming to America to become a leading authority in the world of academic Surgery and Basic Science research and the recipient of awards from the American College of Surgeons. His wisdom and perseverance instilled in me the courage to seek beyond conventional norms."

During his senior years in his surgical training, Dr. Williams received the mentorship of Dr. Robert Frater, Acting Chairman of the Cardiothoracic Surgery Department at Einstein, who introduced him to the world of cardiothoracic surgery and who endorsed him as a potential candidate for fellowship training in cardiothoracic surgery. Dr. Williams then went on to train in cardiothoracic Surgery at the University of Medicine and Dentistry of New Jersey (UMDNJ- New Jersey Medical School) Newark campus.


"The cardiothoracic surgery training was intense and demanding but full of rewards for the heart. Again, working in the inner city and its population help me see the other part of society with its continuous problems like a vicious cycle with no end in sight. As I came face to face with this every day, it made me see clearly and first hand the problems that plague our health care system." Dr. Williams completed his board certification in General Surgery in 1997(American Board of Surgery) and Cardiothoracic Surgery in 2001(American Board of Thoracic Surgery)

After completion of his surgical training, Dr. Williams began his private practice.

It was during the beginning of my practice that "I heard the call to service".

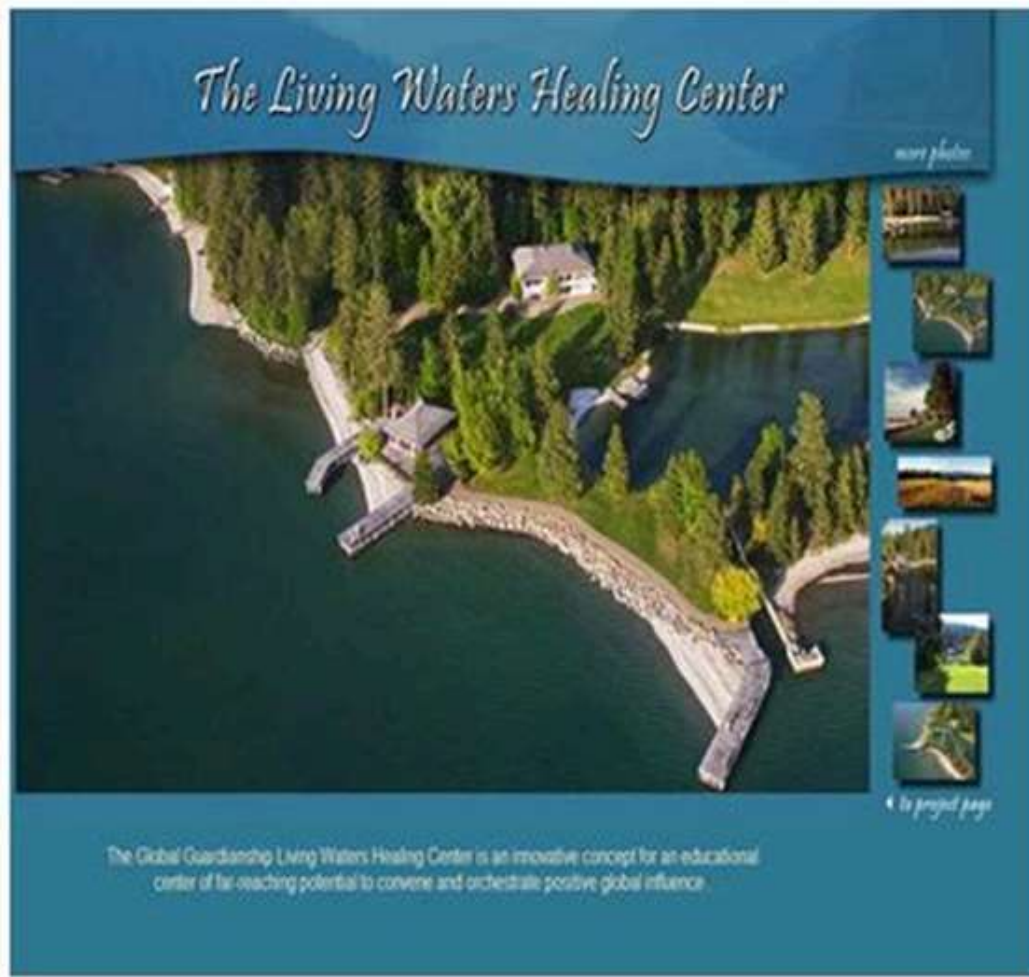
It became clear that for him path of medicine would lead him to a higher purpose and that caring for those in need went far beyond the financial rewards in which our health care system is entangled at this time.



It was in the fall of 2000 when I first came into contact with Dr. Devra West, whom we graciously and fondly call "Surya Ma" (a name reflecting high honors on the spiritual path) during a transformational training at her retreat center in Montana. I quickly came to recognize that she is one of her kind among the few contemporary illumine minds here in the west. She is a modern day pioneer and visionary who lives her life as an example in service for the greater good of humanity. It was as if I had been ignited to see and know and experience at all new levels of possibility, and as a physician, I felt privileged to receive the gold that her teachings have to offer. And I have been inspired to pass on to society at large, the tools that have empowered me to engage the philanthropic spirit in service to humanity and more over into my medical practice. There are a number of issues I have with this statement. Firstly, there is the obvious use of his medical credentials to pimp himself on behalf of Devra Patton West, the leader of his cult, for the obvious purposes of using his 'perceived' credibility to give her credibility! Secondly, leaving aside the revelations contained in the **Whitefish Pilot** [12A] newspaper about Devra West's obvious criminality, is the fact that right next to Dr. Williams' gushing testimonial about his cult leader is this image seen below here.



This above image was of a multi-million dollar lakeside property owned by Robert & Tabby Ivy which Devra Patton West was portraying, on her website and in her brochures, as belonging to her. She did this to give the public that she was a wealthy business woman – clearly this was fraud. Dr. Williams must have known about this since his testimonial was on the very same website as the above image. Robert & Tabby Ivy were interviewed by the Whitefish Pilot newspaper; here is what they had to say about this matter:-

A third Lakeside property -- the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her."

Obviously Williams had no problem with this massive fraud even though his image appeared next to images of the Ivy's property which he knew did not belong to his cult / gang leader. Had he had an ounce of integrity he would not have gone on to issue these 'testimonials.'

So the law, up until now, has been totally impotent to deal with a career criminal like Patton West and as a consequence she has been allowed to get away with multiple murders over the past 30 plus years. What follows are some more examples of what Patton West and her accomplices call 'World Service.'



Above from left to right: Career criminal Patton West masquerading as a guru. (1) Lisa Swidler murdered to keep her from going to the police. (2) Marion Cantwell kidnapped, beaten, the victim of extortion and threats of murder. (3) Dr. Pat Cole MD viciously beaten on multiple occasions, the subject of extortion and threats of murder. (4) John Watson defrauded, the victim of defamation and a failed murder attempt. In 2010 Watson was the victim of a concerted effort by cult members Patton West, Williams & Reynolds to bankrupt Watson into silence.

EXAMPLE 1. The Suspected Murder of Student Lisa Swidler. Lisa may have been murdered in 2005 to stop her going to the police about crimes committed against fellow students, [Dave Kushner](#) (defrauded out of \$30,000), [Mike Hendrickson](#) (defrauded out of \$200,000) and [Marion Cantwell](#) who after selling her home was the victim extortion. Lisa was also aware of the [brutality](#) being meted out to Dr. Pat Cole MD by Patton West, while in the process of extorting \$1.3 million from Cole.

EXAMPLE 2. Marion Cantwell Kidnapped, Falsely Imprisoned, Threatened with Murder and the Victim of Extortion. After the sale of her home, student [Marion Cantwell](#) was kidnapped, falsely imprisoned and beaten. After being forced to make a 'donation' of tens of thousands of dollars, Marion was told she would be murdered if she went to the police.

EXAMPLE 3. The Planned Murder of Dr. Pat Cole MD by Patton West. Patton West was overheard by employee, [Carlida Finch](#), talking about the murder of her business partner Dr. Cole. Cole was viciously assaulted several times (the [Whitefish Pilot](#) newspaper has the details) by Patton West, while extorting the victim's entire net worth from her, which included Cole being forced to sign over her \$750,000 home to Patton West. West was convicted in 2008 of assaulting Cole. Cole was not murdered getting a reprieve after emptying her bank account into Patton West's.

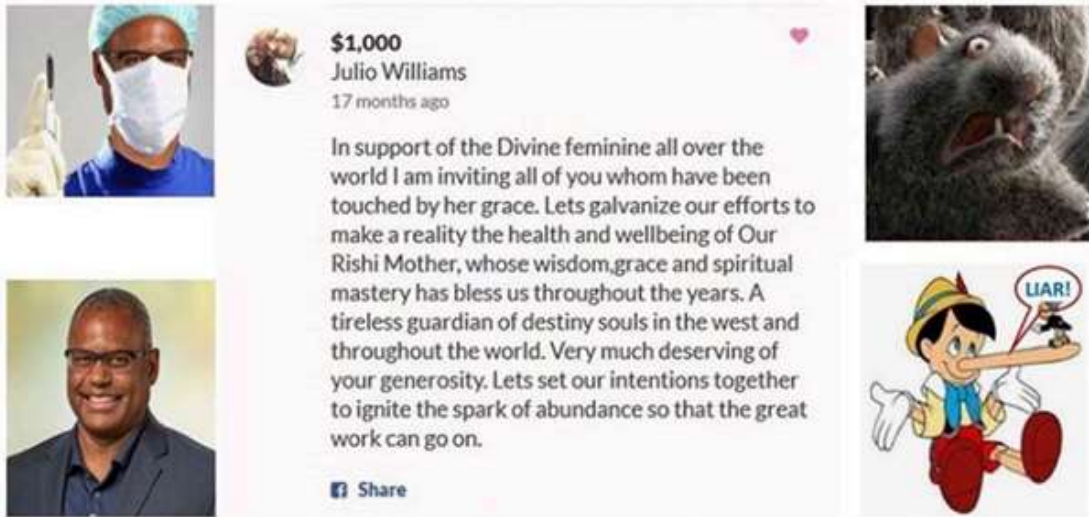

Williams was not finished yet as when information started to appear on-line again that clearly showed that Patton West, Williams, Coffin and Patton West's ex-husband Jack West were all part of a cult / criminal racketeering gang Williams posted a hatchet piece about Watson in a vain attempt to gain the moral high ground. Excerpt 1. The Headline refers to the injunction that West 'bought' by outspending Watson in court using \$2,000,000 that Dr. Julio Williams MD provided for her legal expenses. The subheading in small print below, asserts falsely that Devra Patton West was the victim of a Cyber Scam, when in reality, it is she who is using the internet to attract victims to her cult who are then robbed, defrauded and become the victims of extortion.

Compare the reality of what West did in Montana. Two arrest warrants (one for [criminal check fraud](#) and one for [felony theft](#)), a [conviction for assault](#), multiple appearances in court as the defendant in fraud related lawsuits including the one John Watson brought [and won in 2008](#). Devra Patton West was also forced in 2008 to sell her assets at a [Sheriff's Sale](#) to pay past victims of crime \$2,000,000 in court fines and interest. This idiot is now being portrayed online by Williams and others as a virtual wellspring of living divinity. Who do you think is committing cybercrime?

Excerpt 2. There was no cyber extortion scam against 'Rishi Devra.' Apart from anything else, Williams is referring to events that occurred in Montana when Devra Patton West was calling herself the Ascended Master Surya Ma. She only changed her name, for the third time in 6 years, after being forced to leave Montana, as she was forced to leave New Mexico in 1995. As we have shown above, after Devra Patton West was found guilty of assaulting Dr. Pat Cole MD, she posted a statement on her website claiming that the bogus assault case was dismissed by the courts. West went on to state that victim Dr. Pat Cole, who West extorted \$1.3 million from, was guilty of trying to defraud her! Similarly with Watson.

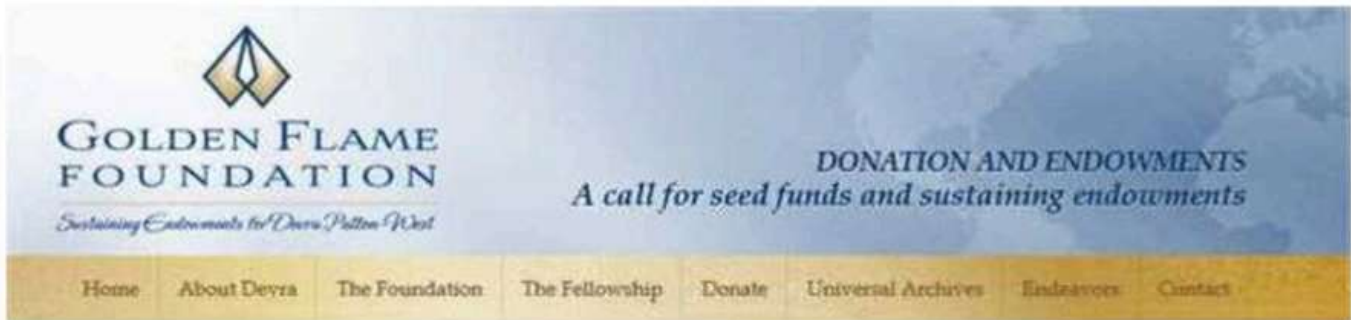
