MORE ON MULTIPLE MURDERS BY PATTON WEST...

In 2002, while the whistleblower John Watson was working as a business consultant for Patton West her then husband Jack West warned Watson that those who opposed his wife had a habit of dying suddenly. The warning came after Watson discovered the massive financial fraud being perpetrated by both Patton West and Jack West. Watson did not take his warning seriously at the time. However three years later in 2005 Lisa Swidler, a long term cult member / student / and teacher at Patton West's school for occult studies, died suddenly under mysterious circumstances.

Upon further investigation a motive, on the part of Patton West, for the murder of Lisa Swidler was discovered. In 2005 Patton West was swindled out of \$650,000 by con artists Wilson & Ross. Where Patton West got the \$650,000 to invest is another matter but losing those funds left Patton West scrambling for money. In the same year, 2005, Patton West decided to 'harvest' whatever wealth she could get from her cult. That year 'students' Dave Kushner was defrauded out of \$30K, Mike Hendrickson defrauded out of \$200K and Marion Cantwell kidnapped, held captive and beaten until she gave up part of the sale proceeds of her house. Marion was told that if she went to the police she would be murdered. So Patton West had MOTIVE for defrauding members of her cult. The occult [secret weapon](#) Patton West uses to intimidate and murder those who 'oppose' her is not regarded as a weapon under legal statute so not only did Patton West have MOTIVE she had OPPORTUNITY.

THINK ABOUT IT...

Patton West acquired occult (hidden) knowledge during her 18 months of study at the 'Robert Jaffe School for Energy Mastery.' Upon ending those studies in 1991 she declares herself to be an Ascended Master. In 1995 she is chased out of New Mexico at the point of a gun by one victim who realised that the police / law courts were impotent against such a dangerous and evil psychopath. She and her cult relocate to Montana. In 2002 Jack West tells the whistleblower John Watson that those who oppose his then wife have a habit of dying suddenly. The word 'those' implies 2 or more. Let us run with just two murders / extra judicial killings between 1991 & 2002. In 2005 Lisa Swidler was murdered by Patton West. In 2007 business consultant John Watson was supposed to have died at Patton West's hands. That brings the total of murders / extra judicial killings to four. So between 1991 & 2007 = 16 years there were a minimum of 4 murders / extra judicial killings. Between 2007 & present day = 17 years. Given 4 murders in the 16 years between 1991 & 2007 it is reasonable to assume that there would have been an average of another 4 murders making 8 murders / extra judicial killings over the last 33 years. Because these deaths appear to the authorities as 'death from natural causes' none of these murders have been investigated. We suspect there are many more than 8 murders. Why would senior cult member Geoffrey Reynolds so confidently announce Watson's murder ahead of time to a local news reporter if he was a) not confident it would happen and b) confident that the murder of Watson would not be linked to Patton West.

Multiple murders are going to be hard to prosecute however there are tens or scores of victims who were not murdered but were made ill or injured by Patton West's occult weapon. Two that come to mind are Tanya Hurley. Who just days after posting these two emails (1) (2) on the whistleblower's website ended up in hospital with damage to her internal organs. The victim that comes to mind is Diane Stoner who upon leaving the cult in 2003 downloaded a scores of files from Patton West's computer and gave those files on a thumb drive to the whistleblower. Within days of the files being uploaded on to the whistleblower's web site Diane ended up in hospital with a serious injury. John Watson has 17 years of such attacks and is ready to share what he knows with the FBI and Police forces of Montana and Arizona. Dr. Pat Cole MD, Patton West's supposed business partner, was told by Patton West that she, Patton West, had the spiritual authority to "take her out." Read Cole's statement to the [Whitefish Pilot](#) newspaper. We suspect there are scores or more victims of occult (hidden) violent attacks against those who have opposed the psychopath. Being insane Patton West does not need 'motive' for the violence or murders. We aim to make it clear that she has 'opportunity.'

NONE OF THIS WAS INVESTIGATED. APPARENTLY MONTANA WAS / IS STILL THE 'WILD WEST' AND IT IS THEREFORE DIFFICULT TO PROSECUTE ORGANIZED CRIME.

When Watson, defrauded out pay and shares in 2002, went public and put up a website in 2006 Geoffrey Reynolds CPA, a senior member of Patton West's cult, announced in August 2007 that Watson would be dead within 12 months. Shortly after making that statement a failed attempt was made on Watson's life by Patton West. Another failed attempt was made on Watson's life in October 2023. Why would Reynolds so confidently state that Watson would be dead within 12 months? We suspect that Patton West shared details of previous murders with Reynolds giving Reynolds the confidence to make the statement. That Patton West has murdered in the past and on several occasions and gotten away with it explains her belief that she is now a minor deity and dresses accordingly.

FBI POLICE TAKE NOTE. The attacks against Watson continue but he is still alive and ready to testify as are Kushner, Hendrickson & Cantwell and countless other victims of theft, fraud, extortion, embezzlement and violence. Additionally Patton West has been busy this last decade or so since arriving in Arizona after being forced out of Montana and New Mexico. Patton West is currently under investigation for a multitude of crimes committed recently including the alleged defrauding of the US government out of \$500K in SBA Loans. Recently all the senior members of her cult / criminal racketeering gang [Julio Williams](#), [Geoffrey Reynolds](#), [Corinne Coffin](#) and [Jack West](#) have tried to put distance between themselves and Patton West.

They all understand that, in respect of the \$500K Patton West obtained for non-existent employees, that the US government, unlike ordinary victims, can spend unlimited resources to prosecute crime.

These bulletins are being sent out with the objective of persuading the authorities to launch a serious criminal investigation into Patton West's activities over the past 32 years in three western states NM, MT & AZ. Given 32 years of Racketeering and Domestic Terrorism across multiple states that investigation should be held under R.I.C.O. statutes.

In the UK we have a word for 'bottom feeders' like Geoffrey Reynolds and the word is **SCUM**.

(adj.) Possibly the worst word you can have your name associated with.

It is hard to define the word, but it is basically used to describe someone so disgraceful that they are seen as the lowest form of life. "Worthlessness", "waste of skin", "dirt". "Nothing". Far worse than most other insults, where the victim is often just referred to as genitalia.

The urban dictionary has other equally negative definitions for the word SCUM.

Scum are people that would sell their wife and children if the price was right. No crime is off limits for scum like Geoffrey Reynolds CPA. Becoming a pathological liar for money? No problem – tell me what to say? Defrauding individuals and government out of millions of dollars. No crime is too big? Being complicit in the murder of a whistleblower going public about serious crime. No problem. Tell me when the whistleblower is going to be murdered and I'll announce his murder and the campaign of intimidation directed at his family to the press in advance. Make false statements to a court as part of a \$10,000,000 extortion scam. Not a problem where do I sign?



Above left: Geoffrey Reynolds CPA travelled from California in September 2006 to take up employment in what he thought was a normal corporation. Only after loaning \$300,000 to its CEO Patton West did he realize that the corporation was a front for organized crime. Reynolds agreed to become complicit in serious crime to 'save' his marriage, his CPA license and his \$300,000!

We will now set out just a few of the crimes Geoffrey Reynolds CPA agreed to commit in return for the \$300,000 he was duped into loaning Patton West, shortly after commencing his employment with her in September 2006. That Reynolds had fallen totally under Patton West's control after loaning her his life savings is made very clear in two emails sent to the whistleblower by one of his work colleagues in March 2007. In the first of email entitled '[Help Me](#)' Rebecca West, no relation to Patton West, talks about all the serious crimes being committed right under Geoffrey Reynolds' nose. The second email entitled '[What is your status](#)' sets out how Reynolds was hoping to save his marriage and his CPA license by not reporting these serious crimes to the police. Let us now get specific about just a few of Reynolds' crimes.



**DANGEROUS PSYCHOPATH ASSAULTS
FEMALE PHYSICIAN WITH REPEATED HITS TO

1. The April 2006 vicious assault by Patton West upon Dr. Pat Cole MD as part of a criminal conspiracy to extort \$1.3 million from Cole.

Reynolds failed to report the campaign of violence and intimidation by Patton West towards the victim, Dr. Pat Cole, and several witnesses to the assault. This campaign being carried out right under Reynolds' nose was intended to force the victim and witnesses into withdrawing their statements against Patton West. Review these witness statements. (1), (2), (3) (4) & (5). Here is a [statement](#) by fellow employee, Carlida Finch, who overheard Patton West planning Cole's murder. Cole got a reprieve after handing over \$1.3 million to Patton West. Patton West's multi-million dollar a year criminal racketeering business model relies on the public believing the lies and propaganda that Patton West is a minor deity, so the truth has to be hidden at all costs. This is fraud. Shortly after news of the assault on Cole went public in the [Whitefish Pilot](#) newspaper on July 12th, Reynolds posted multiple statements on Patton West's website denying the assault had ever occurred.

While publicly denying the assault had occurred, in private Reynolds was desperately emailing the service provider of Watson's website in an attempt to force off that website a copy of Patton West's written admission that she had assaulted Cole. This admission was sent to her entire mailing list on April 17 2006; just days after the assault occurred with a copy finding its way on to Watson's website. Within the missive, entitled, '[The Law of Severity on the Path to Purification](#),' Patton West admits the assault and justifies the attack on Cole by asserting she was a Nazi in WWII in another life time. Reynolds hoped to remove the admission of guilt from Watson's website by having Patton West [claim copyright](#) of document!

Geoffrey Reynolds' employment came about because the previous 'finance controller' [resigned rather than manufacture false invoices](#) to make it look like the \$436,000 literally beaten out of Cole was received a result of normal business activity. No such problem for Reynolds, who gave a statement to the [Bigfork Eagle](#) newspaper on August 9 during which he more or less 'admitted' money laundering \$436,000 in cash through West's business, as payment for an "internship" and "therapy." Who cashes in their entire IRA and [borrows \\$50,000 from their Aunt](#) to pay for an "internship" and "therapy?" Reynolds also vehemently denied that Cole's injuries were caused by Patton West assaulting Cole, even though the assault occurred 6 months before Reynolds' employment commenced, and even though there were several witnesses present when it happened. As detailed below, Patton West was found [guilty of assault](#) in April 2008 and fined \$500 and given a 6 month suspended prison sentence. On the very day the [press announced her conviction for assault](#), Patton West published a propaganda [statement on her website](#) denying her conviction and asserting that the court had thrown out Cole's bogus assault case!

2. More lies and more evidence of multi-million dollar fraud perpetrated by Reynolds

It is clear from witness statements that Reynolds, during the 2006 to 2008 time period, had fraudulently applied for \$30,000,000 in grants from the federal / state governments to build a spa complex. Reynolds applied for the grants knowing that the corporation he was a director of was a front for organized crime. Though Reynolds' title was 'Finance Controller' the corporation itself was the public face of Patton West's cult, which she ruled with an iron hand. Reynolds' title and the titles given to countless other employees before and since, was done as window dressing to give Patton West's criminal business model credibility in the eyes of the public and the authorities. And when applying for millions of dollars in government grants. The following documents indicate that Patton West, should she obtain the \$30,000,000, was intending to use at least \$2,000,000 of that money to pay off her creditors.

1. [Email](#) from Patton West's step mother to Watson's lawyer affirming that Patton West intended to pay back a \$30,000 loan to her out of the \$30M grant money.
2. [Email](#) from Patton West's office manager Rebecca West (no relation) stating that she feared the grant money was fraud, and if not fraud and it came, Patton West intended to pay off her debts with it, including thousands of dollars in wages owed to her employees. On page 2 paragraph 5 there is a reference to the \$30M grant money.
3. A copy of the document announcing a [Sheriff's Sale](#) in 2008 to force Patton West to pay her creditors \$2,000,000 in court fines and interest.
4. A copy of the [statement](#) Patton West made in 2009 while being deposed by Watson's lawyer, within which she admitted to being \$2,000,000 in debt and admitting that Reynolds was not only aware of her financial situation but was managing it for her.

Reynolds obviously knew about Patton West's criminality and her financial problems but I bet he did not declare this information in his submission to the federal government when applying for \$30,000,000 in grant money.

3A. Reynolds was complicit in the August 2007 attempt by Patton West to murder fraud victim turned whistle-blower John Watson.

John Watson was a business consultant recruited by Patton West in January 2002. Watson was tasked with setting up a for-profit and several non-profit corporations, which he did over a 6 month period. At the completion of his contract, Patton West told Watson that she was not going to pay him what she owed him. In March 2003, Watson announced he was going to sue Patton West for fraud. After he announced his decision to go to law, Patton West demanded a private meeting with Watson at his ranch which, unbeknownst to Patton West, the meeting was recorded with a digital tape recorder. Long story short, Patton West admitted defrauding Watson but did not see herself writing out a cheque for what she owed him. She went on to threaten that if Watson went to law, she would get so f*cking down and dirty, huge expenses coming out of his pocket and not hers because members of her cult / criminal gang would pay her legal fees. Below are excerpts from the conversation Watson had with Patton West.

Watson went ahead with his lawsuit against Patton West which [he won in 2008](#). Along the way, he became the subject of [multiple defamations](#) by Patton West and members of her cult. He was also the subject of multiple false witness statements that Patton West had told her employees to manufacture on pain of being fired. Here is an [email from one of those employees](#) sent to Watson's lawyer retracting her false statement. While giving a statement to the [Bigfork Eagle](#) newspaper on August 9 2007 Reynolds, in what he thought was an 'off the record' conversation made the following comments to the reporter [Constance See](#).



Above: Senior cult member Geoffrey Reynolds CPA reveals Patton West's plan to murder Watson in what he thought was an 'off the record' conversation to a reporter. Just as Reynolds predicted a failed attempt was made on Watson's life days later. As predicted by Reynolds a campaign of intimidation was directed at Watson, his wife and children which 13 years later is ongoing.

Reynolds stated, and I quote, "Watson will be dead within 12 months or in jail for reacting to what Patton West was going to do to his wife and children." End quote.

Constance See took the threat seriously enough to pass it on to [John Nielsen](#), an IRS criminal investigator looking into Patton West's finances at the time. We are sure that both Constance See and John Nielson will remember the threat which was passed on to Watson and his lawyer. We are sure both will be prepared to testify as much at Reynolds' trial for racketeering and complicity to commit murder.

Because of the occult (hidden) nature of the weapon used by Patton West to carry out her extra judicial killings, no investigation took place. However, we are certain that after interviewing a few of the scores of victims over the past 30 years, it will become clear to the FBI that Patton West's 'World Service' propaganda is a front for racketeering and murder.

Reynolds must have been sure about Patton West's ability to murder Watson. Why else would Reynolds have announced Watson's impending death to the press? Reynolds must have been sure that, had Watson been murdered, that neither he or Patton West would be investigated.

The reason for Reynolds' confidence was twofold (1). the [secret weapon](#) used by Patton West to murder those who oppose her is occult in nature (hidden) and not recognized by the legal system as a weapon. (2). Patton West had 'successfully' murdered student [Lisa Swidler](#) in 2005 to stop her going to the police, and got away with it. Additionally in 2002 Jack West, Patton West's then husband, had warned John Watson that those who opposed his wife had a habit of dying suddenly. At this point we would remind the reader that only eleven months had elapsed between Reynolds' employment commencing in September 2006 and Reynolds announcing Watson's impending murder to the press in August 2007. As we shall see, Reynolds took to crime like a duck to water!

3B. After the murder plot failed Reynolds joined a 2010 conspiracy orchestrated by Patton West to bankrupt Watson into silence. The objective being to deny the public information about Patton West's criminal past.

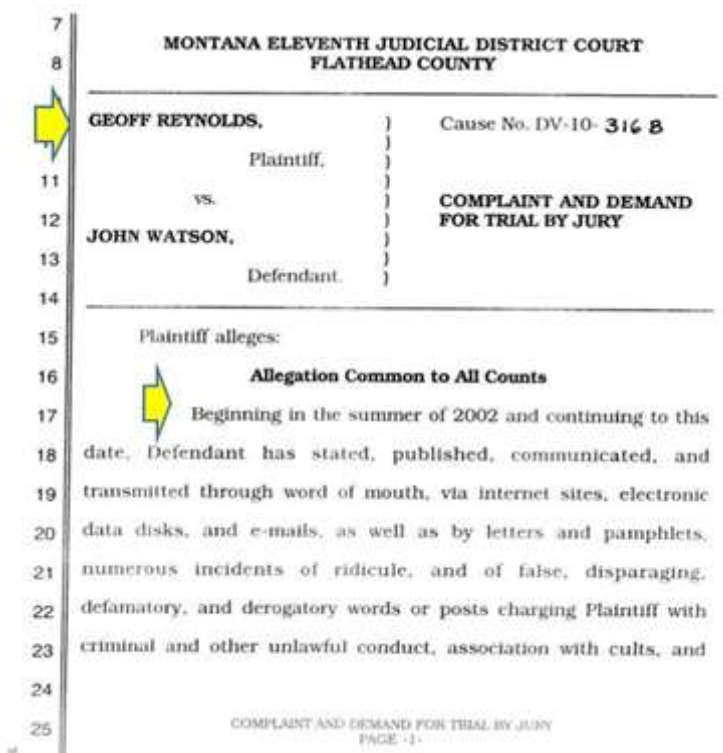
As stated earlier Watson won his fraud lawsuit against Patton West in 2008. Patton West appealed the judgment and in 2010 the judgement against Patton West was upheld. However, the financial award to Watson was reduced. While attending court in Montana in 2010, Watson was served two defamation lawsuits by Patton West & her stooge scumbag Geoffrey Reynolds. Again we would point out that Reynolds' employment started with Patton West in September 2006 and Watson's 'employment' as a consultant ended in August 2002. The point being that Reynolds did not know Watson existed until he traveled from California to Montana in September 2006. It therefore follows that Reynolds' decision to launch a lawsuit against Watson (for a defamation that did not occur) was entirely motivated by Patton West.

To be perfectly clear, scumbag Reynolds agreed to give false witness to a Montana court within which he demanded \$5,000,000 in reparations for something that never happened!

Below is an excerpt from Geoffrey Reynolds' resume as posted on [his own website in 2010](#), at the very time he made his false statements to court in Montana. Most of what Reynolds is saying below, is a pack of lies as one will quickly discern by reading the [Whitefish Pilot](#), [Bigfork Eagle](#) newspapers and a lengthy [statement](#) Patton West gave to the Montana court in 2009. This statement showed her to be \$2,000,000 in debt, close to bankruptcy for the second time and living in a caravan in Reynolds' back garden. So there were no land purchases or properties to manage and no staff of 15 to manage. However, Patton West did make it clear that Reynolds was the 'money man' controlling everything.

Senior Financial Manager, Surya Enterprises Unlimited, Inc., 2006 to 2014. Directs financial, legal, HR, IT and day-to-day operations. Securing funding and managing banking relationships. Set up and maintains accounting and computer systems. Created financial procedures and checks to secure and manage all assets. Created flexible financial projections for 1, 2, 5, 10, 20 years. Envisioned company's future and implement plans, strategies and policies to guide and direct employees to achieve it. Supervised and coordinated organization's operations and made sure employees have the resources needed to do their jobs. Over sees all operations to minimize expenses. Completely responsible financial system and all financial reporting and management reports. Managed all property under control of the company. Negotiated office leases and land purchases. Lead staff of 15.

So if Reynolds' employment commenced in September 2006, then how could Reynolds possibly have been defamed between 2002 & 2006? Below is a copy of Reynolds' pleadings to court in 2010.



Of course the answer is that Reynolds was not defamed. It was a lie. Like the four statements posted on Patton West's website, denying that she had brutally assaulted Dr. Pat Cole MD. It was lie. Like Reynolds receiving \$436,000 from Dr. Cole and posting it through Patton West's business as 'normal' business receipts, knowing it had been extorted from Cole.

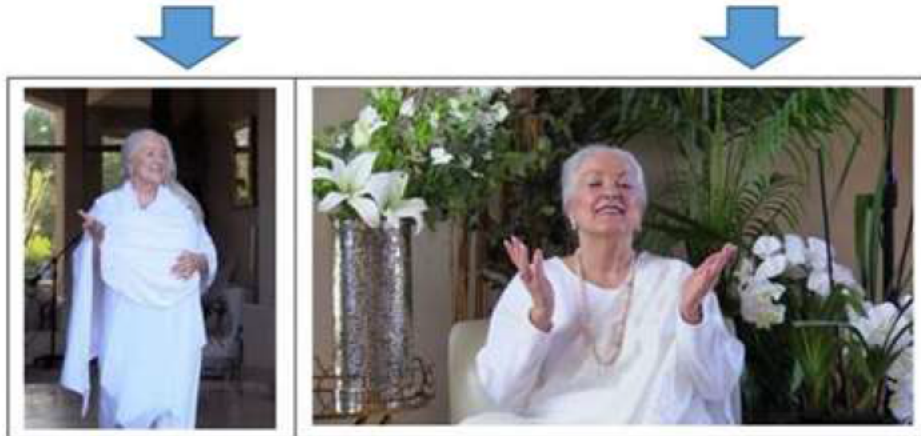
MOTIVE FOR MURDER & CRIMINAL CONSPIRACY? It was clear that Patton West's criminal racketeering business was dead in the water in Montana as long as Watson's website was up which detailed her criminality in Montana and New Mexico before that. Before Patton West, Reynolds, Williams and the rest of the cult could move on to Arizona, they had to force down Watson's websites by any means. Murdering Watson was the preferred solution, which Reynolds was quite happy to announce to the Montana press in August 2007. However after the murder plot failed Patton West, Reynolds & Williams had to wait three years until at last Watson turned up in court in Montana in 2010 after winning his fraud lawsuit against Patton West. At which point, scumbag Reynolds played his role in Patton West's conspiracy to bankrupt Watson into silence by issuing multiple frivolous (without merit) lawsuits against Watson that she hoped he could not afford to defend.

The TRUTH is an absolute defense against defamation but only if you can afford to pay lawyers to defend the truth in court. In addition to lawyers' fees (Watson had spent a lot of money and 5 years winning his fraud lawsuit against Patton West) Watson had to pay for the cost of air fares and hotel bills, as in 2005, he had emigrated abroad for safety reasons. 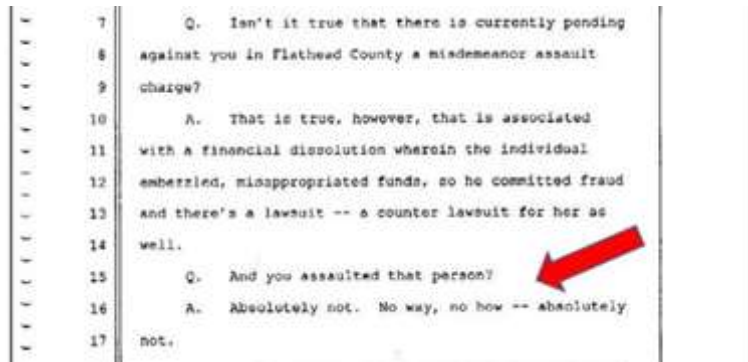

8. The vicious assault on Dr. Pat Cole MD Part 2. Patton West was convicted of the assaulting Dr. Pat Cole MD in April 2008. A scanned copy of the court documents can be reviewed by going [here](#).



Patton West's response to news of her conviction for assault appearing in a local newspaper was to post a statement on her website denying the conviction. She even states that the court dismissed the 'bogus assault case' which is a total lie.

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

Like the rest of Patton West's testimony, her answer to the court was a lie. As the [Whitefish Pilot](#) newspaper article published that very day, makes clear Patton West was in debt. The following is a quote from the that news article.

Here in the Flathead, West ran into problems over several properties where she lived. On June 1, she was evicted from a \$2 million Lakeside waterfront home when she failed to pay a second \$50,000 down payment. She then moved into another Lakeside with her son and daughter-in-law. "All she got out of the house was her cat," said Larry Phillips, a Realtor with Land Rush Realty. When asked about the eviction, West said a few weeks away from home were worth the trouble. She claims to be negotiating a better deal on the property due to a water rights dispute. According to court documents, West is behind in payments on the second home.

A month later, a second newspaper article was published by the [Bigfork Eagle](#) newspaper. Which categorically showed that Patton West was not a billionaire, not a millionaire and not even solvent. The following is a quote from that article.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute. Besides being evicted from her Bayside home

in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Patton West refers to Watson's win in court as a 'technical' error. Reynolds & Williams have failed to take into account two important facts.
