Dear John:

Here are the questions.

- 1. Tanmayo gave Devra \$60,000.0 for PPI last October in Israel and several other donations amounting to hundreds of thousands of dollars, according to Cheryl over different periods of time. What happened to that money? How come she could not afford my salary and had no funds for PPI when she had all that money?

One of these generous donors works at the CDUF as a volunteer on a daily basis. She came to ask me many times about what is happening to her money and each time I tell her 'go and ask Cheryl". Does she know that these volunteers are also suspicious of Jack's involvement in finances? Why does Cheryl keep everything secret and never publishes P&L or Balance Statements, etc...? What is she and Jack hiding?
