**CORINNE COFFIN AKA 'TANMAYO'**

For two or three decades, Ms. Coffin has been a senior member of a US based cult / criminal racketeering gang headed by self-appointed 'Planetary Regent' Devra Patton West. During her tenure Ms. Coffin has financed the cult / gang's criminal activities to the tune of millions of US dollars. Ms. Coffin is a Brazilian citizen and yet during capital controls meant to stem the flow of capital out of Brazil at the beginning of this century Ms. Coffin kept the flow of funds into the USA via intermediary's thus circumnavigating Brazilian capital control laws.

Between 2004 and 2009 only Patton West's charity was struck off for fraud in 2004. She was the subject of two arrest warrants one in 2008 and one in 2009. She was convicted in 2008 of assaulting her business partner Dr. Pat Cole MD. In 2008 she was also found guilty of defrauding another business partner John Watson. Also in 2008 Patton West was the subject of a Sheriff's Sale to force her to pay past victims of crime \$2,000,000 in court fines and interest. In spite of knowing about all the criminal acts committed by Patton West Ms. Coffin continued to fund Patton West's criminal acts (Racketeering & Domestic Terrorism) and remained as 'treasurer' of Patton West's 'front company' until 2021. Ms. Coffin only distanced herself from Patton West after her cult leader defrauded the US government out of \$500,000 in SBA Loans.

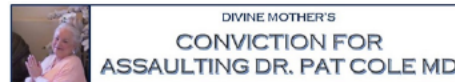

**Ms. Coffin continued to fund Patton West's cult / criminal racketeering gang regardless of the above crimes.**

Though Ms. Coffin resides mainly in Brazil the idea that she could be associated with Patton West for 25 plus years, fund Patton West's criminal activities in the USA for 25 years and not know what was going on is ridiculous. No one gives away \$1,000,000 plus without knowing how it is going to be spent is ridiculous. Ms. Coffin visited Patton West regularly the idea that Ms. Coffin did not know about the two arrest warrants, the conviction for assault and the Sheriff's Sale forcing Patton West to pay past victims of crime \$2,000,000 in court fines and interest is laughable (see above).

In March 2007 one of Patton West's employees, Rebecca, went public about the crimes being committed by Patton West on an industrial scale against her own employees. New recruits had their wages and benefits cut on day one of their employment. Patton West subsequently wrote to Rebecca stating that it was, and I quote, "**A good day to die.**"

Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). Within days of taking up employment the advertised wages are reduced and the advertised health insurance is withdrawn. By 2003 Joseph Costantino was owed \$20,000 in salary and overtime which Patton West refused to pay. After taking Patton West to an employment tribunal Joseph settled for \$10,000. In 2003 Joseph had facilitated multiple statements from employees about the crimes being committed by Patton West against them. Shortly afterwards Joseph died suddenly.

After Patton West's charity was struck off for fraud in January 2004 Patton West had no choice but to move her cult / criminal operations to a new location. Accordingly she wrote to all of her cult members telling them that she was moving to 'Shamballa' and that only those willing to commit 66% of their net worth were allowed to follow her there. Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Unfortunately for Cole she did not give up her wealth as fast enough so Patton West initiated a campaign of violent beatings to speed things up. Another employee, Carlida Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

In 2005, having just sold her home, Marion Cantwell was kidnapped by Patton West, falsely imprisoned and beaten until she agreed to make a large donation to Patton West's good causes (herself). Upon release Marion was told that she would be murdered if she went to the police. Some months later the whistleblower had a phone call from Marion's new employer. Apparently Marion had shared her experiences with her new employer who wanted to make sure that Marion was indeed a victim and not an active member of Patton West's cult / criminal racketeering gang. The whistleblower was happy to confirm that Marion was indeed a victim.

After being defrauded out of wages and shares fraud victim turned whistleblower sued Patton West a lawsuit he won in 2008. However along the way on August 9 2007 senior cult member Geoffrey Reynolds announced Watson's impending murder to a local newspaper reporter. The newspaper reporter took the threat seriously and shared it with a federal agent who was investigating Patton West at the time. Approximately one week later Patton West made a failed attempt to murder the whistleblower. As well as announcing Watson's impending murder Reynolds also announced a campaign of occult violence against Watson, his wife and children which is ongoing. More recently, in November 2023, Patton West made another attempt to murder Watson using a different tactic. Reynolds did not announce this in advance! We will share the details with law enforcement.

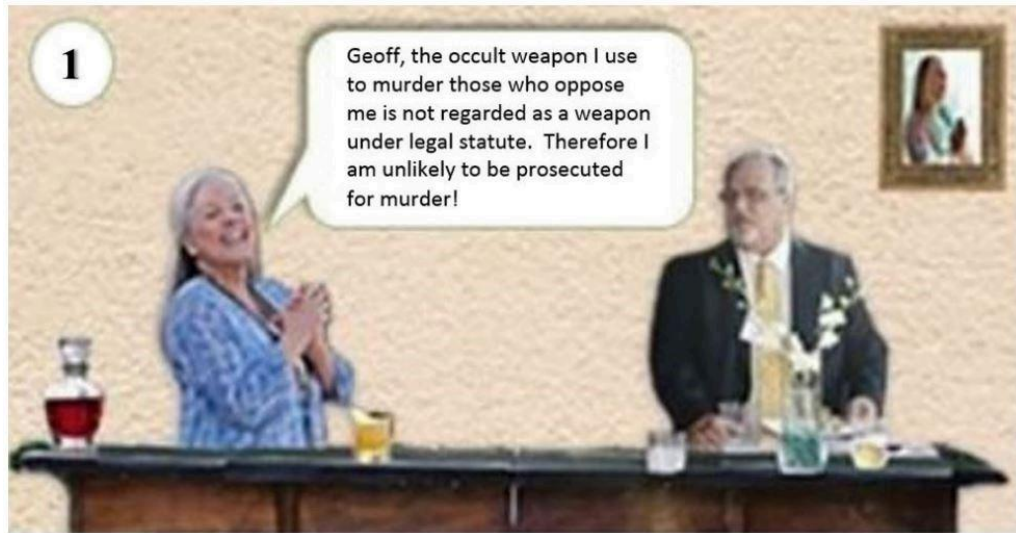

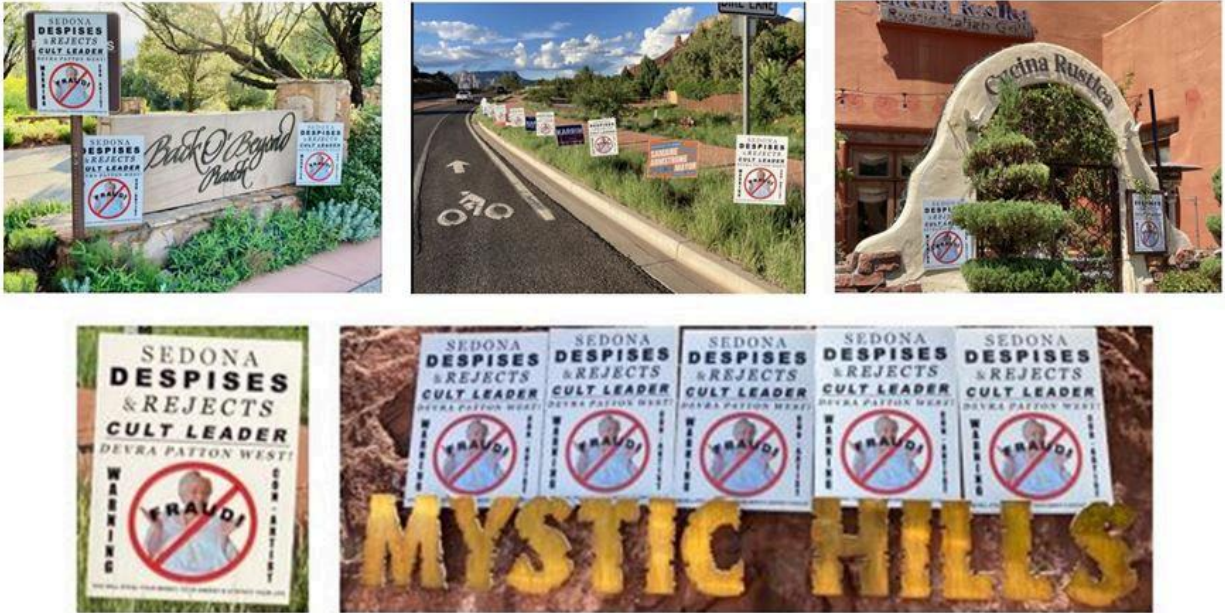
