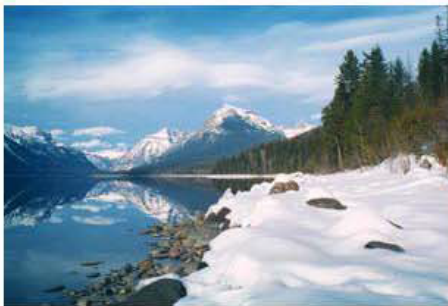

Jack West has known what Patton West has been doing for over 40 years. Corinne Coffin and Julio Williams have known what Patton West has been doing for well over two decades. Coffin and Williams are both 'disciples' of Patton West and have paid Patton West a fortune so she can teach both of them how to do to their fellow man what Patton West has been doing for decades. Reynolds, lacking a moral compass, just accepts that murder and violence are the cost of doing business.

EMPLOYEE 2. As explained above, Patton West did not want more employees that she could not afford to pay. What Patton West did want was low paid or non-paid slaves she could lord over in her cult. The following statement is by Carlida Finch, who was hired as an employee but began receiving an enormous amount of pressure to join Patton West's cult. Her statement speaks for itself...

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

Dr. West believes that the rest of the world operates out of the "lesser" mind, as opposed to the "Christ conscious" enlightened mind. Unless willing to submit to Dr. West destroying the lesser mind through her techniques of Transpersonal psychology and eastern traditions she felt her employees had no value. It is disconcerting to be forced to adopt your employer's philosophy as modus operandi for your own life and discouraging to have 35 years of experience in the work place denegated for the same reason. Devra recently stated, after hiring Ray Solanki as her business manager that she would only hire disciples as execs for the corp, leaving those who don't join her with no chance for advancement. Mr. Solanki introduced himself as "from another planet" at the first staff meeting at which he was present. Devra was unhappy with the way employees treated her, we did not stand each time she entered or left the room. In the past she had rose petals spread at her feet by disciples

Dr West was subtly abusive, she constantly extolled her "genius and brilliance" while denigrating anyone else's abilities. There was no such thing as conversation, she did all the talking even talking over everyone else. I tried to just humor her and keep my job as it paid well. How does one talk to one's employer about their abusive behavior?

The above are comments from just two employees. Here are links to two other employees [Beatrice McGuire](#) and [Susannah Felder](#) who were both violently assaulted by Patton West, both in front of witnesses. This is the tip of the iceberg. This has been going on for three plus decades since 1991. Both Rebecca West (1) (2) (3) (4) and Carlida Finch (1) (2) (3) lodged complaints and each attended employment tribunals. BUSINESS CONSULTANT 1. Dr. Pat Cole MD was a so called business partner of Patton West. As Patton West made very clear in her interview with the whistleblower, John Watson in 2003, (which he recorded) Patton West does [not have partners](#). In the same interview Patton West stated that she was a [control freak](#), that her [agreements were worthless](#) and that she disposes of people [like used Kleenex](#). Of course she does not tell any of her victims this in advance, they have to find this out for themselves!

In January 2004, Patton West's charity was struck off the Montana charity register, after the authorities received evidence from the whistleblower that Patton West and her then husband, Jack West, were defrauding the charity out of hundreds of thousands of dollars in public donations. In response, Patton West announced that she was moving a hundred miles north in Montana from Victor MT to Lakeside MT, which she referred to as 'Shamballa.' She wrote to the mailing list of her cult announcing that only those willing to commit 66% of their net worth to Patton West would be allowed to join her in Shamballa. Unfortunately for Dr. Cole, she committed to join Patton West in Lakeside (Shamballa) knowing she was expected to give up 66% of her net worth. Long story short, Patton West got tired of waiting for her business partner to hand over her wealth so she commenced a campaign of violent assaults against Cole, which led to the police being called and Patton West being charged with assault.



Patton West viciously assaulted Dr. Pat Cole MD on a number of occasions as part of the process of extorting \$1.3M from Cole. During one of the assaults Patton West repeatedly hit Cole over the head with the heel of her shoe until blood ran down the victims' blouse.

Patton West was overheard by another employee stating that, because she was an enlightened being, she did not care about murdering Cole because she, Patton West, would be just as comfortable in a \$6M mansion as in a 6' X 6' jail cell!

Patton West was convicted of assaulting Cole in 2008.



Dr. Cole MD was one of scores of victims who joined Patton West's cult on the promise of 'enlightenment.' Fearing for her life and being brutalized daily, Cole signed over her home to Patton West (worth \$750,000) and paid \$436,000 to Patton West for an 'internship' and for 'therapy.' Basically, Patton West took every cent Cole had plus \$50,000 that Cole was 'persuaded' to borrow from her aunt. BUSINESS CONSULTANT 2 John Watson joined Patton West as a consultant in January 2002, leaving after being defrauded in August 2002. After Watson launched a fraud lawsuit against Patton West in 2003 and put up a website to warn the public in 2006, he became the victim of countless [defamations](#) at the hands of Patton West and the senior members of her cult.

In December 2006 Watson, his wife and children became the victims of a campaign of [occult violence](#) directed at them by Patton West (see above image). Patton West is an Occult Master. However, that information / knowledge was never intended to fall into the hands of someone who is mentally unstable. Patton West only acquired this knowledge after prolific use of banned substances and 18 months of training. Since 1991, Patton West has used the occult (hidden) knowledge she acquired between 1990 & 1991 while attending the Robert Jaffe School for Energy Mastery, as a weapon with which to feather her own financial nest at the expense of everyone she has met since.

Senior cult member Geoffrey Reynolds, knew of Patton West's secret weapon and knew she had murdered before with impunity. Being an ex-marine, the threat of murder did not bother Watson who continued with his lawsuit which [he won in 2008](#). Having failed to intimidate or murder Watson, Patton West, with the help of fellow conspirators Reynolds and Williams, mounted multiple frivolous lawsuits against Watson hoping to outspend him in court which is exactly what happened.

After being defrauded out of pay and shares business consultant John Watson successfully sued Patton West for fraud and won that lawsuit in 2008. Along the way Watson put up his own website and caused three newspaper articles to be published about Patton West's criminal activities in Montana. This eventually led to the cult leaving Montana. Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.
Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.
After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.
Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.
Justice of the Peace David Orsley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.
West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.
West's trial originally was scheduled for April 2007. Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.
