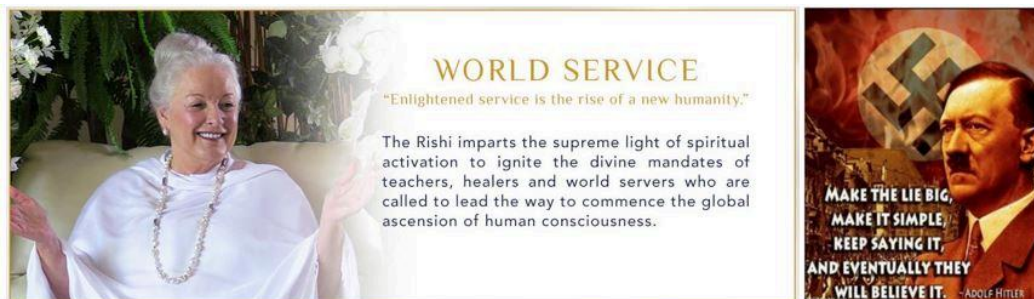


### **The highlights low points so far...**

1995. Dr. Pat Cole was a member of Patton West's cult in New Mexico as evidenced by [the file she gave to the police](#) citing dozens of abuses by Patton West between 1991 through to 1995. Patton West was forced to flee New Mexico chased by one of her gun wielding victims who understood the police were totally impotent.

2004. In January 2004 Patton West's charity 'The Circle of Divine Unity' was [struck off](#) the Montana charity register after fraud victim turned whistleblower John Watson reported Patton West's criminal activities to the Secretary of State for Montana! Patton West has since tried to murder Watson twice once in 2007 and again in 2023.

2004. Realising that she owed \$2,000,000 in court fines and interest to previous victims of crime, Patton West did three things. The first was to steal the charity's main asset, a property in Victor MT worth \$1,250,000 in 2004, putting it in a trust fund for herself and her son Rob Meador. The second thing she did was to empty the charity's property of \$4,000,000 in art work and valuables and hid them in a lock up for ten years. The third thing she did was tell her brainwashed and conditioned cult / gang members that she was moving to Shamballa. In reality Patton West was moving 100 miles north to Lakeside MT. Then Patton West told the members of her cult that she could only take the wealthy members of her cult with her to Shamballa and only those who promised to give Patton West 66% of their net worth to fund her luxurious lifestyle costs.



2006. Though Dr. Cole MD agreed to move to Shamballa (LOL) with Patton West she did not hand over 66% of her wealth fast enough. To move things along at a faster pace Patton West launched a campaign of violence against Dr. Cole whose obvious intent was to intimidate / force Dr. Cole to hand over her wealth. After one particularly vicious attack during which Patton West repeatedly hit Cole over the head with the heel of her shoe causing blood to run down on to Cole's blouse the police were called.

2007. As a result of the violence Dr. Cole handed over her entire net worth estimated at \$1.3 million to Patton West which included signing her home over to Patton West and included a [\\$50,000 loan](#) Cole was 'forced' to borrow from her aunt. The [Whitefish Pilot](#) newspaper gives details

about the assault.

2008. Patton West was found guilty of assaulting Cole but because Patton West got the 'liars for hire' in her cult to issue false statements denying the assault Patton West was [found guilty of misdemeanor assault](#), was fined \$500 and given a 6 month suspended prison sentence. Which was a joke because Patton West never stopped attacking Cole or any of her other victims. Instead of overt face to face violence (which Patton West gets off on) instead she used her occult weapon knowing no one would be able to prove that she was causing illness and injury to Cole.



*Above: Giving a criminally insane narcissist like Patton West occult knowledge is like giving a rabid gorilla a loaded machine gun. For 32 plus years Patton West has used that knowledge as a weapon to rob, defraud, extort and violently assault victims in three western states. Those who oppose her are subject, like Watson and family, to violence and murder. Because the weapon used to facilitate serious crime is not a knife, a gun, poison etc. the police have done nothing – so far.*

Patton West acquired occult (hidden) knowledge while attending the '[Robert Jaffe School for Energy Mastery](#)' for eighteen months between 1990 & 1991. Since then she has been operating her own school for occult studies. Below here are a list of the attacks directed at fraud victim turned whistleblower John Watson. These include the following:-

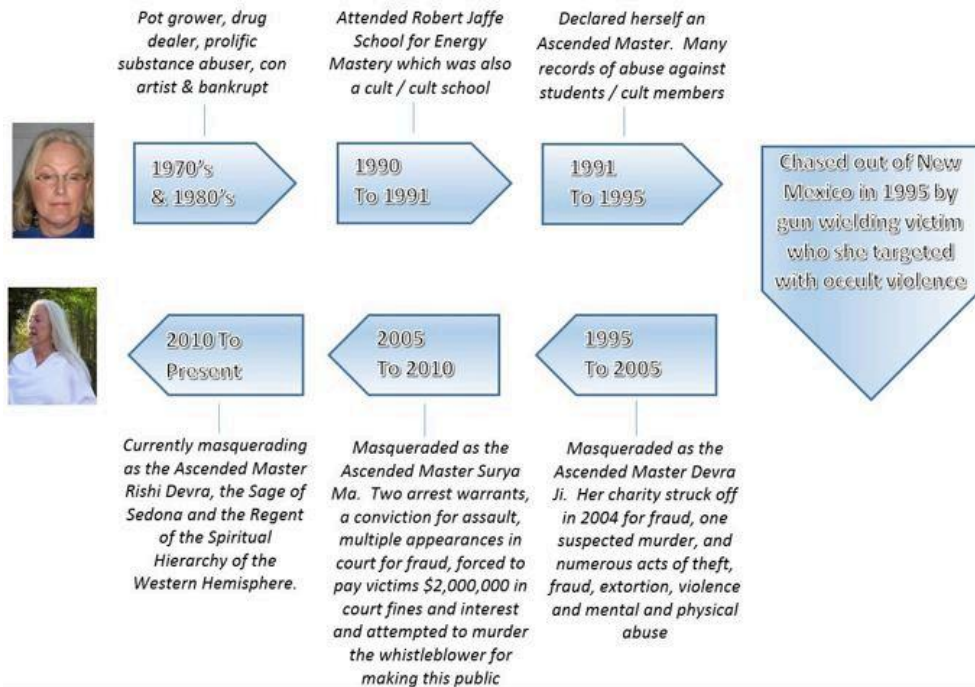

Here is an excerpt from the missive entitled '[Financial Form Building](#)', which was sent out to the entire cult mailing list telling them that they need to hand over 66% of their net worth to fund Patton West's lifestyle costs...

You will find the truth in the quiet sanctuary of your hearts of which I speak. You will also find the gateway to a abundance which is God's love, as you make your way through the ~~fire~~ demand of Truth.

For now, I will only say that there are none of you who are as yet fulfilling the standards of criteria for passage into the domain that the Masters will be anchoring at the Shamballa Sanctuary. As yet most of you are in the 30% to 40% range of balance of truth with me. You must fulfill balance of truth with me as well as with the ashram. Shirley and Lisa are approaching the 60% "wonder mark" and I hope will soon anchor a solid 66% exponential factor for both requirements. I remind you that at 66% the wheel turns, and the manner and timing of manifestation "time jumps" and this includes the truth of abundance. It is for this reason that I have been required to step out of the group energetic. I am in a time jump that is the reflection of my light and this is not to be disturbed by negative thought form. There can be no sacred manifestation in lower time. I can not succeed through co-creation with ~~miasim~~. I can co-create with the to varying degrees with the Trusted Disciple. This increases as you increase you light.



I am also in great, great faith that you will wish to rapidly seek the ~~necessary~~ fulfillment of your sacrifice, so that you are in ~~responsibility~~ and balance with your Master Teacher and with your Ashram. Above: The red arrow highlights the demand for 66% before her 'students' can move to Shamballa with her. The yellow arrow refers to Patton West's comments about being in 'balance' with your Master Teacher. The blue arrow refers to the evil of money and the accusations that her 'students' are not giving enough i.e. are 'withholding' their own money!

Prior to the assault on Cole that led the police to become involved Patton West was overheard talking about murdering Cole. Here is an excerpt from a statement made to the authorities by employee Carlida Finch. You can read Caarlida's statement in full by going [here](#).

### Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

Above: Carlida refers to the 'Law of Severity' (see below). It speaks volumes to Patton West's mental state that she would think that an enlightened person would murder another human. Patton West had previously threatened to break every bone in Cole's hands. On the 17th as Carlida explains, Cole came to work with bruises on her hands. The document that Carlida found written by Patton West shows just how incredibly evil Patton West is. In the previous image Patton West lectures her minions about 'withholding' their money from her. In the missive referred to above entitled 'The Law of severity etc.' Patton West manufactures a totally fictitious conversation with long dead Ascended Masters whose role is to justify Patton West's vicious assault on Cole. In Patton West's haste to demonize Cole Patton West asserts that Cole was a Nazi in the WWII death camps! Patton West is mentally ill and an obvious and clear danger to the public.

After the assault and the police being called there was such upset and trauma within the cult at what Patton West had done. As a result Patton West issues a statement which she posted to her entire mailing list. The missive was entitled 'The Law of Severity on the Path to Purification.' Below here is a short excerpt from that missive which on its own should be enough to put Patton West into a mental institution for the rest of her life but apparently, so far at least, lunatics like Patton West can get away with anything if they pretend to be a quasi religious organization or a cult.

April 17, 2006 From Master El Morya of the Shamballa Councils

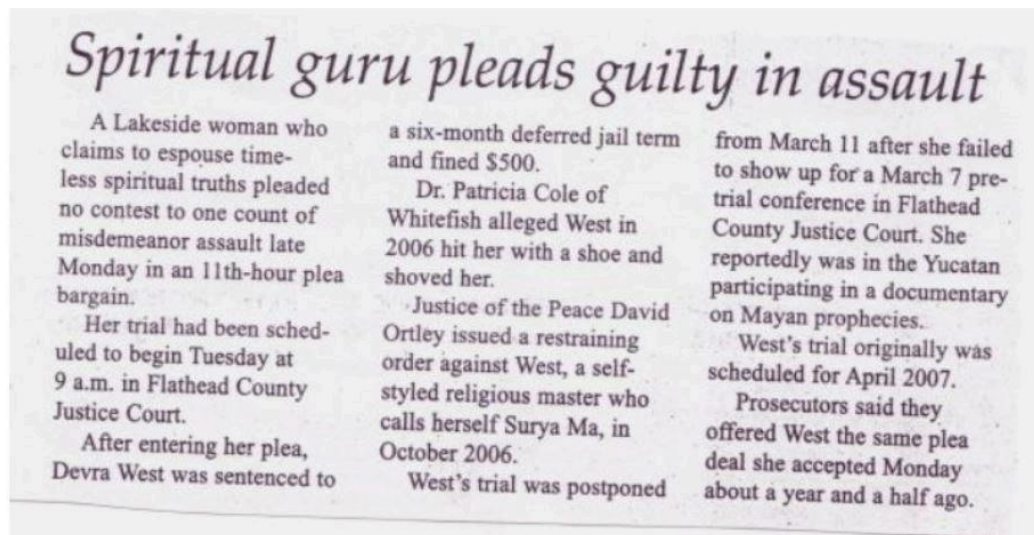

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. In case anyone doubts Watson's claims about two murder attempts here, coincidentally, is more evidence that murder is used as a tool. The ability to use her occult [secret weapon](#) to commit murder and commit scores of lesser crimes and get away with it for 32 plus years, is all the justification Patton West needs to elevate her status to that of a minor deity! Below here are a small portion of her victims subject to threats of violence and murder...

### CRIMINALLY INSANE NARCISSIST



In March 2007 one of Patton West's employees, Rebecca, went public about the crimes being committed by Patton West on an industrial scale against her own employees. In response Patton West used her 'secret weapon' against Rebecca who asked the whistleblower for help dealing with Patton West's "Shamanic witchcraft." In her email Rebecca wrote about the huge turnover in employees. New recruits had their wages and benefits cut on day one of their employment. Patton West subsequently wrote to Rebecca stating that it was, and I quote, "A good day to die."



Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). Within days of taking up employment the advertised wages are reduced and the advertised health insurance is withdrawn. By 2003 Joseph Costantino was owed \$20,000 in salary and overtime which Patton West refused to pay. After taking Patton West to an employment tribunal Joseph settled for \$10,000. In 2003 Joseph had facilitated multiple statements from employees about the crimes being committed by Patton West against them. Shortly afterwards Joseph died suddenly.

MURDER AN ACCEPTABLE COST OF DOING BUSINESS?



In 2005 Lisa Swidler, a student and teacher at Patton West's unaccredited school for occult studies, died suddenly and unexpectedly leaving behind two small children under the age of 10 years. Maybe it was a total coincidence that at the time of her sudden death Lisa had fled the cult and was likely going to the police to report three serious crimes she had witnessed Patton West committing against other 'students.' Dave Kushner was defrauded out of \$30K. Mike Hendrickson defrauded out of \$200K. And last but not least Marion Cantwell was kidnapped, held hostage and beaten until she agreed to make a large donation to Patton West from the sale proceeds of her house.

MURDER AN ACCEPTABLE COST OF DOING BUSINESS?



After Patton West's charity was struck off for fraud in January 2004 Patton West had no choice but to move her cult / criminal operations to a new location. Accordingly she wrote to all of her cult members telling them that she was moving to 'Shamballa' and that only those willing to commit 66% of their net worth were allowed to follow her there. Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Unfortunately for Cole she did not give up her wealth as fast enough so Patton West initiated a campaign of violent beatings to speed things up. Another employee, Carlida Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

*Above left to right: Senior cult members Julio Williams (2000 to 2021), Geoffrey Reynolds (2006 to 2014), Corinne Coffin (1995 to 2021) and last but not least Jack West (1970's to present day). None of the aforementioned rats were bothered about the murders or crime being committed on an industrial basis by Patton West. They worshipped Patton West's ability to murder with impunity. Williams & Coffin only decided to leave the cult in 2021 after Patton West defrauded the US government out of \$500K in SBA Loans understanding that unlike individual victims the US Gov. has endless resources to prosecute organized crime.*

## 2. RACKETEER INFLUENCED AND CORRUPT ORGANIZATIONS (ACT)

Under RICO, a person who has committed "at least two acts of racketeering activity" drawn from a list of 35 crimes—27 federal crimes and 8 state crimes—within a 10-year period can be charged with racketeering if such acts are related in one of four specified ways to an "enterprise".<sup>[citation needed]</sup> Those found guilty of racketeering can be fined up to \$25,000 and sentenced to 20 years in prison per racketeering count.<sup>[citation needed]</sup> In addition, the racketeer must forfeit all ill-gotten gains and interest in any business gained through a pattern of "racketeering activity."<sup>[citation needed]</sup>

When the U.S. Attorney decides to indict someone under RICO, they have the option of seeking a pre-trial restraining order or injunction to temporarily seize a defendant's assets and prevent the transfer of potentially forfeitable property, as well as require the defendant to put up a performance bond. This provision was placed in the law because the owners of Mafia-related shell corporations often absconded with the assets. An injunction and/or performance bond ensures that there is something to seize in the event of a guilty verdict.

We estimate that Patton West is guilty of no less than EIGHT ACTS of RACKETEERING activity within a ten year period. As [this email](#) shows Jack West has been directly involved for at least 30 years maybe 40 years so he should be tried under RICO statutes. With Reynolds and Willaims guilty of at least three ACTS of RACKETEERING each. Ms. Coffin has been funding these crimes (as has Williams) for 2 or 3 decades.
