

Dear FBI & Local Law Enforcement, last week Occult Thief / Suspected Serial Killer Devra Patton West made another concerted effort to try to murder the whistleblower after the failed murder attempt in 2007 and subsequent failed ten years of violent 'under the radar' intimidation. 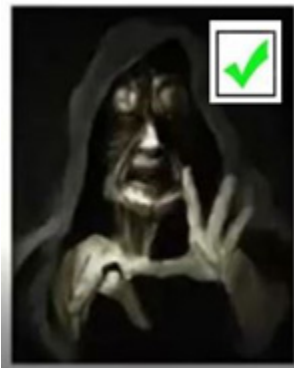
1. Never been successfully prosecuted for scores of crimes involving theft, fraud, extortion and violent assault as explained below.

If these attacks, designed to intimidate and to kill, continue against the whistleblower I may decide to send you emails on a daily basis until there is clear evidence that a criminal investigation is underway into the activities of Devra West and her murderous cult.

Before getting into the second attempt on the whistle-blower's life by **'world server'** Devra Patton West last week, let me spell out again, this vile creature's modus operandi / criminal business model.



Prior to 1990, Devra & Jack West were both small time con artists defrauding individuals like [Jeremy Samuelson](#) out of \$10,000 here and [Satya](#) out of \$6,000 there - one victim at a time. After Devra West's jewelry business went bankrupt, she decided that a career change was called for so decided to become an Ascended Master. Accordingly between 1990 and 1991, she attended a two year course at the prestigious '[Robert Jaffe School for Energy Mastery](#)' at which she acquired occult knowledge, which was to underpin her criminal business model for the next quarter of a century or more.

Devra West is not shy about bragging about her occult abilities; below here is an excerpt from an interview she gave to the [Whitefish Pilot](#) newspaper in July of 2007 after they wrote an extensive article about her criminal behavior in the Lakeside MT area.

"West claims to have been trained in [shamanic visioning](#) and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can [heal people](#) with various illnesses, including leukemia, and she plans to teach what she knows to [cardiologists and other physicians](#) when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said."

So above, highlighted in yellow:-

1. Devra West admits to being trained as a shaman.
2. No one connected to her has ever seen her 'heal' anyone and the only cardiologist that she knows is [Julio Williams MD](#), a senior member of her cult who finances her criminal activities, markets her to the public in the hope of attracting more victims and, when required, provides her with false witness statements when news of her criminality leaks outside the cult into the public domain. Such occurred in July of 2007, when the [Whitefish Pilot](#) published its news story about West's criminality.
3. The last statement highlighted in pale green in the excerpt above, should alert even the dumbest amongst her followers that she is a raving egomaniac, who has drunk too much of her own Kool Aide.

That Devra West is a shaman is not in doubt.

That she uses her occult knowledge to commit acts of theft, fraud and extortion is also not in doubt.

That she uses her occult knowledge to intimidate victims and unfavorable witnesses into remaining silent and not going to the police or courts for justice is not in doubt.

That she has the ability to [murder](#) those who go 'public' is not in doubt, as those who have passed through the cult and survived Devra West's so called '[world service](#)' efforts will attest.

So we know from individual victims like [Jeremy Samuelson](#) and [Satya](#), that Devra West was a con artist in the 1970's and 1980's. We know that after acquiring occult (hidden) knowledge in the early 1990's that she graduated from being a common criminal conning individual victims out of thousands of dollars, one at a time, to conning tens or scores of victims at a time out of hundreds of thousands of dollars at a time. We also know that she acquired the ability to use this knowledge to violently intimidate or even murder those victims or witnesses that went public. The murders appearing to the authorities as though the victim had died of 'natural causes.'

Fast forward a couple of decades and, after being run out of New Mexico in the night by a gun wielding victim in 1995 and being driven out of Montana in 2011 by adverse publicity, multiple arrest warrants, a conviction for assault and multiple appearances in court as the defendant in fraud related lawsuits, our wanna-be Ascended Master reincarnated herself in AZ as the Ascended Master Rishi Devra! Here is what happened when the Occult Thief / Suspected Serial Killer Devra West arrived in Cave Creek / Carefree AZ her third western state in 20 years.

(1). Up go the [flashy websites](#) packed with lies, deceit and propaganda about her past and her status as a 'divine being.' Up goes the propaganda about the 'Royal Path', a concept that does not exist outside the mind of Devra West. Up goes the propaganda about the 'Universal Archives', another concept that does not exist outside the mind of Devra West, unless you count the 'lock up' full of the self-published ravings of a mentally ill egomaniac! Then there are other preposterous statements, like her claim to be [holding open the gates of time](#) or my other favorite which is that she was [awarded her two fake doctorates by the Christ](#) in person!

However, Devra West preys on the spiritually confused and like Hitler and Goebbels, she believes that if she keeps telling the same lies over and over again, those lies will become other's truth. In fact, in a face to face meeting with the whistleblower in March of 2003, Devra West came out and claimed that the truth did not actually matter as she could convince the public that her lies were their truth. (2). By organizing her 'business model' as a cult, which is hidden inside a 'quasi religious' organization she achieves two objectives. The first is to keep the details of her criminality hidden from public view by a veil of secrecy, and secondly, she is able to make the most outrageous claims about herself and her past without fear of prosecution because all of her lies are 'protected' under religious freedom laws. This includes the obvious lies in the form of her fake 'life journey' and the testimonials given to by the senior members of her cult, who are all very aware that she uses murder as a weapon!

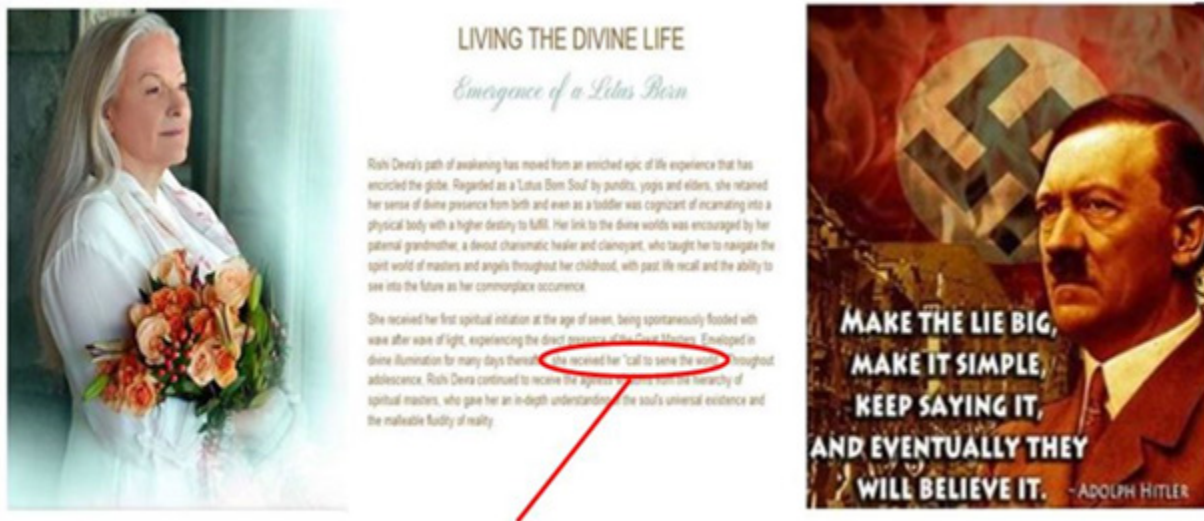
Nowhere in that fiction will you see mention of the fact that she was ran out of New Mexico, at the point of a gun by an angry victim in 1995. Nowhere in that work of fiction will you read about her reign of terror as the Ascended Master Devra Ji, between 1995 and 2004. 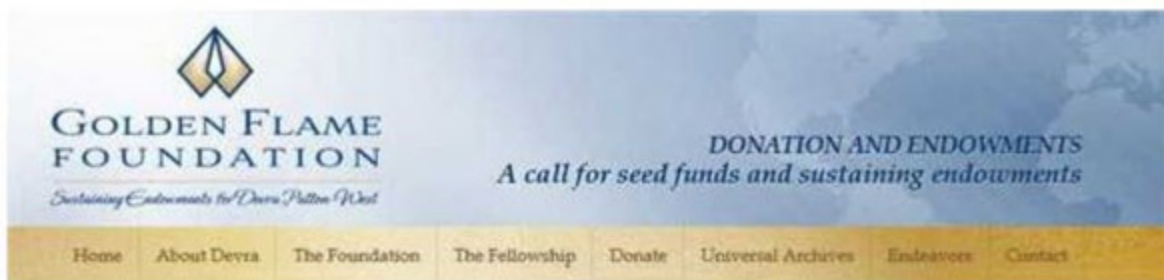
(1). Attracting huge donations elicited from the public on the basis of the lies, deceit and propaganda to be found on her website.

But what can Julio Williams do after 17 years of brainwashing and conditioning? He has little discretion to act on his own volition, as is clear from the second left image below. So as well as 'fronting' her criminal fraud scam in MT when she was calling herself the Ascended Master '**Surya Ma**', he now reprises his role of 'marketing director' and does the same for her in Arizona. Now she is calling herself 'Rishi Devra.' Williams has even gone to the lengths of **buying a property a short distance away from hers** so that he can host 'Sacred Sundays with Rishi' knowing full well that those he has helped to entrap, will become the victims of financial or violent crimes or both.

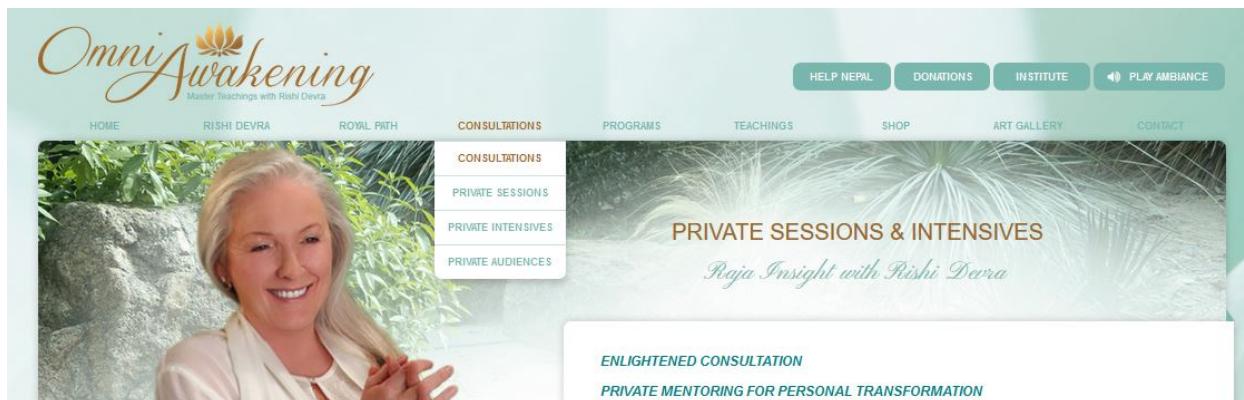
Here are examples of (2) attracting the Sheeple. The image below is self-explanatory; suffice to say, this is one of the roles that Jack west plays in the cult / criminal conspiracy.



Occult Thief Devra Patton West sits on her throne and lords over the sheeple as they hang on her every word. Jack West, Devra West's ex-husband accomplice in organized crime since the 1970's, sits amongst the new intake just as he did in 2000 when the whistle-blower was recruited from a meditation group he chaired.

His role is to meet, greet and circulate amongst the potential recruits to the cult to see which is wealthy, which has influence and who would be useful as low paid or no-paid labor. This well-oiled criminal conspiracy has not changed in its approach in two decades or more and why should it? As Devra and Jack West's guru / cult / extortion business model has netted tens of millions of dollars a year for **world service** and yet no records exist of funds going anywhere except to fund her lavish lifestyle costs.

Here are some examples of (3) wealthy donors being defrauded out of their life savings. The scam works like this. The spiritually confused attend meetings like the one above, where the wealthy are identified by Jack West, which results in a private audience. Or the spiritually confused (and hopefully wealthy) respond to the invitation [on her website](#) to have a consultation or a private session, or a private intensive.



After gaining the target's confidence with a blend of clairvoyance and ritual magic, Devra West then decides which way she is going to 'skin the cat' so to speak. There are only two approaches; the soft approach, as used on heiress Corinne Coffin AKA Tanmayo, or the hard approach, as used on Dr. Pat Cole MD.

1. The soft approach can take the form of Devra West telling the target that she and the target, (nearly always women) were sisters in another lifetime and that during that life time, the 'target' betrayed her with the result that she is now being given the opportunity to

make amends by giving a large financial donation to her. Devra West will say that their meeting was not by chance and that the Ascended Masters had brought them together to give the target a chance to make amends and burn off some karma. Devra West will go on to say that if the target does not respond and take up the generous offer to pay her \$500,000 to set matters right, the Ascended Masters will give the target a sign by visiting upon her a series of debilitating migraine headaches. Those that do not cough up the funds within a short time period, are visited with a series of migraine headaches so severe, that they render the target unable to function. The target becomes a believer and pays up!


While working for Devra West as a consultant in 2002, when she was calling herself the Ascended Master Devra Ji, the whistle-blower was informed by two of Devra West's other employees, Diane Stoner (secretary) and Kathleen Francisco (housekeeper) that Devra West had ~~extorted~~ received a donation for \$500,000 in this way. 2. Method two is to recruit the wealthy 'target' into one of Devra West's great fund raising causes, none of which are ever meant to come into reality but are used as a 'fund raising' focus by West to get the money flowing. If the target does not come forward with the required amount of funding (for her good causes – nearly always herself) the target is isolated and then mentally and physically abused by the senior members of the cult, as described here by ex-student [Debra Coffey](#). All of this is choreographed by Devra West, and if the overt violence fails, then the target becomes the subject of a campaign of under the radar occult violence designed to intimidate them into emptying their bank accounts into Devra West's.

These are the two approaches that Devra West used when calling herself the Ascended Master [Devra Ji](#) in Victor MT (between 1995 and 2004) and when she was calling herself the Ascended Master [Surya Ma](#) (between 2005 and 2010). Given the way her website is set up and the way she, [Julio Williams](#) and [Jack West](#) are still working the same well-oiled scam. Clearly, nothing has changed apart from more expensive air brushed photos and on the website, even more outrageous lies from Devra West to suck in the sheeple.

Before viewing this email, sent to the whistleblower in March of 2007, let's have a quick look at how senior cult member, Julio Williams, was marketing the Occult Thief / Suspected Serial Killer Devra West to the public in 2007. It was in the fall of 2000 when I first came into contact with Dr. Devra West, whom we graciously and fondly call "Surya Ma" (a name reflecting high honors on the spiritual path) during a transformational training at her retreat center in Montana. I quickly came to recognize that she is one of her kind among the few contemporary illumine minds here in the west. She is a modern day pioneer and visionary who lives her life as an example in service for the greater good of humanity. It was as if I had been Ignited to see and know and experience at all new levels of possibility, and as a physician, I felt privileged to receive the gold that her teachings have to offer. And I have been inspired to pass on to society at large, the tools that have empowered me to engage the philanthropic spirit in service to humanity and more over into my medical practice. She is a Master Healer because she is a Master Soul. Her very presence is a healing presence. Because she heals from a greatness of heart, she has opened my sight to my own greater capabilities as a human being.

I am delighted and honored to further her work in all ways possible and for the opportunity to serve as board member of the Global Guardianship Initiative and look forward to becoming a dynamic force in the implementation of the different projects on a long-term basis.

Now compare Williams comments with the reality of what it was like for those trapped inside the cult and being 'processed' either as low paid or no paid slaves, or as wealthy targets in the process of becoming the victims of extortion via one of the two approaches described above and favored by **'world server'** Devra Patton West.

This from employee Rebecca West, no relation to Devra West, sent to the whistleblower and posted on his website in March of 2007 at the same time senior cult member Williams was marketing the suspected serial killer to the public as a 'divine being.' The comments in square brackets are mine and I have also inserted into the email genuine testimonials given by senior members of her cult.

Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with

her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

[The above reference to more than 30 employees coming and going reflects the 'revolving' door policy Devra West has to employees. If they submit to her will and become low paid or no paid members of her cult they can stay. If they refuse to submit to her will and join the cult they are fired before the 90 days is up after which she has to pay employment insurance!]

I have written her a letter that I have been hesitant on sending her, as I know it will create a wave of violent behavior and I have little to protect myself. My only safety net per law enforcement is to write a "Letter of No Contact" and mail it. If she stalks me, and I have this letter in hand, law enforcement will respond and then maybe the Judge will order a "no stalking order" against her! I have been hiding in my home for many days now, afraid to go anywhere. This whole situation has been a horrible drain on my relationship with my partner, as he is having a very difficult time trying to understand what I am going through. In fact most "men" think it is no big deal, "if she comes after you "you can kick her ass!", what are you so afraid of?" This attitude is pervasive and includes her current finance controller [Geoffrey Reynolds CPA], whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates me before, during and after work, and advises if she comes after me, I should just kick her ass!



Rishi Devra has been guiding my life for many years. I am honored that she allows me to help her global awakening move forward.

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. **I need support in how to deal with her shamanic witchcraft. Can you tell me more?**

[Note the comments from Rebecca West about 'shamanic witchcraft' being used against her and Dr. Cole MD. Here is a quote from another email also sent by Rebecca on [March 9th 2007](#). "I very much have the support of local law enforcement as the photos of Pat's beatings candidly show the truth and which she calls [Core Impacting and/or Shamanic Blows!](#)"]

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available. Again the crux is finding a law firm willing to take the case without a hourly payment of services.

With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her.

[Here we see Rebecca describe the 'hard' approach used by Devra West to extort Dr. Cole's entire net worth.]

I am aware that the only person still financially supporting Devra (the finance controller [Geoffrey Reynolds CPA] is out of money), is Dr. Julio Williams and he gave her \$100,000 last week.

Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through.

Tanmayo's (coca-cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000.

[Tanmayo (coca cola heiress) has been on the receiving end of the soft approach for many years and was one of the wealthy targets being milked of her fortune in 2002 when the whistleblower was acting as a consultant. I guess in 2007 her son finally got to see how much of his inheritance had been passed to Devra West. In addition to the 'sister act' that Devra West uses she also uses brainwashing and ritual magic on targets as can be seen in [this email](#) sent to Tanmayo shortly after her wealthy father died. See how many times Devra West mentions the word 'gold' in her email to Tanmayo.]

You can see that I, Dr. Cole and many others have much to lose and confidentiality between us is very important. I tried to talk to Dr. Cole about you and she feels you took your case too far...I will not pass judgment until you show me otherwise and beg of you to realize the vulnerable position I am in by living only 5 miles

from her! I am more than willing to talk to your Attorney to support the situation, all I ask is for your assistance in attempting to get my hard earned monies owed me through the MT ST Wage and Labor Board. I am aware there are several other former employees that filed claims with the MT ST Wage and Labor Board and any documentation or advice to support me in this endeavor would be greatly appreciated.

I know that unless the \$30M comes in this week, the Naka Shela Retreat Center is lost to foreclosure along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his wife Jamie, and their newborn and 7-year daughters living upstairs. Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month.

[The \$30M referred to was the fraudulent application of \$30,000,000 in CPEA grant money by Devra West and Geoffrey Reynolds. It is unlikely that Devra West told the truth about her past, or the fact that she was running a cult when applying for the funds. It is also unlikely that Devra West declared that at least \$2,000,000 of these funds were to be diverted to pay off her debts, as is obvious from other correspondence between Rebecca West and West's step mother Carol Patton whom West defrauded \$30,000 from.]

I just spoke with the finance controller this morning, and he is telling me that unless I talk to Devra today, I can forget about the monies owed me. I reminded him that a missing paycheck and overtime are due me even if she calls it a "Bonus" and that several other people have taken her to the labor board and I would be no different. I have asked him to lay me off and to explain to her the repercussions of not paying me before I am forced to file a claim. I also told him I had no intentions of talking to her as I had already sent her a letter requesting the monies owed me, before I would be willing to talk to her. She responded a couple days ago by sending an e-mail to my private address where she stated she would not read my letter. It is obvious that she is afraid of me or she would have fired me already! I know too much, am a local resident, and have worked extensively with local law enforcement as a former Administrator of Emergency Services.

[In the above paragraph, Rebecca talks about missing pay checks and making a complaint to the labor board. Another employee who made a complaint to the labor board was Carlida Finch, who alleged that she was given the choice to join the cult or be fired. Carlida also overheard Devra West planning the murder of Dr. Pat Cole, but her murder was called off after Dr. Cole MD agreed to "donate" her entire net worth amounting to \$1.3 million and an additional \$50,000 she was forced to borrow from a wealthy aunt.]

Dr. Cole and I are very afraid, but this does not preclude me from standing up for what is right even if I lose my life over it! Until last week Dr. Cole thought she was all alone and was happy just to have a normal life again. Upon contacting her for the first time last week, (since the court hearing last November), she realizes and accepts the fact that there are many other victims, including myself and it is unfair for her not to come forward in an effort to stop Devra from continuing her deceit

and corruption of innocent people. Unfortunately, it always comes back to a money issue and the fact that she has hidden her assets in her home which is about to be foreclosed on. (This very much alarms me as this may be the only way to get some of the money back to those she has robbed).

[Devra West uses murder and the threat of murder as a weapon, so anyone not emptying their bank account quick enough or going public about what goes on inside the cult has every reason to be afraid.]

I have followed the \$30M CPEA funding issue closely and although the monies are earmarked for a 3-Tier Business Plan to develop Spas is the very way to pay off her debt to all of us. If she thought for a moment that she could buy her way out would do so in a heartbeat even though she vindicates herself through the Masters as needing to prove she has done nothing wrong. According to the Masters, Dr. Cole and all the others got their due punishment and their reputations need to be destroyed in the interest of saving ourselves from their evil.

[As explained above, the application for the \$30,000,000 in CPEA grants was fraudulent and, had the application been successful, Devra West would have used millions of those dollars to pay off her debts. Because the application failed, Devra West became the subject in 2008 of a Sheriff's Sale to force her to pay her creditors the \$2,000,000 she owed them in court fines and interest.]

I know that I can never be in the same room with her again, due to her ability to read my mind. I am not sure how she does this and would greatly appreciate any light you can shed on her abilities. I must continue filling out a job application, so I will end for now. You can trust me and I pray you will do the same for us by keeping this information confidential. We are awaiting an answer from the Attorneys as to whether they will take this case without monies being paid upfront. If not, would Jennifer Lint be willing to take our cases based on the additional 30+ people who have suffered? She must have a wealth of knowledge due to the many years of her involvement. It is too bad she quit working for you, and if it would help for me to talk to her, I would be willing to do so, but at this point only if the local attorneys are unable to do so, (we will know tomorrow).

[Above, Rebecca West refers to Devra West's ability to read her mind and later on in that paragraph refers to some 30+ people who have suffered – the tip of the iceberg I am sure.]

If you align with Hendrickson's Attorney instead, would he be willing to help us? I have the ability to bring to you 30+ former employees and with your 40 former students/employees statements maybe we can stop her! Devra checks your website daily so be careful for our sake. In addition, she has her computer technician check your site daily and at this point he has turned coat, although he has been my friend for 25 years! This only goes to show everyone how powerful her web of influence has on people!

[Rebecca refers to Mike Hendrickson, who was defrauded out of \$200,000. But rather than become the victim of occult attacks or murder, decided to walk away empty handed like most victims do.]

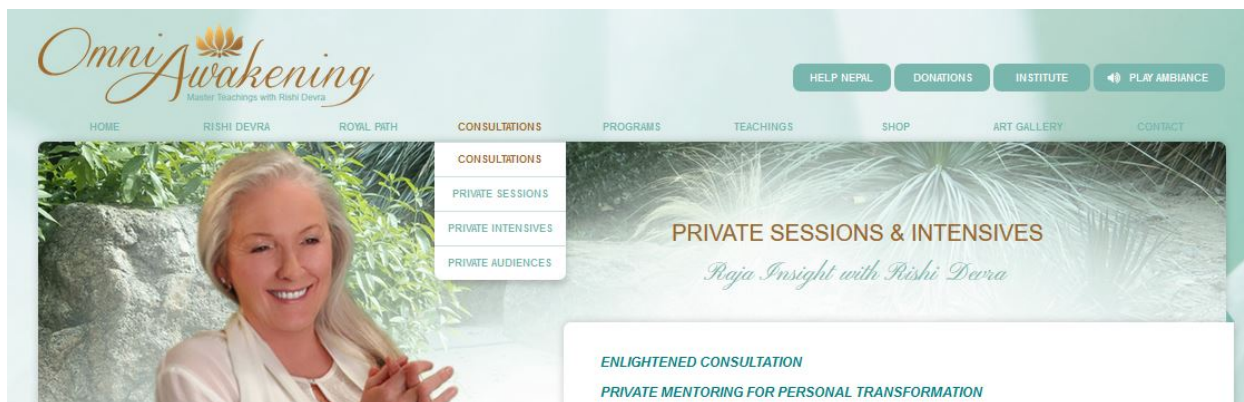

Shortly after these emails were sent by Rebecca West, the whistleblower sent them, and all the other information that he had gathered about Devra West while researching his lawsuit against her, to the press. On 12 July 2017, the [Whitefish Pilot](#) newspaper published their story, to be followed by the [Bigfork Eagle](#) newspaper, who published their story on August 9 2007. Both stories effectively made it clear to the public that the 'divine being' routine that Devra West and her cult were using to attract the spiritually confused to the cult, like moths to a flame and often with the same result, was a pack of lies.

In the following two years, Devra West became the subject of two arrest warrants, one for criminal check fraud and one for felony theft, was convicted of assaulting her business partner Dr. Cole MD and became the subject of a Sheriff's Sale to force her to pay her creditors \$2,000,000 in court fines and interest. As a result of the publicity he had caused that effectively made Montana a no-go area for Devra West and her cult, the whistleblower became the subject of a murder plot by Devra West, which Geoffrey Reynolds CPA blurted out to the press, in what he thought was an off the record comment he made while being interviewed by the Bigfork Eagle reporter on August 9 2007.

Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortleby issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

CONVICTION FOR FOR ASSAULT

What you will see are lots of lies, propaganda, deceit from the 'liars for hire,' the senior members of her cult, who try to convince you, as does 'Chief of Marketing' Julio Williams MD that Rishi Devra is a 'Divine Being.'

Last week, believing that the whistleblower was directly responsible (again) for using the truth to jeopardize her multi-million dollar a year criminal business model, the Occult Thief / Suspected Serial Killer Devra Patton West decided to target the whistleblower for murder once again. Believing that she is totally beyond the reach of the law (in spite of the fact that there are now scores of victims) and having the plausible deniability that her occult murder weapon offers the normal bouts of daily / nightly 'under the radar violence' were ramped up to a level that Devra West hoped would result in the death of the whistleblower.

To be clear, she hoped that the **core impacting shamanic blows to the whistleblower's head, as described by Rebecca West, and as used against targets of extortion on a regular basis, would result in not just sever migraine headaches, but also death.**

In 2005, after witnessing Devra West extort \$30,000 from student Dave Kushner and after witnessing the kidnapping, false imprisonment and extortion for tens of thousands of dollars from student Marion Cantwell, student Lisa Swidler tried to escape the cult and died suddenly of 'internal bleeding.' The whistleblower is convinced that Lisa Swidler was murdered by Devra West to keep her quiet.



In 2007, employee [Carlida Finch](#) overheard Devra West planning the murder of Dr. Cole MD. Below, is part of her statement to the authorities.

Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

At the time of the 2007 murder attempt by Devra West against the whistleblower, senior cult member [Geoffrey Reynolds CPA](#) was not only aware of what Devra West was going to do, but predicted the murder some three weeks before the attempt was made to the Bigfork Eagle news reporter. Some ten years and with her criminal business model in danger again (from the truth) it is the turn of yet another senior member of the cult to be complicit in the latest murder plot this time Dr. Julio Williams MD.

I BELIEVE THAT DEVRA WEST IS A COLD BLOODED KILLER.

For the past three years, the whistleblower has been sending on average two emails a week to Julio Williams MD (not a party to the frivolous lawsuit launched by West & Reynolds in 2010) for the purpose of laying a 'paper trail' which could be used as evidence in a criminal court at a later date, to convict Devra West and the rest of the cult for their crimes. To date, this amounts to over 300 emails which are in effect a daily log of the 'under the radar' violence directed at the whistleblower by the occult killer Devra Patton West - whom Julio Williams is closely aligned with.

However, never once has Julio Williams MD shared any of these emails with the police, FBI or the authorities; as to do so would bring attention to the cult's criminal activities and his part in them. It is also obvious that Julio Williams has been passing on the whistleblower's emails to Devra West, as within an hour of the whistleblower sending some of the emails to Williams, telling him that he and the rest of the cult are going to jail, another attack is launched by Devra West in response. Proof, if further proof was needed of Williams' complicity in the murder conspiracy.

I would once again ask the FBI and Local Law Enforcement to use this information to launch an investigation into what is a murderous criminal conspiracy run by Devra West, who with the help of her accomplices, presents herself fraudulently to the public as a **'world server'** when in reality she is an Occult Thief / Suspected Serial Killer. Here once again are 30 examples of her **'world service.'**

The following examples, in reverse chronological order, occurred during Devra Patton West's incarnation as the Ascended Master 'Surya Ma' in Lakeside Montana between 2005 and 2011.

1. Arrest Warrant for **Felony Theft** December 16 2009.
2. Judgement against Devra West (and son Chris Haywood) **for fraud**; both had ignored the court proceedings brought against them by 'Top to Bottom Construction.'
3. Arrest Warrant for **Criminal Check** Fraud April 16 2008.
4. Conviction for Assault April 2008; Newspaper article **announcing conviction**, Devra West's **written admission** of April 17 2006 that she had assaulted Dr. Cole MD, West's denial and subsequent **clarification by newspaper** that West was guilty.
5. **Judgment** handed to the whistleblower in October 2008 by a Montana court finding that Devra Patton West had defrauded him; newspaper article in **Ravalli Republic** announcing judgment.
6. On 20 May 2008, Devra West became the subject of a **Sheriff's Sale** to force her to pay \$2,000,000 in court fines and interest to her creditors arising from her earlier **'world service'** efforts as the Ascended Master Devra Ji between 1995 and 2004.

7. In 2007, Devra West's criminal activities became the subject of two newspaper articles published in the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers. While these two articles are informative, they do not truly show the scope of West's criminality, most of which is hidden inside the cult.

8. The fraudulent depiction of a multi-million dollar lakeside property on her website and in her brochures as belonging to her; this property described as 'Surya Ma's Abode' in reality, belonged to Robert & Tabby Ivy, who over a two year period repeatedly asked Devra West not to use images of their property. See July 12 2007 [Whitefish Pilot](#) news article for details.

9. Also on July 12 2007, Devra West appeared in court as a witness for her son in his attempt to get custody of his infant daughter from his estranged wife. During her appearance in court, Devra West described her businesses as [multi-billion dollar enterprises](#) even though at the time, she had a lien against her for [unpaid employment insurance](#) and was in the process of being evicted from two rental properties in quick succession.

10. While in court, she was asked by counsel about the many ex-employees that had posted statements on the whistle-blower's website, alleging that they were mentally and physically abused by her. The Master Liar's response was to say that many of those mentioned on the whistle-blower's site were [fictitious or fabricated](#). Below is a graphic which shows how her 'business model' works; the photograph contains most of the employees (and some students) that Devra West says do not exist!

11. Devra West, with the aid of senior cult member [Geoffrey Reynolds CPA](#), had fraudulently applied for \$30,000,000 in CPEA grant money; when the grants were denied Devra West, owing millions in court fines, decided to 'harvest' one of the wealthier members of her cult – Dr. Pat Cole MD.

12. Devra West is a vicious and violent criminal who uses her occult knowledge to terrorize both victims and witnesses into silence. Here is a short excerpt from a harrowing email [entitled 'Help Me'](#) that Rebecca West (no relation to Devra West) sent to the whistleblower in March of 2007 – Rebecca being a friend of Dr. Cole's and a witness to Devra West's brutality towards her.

"I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I

need support in how to deal with her shamanic witchcraft. Can you tell me more?"

Clearly, the con artist Devra West could not allow news of her brutality towards members of the herd trapped inside her cult to escape into the public domain it might interfere with her multi-million dollar a year ~~fraud-scam~~ **'world service'** efforts!

Also in 2007, the whistleblower was contacted via his website by Michelle Fetveit a Lakeside MT neighbor of Devra West's after she got into a 'water dispute' with Devra West. As with Rebecca West (and countless other victims) Michelle reported being the subject of 'occult' attacks and was also woken up at 3.00 am each morning. The whistleblower has never met either of these women and yet they both report being subject to the exact same phenomena – the common denominator being Devra West. 13. Around this time Devra West, already a Master in what she calls the malleable fluidity of reality (lies, deceit and propaganda) announced that she was single handedly [holding open the gates of time!](#) This in addition to an earlier statement to her students insisting that her two doctorates were [presented to her by the Christ](#) in person.

14. On or around the 14 April 2006, Devra Patton West viciously assaulted Dr. Pat Cole MD who was both a 'student' and business partner of Devra West's. The assault was part of a well-orchestrated campaign of violence aimed at extorting \$1.3 million from Dr. Cole, which Devra West succeeded in doing. This story, along with many other crimes being carried out by Devra West at the time, is covered by two news articles that were published by the [Whitefish Pilot](#) & [Bigfork Eagle](#) on July 12 2007 and August 9 2007 respectively; see point (7) above.

15. Following the assault, which shocked many of the witnesses present, Devra West issued a written statement to her entire mailing list seeking to justify the assault by saying that the victim was a Nazi in the WWII death camps in another lifetime and that though the assault was severe, it was at all times administered with grace. Here is a link to the missive she sent out after the assault it is entitled ['The Law of Severity on the Path to Purification'](#) evidence enough that Devra West is a dangerous psychopath. Devra West would later deny that she had assaulted Dr. Cole MD, fail to turn up for court hearings and was found guilty by the courts in April 2008.

The following examples, in reverse chronological order, occurred during Devra Patton West's incarnation as the Ascended Master 'Devra Ji' in Victor Montana between 1995 and 2005.

16. In 2005, after her Victor MT charity was struck off, desperate for funds and owing \$2,000,000 in court fines and interest to creditors Devra West, still posing as the Ascended Master Devra Ji, [wrote to her mailing list](#) in an attempt to bully the individual rank and file cult members into giving up to 66% of their net worth to her. Within that missive she made the following statement:-

“It will be your privilege to seed my financial transition.”

17. In 2005, some eighteen months after issuing legal proceedings against Devra West for fraud, the whistleblower became the subject of a campaign of defamation, character assassination and dirty tricks at the hands of Devra West and her cult. This took the form of a [defamatory statement](#) posted on Devra West’s website by three of her cult members amongst them Dr. Julio Williams MD. He also received a [threatening email](#) from Julio Williams MD, stating that he was personally going to fund Surya Ma’s legal expenses to the tune of \$2,000,000 and that the whistleblower should not “fu*k with him or else.”

The whistleblower was also advised by a friend still in the cult, that Devra West had ordered her employees to ‘manufacture’ false statements about the whistleblower or be fired for refusing! [This link](#) leads to an email from a member of the cult, who later retracted her false statement.

18. Ingrid Bayer, a teacher at Devra West’s unaccredited school, wrote to the whistleblower stating that her 6 year old son had been abused by Devra West; here is a short excerpt from Ingrid’s statement which can be read in full by following [this link](#).

“I am a firsthand witness to the [physical and emotional abuse from Devra as I experienced it myself, as well as witnessing the abuse of my 6 year old son by Devra.](#)”

Perhaps Ingrid’s 6 year old son represented a threat to the beast’s [‘world service’](#) efforts?

19. Lisa Swidler, student and confidant to Devra West, died suddenly and mysteriously of ‘natural causes’ after witnessing two serious crimes that were committed by Devra West against two other students to West’s unaccredited school. Lisa broke away from the cult and died shortly after, leaving behind two small children under age ten. The whistle-blower believes she was murdered by Devra West to keep her quiet.

20. Sometime in 2005, Devra Patton West without a business container to run her fraud scam from and heavily in debt, allegedly kidnapped student [Marion Cantwell](#), held her captive, beat her and only released her after Marion agreed to ‘donate’ tens of thousands of dollars from the sale of her home to Devra West. I suspect this money was not for [‘world service.’](#)

21. [Dave Kushner](#), a student of Devra West’s, was defrauded out of \$30,000 by Devra West this money supposed to be a two week bridging loan. Dave Kushner never got a penny back and Devra West refused to ever speak to him about it. Rather than become a murder victim Dave Kushner decided not to go to the police or to court for restitution even though he had a signed agreement from Devra West in respect of the loan! As Devra West made clear to the whistle-blower in 2003 [her agreements are worth nothing!](#)

22. In 2004, student Mike Hendrickson was defrauded out of \$200,000, as after signing a note at the bank to guarantee the charity’s overdraft of \$200,000, Devra West emptied the bank account and put the \$200,000 in a personal trust fund for herself and her eldest son, Rob Meador. Mike is mentioned in the [Whitefish Pilot](#) news article; he too chose to walk away rather than become a potential murder victim.

23. At around this time, the whistleblower received [an email from Judy Morris](#), an ex-student / cult member, that was part of Devra West's European group of students informing him that many of the European students had taken out loans and mortgages to give money to Devra West. They were told, and I quote, "The more they gave the more God would love them."

24. Around this time, according to another student, Elaine, who wrote to the whistleblower in 2009 about a conversation in 2004, Devra West bragged about her ability to attract wealth – no mention of 'world service' here is an excerpt from Elaine's email.

While Devra is obviously a pathological liar, she unwittingly reveals herself quite frequently because she can't keep her own mouth shut and so loves to brag. This was more than five years ago -- in the course of bragging about her ability to attract wealth, she explicitly stated she doesn't have any bank accounts because she didn't need them in order to be wealthy. She then pointed out that at that very moment she was wearing \$250,000 worth of emeralds. And she implied she had a lot more than what she was wearing. She's so sure she's smarter than everyone else, I doubt the jewels are very far away and I strongly suspect she has at least a million in jewellery.

Maybe the jewelry, precious metals and the millions in artwork and valuables stolen from the Montana charity will be combined to fund her ['world service'](#) efforts?

25. In 2004, having had her charity, The Circle of Divine Unity, struck off for fraud in November 2003, Devra West perpetrated a massive fraud on that charity which resulted in her stealing a property from the charity paid for by public donation worth \$1,250,000 (2003 valuation) which she put into a personal trust fund for her and her son Rob Meador. Former board member of that charity [AJ White](#) describes the theft of \$80,000 from that charity by Devra West and the conversation she had with Devra West about the charity's finances during which Devra West stated that all the money belonged to her!

26. At the same time, Devra West stole \$4,000,000 (2002 valuation) of artwork and valuables and hid them in a lock-up until the statute of limitations on theft passed, at which time in 2014, these items appeared at auction in Cave Creek AZ and as for sale from her website. In a statement given under oath (she is a compulsive liar) while being [deposed in October 2009](#) Devra West stated that the art work and valuables on a list shown to her by the lawyer did not exist, were not hers and if they did exist were stolen. These are the very items that were being auctioned by her in 2014 or as for sale from her website; many of these stolen items they are still being advertised for sale as the 'Rishi Collection' from her website under the ['art gallery'](#) tab. Who says organized crime does not pay.

27. On November 23, 2003, Devra West's charity 'The Circle of Divine Unity' was struck off the Montana charity register after rampant fraud was discovered by Devra and Jack West who were found to be using public money given as donations for certain projects being used to fund their lifestyle costs including the purchase of jewelry by Devra West.

28. In March of 2003, Devra West asked for and was given an opportunity to meet with the whistleblower in private at his property in Victor MT. Notionally the meeting was to see if they could settle their differences without going to law; fearing some kind of trick or stunt by Devra West the whistleblower made an audio recording of their encounter which turned out to be nothing more than Devra West threatening him if he went to law. In 2002, while attending a function held in Montreal by Devra West, student [**Beatrice McGuire**](#) was viciously assaulted by Devra West to the extent that she needed plastic surgery to repair a torn ear. The reason for the attack was that Beatrice challenged some of the obvious lies being spouted by Devra West. Although the attack took place in front of scores of witnesses, Devra West later stated that her recollection of the incident was different to that of the victim's. None the less, Devra West had her charity pay the medical costs of repairing Beatrice's ear.

30. In 2000, employee [**Susannah Felder**](#) was viciously attacked by Devra West with the result that Susannah was partially scalped by Devra West.
