In truth this dangerous psychopath has evaded trial for murder and other serious crimes because witnesses live under the threat of murder and for the most part are too afraid to come forward and testify against her.

While we wait for the police and the authorities to bring her into custody for:-

- **1. MURDER.** The perceived wisdom is that in 2005 Devra West murdered cult member Lisa Swidler. Devra West had motive and opportunity to be discussed in greater detail below.
- **2. Threatened Murder.** In 2006 Devra West was, according to another member of her cult, planning to murder Dr. Pat Cole MD, a senior cult member and business partner of Devra West's. Devra West had motive and opportunity to be discussed in greater detail below.
- **3. Attempted Murder.** In 2007 Devra West planned to murder the whistleblower after he went public about the inner workings of her cult. Senior cult member Geoffrey Reynolds, shared the plan to murder the whistleblower, in what he thought was an 'off the record' discussion with a news reporter two weeks before Devra West made her failed attempt on the whistleblower's life. Devra West had motive and opportunity to be discussed in greater detail below.
- **4. Theft, Fraud & Extortion.** Several well documented counts of theft, fraud and extortion mainly against the members of her own cult.

Let us drill down into the detail of one of her best documented crimes, understanding that the main purpose of the cult that Devra West ran in Montana between 1995 and 2010 (and New Mexico before that) was to keep all details of her criminality hidden from the public. In the case of item (2.) on the list above, the **threatened murder** of a local female doctor **while extorting \$1.3 million from her**, the bond of secrecy was broken when another victim inside the cult wrote a series of harrowing emails to the whistleblower. That victim's name was Rebecca West (no relation to Devra West).

Rebecca was first a friend of Dr. Cole's and like her, also trapped inside Devra West's cult though from outside the cult it would appear that Rebecca West and Dr. Cole MD were just employees of one of many failed businesses which were operated by Devra West as a 'front' for racketeering and organized crime. Because of Rebecca's bravery, the world got to know about the terrible conditions being suffered by those trapped inside Devra West's cult which was being run by her as a medieval fiefdom inside modern day America, right under the authorities' noses. Below is an email that Rebecca West sent the

whistleblower in March 2007; this email makes it crystal clear that Devra West is no guru, no Ascended Master but that she is a card carrying psychopath who ran a revolving door policy in terms of the recruitment of employees. Two things become obvious from reading this email.

- 1. Devra West was recruiting employees for non-existent jobs from all over the USA. If those employees did not submit to her will after brainwashing and conditioning to become low paid / no paid members of her cult she would fire them before the end of 90 days after which she would have to pay employment insurance.
- 2. Employees and students alike were treated like cattle / serfs and were forced to 'donate' part of their net worth to fund the luxury lifestyle and finance the delusions of someone who is clearly criminally insane. Her mental health combined with her ability to terrorize or murder victims and witnesses with plausible deniability was / is a powerful weapon that Devra West does not hesitate to use. After 27 years of getting away with serious crime she now believes her own rhetoric about being a 'divine being' and so theft, fraud and extortion are morphed into 'donations' and violence is morphed into 'therapy.'

Here is that email; the highlighting and comments in square brackets are mine....

Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining [1]. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred [2]. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant) [3].

I have written her a letter that I have been hesitant on sending her, as I know it will create a wave of violent behavior and I have little to protect myself [4]. My only safety net per law enforcement is to write a "Letter of No Contact" and mail it. If she stalks me, and I have this letter in hand, law enforcement will respond and then maybe the Judge will order a "no stalking order" against her! I have been hiding in my home for many days now, afraid to go anywhere [5]. This whole situation has been a horrible drain on my relationship with my partner, as he is having a very difficult time trying to understand what I am going through. In fact most "men" think it is no big deal, "if she comes after you "you can kick her ass!", what are you so afraid of [6]?" This attitude is pervasive and includes her current finance controller [Geoffrey Reynolds CPA], whom she has extorted from him over \$300,000 since Sept 06' [7]. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates me before, during and after work, and advises if she comes after me, I should just kick her ass [8]!

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more [9]?

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is

available [10]. Again the crux is finding a law firm willing to take the case without a hourly payment of services. With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her [11].

I am aware that the only person still financially supporting Devra (the finance controller is out of money), is Dr. Julio Williams and he gave her \$100,000 last week [12]. Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through [13].

Tanmayo's (coca-cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000 [14].

You can see that I, Dr. Cole and many others have much to lose and confidentiality between us is very important. I tried to talk to Dr. Cole about you and she feels you took your case too far...I will not pass judgment until you show me otherwise and beg of you to realize the vulnerable position I am in by living only 5 miles from her! I am more than willing to talk to your Attorney to support the situation, all I ask is for your assistance in attempting to get my hard earned monies owed me through the MT ST Wage and Labor Board. I am aware there are several other former employees that filed claims with the MT ST Wage and Labor Board and any documentation or advice to support me in this endeavor would be greatly appreciated [15].

I know that unless the \$30M comes in this week [16], the Naka Shela Retreat Center is lost to foreclosure [17] along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his wife Jamie, and their newborn and 7-year daughters living upstairs. Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating [18]. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month.

I just spoke with the finance controller this morning, and he is telling me that unless I talk to Devra today, I can forget about the monies owed me [19]. I reminded him that a missing paycheck and overtime are due me even if she calls it a "Bonus" and that several other people have taken her to the labor board and I would be no different. I have asked him to lay me off and to explain to her the repercussions of not paying me before I am forced to file a claim. I also told him I had no intentions of talking to her as I had already sent her a letter requesting the monies owed me, before I would be willing to talk to her. She responded a couple days ago by sending an e-mail to my private address where she stated she would not read my letter [20]. It is obvious that she is afraid of me or she would have fired me already! I know too much, am a local resident, and have worked extensively with local law enforcement as a former Administrator of Emergency Services.

Dr. Cole and I are very afraid, but this does not preclude me from standing up for what is right even if I lose my life over it [21]! Until last week Dr. Cole thought she was all alone and was happy just to have a normal life again. Upon contacting her for the first time last week, (since the court hearing last November), she realizes and accepts the fact that there are many other victims [22], including myself and it is unfair for her not to come forward in an effort to stop Devra from continuing her deceit and corruption of innocent people [23]. Unfortunately, it always comes back to a money issue and the fact that she has hidden her assets in her home which is about to be foreclosed on [24]. (This very much alarms me as this may be the only way to get some of the money back to those she has robbed).

I have followed the \$30M CPEA funding issue closely and although the monies are earmarked for a 3-Tier Business Plan to develop Spas is the very way to pay off her debt to all of us [25]. If she thought for a moment that she could buy her way out would do so in a heartbeat even though she vindicates herself through the Masters as needing to prove she has done nothing wrong [26]. According to the Masters, Dr. Cole and all the others got their due punishment and their reputations need to be destroyed in the interest of saving ourselves from their evil [27].

I know that I can never be in the same room with her again, due to her ability to read my mind. I am not sure how she does this and would greatly appreciate any light you can shed on her abilities [28]. I must continue filling out a job application, so I will end for now. You can trust me and I pray you will do the same for us by keeping this information confidential. We are awaiting an answer from the Attorneys as to whether they will take this case without monies being paid upfront. If not, would Jennifer Lint be willing to take our cases based on the additional 30+ people who have suffered? She must have a wealth of knowledge due to the many years of her involvement. It is too bad she quit working for you, and if it would help for me to talk to her, I would be willing to do so, but at this point only if the local attorneys are unable to do so, (we will know tomorrow).

If you align with Hendrickson's Attorney instead, would he be willing to help us [29]? I have the ability to bring to you 30+ former employees and with your 40 former students/employees statements maybe we can stop her [30]! Devra checks your website daily so be careful for our sake. In addition, she has her computer technician check your site daily and at this point he has turned coat, although he has been my friend for 25 years! This only goes to show everyone how powerful her web of influence has on people [31]!


Let me now comment on each of the many points raised by the above email, which clearly shows that Devra Patton West, then calling herself the Ascended Master 'Surya Ma,' was (and is now) running a criminal / racketeering business model and that disguised as a guru she commits acts of theft, fraud, extortion, violent assaults and even murder in the course of running her criminal enterprise.

1. Against all employment and state laws Devra West was advertising non-existent jobs to people who would travel from all over the USA only to be told on arrival that the there was a 'misunderstanding' about the wages offered and that they would have to accept a pay cut of 20% on day one. Additionally the healthcare benefits advertised were never provided. If new employees refused to 'submit' to the will of the Master Abuser they were fired before the end of the 90 day period after which Devra West would have to pay employment insurance. In fact when the story of West's criminality broke in the Whitefish Pilot newspaper it became clear that Devra West, though posing as a billionaire business woman, was \$2,000,000 in debt had a lien against her for unpaid employment insurance.

2 & 24. Devra West's criminal / racketeering business model was based on her ability to manipulate, thieve, defraud and extort money from employees and students trapped inside her cult to fund her luxurious lifestyle and finance her delusions of grandeur. The following illustration shows how this works.





Put simply at its core Devra Patton West's 'business model' is a well-oiled criminal conspiracy which is hidden inside a cult which is in turn hidden inside a quasi-religious outer shell. The appearance of being a religious organization allows Devra West to tell the most outrageous lies about herself, allows her to morph theft, fraud and extortion into 'donations' and violence into 'therapy.' For the most part of all of this crime is kept hidden inside the cult.

The public face of the current iteration of criminal / racketeering business model is known as the 'omniawakening' with the underlying legal 'container' being the 'Golden Flame Foundation' an Arizona corporation. The 'container' used by Devra West in Flathead Lake MT was 'Sacred Environments LLC' and before that in Victor MT it was a charity 'The Circle of Divine Unity.' In brief her details of her real history / life story prior to 2007 include the following:-

- 1. There are records that speak to the fact that many persons were mentally and physically abused by Devra West in New Mexico before she moved to Montana, having been chased out of NM in the middle of the night by one gun wielding victim who wanted to take the law into his own hands. The <u>records Dr.</u>

 Pat Cole handed over to the Flathead Sheriff's department touch upon this.
- 2. While operating as the Ascended Master 'Devra Ji' between 1995 and 2004 in Victor MT, Devra West defrauded / extorted money from three cult members <u>David Kushner</u>, <u>Marion Cantwell</u> and <u>Mike</u> <u>Hendrickson</u> and murdered a third, <u>Lisa Swidler</u>, to keep her from going to the authorities.
- 3. After her charity was <u>struck off</u> by the Secretary of State for Montana for fraud in January 2014, Devra West stole the charity's main asset <u>a property</u> worth \$1,250,000 (as valued in 2002), which was funded largely by public donations, and put it in a private trust fund for her and her eldest son Rob Meador. At the same time she stole \$4,000,000 worth of <u>artwork and valuables</u> (as valued in 2002) from the charity, also paid for largely by public donations, and hid the items in a lock up until after the statute of limitations for theft passed. In 2014, some of these items appeared at auction in Cave Creek AZ and as for sale from her website. Currently, they can be seen featured on her website under the <u>'art gallery'</u> tab. Unfortunately for Devra West, a prolific liar, there is a record of her being questioned under oath in 2009 when she stated that the items did not exist, were never hers, that she said goodbye to all possessions and that most were stolen or lost! - **3.** Under state law it is not permitted for an employer to unilaterally demote an employee and reduce their wages. That said, Devra West's cult was not subject to state / federal law as she had a lengthy supply of other cult members to act as false witnesses for her making it near impossible for victims of crime to get justice at employment tribunals, in civil and criminal courts.
- **4. & 5.** Again, Devra West was in effect running her own fiefdom which for reasons explained above was not subject to federal or state laws. Because of her ability to use fear to manipulate others, her abuses and acts of violence were for the most part kept secret inside her cult.
- **6.** What victims like Rebecca West and scores before her are afraid of is both the physical violence meted out by Devra West on victims, like <u>Susannah Felder</u> and <u>Beatrice McGuire</u> (one being partially scalped the other needing plastic surgery) and the covert, 'under the radar' violence courtesy of her occult abilities occult abilities mentioned by Rebecca West in her email and commented on below here.
- **7 & 8.** Geoffrey Reynolds CPA was recruited just like all the other employees and professionals that were duped into believing that she was a real employer and that they were applying for real jobs. In Reynolds' case, not only did he end up being unwittingly recruited into her cult but shortly after joining her cult he was duped by the Master Manipulator into loaning her his life savings amounting to \$300,000. The result was that Reynolds, if he ever wanted to see his \$300,000 back, became a willing accomplice in her criminal racketeering business model the highlights of which were money laundering the proceeds of crime through her business, complicity in the plot to murder the whistleblower and when that failed he 'fronted' a criminal conspiracy masterminded by Devra West to bankrupt the whistleblower. The motive? To silence the whistleblower from sharing the very information you are reading now which if widely disseminated amongst the public would end her multi-million dollar a year criminal / racketeering business model.

Long story short, Reynolds ignored the pleas for help from Rebecca even though he was well aware of the crimes being committed around him by his 'employer' Devra West.



- **9 & 28.** Up until attending the 'Robert Jaffe School for Energy Mastery' between 1990 & 1991, Devra West and her then husband, Jack West were pot growers and small time crooks, defrauding individuals out of several thousand dollars at a time as victims <u>Jeremy Samuelson</u> and <u>Satya</u> attest. In fact, Satya attended the energy school at the same time as Devra West and described her as, and I quote, "A deeply disturbed psychopathic person / personality." After acquiring occult (hidden) knowledge at the energy school Devra West psychosis expressed themselves in three ways:-
- 1. She announced that she was an Ascended master and that anyone not agreeing was 'blocking the energies.'
- 2. Her criminal / delusional / mental health issues combined with the ability to make ill, injure and even murder victims with plausible deniability gave her a 'god complex' with the result that she felt she could justifiably prey on us lesser beings. Lesser beings being everyone she came into contact with since her self-elevation to the

status of a minor deity and more recently her self-elevation to <u>'The Regent of the Spiritual Hierarchy of the</u> Western Hemisphere.'

3. Rebecca asks the whistleblower how Devra West can read her mind; the answer is both simple and scary. It is a well-known fact that those working with demonic entities appear to be able to read the minds of others when in fact the demonic entity residing in the astral plane in the lower 4th dimension is reading the mind of the victim and sharing that information with the host – in the case Rebecca asks about Devra West. Nowhere is this better illustrated than with 'Demon Magicians' like Dynamo. Follow this link to the start of this video to see what appears to be 'mind reading' magic that Dynamo performs with the help of the demonic entities that he works with. The good news is that while 'magicians' like Devra West 'bind' and 'control' demonic entities to their will throughout their lifetime the deal is that when Devra West dies she will be bound to the will of the demonic entity for all eternity.

10 & 11. There are many ex-employees and ex-students who allege that they were mentally and physically abused, and in some cases, violently assaulted by Devra West. A visit to the following website will reveal scores of written and audio statements from past victims – victims who Devra West denied existed when questioned in court on July 12 2007, while appearing as a witness for her porn loving / wife beating son in a custody battle for his infant daughter against his estranged wife, Jamie Haywood. When questioned about the employees, West stated that many of them were fabricated and fictitious and when asked if she assaulted Dr. Cole she replied no way no how!

In reality on April 17 2006, days after her assault on Cole, West wrote a missive to her extensive mailing list entitled, 'The Law of Severity on the Path to Purification,' wherein she admitted the assault stating that the assault was severe but administered with grace! She went on to justify the assault to the members of her cult by saying that the victim was a Nazi in the WWII death camps in another lifetime therefore the beating was justified and long overdue! No mention of the \$1.3 million extorted by violence from Dr. Cole MD. Perhaps this is what is meant by the 'Divine Embrace?'

12. Dr. Julio Williams has been a disciple / cult member since 2000; originating from the Dominican Republic and growing up with Voodoo joining Devra West's black magic / Satanist cult was a dream come true for this weak-minded easily manipulated pawn to West's black queen.







Dr. Julio Williams seen above here on the left getting what he thinks is a 'blessing' from his occult master when in reality like the demonic entities she works with West is binding Williams to her will making him a slave to her ambition; note the dazed look on the woman in the foreground. Williams is powerless to resist her demands even if it means the destruction of his reputation and jail time for his role in funding organized crime and recruiting new victims for her to prey on. The \$100,000 'donation' referred to in Rebecca West's email is just the tip of the iceberg.

13. Rebecca West knows that Devra West converts the profits from her criminal / racketeering business into cash, jewelry and precious metals as do other students. Follow this link to read a statement from ex-student Elaine who in conversation with Devra West, who was wearing a \$250,000 emerald necklace at the time, was told that there was a lot more where that came from. And, as pointed out in item number (2.) above some \$4,000,000 worth of artwork and valuables were stolen from the charity and hidden in a lock up. It is believed that most of her illicit gains are funneled into offshore accounts with Israel being a prime location for the millions acquired through a quarter of a century of organized crime and racketeering.

14. Whether received through theft, fraud, extortion or via donations manipulated out of the wealthy money only flows one way and that is **into** the hands of Devra West never out of her hands to others or to the fake 'good' causes she uses to focus the fund raising efforts of her cult on. In the paragraph referred to here Tanmayo's son (the son of a wealthy Brazilian Coca Cola Heiress Tanmayo AKA Corinne Coffin's) demanded the millions of dollars Devra West had extorted from his mother be returned to her.



In the image above Devra West, then posing as the Ascended Master Devra Ji, shows how easy it is to extract millions of dollars from gullible wealthy females as she extracts approximately \$750,000 from wealthy heiress 'Tanmayo' for a project that never came into being! Follow this link to view a document showing the 'donations' made by Tanmayo to fund a totally non-existent project and to read a copy of the kind of emails Devra West sent to Tanmayo knowing that she was about to inherit yet more money as a result of the death of her father — money that Devra West hoped she would get the lion's share of. See how many times Devra West mentions the world 'gold' in the letter entitled 'Give Me Your Gold' that she sent to Tanmayo — clearly there was more than just subliminal suggestion going on there. No wonder Tanmayo's son was so angry.

In the same paragraph, Rebecca West refers to the fact that Geoffrey Reynolds has gotten himself into a very difficult situation after being manipulated into loaning his life savings to Devra West.





Reynolds would have to commit several serious crimes for Devra West before being repaid the monies owed to him – crimes that are now coming back to bite him as the authorities show interest in the claims that Devra West murdered Lisa Swidler, that Reynolds was complicit in the plot to murder the whistleblower and took a leading role in the conspiracy to bankrupt him.

15. As explained earlier, any action taken against Devra West, either at the labor board or in civil or criminal court, is met with dirty tricks by Devra West which include, lies, false witnesses (like the ones used against the whistleblower one of whom retracted her false statement), intimidation, threats of

violence, violence and murder. I believe that though obviously truthful and justified, Rebecca's claims to the labor board that her working environment was dangerous were thwarted by Devra West and the senior members of her cult who lied in their submissions. Below, is one such statement from senior cult member Julio Williams MD with one above from senior cult member Geoffrey Reynolds CPA.



16 & 25. The \$30,000,000 that Rebecca West referred to was the fraudulent application made by Devra West and Geoffrey Reynolds CPA for \$30M in CPEA grant money. It is unlikely that West or Reynolds declared the true nature of their 'business model' or that the only shareholder with any power to make decisions was Devra West with other members of her team being members of her cult without voices in what was a criminal racketeering business model masquerading as a legitimate business to the public, to the authorities and to prospective lenders. It is clear from Rebecca West's comments and those of Devra West's step mother, Carol Patton, that Devra West intended to use the grant money, were the application to be successful, to pay off the debts she had at the time which in 2007 amounted to \$2,000,000 or more.

I seriously doubt either West or Reynolds declared that piece of information in their submission for \$30M in grant money. Follow this link to read Carol Patton's email to the whistleblower's lawyer asking for help in getting \$30,000 back from Devra West that she was defrauded out of. Note Carol Patton's comments about Devra West getting \$33,000,000 and using that money to pay off her debts. One of those debts was approximately \$2,000,000 in court fines and interest which in 2008 would become the subject of a Sheriff's Sale i.e. Devra West being forced to sell all her belongings including the property worth \$1,250,000 that she stole from the charity in 2004 to pay off those debts. In 2013, Devra West became a party in another fraud scam this time alleging to be a victim. It turns out that in the spring of 2005 she paid a deposit of \$650,000 to the Fountain Group run by Edmund Wilson and Walter Ross. Both were subsequently prosecuted by the Securities Commission in 2013 in a legal action that included Devra West as a plaintiff; the documents relating to this court case can be reviewed by going here.

The big question that arise from the above is around the timing of the deposit of \$650,000 that she gave to Messrs. Wilson & Ross. In other words did she extort \$30,000 from ex-student Dave Kushner, tens of thousands of dollars from ex-student Marion Cantwell and \$200,000 from ex-student Mike Hendrickson all in 2005 to pay for the deposit? Or after finding out she had been defrauded by Messrs. Wilson & Ross did she steal the money from the three ex-students to make up her losses? More importantly did she murder Lisa Swidler, a witness to the crimes against Kushner and Cantwell, to keep her from going to the police?


17 & 18. It must be obvious to all by now that Devra West is no guru and certainly no planetary regent but rather a callous and vicious predator, who feels it is her right to prey on the rest of us using her occult knowledge to leverage her criminal racketeering business activities. As the third illustration in this email above clearly indicates, both employees, students and anyone else crossing Devra West's path are fair game to be ripped off by this dangerous psychopath. As referred to above, when referencing Devra West's step mother Carol Patton, no one is immune for her voracious appetite for other people's money not even relatives.

This much was echoed in her daughter in law, Jamie Haywood's, <u>email to the whistleblower</u> received in July of 2007, wherein Jamie also references living in the property extorted from Dr. Cole MD. Additionally, Jamie mentions the fact that she and her infant daughter were the subject of a campaign of occult 'under the radar' violent attacks from Devra West as she sought to intimidate her into giving up her infant daughter to West's son Chris Haywood. I suggest the reader reviews the sordid nature of Devra west's home life by reading the transcript of the custody hearing that took place on July 12 2007; you can do this by going here (1) (2) (3) to review sections 1-3.

19 & 20. As made clear earlier, Devra West was not a normal employer running a normal corporation that employed individuals in the normally understood definition of what that means. Instead, she was (and is) a dangerous psychopath running a cult that was disguised as a quasi-religious organization where in reality that outer shell hid a criminal racketeering business model that has now operated in three western states over the past 27 years and has netted Devra West tens if not hundreds of millions of dollars at the expense of scores of victims of theft, fraud, extortion, violent assaults and perhaps several murders. Under the circumstances why would this potential serial killer be in the slightest bit bothered by state employment law or the need to read an employee's letter?

21. Rebecca West would not be the first to lose her life at the hands of Devra West. We have already referred to the murder of Lisa Swidler by Devra West in 2005. As the reader will discover below, according to employee Carlida Finch, Dr. Cole was also slated for murder in 2006 until she agreed to hand over the \$1.3 million. Devra West desperately needed to pay off her huge debts referred to above. Then, in July of 2007, it became clear from the statements made by senior cult member Geoffrey Reynolds CPA to the Bigfork Eagle news reporter that the whistleblower was also slated for murder and indeed shortly after Reynolds's statements to the news reporter an attempt was made on the life of the whistleblower. In Rebecca West's case she received an email from Devra West telegraphing the threat

of murder in a way that to anyone not knowing anything about Devra West or her psychopathy would pass off as just a metaphor – and not a real threat. Here is a link to the email Devra West sent Rebecca West stating within that it was, and I quote, "A good day to die."



22 & 23. Yes there are many other victims, probably scores of victims, and this maybe the tip of the iceberg as many will be too afraid to come forward. The website referred to at the bottom of this page has a 'potted' history of some of Devra West's criminal / racketeering fraud scams and list victims many of them from inside her cult. The Whitefish Pilot & Bigfork Eagle newspapers list her criminal activities in Flathead Lake MT. Devra West has spent a fortune trying to seep the internet of anything that contradicts her 'divine being' narrative and in the case of the whistleblower when intimidation and attempted murder failed she simply joined with senior cult member and stooge, Geoffrey Reynolds CPA, in a frivolous lawsuit and outspent him in civil court; effectively neutralizing his win in court against her for defrauding him.

26 & 27. Like all psychopaths, Devra West is a pathological liar, as is confirmed by ex-student Debra Coffey who explained in her <u>statement to the whistleblower</u> that Devra West regularly assaulted students and employees saying afterwards that she did not do it God did it! Additionally as in the case of the vicious assaults on Dr. Cole MD, which culminated in Devra West extorting \$1.3 million from her (and resulted in the police being called and West later being convicted of assault), she sought to justify the assault to the rest of the cult by asserting that the victim was a Nazi in the WWII death camps in another lifetime. Here is an excerpt from <u>'The Law of Severity on the Path to Purification,'</u> wherein Devra West, pretending to be channeling the long dead Ascended Master El Morya, basically admits the assault, admits it was severe but states that it was administered by her with grace.

The Law of Severity on the Path of Purification Response to the Call of Master Surya Devi for Review

April 17, 2006 From Master El Morya of the Shamballa Counsels

At no time has Surya Ma's intentions been rooted in anything other that the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samscara remains a factor to be

If Devra West went to court to answer just a fraction of the crimes she has committed against fellow human beings, she would be either certified as mentally insane or locked up for the rest of her life. Up

until now, 'rent a liars' and assholes like senior cult members Reynolds, Williams and ex-husband Jack West have managed to keep her out of jail by supplying her with a steady flow of false witness statements making it nearly impossible for anyone to mount a case against her at the labor board or in civil court proceedings.

However, it must be obvious to all that there is now so much evidence of 'intent to cause harm' on the part of Devra West to society at large that criminal proceedings against Devra West for attempted murder. Racketeering and lesser financial crimes is highly possible.

29 & 30. Unfortunately faced with the proposition of being on the end of a campaign of dirty tricks and occult 'under the radar' violence for years to come, Mike Hendrickson, like 95% of the victims of crime at Devra West's hands chose to walk away empty handed and write off the \$200,000 he was defrauded out of. He knew that neither the police or law courts are a match for Devra West but maybe now, over a decade later, and after all the work the whistleblower has done that is about to change.

31. Yes, Devra West has been very successful at manipulating people into believing that her delusions of grandeur are a reality and that she really is a 'divine being.' She preys on spiritual seekers need for guidance by positioning herself as the answer to their prayers attracting the spiritually confused like moths to the flame often with the same outcome.

SUMMARY....

The above email is one of several harrowing emails sent by Rebecca West to the whistleblower in March of 2007 – the others can be read by going here. In June 2007 the whistleblower passed these emails (and much of the information he had gathered while researching his fraud lawsuit against Devra West) to the Whitefish Pilot newspaper group. Following several interviews with victims / affected parties the Whitefish Pilot published their story about Devra West's criminal racketeering business model in July of 2007 to be followed by another story published by the Bigfork Eagle in August 2007.

Between 2007 and 2008, while masquerading as the Ascended Master 'Surya Ma,' Devra West became the subject of the following:-

- 1. In 2008 she was the subject of an Arrest Warrant in Montana for Criminal Check Fraud.
- 2. In 2008 a Montana court Convicted of Assault.

- **3.** In 2008 Devra West became the subject of <u>'Sheriff's Sale'</u> to force her to pay her creditors (people she had defrauded in Montana) \$2,000,000 in court fines and interest.
- **4.** A Montana court granted <u>judgment against her</u> for defrauding the whistleblower out of pay and shares. One of several civil court cases against her at the time for fraud related matters.
- **5**. In 2009 a Montana court issued an <u>arrest warrant</u> against her for felony theft.

After all the negative publicity about her criminal / racketeering activities in Montana it was obvious to Devra West and her cult that the 'divine being' routine was no longer going to fly in Montana so.....







The 'Surya Ma' identity used in Montana (above left) was dispensed with to be replaced with the 'Rishi Devra' identity used (above right) in Arizona. Unfortunately for Devra West her attempts to silence whistleblower by murder and by attempting to bankrupt him failed with the result that her sordid criminal past has followed her!

Her various Ascended Master 'identities' (Devra Ji 1995 to 2005, Surya Ma 2005 to 2010, Rishi Devra 2010 to present) are created to feed her narcissistic mental health issues and with millions of dollars, acquired through 27 years of running her criminal / racketeering business model she is, like a Hollywood studio, able finance the most elaborate illusions to feed her narcissistic God complex. Lately though, not content with being just a mere Ascended Master, this narcissist has recently elevated herself to the status of 'The Regent of the Spiritual Hierarchy of the Western Hemisphere.' Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

- 1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
- 2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for those nonexistent wrongs).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! Listen to two of her admin staff, Diane Stoner and Kathleen Francisco talking about one this.


