

Dear FBI, IRS and Sedona & Scottsdale police departments,

This week's bulletin about Devra Patton West's criminal racketeering business model. This week we make the comparison between Rishi Devra (AKA Devra Patton West) & John of God (AKA Joao Teixeira de Faria). Both use their occult knowledge to commit serious crimes, including murder and both had, until recently in the case of John of God, avoided arrest for their crimes. It is clear that she is a multi-millionaire who pays little or no taxes and whom came into a windfall of several million dollars' worth of artwork and valuables that went missing from a Montana charity in 2004 only to turn up in Cave Creek AZ in 2014. I am guessing that the statute of limitations on theft is 10 years? Ms. West, as an instrument of mercy, is currently offering 'Divine Grace Healings' to the wealthy and gullible for \$500,000 each.

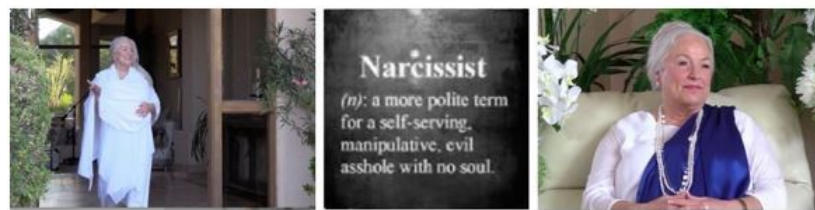

Devra Patton West's Favorite Crimes. Her M.O. (modus operandi) is centered on two of her great weaknesses; namely the need of all psychopaths to rule and control the lives of those around her and secondly, to prey on those she subjugates to her will for the purpose of amassing financial wealth through theft, fraud and extortion. Here is a brief resume of her activities in Montana.



THE PATHOLOGICAL LIAR THAT IS DEVRA PATTON WEST

Early Criminal Career. 1970's to 1990's Pot grower, drug dealer, ex-bankrupt and small time con artist who defrauded Jeremy Samuelsson out of \$10,000 and Satya out of \$6,000.

Drugs and Altered States of Reality. Unlike most narcissists who are content to live in their own fantasy world Devra Patton West wanted to populate her delusional reality with 'extras' who could play the role of serf's / students to her role as ruler / divine being. Having been a prolific abuser of dangerous drugs that took her into altered states of reality all she needed to become a divine being was the proper training in how to use those altered states of reality to manipulate the lives of others. To obtain that training she attended the Robert Jaffe School for Energy Mastery between 1990 & 1991. Upon completing that course of training she announced herself to be an Ascended Master and that anyone not agreeing was 'blocking' the energies.

The Narcissist Starts a Cult around Herself. After starting a small cult in New Mexico, where she used her occult knowledge to leverage her criminal activities, she was chased out of that state in the middle of the night by one gun wielding victim who realized that the police could not help him.

Clear Evidence of Organized Crime / Racketeering. Between 1995 and 2010 Devra Patton West changed her location within Montana twice and changed her name twice. During her reign of terror there she racked up two arrest warrants (the one on the left was for felony theft) the other for criminal check fraud. She acquired a conviction for assault and was the subject of a Sheriff's Sale to force her to pay her creditors \$2,000,000 in court fines and interest. She made several appearances in court as the defendant in fraud related lawsuits including one the whistleblower brought against her which he won in 2008.

Murder, Attempted Murder and Threats of Murder. Devra West was suspected of murdering ex-student Lisa Swidler who witnessed Devra West committing two serious crimes against two other ex-students. Dave Kushner was defrauded out of \$30,000 and the other, Marion Cantwell, was kidnapped, held captive and beaten until she agreed to "donate" tens of thousands of dollars to Devra West. Devra West threatened to murder local female doctor / heiress Dr. Pat Cole MD but allowed her to live after the victim agreed to "donate" \$1.3 million. Last but not least Devra West made a failed attempt to murder the whistleblower John Watson in July of 2007; senior cult member Geoffrey Reynolds actually announced the whistleblowers impending death to the media days before she made her attempt.

This is a small portion of the FACTS. None of which are mentioned on Devra West's website because under religious freedom laws she can tell as many lies as she wishes with little fear of prosecution. However wire and mail fraud, theft, fraud, extortion, murder and racketeering are not protected by religious freedom laws!



Like all narcissists, Devra Patton West does not see herself as at fault, no matter how bad the crimes are. As she told the whistleblower in March 2003 after she defrauded him out of wages and shares, she said that, and I quote:-

"The truth does not actually matter if I can persuade the public that my lies are their truth!"

Indeed, when she looks in the mirror she sees herself as an angel, not a devil who has wrecked scores of lives by mentally and physically abusing students, employees and business consultants that were duped into believing that she was a humanitarian not a money grabbing suspected serial killer whose only thoughts are for herself.

Brazilian prosecutors charge healer 'John of God' with rape, sexual assault



BRASILIA (Reuters) - Prosecutors on Thursday charged a disgraced Brazilian faith healer with rape and sexual assault, following his arrest after allegations from hundreds of women who said he had sexually abused them while seeking spiritual guidance or psychic healing from him. João Teixeira de Faria, known as "John of God," was arrested earlier this month and has been imprisoned since.

He became a celebrity after his healing methods were featured on Oprah Winfrey's television show in 2013 and drew thousands of Brazilians and foreigners to his spiritual centre in the small town of Abadiânia, in the central Brazilian state of Goiás.

His fame has been boosted by supposedly miraculous surgeries he claims to have performed with his hands and without anesthesia. Goiás prosecutors charged Faria on Friday on four counts of rape and sexual assault, a spokesman said in a statement. Farias has repeatedly said he is innocent. The accusers are not just Brazilian citizens, according to prosecutors, and include four women from the United States, three from Australia and three from different parts of Europe.

Spiritual leader has plans for healing center in Whitefish

A self-styled clairvoyant and spiritual healer from Lakeside who claims the Osprey House on Angel Point as a future VIP spa faces criminal charges stemming from an alleged assault on a Whitefish doctor. "She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement.

Cole claims Ms. West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself."

Photos taken after the alleged beating were submitted to the sheriff's office.

Devra Patton West's use of the Occult. She is not shy about advertising her occult abilities. The following from the same Whitefish Pilot news article referred to above:-

*An author and speaker, West claims she recognized her clairvoyant and healing gifts at age six when she began "interacting and communicating with archangel Michael," according to her book "The Christ Heart." West claims to have been trained in **shamanic visioning** and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives.*

*She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. **"If you ever saw me heal, you'd be down on your knees crying like a friggin' baby,"** West said.*

The two highlighted statements above from Devra Patton West leave us in no doubt as to what she thinks of her abilities. Let us now review what some of those around her think about her use of the occult.

1. From Employee Rebecca West. The first statement is an excerpt from a harrowing email that Rebecca West sent to the whistleblower John Watson in March 2007; Rebecca (no relation to Devra West) was West's office manager at the time. As you can see from the email, Rebecca is asking the whistleblower for help with Devra Patton West's use of shamanic witchcraft against her, Dr. Pat Cole and several other individuals.

Dr. Cole was viciously assaulted by Devra Patton West, the police were called and Devra West was charged with assault and eventually convicted in April 2008. However in March of 2007, Devra West was using occult 'under the radar' (hidden) violence to intimidate both victim and those witnesses hostile to herself, in the hope of intimidating them into withdrawing their statements against her. Here is that excerpt from Rebecca's email to the whistleblower entitled **'Help Me.'**

Dear John,

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available.

2. From Daughter-in-law Jamie Haywood. Put simply, Jamie Haywood was the estranged wife of Devra West's porn loving, wife beating son, Chris Haywood. Devra West was assisting her son to gain custody of his infant daughter from her daughter-in-law, Jamie Haywood. In addition to lining up false witnesses, bribed witnesses, Devra Patton West launched a campaign of occult 'under the radar' violence against her daughter-in-law designed to force her to give up her infant daughter to her son, who had an FBI criminal record for forgery, substance abuse and traffic violations! Below is an excerpt from Jamie Haywood's email to the whistleblower John Watson, sent to him a day or two before the custody hearing.

Hello, my name is Jamie Haywood, Chris Haywood's ex-wife. And Devra West's ex daughter in law. Well actually I am in the middle of the divorce.

I finally found this website and have been searching for you and Pat Cole due to the fact that my daughter and I have been subjected to this nasty woman. I thought that I was going crazy and thought there was something wrong with my daughter. Until my mother took me to see a true 'guide' and this wonderful woman told me that I had a spell put on me. She then started to test where it was, lo and behold in the left front side of my brain. Yea something to make me go crazy and whatever else! And that's not all; she also put one in my 11 month old daughter's internal organs. So this 'guide' took some time and finally removed these wicked spells off of me and my daughter then she told me that I would be protected.

The meaning of Jamie Haywood's email is perfectly clear. Like Rebecca West, Dr. Cole MD and others Devra Patton West was using her occult knowledge to target Jamie Haywood with occult 'under the radar' violence to intimidate the mother into giving up her baby. If that failed plan 'B' was to destroy the mother's psyche / sense of wellbeing so that when the custody court hearing was convened the mother could be made out to be mentally unstable. This did not work with Jamie Haywood who got to keep her daughter.



Above: How do you separate an infant female child from its wholesome all American Pie mother and give it to a porn loving, wife beating husband? Simple if the husband's mother is an Occult Master. She targets the mother relentlessly to the point where she thinks she is mentally ill and hay presto the father looks like a better bet!

This is not far-fetched, as this is exactly what Devra West did for her son, Chris Haywood, in his first custody battle with ex-wife, Kendall, some years earlier. In that case, the mother Kendall was relentlessly targeted day and night for months until she thought she was going crazy. Clearly, the poor woman had no idea what was happening to her and there was no one she could talk to except a psychiatrist, which totally played into Devra West's hands, as by the time the custody hearing was convened, Kendall was deemed to be mentally unstable (as intended by Devra West). As a result of Devra West's actions, Kendall ended up losing custody of her daughter to West's porn loving, wife beating son, Chris Haywood, who in the run up to the custody hearing with Kendall, had got his underage girlfriend pregnant, whom he forced her to have an abortion because it would not have looked good for him at the custody hearing with his first wife!

Please read [part 2 of the transcript](#) for the custody hearing, Haywood V Haywood, which was held on 12 July 2007. Not only does Jamie confirm Devra West's use of the occult against her and her daughter in court, but it also gives a window into the sordid home life of Devra Patton West which is in stark contrast to the stage managed photos shown on her \$100,000 plus website.

3. The whistleblower John Watson. The occult 'under the radar' violence directed at the whistleblower took the following form:-

The Subtle. Nightmares, voices in the head just before sleep announcing the whistleblowers impending death, banshee screams, gurgling sounds in the head, high pitched tones, buzzing etc. Energy directed at the target(s) intended to cause anger, upset and discord amongst couples and family members. (Many cult ex-members state that their marriages and relationships were broken by West using her doctrine of divide and conquer when populating her cult).

Not so Subtle. Telephone calls from a Montana number (where West and her cult were situated in 2007); upon answering the call, there was loud music playing (flight of the Valkyries) after listening to the music and hanging up the right ear was damaged for several days as a result of occult spells embedded in the music. Severe migraine headaches, the feeling that the scalp is burning. The aforementioned often lasts for days. Partial paralysis of one side of the body, normally a leg; this attack accompanied by extreme pain down one side of the body. Attacks on the kidneys and vital organs, muscles seizing up such that one can hardly walk - this accompanied by severe pain.

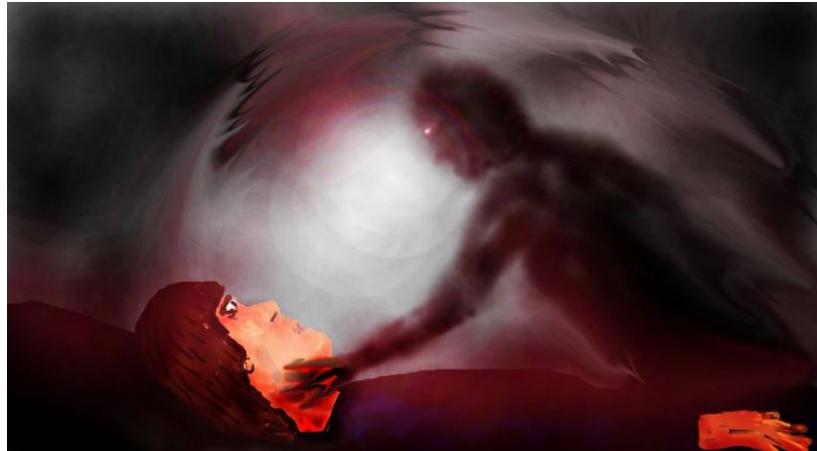


Devra West's criminal / racketeering business model is entirely based on her ability to use occult 'under the radar' violence and intimidation against victims and witnesses of crime and not be called to account. Clearly, Geoffrey Reynolds was briefed about the murder of the whistleblower why else would this scum bag announce the whistleblower's impending murder to a newspaper reporter two weeks before Devra West made her attempt.

Attacks on sinuses causing them to run continually, attacks on the digestive systems causing acid reflux such that it burns through the intestines (this the way Lisa Swidler was murdered). After the whistleblower caused two newspaper articles to be published by the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers in July and August of 2007 about West's criminal activities and, when it looked like the whistleblower was going to win his lawsuit against Devra West for fraud, Devra West decided to murder the whistleblower. Accordingly, senior cult member Geoffrey Reynolds, in what he thought was an 'off the record' chat with the Bigfork Eagle reporter on August 9 2007, announced that the whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family.



Waking up from a troubled sleep, the whistleblower found he could not breathe and felt like there was a heavy pressure on his chest. It was as though a very heavy person was sat on his chest. For what seemed an eternity, the whistleblower struggled to take a breath and eventually, through sheer will power, managed to break the spell. Detectives questioning a celebrity medium in [Brazil](#), accused of sexually abusing more than 300 women, have reported **spooky goings-on** during their two hour interrogation. Unexplained incidents ranging from a **'bizarre' computer crash to wiring on electrical appliances suddenly 'short circuiting'** appears to suggest supernatural forces were at play during the interview. The mysterious problems unnerved cops but didn't deter them from collecting the testimony from faith healer, João Teixeira de Faria, who is known as João de Deus – John of God on Sunday night in Goiânia.

Detective Karla Fernandes, responsible for coordinating the task force investigating the allegations, claimed that as the spiritual guru began to speak, **strange things started to happen**. She said to Folha de Sao Paulo: 'Suddenly the computer that was being used to transcribe the suspect's answers to the allegations **seemed to have a life of its own and the commands on the keyboard wouldn't work**. 'When the clerk tried to enter the medium's statement, **the keys locked on a specific letter and 'OOOOOOO'** was recorded continuously on the screen for a few seconds.' Although this has never happened before, bemused agents put the incident down to a faulty computer.

But when the printer in the room **began to print without receiving a command and a fridge blew up, their thoughts turned to paranormal interference**. Det. Fernandes said: 'It was hot in the interrogation room and I decided to turn on the air conditioning. 'I plugged the lead into an extension shared with a mini-fridge and **the electrical wiring suddenly exploded, burning out the fridge. Everyone in the room screamed with fright**.' According to the officer, the 76-year-old spiritual healer, who is accused of sexually molesting women during private consultations at his clinic, stayed silent. She said: 'Although these things happened and surprised us, they failed to interfere with our work. He (John of God) didn't say a word.'

Court documents show that Teixeira **tried to withdraw nearly \$9 million before surrendering** to police on Sunday. The documents seen by The Associated Press are part of a judge's ruling rejecting bail. Fagner Pinho of the prosecutor's office also said Wednesday that investigators found firearms and large quantities of cash in a house used by Teixeira as a spiritual retreat. Investigators also believe that two unexplained incidents which occurred prior to Teixeira giving himself up, **could be linked to the occult**.

A police clerk, who was meant to transcribe the faith healer's testimony at the police station in the rural town of Annapolis, **was run over in a car accident and broke his arm**. Investigators originally intended to question the suspect at this small outpost. But the unexpected incident meant the interview had to be transferred to Goiânia, the capital of the state of Goiás. And last Friday as the press staked out John of God's house in the city of Abadiânia, rumors began to circulate **that 'spirits' had cursed the reporters**, photographers and TV camera crew who had camped for nearly 24 hours waiting for the psychic healer to surrender after a warrant was issued for his arrest.

Hardened professionals admitted they started praying when a news agency photographer in the press pack suddenly fell ill and lost consciousness for a few minutes. Many who were reluctant to admit the 'episode' was associated with John of God's 'mystic powers', did concede that a paranormal association wasn't so 'far-fetched'. Det. Fernandes agreed the unexplained happenings cannot be 'flippantly' dismissed. 'I accept that we are dealing with a situation that involves beliefs and mystic energies,' she said adding **she believes John of God has supernatural powers**. 'I'm spiritualist and a believer in the spirit world and the paranormal. Although I'm not afraid, I do have a healthy respect for the unknown.'

Murder used by Devra Patton West (Rishi Devra) and Joao Teixeira de Faria (John of God) to silence critics and whistleblowers.

Devra Patton West’s use of Murder to Silence Critics. In 2005, months after her charity had been [struck off for fraud](#) by the Secretary of State for Montana, Devra Patton West was desperate for money. It was not that there was not money available but because she owed her creditors \$2,000,000 in court fines and interest what money she had stolen or defrauded from her charity, some \$5,250,000 (in 2004 values) was spirited away to keep it from her creditors. A property owned by the charity and largely paid for by public donations (worth \$1,250,000 in 2002) was put in a trust fund for her and her eldest son, Rob Meador, and artwork and valuables (worth \$4,000,000 in 2002) disappeared and turned up ten years later in 2014 at her Arizona compound.

To fund her lavish lifestyle, she needed cash and to obtain that, she defrauded and extorted money from three of her students. A student close to Devra West, Lisa Swidler, negotiated a two week bridging loan of \$30,000 on behalf of Devra West from student, Dave Kushner. Once the money was handed over, Devra West refused to repay the funds or even discuss them with the victim, even though he had a loan agreement that she had signed. As she so eloquently stated above “my agreements are worthless.” [Go here](#) to listen to Dave Kushner talking about this to the whistleblower in 2005.

Shortly after selling her home in 2005, student Marion Cantwell was kidnapped, held captive and beaten by Devra West until she agreed to make a large donation to Devra West’s good causes – herself. Lisa Swidler was a senior student of Devra West’s and, as mentioned above, acted as a go-between for Ms. West when negotiating the 14 day bridging loan from Dave Kushner in 2005 which Devra West never had any intention of repaying. After this experience, and after learning about the kidnap of Marion Cantwell, Lisa decided to leave the cult and shortly afterwards Lisa died suddenly and mysteriously of internal bleeding.

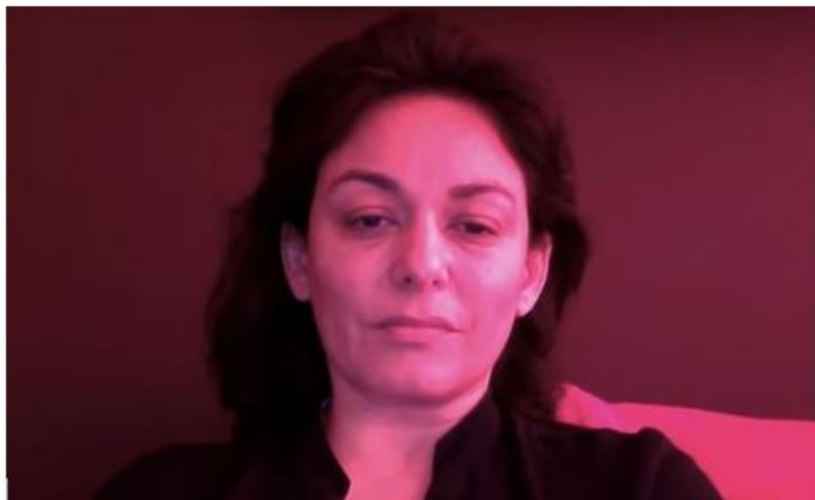
Lisa, before this tragedy was a perfectly healthy mother of two children under ten years old. Many in the cult thought she was murdered by Devra West, and if true, it certainly worked as a warning to the rank and file of the cult, as both Dave Kushner and Mike Hendrickson, the former defrauded out of \$30,000 and the latter out of \$200,000, both decided to walk away empty handed.

Mike Hendrickson was also a student of Devra Patton West's. Mike was a partner in a Colorado firm of accountants and had been West's business manager until he advised Devra Patton West and her husband, Jack West, that they were both breaking the law by defrauding their charity. Mike was immediately removed from his position in the West's charity and told to go away until he was prepared to apologize for questioning God's representative on earth about money matters. Mike had signed a note at the charity's bank guaranteeing a \$200,000 overdraft. Unfortunately for Mike Hendrickson, Devra Patton West stole his \$200,000 and put it in her trust fund! Mike gets a mention in the Whitefish Pilot newspaper article about West's criminality in Flathead Lake MT.

A woman who helped to bring down a Brazilian faith healer accused of sex abuse has taken her own life in [Spain](#). Sabrina Bittencourt, 38, died at her home in Barcelona just days after accusing John of God - real name Joao Teixeira de Faria - of running a 'sex slave farm'. She claimed young girls were held captive in a farming operation which exported babies on the black market. The women would be murdered after ten years of having babies in the alleged scheme run by the 77-year-old celebrity faith healer, who was arrested last year after hundreds of women accused him of abuse, she said.

John of God, pictured with one of his patients, has been accused of sex abuse by hundreds of women and was arrested last year in Brazil. Ms. Bittencourt left Brazil and was **forced to live under protection after receiving death threats**. Her eldest son, Gabriel Baum, confirmed her death, writing on Facebook: 'She took the last step so that we could live. They killed my mother.'

Sex abuse victim support group Victimas Unidas, who worked with the 38-year-old, said: 'We announce with regret the death of Sabrina de Campos Bittencourt, which occurred around 9pm on Saturday on February 2 in Barcelona where she was living. 'The activist committed suicide and left a farewell note explaining the reasons why she took her own life.' Before her death she was quoted as saying: 'Hundreds of girls were enslaved over years, lived on farms in Goias, served as wombs to get pregnant, for their babies to be sold.' 'These girls were murdered after 10 years of giving birth. We have got a number of testimonies.' Ms. Bittencourt had received reports of children being sold for between £15,000 and £40,000 in Europe, Australia and the United States, she said.

Hundreds around the world, have already accused John of God of sexually abusing them during healing sessions. The faith healer became a wanted man after ten women accused him of abuse during a late night chat show on Brazil's Globo TV network last year. After the initial interview on TV, authorities were reportedly contacted by more than 600 other accusers, including Faria's adult daughter, Dalva Teixeira. He was arrested in December and remanded in custody before being charged with rape and sexual assault. John of God - known as Joao de Deus in his native language - denies all of the charges against him.

Faria rose to international fame for his 'psychic surgeries' that he claimed could cure diseases, including cancer. The faith healer gained international fame in 2010 when Oprah Winfrey visited his retreat to interview him for her talk show. Former U.S. President Bill Clinton and supermodel Naomi Campbell are among those rumored to have visited him.

Occult Masters like Devra Patton West AKA 'Rishi Devra' and Joao Teixeira de Faria AKA 'John of God' can, using occult knowledge, target victims anywhere on the planet for pain, injury and murder – distance is no object. It is quite possible that Sabrina Bittencourt, after weeks or months of daily / nightly occult attacks took her own life out of desperation.

Similarly here are two examples of how Devra Patton West has targeted victims regardless of where they are in the world.

1. In August 2007, senior cult member Geoffrey Reynolds announced to the press that John Watson, the whistleblower, would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. Clearly, Reynolds knew that murder would be attempted and if that failed then they hoped to provoke the whistleblower into doing something that would land him in jail.

2. Both of Devra West's daughter-in-laws were targeted in the hope that she could intimidate the young mothers into giving up infant female children to her less than wholesome son. After a concerted attack on wife number one, poor Kendall Haywood sought psychological help and was deemed to be less of a viable option than West's porn loving / wife beating son, so mission accomplished and he got custody. Devra West tried the same strategy a few short years later, to get custody of a young infant child from Jamie Haywood, wife number two. On that occasion she failed, and Jamie kept custody of her daughter.

What we are saying loud and clear, is that in addition to intimidation, violent assaults and murder Devra Patton West is using the occult against victims and witnesses to undermine and influence the outcome of trials and court hearings in her favor.

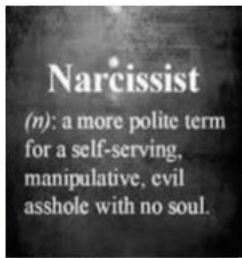

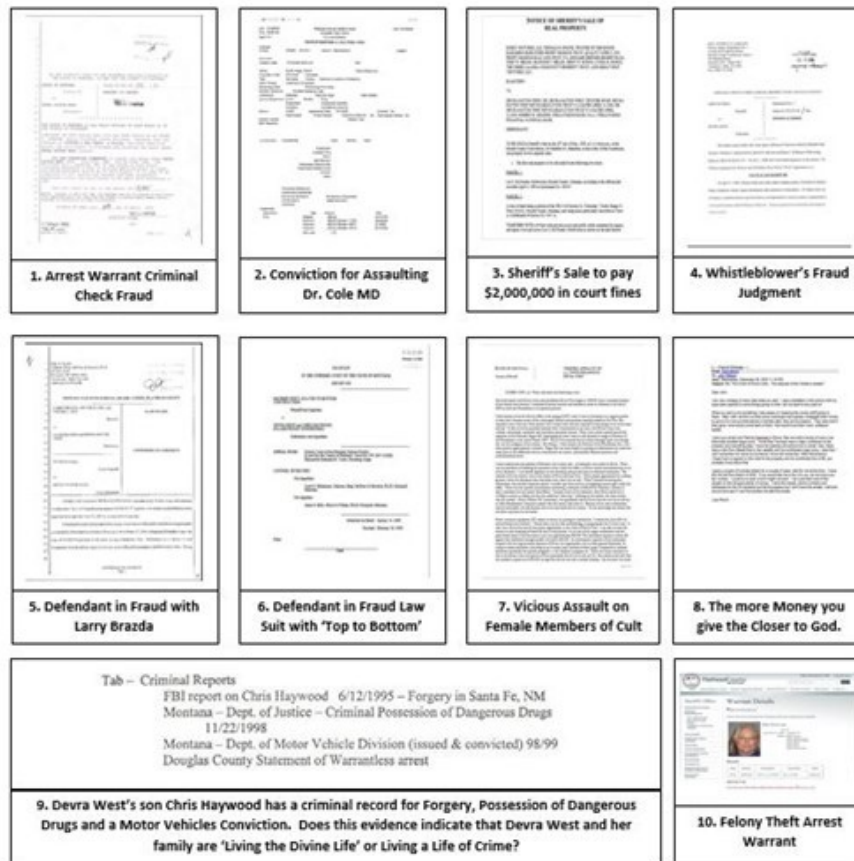
