

Subject: Geoffrey Reynolds CPA and his links to Organized Crime.

We write to advise you about Geoffrey Reynolds CPA who is (or was until recently) employed in some capacity at McSwain & Co. an Olympia firm of accountants. We cast no dispersions against McSwain & Co. as it is doubtful that when they interviewed Geoffrey Reynolds in 2014, that he came clean about his past links to organized crime. It is doubtful that he admitted to being complicit in a 2007 plot to murder a whistleblower who went public about the cult / criminal gang that Reynolds was a member of. It is doubtful that, after the murder plot failed, that Reynolds admitted his part to 'fronting' a 2010 criminal conspiracy to extort \$10,000,000 from the whistleblower – in an attempt to silence him.

Reynolds announced the impending death of the whistleblower to a newspaper reporter some ten days before the leader of his cult / gang made her failed attempt on the whistleblower's life. However, without a criminal trial and witness statements to affirm Reynolds' guilt, this matter remains hard to prove. Not hard to prove is Reynolds' involvement in the 2010 criminal conspiracy to extort \$10,000,000 from the whistleblower. 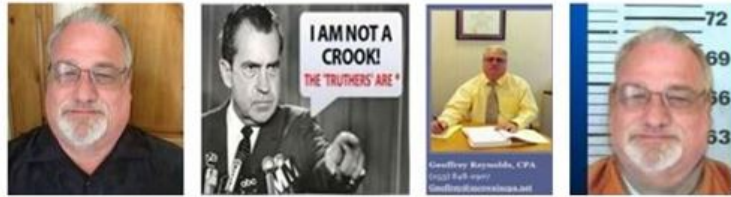

We are circulating this information because we believe that the truth about Reynolds' past links to organized crime and his total lack of integrity should be made known to other potential employers in the area. We repeat that we have no issue with McSwain & Co. who were obviously unaware of Reynolds' colorful past when they employed him in 2014. It is not even clear whether McSwain & Co. are currently employing Reynolds, though as of the time of writing this report he was still featured on their [website](#) in the manner described above. However on his personal website, see above highlighted **blue**, he says he is an independent consultant?

In the event that Reynolds has already been let go, we make the point that any future employer cannot rely on Reynolds' resume as it is a lie, a total fraud. For example, if you compare what Reynolds says on his personal resume about his time as a Senior Financial Manager, **Surya Enterprises Unlimited, Inc., 2006 to 2014**, it bears no relationship to reality or the truth. For the FACTS one need look no further than a series of emails from the then office manager Rebecca West (no relationship to the cult gang leader Devra West). Rebecca's series of [harrowing emails](#) to the whistleblower make it clear that 'Surya Enterprises Unlimited, Inc.,' was a front for a criminal racketeering gang. Two newspaper articles published by [Whitefish Pilot](#) & [Bigfork Eagle](#) newspaper also make that point very clear.

Finally, what better confirmation could we have of the criminal nature of the above 'business' than the statements given by the cult / gang leader herself, while being deposed by a Montana court in October 2010? In the following [statement](#), given under oath, Devra West admits that she is \$2,000,000 in debt and that Geoffrey Reynolds, as well as funding her lifestyle and putting her up in a caravan in his back garden, is the financial master mind of her criminal enterprise. Not mentioned in the statement are the two arrest warrants, a conviction for assault, the fact that she was forced to sell all of her assets to pay past victims of crime \$2,000,000 in court fines and interest. Not mentioned either are the multiple appearances in court as the defendant in fraud related civil lawsuits.

We will leave you with one of the last actions he made in 2014 on behalf of Devra West, his cult / gang leader, before Reynolds moved away to start a new life in Washington and commence his employment with McSwain & Co. Having been chased out of New Mexico by one gun wielding victim in 1995, Devra West set up her tried and tested guru / cult / extortion business model in Montana, complete with a new name, new fake identity and false bio. After scores of victims in Montana, she was obliged to leave that state in 2010; no problem, just move to another western state where they either do not understand white collar crime or do not have the resources to prosecute it. Currently, complete with yet another new name, fake identity and false bio she is operating in Arizona.

The following statement was posted on the social media 'Meet Up' site. This was Reynolds' parting gift to his cult / gang leader and his attempt to attract new victims into her cult. Please note that this statement was posted on the web January 10, 2014 and in the 'Introduction' Reynolds asserts that he has worked with Devra West, then calling herself Rishi Devra, for the last 6 years (this is patently untrue). If that is true, then Reynolds commenced his employment in 2008 meaning that he could have been defamed by the whistleblower between 2002 and 2008.
