

Subject: Rishi Devra AKA Devra Patton West – Domestic Terrorism at its ‘Finest.’

FBI Etc.

This week we make the case that Devra Patton West and her accomplices should be treated as a domestic terrorists, or at the very least, prosecuted under the Racketeer Influenced and Corrupt Organizations Act (**RICO**).

While the large number of victims (including murder, attempted murder and violent assaults) warrants Devra Patton West to be treated as a domestic terrorist, we believe that prosecuting her under RICO statutes would also facilitate better forfeiture of assets from West and her accomplices, Geoffrey Reynolds CPA and Julio Williams MD. Below we list at least 8 predicate offenses that should be considered; though some are past the statute of limitations others are still occurring now such as fraud and the commission of murder.

Rishi Devra AKA Devra Patton West – Domestic Terrorism at its ‘Finest?’

Noun: domestic terrorism – Definition *The committing of terrorist acts in the perpetrator's own country against their fellow citizens.*

*Under the 2001 USA Patriot Act, **domestic terrorism** is defined as "activities that (A) involve acts dangerous to human life that are a violation of the criminal laws of the U.S. or of any state; (B) appear to be intended (i) to intimidate or coerce a civilian population; (ii) to influence the policy of a government by etc....*

In the past, criminal gangs like the Italian Mafia used murder, violence and the constant threat of violence to carve out multi-million dollar empires. Witnesses to organized crime were either too afraid to come forward, were paid off, or were murdered before a successful trial could be mounted, making prosecution of gang members very difficult. Their uniforms were expensive tailor made suits and their weapons of choice were automatic firearms; occasionally a firearm would be linked to a murder and, assuming witnesses for the state were not murdered before a trial could be convened, gang members would be jailed or executed. The weak link for the gangs was forensic firearms evidence and brave witnesses not afraid to come forward and testify.

Fast forward to the present to Devra Patton West, the head of a criminal racketeering cult / gang, a suspected serial killer and one who meets the description of a domestic terrorist.



Above: Using millions of dollars from organized crime over the past 27 years, Devra Patton West, from a family steeped in mental illness, lives out her delusions of grandeur lording over others. All the while committing numerous acts of theft, fraud, extortion, violent assaults and at least one murder (and perhaps many more). Using a deadly 'weapon' the authorities do not recognize or understand, a weapon that cannot be traced back to her, she dresses up like a Greek Goddess believing that she is unassailable and beyond the reach of justice.

Over the past 27 years, since acquiring occult knowledge in 1991, Devra West's criminal racketeering business model has operated in three western states where they either do not understand 'white collar' crime or because of lack of resources choose not to prosecute it. In Montana alone, in the 5 year period between 2004 & 2009, Devra West was suspected of, committed or was prosecuted for the following. In 2004 defrauding her charity out of hundreds of thousands of dollars and it being [struck off](#) the Montana charity register. In 2005 she defrauded [Dave Kushner](#) out of \$30,000, [Mike Hendrickson](#) out of \$200,000, murdered [Lisa Swidler](#) and kidnapped, falsely imprisoned, beat and extorted tens of thousands of dollars from [Marion Cantwell](#). The aforementioned were all 'students' to her unaccredited school for occult studies. In 2006 she was arrested for a vicious assault on another student, her business partner Dr. Pat Cole MD, and [convicted of that assault](#) in 2008. In 2007 she tried to murder the whistleblower John Watson, who was in the process of suing her for fraud. In 2008 she was the subject of an arrest warrant for [criminal check fraud](#). In the same year, she was the subject of a [Sheriff's Sale](#) at which her assets were sold (those that were not hidden) to pay past victims of crime \$2,000,000 in court fines and interest.

Third left: Dr. Pat Cole MD threatened with murder, viciously assaulted and the victim of extortion. Right: The whistleblower John Watson defrauded, the subject of a failed murder plot, the subject of a conspiracy by West and Reynolds to bankrupt and thirteen years later, he and his family are still the subject of a campaign of occult 'under the radar' violence directed at him by Devra West.

In 2008 she was found guilty by a Montana court of defrauding John Watson. In 2009 she was the subject of an arrest warrant for [felony theft](#). In 2010, she and senior cult member [Geoffrey Reynolds](#) (also complicit in the plot to murder John Watson) conspired to extort \$10,000,000 from the whistleblower using a pair of frivolous lawsuits against him that they guessed he could not afford to defend. Reynolds' role in the conspiracy was to make totally [false statements](#) to a Montana court, which a) netted him and West \$5,000,000 each in default undefended judgments and b) resulted in the whistleblower's websites being forced down. This is what criminals do if they cannot intimidate you or murder you, they use their millions to outspend you in court to 'buy' the result they want. Apart from getting revenge for the whistleblower's successful court case against West for fraud by removing all evidence of Devra West's past criminality from the internet, she was able to reincarnate herself in Arizona as the Ascended Master 'Rishi Devra; the third such identity in quick succession since 2004.

1. Not everyone is upset about the Devra West's criminal racketeering business model – the family.....



Above far left: Daughter Anna West, one of the main beneficiaries of her mother's multimillion dollar a year criminal racketeering business model, zones out her mother's insanity. Far right: Son Chris Haywood; Devra West used her knowledge of the occult against two of his ex-wives in an attempt to wrest custody of two infant female children from their mothers. The violence and intimidation succeeded against first wife Kendal, but failed against second wife Jamie. Undermining court cases and perverting the course of justice by intimidating victims and witnesses is standard practice for Devra West, as is persuading false witnesses to perjure themselves for her.

Apparently, the photograph of Anna West and her mother (above left) was taken at the sale / auction of artwork and valuables that Devra West stole from the charity she bankrupted in Montana. When questioned under oath about the disappearance of \$4,000,000 (2002 values) of artwork and valuables Devra West responded that she did not know where they were, suggesting that they were lost or stolen. Ten years later, after the expiration of the statute of limitations on theft and embezzlement they suddenly appear in her possession in Arizona. Those who doubt the truth of this should read the [statement Devra West gave](#) the whistleblower's lawyer in 2009 while being deposed. Again, Anna West appears to turn a blind eye to what is obviously organized crime.

Any threat against Devra West's multi-million dollar a year criminal racketeering business model is motive enough for murder and why not if the weapon used to dispatch those who oppose her cannot be traced backed to her! Just as the murder of Lisa Swidler could not be tied to her directly.

Below is a photograph of the members of Devra West's cult circa 2003, when she was calling herself the Ascended Master Devra Ji. Many of the people in that photo raised money for the charity that Devra

West bankrupted and defrauded. They also raised money to pay for the mortgage on the property and gifted (to the charity) some of the artwork and valuables that Devra West is now selling.

Anna West knew many of the individuals in the photo above right; many were her friends, however as each in turn was mentally and physically abused, robbed, defrauded, were the subject of extortion or as in the case of Lisa Swidler murdered, Anna West zoned out what was occurring around her. Her mother, as we proved last week, a pathological liar, lied about each departing victim as attested by her personal secretary Barbara Costantino. Another who felt close to Anna was Tanya Hurley, who in [a written statement](#) to the whistleblower, described Devra West thus in 2003:-

“I developed a close relationship to her daughter Anna West and still hold a place in my heart for her. It is my opinion that Mrs. West is mentally ill and is a danger to herself and others. I was very damaged from my involvement with Mrs. West, physically, mentally and spiritually.”

Within days of reading the statement, Devra West directed a vicious attack at Tanya that put her in hospital for a week.

The whistleblower John Watson was defrauded, he and his family became the target of a campaign of occult attacks (which continue to this day), he was the subject of a failed murder plot by Devra West her mother and when that failed Devra West, and senior cult member Geoffrey Reynolds CPA set about bankrupting the whistleblower John Watson to stop him sharing the truth about her past so she could reincarnate in Arizona with yet another fake identity. Anna West appears to have zoned out the plight of scores of victims of crime at her mother's hands. One can only assume that as long as the money keeps flowing and the narcissistic photos keep getting posted on Facebook, then all is well?



Above: The secret of Devra West's power over victims and witnesses of the crimes she commits, and her hold over the members of her cult is her ability to use occult knowledge she acquired between 1990 & 1991 to intimidate and murder targets at a distance with plausible deniability. Hence, Reynolds' confidence that the whistleblower would either be murdered or be jailed for reacting to what West was going to do.

What Anna West does not seem to take into account is the potential danger her mother's criminality presents to her and her own children. As her father Jack West will attest, he, Devra West and Anna as a child, were chased out of New Mexico in the middle of the night by one gun wielding victim who realized that the police would be unable to help him with the occult attacks being directed at him by Devra West. The same occult 'under the radar' violence has been used against countless victims of crime. For example in 2007 alone, several witnesses to the assault by Devra West on Dr. Pat Cole called the police to say that they were the victims of occult attacks by Devra West. The obvious objective was a) to intimidate Dr. Cole MD into dropping her assault case against her and b) to intimidate several witnesses into withdrawing their statements against her. One of the witnesses Devra West was trying to intimidate was one of her employees, her office manager, Rebecca West (no relation to Devra West).

In March of 2007, Rebecca West sent a harrowing email entitled '[Help Me](#)' to the whistleblower asking for help with Devra West's 'shamanic witchcraft.' As stated above, the same strategy was used by Devra West against her daughter-in-law Jamie Haywood, who also sent an [email](#) to the whistleblower in July 2007, asking for help. Jamie's email mentioned that she and her baby were being targeted by West who was using her secret weapon to intimidate her into handing over her infant daughter. Clearly, Devra West was attempting to undermine the custody hearing involving her son's second wife, to be held on July 12 2007, just as she had succeeded in doing against his first wife a few short years earlier. To come to the point, Devra West lives in a gated community for her own protection. Over the past 27 years she has acquired scores of enemies who have been robbed, defrauded, been the victims of extortion, violent assault, mental and physical abuse and in the case of the whistleblower a failed attempt at murdering him and bankrupting him. Anna West should know that her mother, Devra West, has repeatedly over a 13 year period, targeted his children with vicious occult attacks designed to injure, make ill and maim; all with the purpose of intimidating him into giving up his quest for justice.



*Above: Devra West in a 2003 interview with the whistleblower made no secret of her criminal intent, nor could she hide the fact that she was insane. Admitting the crimes against him, she refused to honor her agreements and said that if he sued her she would get down and 'f*cking dirty'. A less stable person than the whistleblower, unable to get at Devra West for the violence she has administered against his children, might go after her daughter to avenge those attacks; fortunately for Anna West, the whistleblower is mentally stable and not about to walk into the trap set by her mother some 13 years ago. That said, Anna West should be aware that when accomplice Geoffrey Reynolds announced the whistleblower's murder to the [Bigfork Eagle](#) newspaper on August 9 2007, he also stated that, if not murdered, the whistleblower would be jailed for reacting to what Devra West was going to do to him and his family. It is clear from Reynolds' remarks, that Devra West hoped that the violent attacks against the whistleblower and his wife and children would provoke a reaction that would result in the whistleblower ending up in jail.

Clearly, when directing her campaign of violence against those who oppose her (and the families of those who oppose her) Devra West, hiding away in her gated mansion, paid no account to the potential danger her actions might accrue to her own daughter and grandchildren. Her father, Jack West, had told the whistleblower in 2002 that he and his wife Devra West, his then young daughter Anna West, had to leave New Mexico in the middle of the night with only what they could carry because they were being pursued by a gun wielding victim intent on revenge. In targeting the children of her victims, Devra West assumes that none of her victims would, following the logic of 'an eye for an eye and a tooth for a tooth, go after her children. More likely being a psychopath, Devra West just made the decision that placing her daughter in jeopardy was a risk she was prepared to take.



Devra West: A self-serving manipulative, evil asshole with no soul. After defrauding one victim, she tries to murder him, bankrupt him and for the past 13 years has been targeting his wife and children with occult 'under the radar' violent attacks, even though she has children and grandchildren of her own. What could possibly go wrong?

Again, the whistleblower has not reacted to 13 years of continued violence against him, his wife and children; therefore it must be obvious to all that John Watson is still relying on the authorities to administer justice for the crimes committed against him, his family and the scores of other victims who have chosen to walk away rather than become the target of occult attacks or murder. If Anna West feels unsafe, either because of the danger her mother is placing her in or from the potential reaction of victims, we suggest she goes to the police or the FBI to file a complaint, understanding that her mother is mentally ill, is a pathological liar and has a history of violence towards others. Understanding that the FBI already have a huge file on her mother and her mother's closest accomplices i.e. her father Jack West, Geoffrey Reynolds and Julio Williams. Understanding that these bulletins are designed to get the FBI engaged in the affairs of her mother, who we regard as a domestic terrorist / criminal racketeering cult / gang leader and potential serial killer.



Above: John of God and Devra West, both occultists who use hidden knowledge to prey on the public. John of God's obsession is sex and money. Devra West's obsession is control over the lives of others and money. Both are suspected serial killers; and the victims and witnesses of both attest to being the victims of occult attacks.

We are confident that in the very near future, Devra West and her accomplices will be arrested and become the subject of a criminal investigation under racketeering statutes. And after her arrest, as occurred in Brazilian with occult predator 'John of God,' we expect scores of victims will come forward to the police to give evidence against her. The fact that Geoffrey Reynolds was so confident that Devra West would be able to successfully murder the whistleblower, makes me believe that Devra West confided in him that she had murdered others, including the sudden and mysterious death of ex-student Lisa Swidler in 2005. 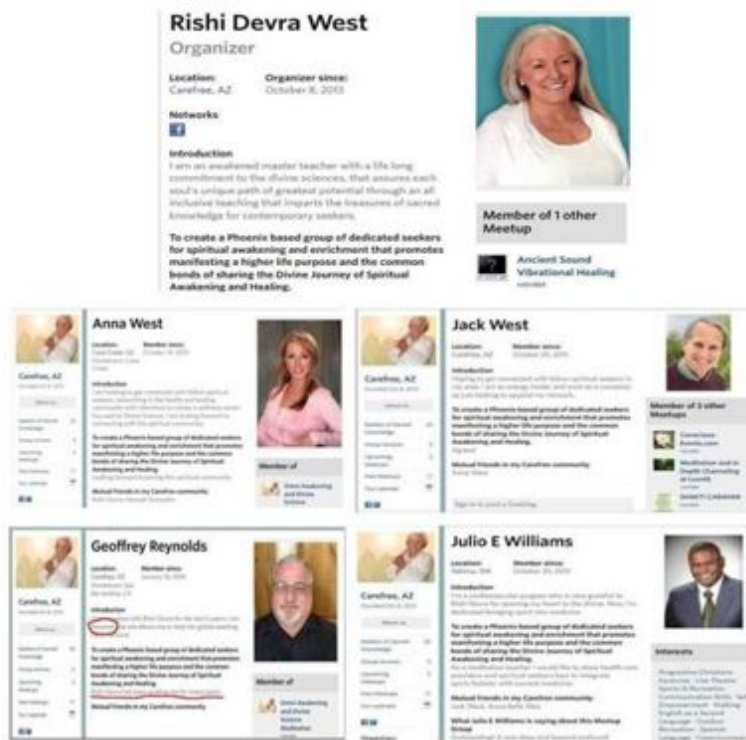
Julio Williams MD a member of west's cult / criminal gang since 2000. Williams posted a defamatory statement about the whistleblower in 2005, sent him a threatening letter in 2007 promising to fund West's legal fees to the tune of \$2,00,000. Williams promotes and supports her claims to be able to deliver 'divine grace healings' and pays for venues for her to interview those prepared to pay \$500,000 for a fake cure!

It is clear that the senior members of Devra West's cult / criminal gang act on her instructions, however illegal and immoral those instructions are. It is clear that Devra West uses murder or the threat of murder as a weapon against victims of crime and against those who would go to the police, or go public about her activities. [Lisa Swidler](#) was silenced, [Marion Cantwell](#) was told that if she went to the police she would be murdered. [Carlida Finch](#) overheard Devra West talking about the murder of Dr. Pat Cole MD. In the case of the whistleblower, John Watson, Geoffrey Reynolds announced his impending murder to a newspaper reporter just before Devra West made her attempt on his life. Julio Williams defamed the whistleblower in 2005 and in 2007, tried and failed to intimidate the whistleblower into dropping his lawsuit against Devra West. During the past 3 years or so, he has received 300 plus emails from the whistleblower detailing the daily / nightly campaign of violent intimidation being directed at him by Devra West. However, he has refused to pass any of these emails on to the police or the FBI because to do so would implicate him in racketeering and murder.

After being forced out of Montana (and New Mexico before that) Devra West set about reincarnating herself as the Ascended Master Rishi Devra in Arizona, and helping her with that endeavor were two members of her family and willing accomplices in organized crime, Reynolds and Williams.



Above: Three quarters of the West crime family - Devra, Anna and Jack West; below them are accomplices Geoffrey Reynolds and Julio Williams. Each aware of Devra West's history of crime and violence, but all doing their part in 2014 on social media to attract new victims using 'Meet Up' which Devra West was later banned from using.

If not a domestic terrorists, then Devra Patton West and her accomplices are certainly guilty of racketeering and should be prosecuted under [Criminal RICO](#) statutes.

RICO predicate offenses...

Under the law, the meaning of **racketeering activity** is set out at [18 U.S.C. § 1961](#). As currently amended it includes:

- Any violation of state statutes against [gambling](#), [murder](#), [kidnapping](#), [extortion](#), [arson](#), [robbery](#), [bribery](#), dealing in [obscene matter](#), or dealing in a controlled substance or listed chemical (as defined in the [Controlled Substances Act](#));
- Any act of [bribery](#), [counterfeiting](#), [theft](#), [embezzlement](#), [fraud](#), dealing in obscene matter, [obstruction of justice](#), [slavery](#), [racketeering](#), [gambling](#), [money laundering](#), commission of [murder-for-hire](#), and many other offenses covered under the Federal criminal code ([Title 18](#));

- [Embezzlement](#) of [union](#) funds;
- [Bankruptcy](#) fraud or [securities fraud](#);
- [Drug trafficking](#); long-term and elaborate drug networks can also be prosecuted using the [Continuing Criminal Enterprise Statute](#);
- Criminal [copyright infringement](#);
- [Money laundering](#) and related offenses;
- Bringing in, aiding or assisting [aliens](#) in illegally entering the country (if the action was for financial gain);
- Acts of [terrorism](#).

We calculate that from the above list of predicate offenses, Devra Patton West has been guilty of the following:-

Murder. Of Lisa Swidler in 2005 (attempted murder of the whistleblower John Watson in 2007).

Kidnapping. Of [Marion Cantwell](#) in 2005.

Extortion. Of monies from [Marion Cantwell](#) and [Dr. Pat Cole MD](#) to name but two. Many other victims expected as part of her criminal business model which involves miracle cures for victims (for six figure sums) after making them ill! Dr. Julio Williams MD on hand to attest to her miracle healing abilities!

Embezzlement. Devra West, after nearly bankrupting her charity, stole \$4,000,000 worth of artwork and valuables owned by the charity which were largely paid for by public donation. When questioned by a Montana court about these assets in 2009 she denied they existed saying that they were lost or stolen. Exact copies of these items turned up in 2014 (after the statute of limitations had passed!) in Arizona. Some were sold but most now appear on her website as part of [‘Rishi’s Art Gallery.’](#)

Fraud. Devra West defrauded Mike Hendrickson out of \$200,000 in 2004, Dave Kushner out of \$30,000 in 2005. Defrauded the state of Montana out of \$1,250,000 in 2004 when, using a series of fake loans, obtained a property belonging to a Montana charity that was largely paid for by public donations. She also

Obstruction of Justice. We know that Devra West used violent intimidation against both of her daughter’s in laws in an attempt to undermine two custody court cases so that her porn loving wife beating son Chris Haywood, [who has an FBI record](#) for forgery, substance abuse and traffic violations, would get custody of his two infant daughters. It worked with wife number one Kendal but failed with wife number two Jamie. Devra West also mounted a campaign of violent intimidation against the whistleblower targeting him, his wife and children in an attempt to get him to drop his fraud lawsuit against her which he won in 2008. This campaign of violence against him and his family continues to this day some 13 years after it started. One can assume that with every court case Devra West was involved with, whether as the defendant or plaintiff, she targeted her opponents in an attempt to undermine / pervert / or obstruct justice.

Money Laundering. The most obvious case of money laundering occurred in 2006 when, after viciously assaulting business partner Dr. Pat Cole MD (for which West was convicted in 2008) accomplice Geoffrey Reynolds CPA passed \$463,000 in cash through West’s business as ‘normal’ receipts. This, after his immediate predecessor resigned rather than be forced by Devra West to [‘manufacture’ false invoices’](#). Reynolds basically admits money laundering these funds in an interview he gave the [Bigfork Eagle](#) newspaper on August 9 2007. In the same interview in what he believed to be an ‘off the record’ conversation he told the reporter that the whistleblower John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family.

Mail & Wire Fraud. If one reviews Devra West’s latest [bio / life journey](#) as featured on her website and compares it with her ‘criminal’ activities over the past decade or more one can see that what is on her

website is propaganda, a pack of lies, a deceit. The public are being invited to make financial donations based on those lies; we believe this is mail and wire fraud.

Acts of Terrorism. We list below just a few of the scores of victims of crime at the hands of Devra Patton West and her accomplices – these are just the tip of the iceberg. If **domestic terrorism** is defined as "activities that (A) involve acts dangerous to human life that are a violation of the criminal laws of the U.S. or of any state; (B) appear to be intended (i) to intimidate or coerce a civilian population then we believe that Devra West is a terrorist.

By our calculations Devra Patton West is guilty of committing 8 of the predicate offenses listed above with accomplices Reynolds and Williams guilty of two apiece.

In the last paragraphs of this email, we outline how she is currently marketing herself as a 'healer' capable of delivering 'divine grace healings' and 'dispensation of karma' for a large fee. Dr. Williams MD, a physician, heart surgeon and senior member of her cult / gang, is often on hand to personally back up her fraudulent claims.

Given that Devra West's website '[Pay Portal](#)' is set up to receive single contributions of up to \$500,000 and, given the unlikelihood that a member of the public would 'donate' that amount, we assume that her 'pay portal' is set up to receive 'donations' arising from organized crime. We have credible evidence from two of her employees, Kathleen Francisco and Diane Stoner, that Devra West was charging \$500,000 for miracle cures in 2003!

GUILTY OF TERRORISM OR RACKETEERING IT IS OBVIOUS THAT DEVRA PATTON WEST IS NOT A GURU

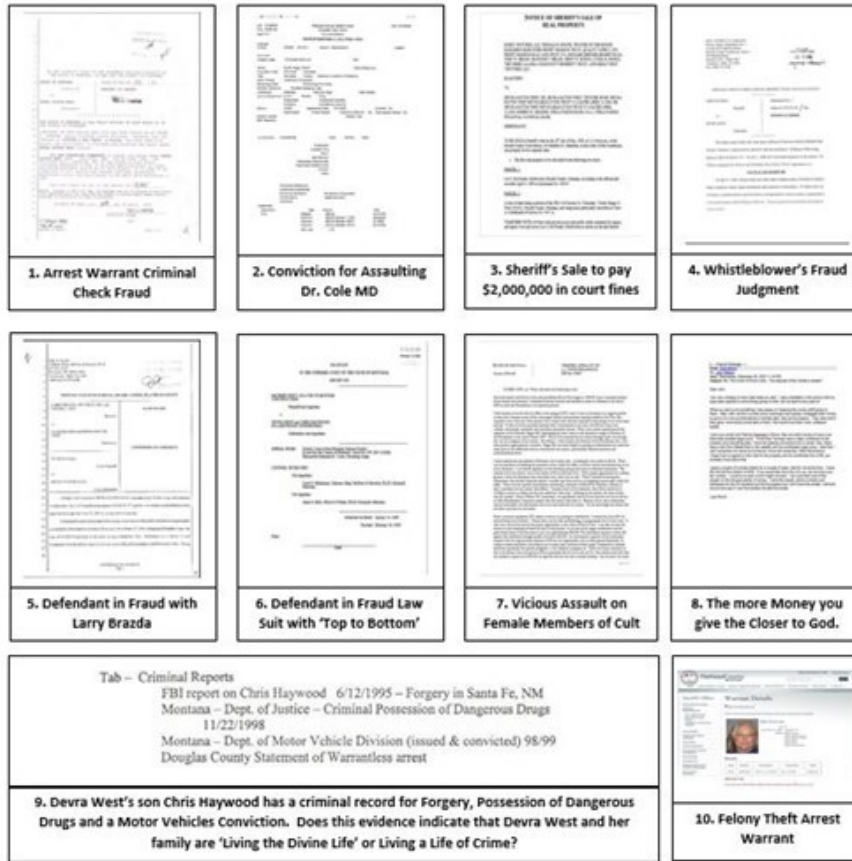

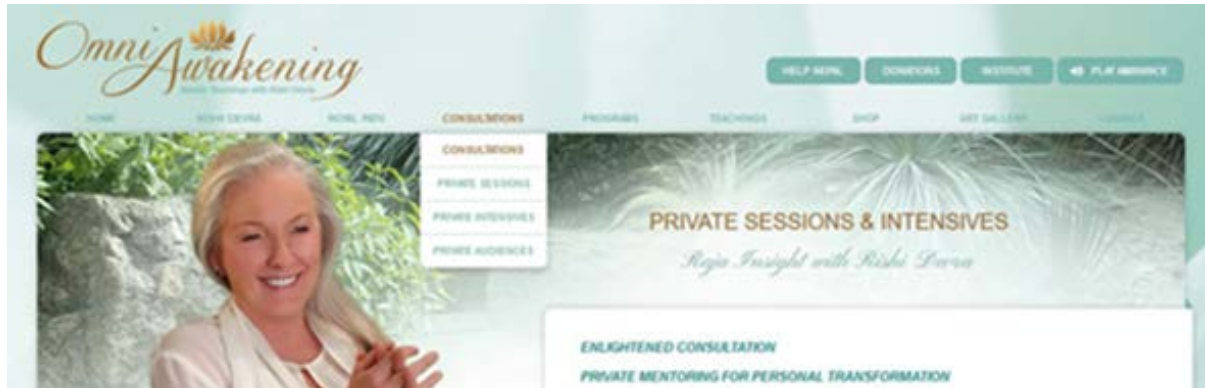

Step 1. Those identified as wealthy targets are invited to attend a 'Private' Sessions or a 'Private' Intensive' as advertised on her website below.



Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

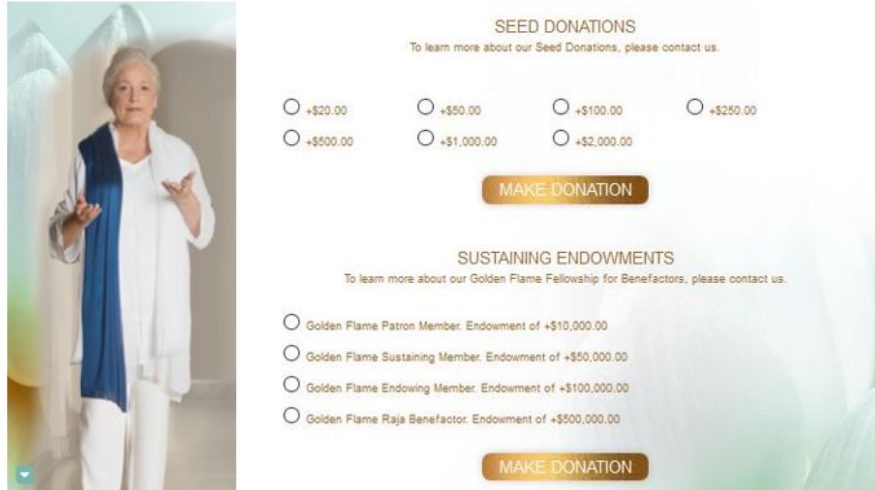
That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.

That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for the nonexistent wrongs the target committed).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! In this way the target receives an imaginary cure and in return [The Regent of the Spiritual Hierarchy of the Western Hemisphere](#) gets to empty the targets bank account into hers. Note her standing there with her hands out saying "give me, give me."



This has been going on for 27 years right under the noses of the FBI and the IRS. It is illegal for a lay person to assert that they are able to cure someone of a health condition. Apparently not so for Devra West! At \$500,000 a go, it is no wonder she can afford the trappings, clothing, lifestyle and home of a multi-millionaire even though she claims to be penniless and the funds she extorts from victims are nowhere to be seen, let alone declared to the IRS as income in her tax returns.
