Subject: Rishi Devra AKA Devra Patton West – Murder and Organized Crime Sold to the Public as 'World Service.'

Dear FBI, IRS and Sedona & Scottsdale police departments,

Following a further attempt last week on the life of whistleblower John Watson, we urge you to open an investigation into the activities of Devra Patton West and her criminal racketeering gang comprising Geoffrey Reynolds, Julio Williams and ex-husband Jack West. We suggest that you get a warrant and review the contents of Julio Williams' email account (details below) where you will find some 300 to 400 emails from the whistleblower logging the intimidation attempts by Devra Patton West over the past four years between 2015 and 2019. A similar number of emails were sent to JC Bartlett, Devra West's lawyer, between 2012 & 2015; copies of these are available from the whistleblower's Gmail account if Bartlett refuses to supply them. We also suggest that you contact Wendy Halloran, an investigative reporter based in Phoenix AZ to whom John Watson gave a 45 minute video interview in 2013.

If you review all of this information, and combine it with the evidence given in these emails and online at this website, you will begin to grasp the magnitude of Devra Patton West's criminal racketeering activities over the past 27 years. After successfully suing Devra Patton West for fraud and, after going public about his experiences, he and his family became subject of a campaign of violent intimidation that started in December 2006 and continues unabated to this day. That is, day in and day out intimidation and provocation for the past 13 years – against one victim who refuses to go quietly like most of the others. Devra Patton West's first attempt to murder John Watson occurred in August 2007, and so sure was she that she would be successful that she had senior cult / gang member Geoffrey Reynolds announce his impending death to the Montana press. The reporter took the threat seriously enough to pass it on to an IRS criminal investigator who was looking into West's finances at the time.

When you grasp the lengths that Devra Patton West and the senior members of her cult / gang have gone to intimidate and snuff out the life of <u>just one of their victims</u> you will begin to understand why only a very small percentage of those robbed, defrauded and who became the victim of extortion go to the police or seek redress through the courts. When you grasp the magnitude of the crimes committed against literally scores of victims over the past 27 years you will begin to understand how it is that Devra Patton West is <u>so</u> wealthy and yet pays little or no tax.

In the body of this email below, is an excerpt from a recent email that John Watson sent to cult / gang member Julio Williams following the latest attempt on his life by Devra Patton West. The contents of Julio Williams email account will provide proof positive that he, like Geoffrey Reynolds earlier, is complicit in Watson's murder and perhaps others. John Watson stands ready to work with the authorities to bring Devra Patton West and her accomplices to justice.

Using the same tried and tested operation, that has worked well in three western states over the past 27 years, Devra Patton West, with the help of her accomplices, portrays herself as a guru and her criminal racketeering business model as 'world service.'

When are the authorities going to investigate the murders? When are the authorities going to investigate the attempted murders? When are the authorities going to investigate the threats of murder against victims of crime?

In 2002, while working as a business consultant for Devra Patton West, her then husband Jack West told John Watson that those who opposed his wife had a habit of dying suddenly. We do not know how many extra judicial killings (murders) that Devra Patton West is responsible for, but we do know that she has plenty of 'opportunity' and plenty of 'motive.' The opportunity arises from the fact that while attending 'The Robert Jaffe School for Energy Mastery' between 1990 & 1991, she acquired occult (hidden) knowledge that allowed her to manipulate the health and wellbeing of others. Knowledge this powerful in the hands of a dangerous psychopath like Devra West is akin to handing a machine gun to mass murder and pointing them towards the nearest shopping mall.

Clearly, Jack West knew his wife was a serial killer but what other evidence do we have?

1. Victim of Murder at the hands of Devra West - Lisa Swidler. After Devra Patton West was allegedly defrauded by another con-artist out of \$650,000 in 2005 (follow this link for details) she decided to harvest funds from several of the wealthier members of her cult. Accordingly, she arranged a 14 day

bridging loan of \$30,000 from student <u>Dave Kushner</u>, which she never repaid. At about the same time she kidnapped, falsely imprisoned and beat student <u>Marion Cantwell</u> until Marion agreed to 'donate' part of the proceeds of the sale of her home to Devra West. Lisa Swidler, witnessing these two crimes tried to escape the cult and died shortly afterwards. Dead men tell no tales and as a confident of Devra West, Lisa knew where many of the skeletons were hidden so she was murdered by Devra West to silence her. However, because the murder weapon is not regarded as a weapon under legal statute, Devra West did not even get a visit from the police; though she had plenty of motive to silence Lisa and plenty of opportunity.

IS THIS EXTRA-JUDICIAL KILLING (MURDER) TO GO UNPUNISHED BECAUSE THE VICTIM WAS A MEMBER OF A CULT AND BECAUSE LEGAL STATUTE ALLOWS DEVRA WEST TO COMMIT MURDERS THAT ARE RULED BY THE CORONER AS DEATH BY NATURAL CAUSES?

2. Victim of Extortion, Kidnapping, Assault and False Imprisonment – Marion Cantwell. After being forced to share the proceeds of the sale of her home with Devra West, Marion Cantwell was told that if she went to the police she would be murdered. Clearly, Devra West uses her ability to commit murder, without fear of being held accountable, as a 'tool' to both leverage her criminality and additionally to ensure that both victims and witnesses do not go public about what happened to them. This is why 90% of victims do not seek redress through the courts or the police. As a foot note, some months after her ordeal Marion Cantwell relocated to California to start a new life there. At which time her new prospective employer, having discovered that Marion used to be involved in Devra West's cult after an internet search, contacted the whistleblower via his website for a reference. The employer wanted an assurance that Marion was a victim of the cult and in no way part of the criminals running the cult. The whistleblower was happy to give that assurance.

IS KIDNAPPING, FALSE IMPRISONMENT, ASSAULT AND EXTORTION TO GO UNPUNISHED BECAUSE THE VICTIM WAS A MEMBER OF A CULT AND BECAUSE THE VICTIMS OF CRIME INSIDE THE CULT ARE TOO AFRAID FOR THEIR LIVES TO COME FORWARD AND REPORT THESE CRIMES?

3. Victim of Extortion, Multiple Violent Assaults and the subject of a Planned Murder – Dr. Pat Cole.

As with Dave Kushner and Marion Cantwell, Dr. Pat Cole, and alleged member and heiress of the Whirlpool family, was targeted for extortion. After a series of prior beatings, the last resulting in Devra West repeatedly hitting the victim over the head with the heel of her shoe until blood ran down the victim's blouse, the police were called and Devra West was cautioned and charged with assault. The facts are clear, not least because within days of the assault on 17 April 2006, Devra West wrote to her cult mailing list advising them that the assault meted was severe (but administered with grace) and that the beating was long overdue because the victim was a Nazi in the WWII death camps (in another lifetime.) A news article published in the Whitefish Pilot fifteen months later on July 12 2007, gives more details.

I strongly advise those seeking the truth to read this missive, entitled <u>'The Law of severity on the Path to Purification</u>,' as no other document makes it so clear that Devra Patton West is criminally insane.

In the two years following Devra West's vicious assault on Dr. Cole MD, as part of a campaign of violence to extort \$1.3 million from the victim which, with the help of accomplices she succeeded in doing, Devra West vehemently denied the assault. She did so both <u>in court</u> when appearing as a witness for her son in his custody battle for his infant daughter and from <u>her website</u>. In the posting she made on her website, she claimed that she had not been found guilty of the assault but that the "victim's bogus

claims" had been dismissed by the court and went on to accuse the victim of being part of an extortion scam against her! The facts are that Devra West was found guilty of the assault, a fact corroborated by a news article that appeared in the Whitefish Pilot newspaper in <a href="April 2008">April 2008</a>. Of germane to these statements is the fact that one of West's employees, Carlida Finch, overheard Devra West planning the murder of Dr. Pat Cole MD. 4. Victim of Fraud, Intimidation, False Witnesses, Occult Under The Radar Violence, a Failed Murder Attempt and a Conspiracy to Extort \$10,000,000 from Him – John Watson AKA the Whistleblower.

In 2002, acting as a business consultant, and after completing the tasks set him, Devra Patton West, then calling herself the Ascended Master Devra Ji, announced that she was not going to pay John Watson the monies she had agreed for the 6 months work that he had just completed. Long story short, she defrauded him. At a meeting at his property in March 2003, a meeting she asked for after John Watson announced he was going to sue her for fraud, she admitted defrauding him and told him that if he sued her for fraud she would get so f\*cking down and dirty – huge expenses coming out of his pocket and not hers. In the 5 years since he launched his lawsuit in 2003 until winning in it in 2008, Devra West used senior cult member Julio Williams to first defame him, and then in 2007 attempt to intimidate him via email. She forced her employees to write false statements about him that she intended to use against him in court. She mounted a campaign of 'under the radar violence' against him and his family members, attempted to murder him and when that failed, conspired to bankrupt him using the civil courts to launch a pair of frivolous lawsuits against him that were intended to bankrupt him with the clear intention of:-

- A. Avenging his win in court against her for defrauding him.
- **B.** Forcing down his websites so that she could reincarnate in Arizona with a new name, a new fake bio, and yet more awards and accolades without fear that the public would have access to the truth about her 'criminal' past.

As long as the truth was available to the public on the internet, her multi-million dollar a year criminal racketeering business model was dead in the water. With evidence available of her criminality in Montana (and New Mexico) no one was going to believe Devra West's outrageous claims to divinity, that she got her fake doctorates <a href="from the Christ in person">from the Christ in person</a> or that she was <a href="single-handedly holding open-the gates of time!">single-handedly holding open-the gates of time!</a> Having failed to intimidate John Watson or murder him, all that was left was to use the law against him by outspending him and 'buying' the result she wanted.

IS FRAUD, CAUSING GRIEVOUS BODILY HARM, ATTEMPTED MURDER AND CRIMINAL CONSPIRACY TO GO UNPUNISHED BECAUSE THE LEGAL SYSTEM IS TOTALLY INEPT AT DEALING WITH SOMONE LIKE DEVRA PATTON WEST? BECAUSE SHE AND HER ACCOMPLICES ARE TOTALLY EVIL AND SUCH PROLIFIC LIARS, DOES IT PUT HER AND THEM BEYOND THE REACH OF THE LAW?

Devra Patton West would be serving multiple life sentences for murder, racketeering and lesser crimes but for the fact that she is aided and abetted by the senior members of her cult / criminal gang who are all willing accomplices in murder and organized crime.

We have looked at just four of the most serious crimes that Devra Patton West committed while masquerading as the Ascended Master Devra Ji between 2000 and 2005, and the Ascended Master Surya Ma between 2005 and 2010. One could add to the short list above perverting the course of justice by intimidating victims and witnesses to civil and criminal court cases, including two custody court cases involving her son, Chris Haywood. Countless acts of theft, fraud and extortion the victims being the members of her cult, individuals who donated cash to her charities and millions of dollars in unpaid taxes. The senior members of her cult aided and abetted her in the following ways:-

1. Geoffrey Reynolds CPA – Crimes Associated with the Extortion of Funds from Dr. Pat Cole MD. Failing to report serious crimes being committed by his employer, Devra Patton West, after taking up his employment with her in September 2006. The following two emails from Rebecca West may explain why. 'Help Me' & I checked you website.' He obviously money laundered \$460,000 of funds extorted from Dr. Cole MD by Devra West, and he more or less admitted it in a statement he gave to the Bigfork Eagle newspaper on August 9 2007. Reynolds money laundered these funds after his predecessor resigned rather than be forced to manufacture false invoices to make it look like the funds extorted from Cole were received as 'normal' business receipts. This email from Carlida Finch speaks to the reasons why the bookkeeper, his predecessor, resigned. He wrote four statements of denial (that Devra West had assaulted Dr. Cole) and published them on West's website; here are those statements 1, 2, 3 & 4. He made those statements knowing full well that Devra West had assaulted Dr. Cole. He made those statements at the very time he was trying to force off the whistleblower's website, a copy of Devra West's statement, 'The Law of Severity on the Path to Purification,' wherein she admitted that she had assaulted Cole. Follow this link to read a copy of Reynolds' email to service provider for John Watson's website wherein Reynolds claims copyright of Devra West's written admission of guilt. He attempted to use the Millennium Copyright Act (MCA) to remove the statement so the public could not see it while he, Devra West and the rest of the cult were denying her guilt.

1A. Geoffrey Reynolds CPA – Crimes Associated with Devra West's Plot to subvert a Civil Lawsuit against her, murder John Watson and the Subsequent Attempt to Extort \$10,000,000 from him. While researching his lawsuit against Devra West who had defrauded him in 2002, John Watson found out that there were literally scores of victims of theft, fraud, extortion and violent assaults at the hands of Devra West. After receiving a series of harrowing emails in March of 2007 from employees who were trapped inside Devra west's cult, John Watson decided to share what he had learned with the press. Accordingly on July 12 2007, the first of two news articles appeared in the Whitefish Pilot newspaper followed by a second article in the Bigfork Eagle newspaper on August 9 2007. While giving a statement to the reporter and, in what he thought was an 'off the record' conversation, Geoffrey Reynolds stated that the whistleblower, John Watson, would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. Several days after his comments, there was a credible attempt by Devra West to murder John Watson, and in the months and years that followed, Devra West launched a campaign of occult 'under the radar violence against John Watson and his family which, if not successful in murdering him, was intended to have him go after Devra West in a way that would likely land him in jail.

Below are two links; the first explains why lunatics like Devra West are so hard to prosecute and the second compares Devra West with her Brazilian counterpart 'John of God' an occult predator, who was recently arrested for scores of serious crimes. After his arrest, 300 victims came forward alleging they too were victims, but were too scared to come forward until he was in police custody. 

When they were apprised of his 'criminal' past they at first sanitized his resume to remove all mention of the 8 years he spent as a member of Devra West's cult / criminal gang, and more recently, removed his photo.

After the murder plot failed, Geoffrey Reynolds waited three years until 2010 when he joined Devra West in a criminal conspiracy to bankrupt John Watson. The conspiracy required Geoffrey Reynolds to make false pleadings to a Montana court using an exact copy of the pleadings Devra West made to that court. They both alleged that John Watson had defamed them, though in fact he was telling the truth about Devra West. However, while the truth is an absolute defense against defamation that defense only works if you can afford to travel to the US and hire lawyers to defend the truth in court. West and Reynolds gambled that the John Watson, after emigrating abroad in 2005, would not be able to afford to defend their pair of frivolous lawsuits. Both sets of pleadings were a pack of lies, but in Reynolds' case more so, as their pleadings asserted that John Watson had defamed Geoffrey Reynolds between 2002 & 2006, and yet Reynolds had not travelled from out of state to Montana to take up his employment with Devra West until September 2006! So, neither he nor John Watson knew the other existed. However, this is what criminals do. If they cannot intimidate you or murder you, they 'buy' the law they want. As a consequence of John Watson being unable to travel to the US to defend himself, Devra West was awarded a \$5,000,000 undefended default judgment, with Geoffrey Reynolds being awarded the same amount even though his pleadings were a total pack of lies. The civil courts are not there to administer justice, they are there to administer the law. The courts are run as a for-profit corporation and as this image makes clear, the main beneficiary of the court system are those who work for it namely the lawyers and the judiciary.

2. Julio Williams MD - Crimes Associated with Devra West's Plot to Plot to subvert a Civil Lawsuit against her, her campaign of intimidation against John Watson and his family and the ongoing attempts to murder John Watson. Williams a member of West's cult since the year 2000, grew up in the Dominican Republic where one of the main religions was Voodoo. Imagine Williams' glee at joining a Satanist Death cult led by Devra West. During the 6 months the whistleblower was engaged by Devra West as a business consultant between January 2002 and August 2002, though having no direct interactions with Williams, he does remember him bawling his eyes out during some of the meetings he

attended. These sessions, which included mood music and ritual magic, were closely choreographed by Devra West as part of the brainwashing and conditioning that each cult member goes through. In 2005, at Devra West's obvious prompting, Julio Williams and two other cult members posted a defamatory statement about the whistleblower on Devra West's website. Knowing that she was being sued by John Watson, the purpose of this statement, directed at the cult, was to try to gain the moral high ground by 'painting' John Watson as the villain while extolling the many virtues of Devra West, which in reality were nonexistent. Indeed it is highly likely that Devra West authored the statement and just attributed it to Williams and two other cult members.

In July of 2007, immediately after the Whitefish Pilot newspaper article was published, mainly focusing on Devra West's vicious assault on Dr. Cole MD but mentioning several other crimes being committed by Devra West at the time, Williams, like cult member Reynolds issued two statements of denial. You can read those two statement by going here 1 & 2. Williams denied that the leader of his cult Devra West had assaulted Dr. Cole MD even though he knew that she had been responsible for the assault, even though he knew the police were called at the time of the assault, even though he knew she had been offered a plea deal to lower the charge to misdemeanor assault. He denied the assault knowing that Devra West had admitted the assault herself in a written statement she sent out to all cult members, including Williams, on April 17 2006 entitled 'The Law of Severity on the Path to Purification.'

In November 2007, Williams tried to 'pervert the course of justice' by attempting to intimidate John Watson who was the plaintiff in a fraud trial with the leader of his cult; Devra West being the defendant. In an email to John Watson, Julio Williams told Watson "not to fu\*k with him" and told Watson that he, Williams, was going to give \$2,000,000 to Devra West for her legal fees. At this point, it is worth going back to what Devra West told John Watson during their March 2003 meeting which was that if Watson sued her, she would get so down and f\*cking dirty, huge expenses coming out of his pocket but not hers (as members of her cult / criminal gang would pay for her legal fees. The member of her gang who funded Devra West's legal fees was / is Julio Williams MD. Since John Watson took a digital tape recorder to the meeting, you are able to listen to the exchange between John Watson and Devra West, including her assertion that Williams would pay for her legal fees, by following these links.



In March of 2007, a few short months before the Whitefish Pilot newspaper published their expose on Devra West's criminal racketeering business AKA 'World Service,' John Watson started to receive a series of emails from employees trapped inside Devra West's cult chief amongst these was from Rebecca West (no relation to Devra West), Carlida Finch and John Mark Young. Anyone reading these harrowing emails cannot fail to come to the conclusion that Devra Patton West was at that time a despot and a tyrant who, wielding her occult weapon, was robbing, thieving, defrauding, terrorizing and preying on her employees. Fully in the know and a willing accomplice to organized crime, Julio Williams rather than distancing himself or going to the police, donates \$100,000 of his fortune to the leader of his cult / criminal gang. After the two newspaper articles appeared in the Whitefish Pilot and Bigfork Eagle newspapers in July and August of 2007, it was obvious that Devra West's criminal racketeering business was 'dead in the water' in Montana as no one was buying the 'divine being' routine which forms the basis of her propaganda. Accordingly, the cult moved to the third western state since leaving New Mexico in 1995 and that was Arizona.



Reprising his role as chief 'liar for hire' Williams started to market Devra West, who he knows to be a Satanist and a suspected serial killer, to the citizens of Arizona as divine being / guru just as he had done in Montana. Williams did this knowing about the two arrest warrants, one for criminal check fraud and one for felony theft. Williams did this knowing about Devra West's conviction for assaulting Dr. Cole MD, the assault that Williams denied happened. Williams did this knowing that Devra West was the subject of a Sheriff's Sale to force her to pay past victims of crime \$2,000,000 in court fines and interest. Williams did this knowing that Devra West was the defendant in several fraud related court cases in Montana including the one John Watson brought against Devra West and who turned whistleblower after learning that he was one of scores of victims of Devra West's so called 'world service.' Williams did so knowing that Devra West and Geoffrey Reynolds planned to murder John Watson and when that failed, tried to bankrupt him by attempting to use two frivolous defamation lawsuits against him in an attempt to extort \$10,000,000 from him.

Since moving with the cult to Carefree AZ, Julio Williams has published a statement on Devra West's website appealing for money for the 'Divine Feminine' which is odd as Williams knows full well that Devra West regularly violently assaults female members of her cult. Some psychopaths kick their dog or cat. Devra West gets off on viciously assaulting women, as has been evidenced by her assault on exemployee Susannah Felder, ex-student Beatrice McGuire and ex-student and business partner Dr. Pat Cole MD. Devra West also assaults children, as Ingrid Smith will attest, and was known to terrorize her pet Labrador who peed itself when she entered the room. Rather than this being a concern for Williams, as a card carrying Satanist like Devra West, theft, fraud, extortion, violent assaults and murder are seen as a badge of honor as one works their way up the ladder inside the cult.

More recently, Williams hosted a 'Sacred Sunday with Rishi' (gag) at a property he rented in Carefree AZ (see image above here) at his own expense and specifically for the use of Devra West. As one can see from the sycophantic 'testimonials' Williams was clearly 'marketing' the suspected serial killer as being able to deliver 'miracle cures' - for a hefty price of course. In contravention of all medical norms, and in contravention of the FDA rules, Julio Williams was on hand as a bona fide physician / surgeon to assure potential candidates for extortion healing that Devra West really was a 'divine being' and able to deliver 'Divine Grace Healings' as advertised on her <a href="Facebook">Facebook</a> pages. Williams knows full well that once wealthy spiritual seekers or the wealthy candidates for healing have been identified, they would be targeted for extortion. He knows that the same weapon used to keep the rank and file members of the cult in-line would be used to make them ill and then force them to pay for a cure. He knows that the same weapon used to murder Lisa Swidler, would be used against them. He knows that the same weapon used in the attempt on John Watson's life will be used against them. He knows that the same weapon used to target the whistleblower and his family for the past 12 plus years, will be used against them. However, being a Satanist all forms of cruelty and harm are like blessings to him.

In 2016, and in an attempt to overcome the truth about Devra West's past criminality in Montana and New Mexico, Julio Williams MD bought a website and posted a statement on it about the injunction that Devra West obtained as part of the frivolous lawsuits that she and cult member Geoffrey Reynolds brought against the whistleblower when he arrived in court in October 2010. The reason John Watson travelled from the east coast of Canada to a Montana court was to see what that court was going to award him for winning his fraud lawsuit against Devra West in 2008. Long story short, rather than end the matter there, Devra West, a vengeful and vile creature and her stooge Geoffrey Reynolds, issued two new lawsuits against John Watson basically accusing him of defaming her and Reynolds. Unable to

travel backwards and forwards to the US to defend those lawsuits Devra West and her stooge Reynolds each acquired default undefended judgments in the amount of \$5,000,000 each and were awarded the injunction they sought preventing the whistleblower from sharing what he had learned while researching his own lawsuit against Devra West. The whole point of the injunction was to hide West's criminal past from the public, so that she could reincarnate herself in Arizona as the Ascended Master Rishi Devra and resurrect the well-oiled criminal racketeering business model that had worked so well for her in Montana and New Mexico. Williams did not tell the truth about how Devra West obtained her injunction / gagging order, instead he asserted that it was obtained as a result of a private investigation by a Judge into a fictitious extortion scam mounted by John Watson against Devra West. The tactic of 'mirroring' her crimes onto her victims was the same tactic used in Montana against Dr. Pat Cole MD and John Watson. In both cases, Devra West denied she was found guilty of assault in Cole's case, and fraud in Watson's case. Instead, she publicly stated from her website that the authorities had dismissed the assault case against her and that Watson's win against her was a "technical error." Which brings us to the last point about Dr. Julio Williams, and one that links him directly as an accomplice to murder and the ongoing attempts by Devra west to murder the whistleblower John Watson. For the past 6 or 7 years, John Watson has been logging the occult attacks on him and his family (wife and children). Between 2011 and 2015, John Watson sent some 300 plus emails to Devra West's lawyers complaining about the occult 'under the radar' violence being directed at him and his family. In 2015, after West's lawyer blocked his emails, the whistleblower John Watson started to send those emails, logging the ongoing attacks against him and his family, to Julio Williams MD. Between 2015 and the present, Julio Williams MD has received some 300 to 400 emails logging the ongoing campaign of occult 'under the radar' attacks by Devra West against John Watson and his family members. This is the very weapon that Devra West has used for the past 27 years, since she acquired that knowledge in 1991, to feather her own financial nest at the expense of everyone who crosses her path.

Last week, after a particularly harsh email from our group in the UK that made it obvious that Devra West was a pathological liar, Devra West launched a series of occult attacks directed at the whistleblower's heart, clearly intended to murder him though similar attacks over the past 12 years

have failed to achieve that end. None the less, the attacks occurred and as a result of those attacks, John Watson sent the following email to Julio Williams MD to add to the 300 or 400 previously sent logging these attacks. Here is an excerpt from that email.

On Saturday, April 27, 2019 9:42 AM, <johnwatson@protonmail.com> wrote:

Julio I write only to add the lengthy paper trail which will be examined in court as part of the evidence against you, Reynolds and the leader of your terrorist / racketeering gang / cult. When on the witness stand you will get to explain why you have not shared these emails with the police and similarly Reynolds will get to explain how he came to announce my impending murder in 2007 and his subsequent involvement in the conspiracy to bankrupt me by joining Devra West in a conspiracy to extort \$10,000,000 from me in 2010 for telling the truth about her criminality. At the same time you will get to explain why you 'market' the lunatic as "wellspring of virtual living divinity." I for one cannot wait to hear your explanations!

For the last 24 hours I have been the subject of a vicious attack by Devra West which has manifest itself as though sharp spikes were driven into my heart. My question to you and her is this. Is that it? Is that the extent of her lore? Is that the extent of puissance? Is that all she has got?

I ask these questions with utter contempt for you and Reynolds who are willing accomplices in organized crime and perhaps multiple murders..... etc.

Julio Williams has been on the receiving end of these emails for the past 3 to 4 years and has received some 300 to 400 of them all logging Devra West's use of the occult knowledge / weapon that she bragged about while being interviewed by the Whitefish Pilot newspaper on July 12 2007. This is the same occult weapon she used against Dr. Pat Cole MD, Rebecca West and several other hostile witnesses that saw her viciously assault Dr. Cole. She used the weapon in the hope that Dr. Cole would withdraw her complaint and that the witnesses that were hostile to her would also withdraw their statements. She used the weapon against her daughter in law Jamie Haywood in the hope that she would give up her infant daughter to her porn loving wife beating son Chris Haywood – go here to read the court transcript of the custody hearing to get an insight into the Sage of Sedona's sordid private life.



Jack West, Devra West's ex-husband accomplice in organized crime since the 1970's, sits amongst the new intake just as he did in 2000 when the whistle-blower was recruited from a meditation group he chaired.

His role is to meet, greet and circulate amongst the potential recruits to the cult to see which is wealthy, which has influence and who would be useful as low paid or no-paid labor. This well-oiled criminal conspiracy has not changed in its approach in two decades or more and why should it? As Devra and Jack West's guru / cult / extortion business model has netted tens of millions of dollars a year for 'world service' and yet no records exist of funds going anywhere except to fund her lavish lifestyle costs.

Having assaulted Beatrice McGuire in front of scores of witnesses and having paid her to have plastic surgery Devra West denies she was responsible asserting that Beatrice McGuire is being mentally ill.

A similar incident happened in July of 2001, when employee Susannah Felder caught Devra West stealing \$80,000 from her charity to pay for her son's legal fees. When challenged about this Devra West attacked Susannah ripping clumps of hair from her head. The following day at a meeting, Jack West blamed the incident on the victim asserting that it was her fault that the soon to be planetary regent had attacked her for calling her out of theft! Board member AJ White's account of the incident shows that Jack West was then and still is now, a willing participant in organized crime. When John Watson joined Devra West's charity 'the Circle of Divine Unity' in January of 2002, he thought he was working for a genuine charity / non-profit charity and had no idea initially that this was a front for a cult. Around the April- May timeframe, Jack West and he while working to clear some dead logs from the charity's property, Jack West confided in him that people who ended up opposing his wife ended up dead. **Step 1.** Those identified as wealthy targets are invited to attend a 'Private' Sessions or a 'Private' Intensive' as advertised on her website below and as hosted by Dr. Julio Williams MD.



<u>Step 2.</u> Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.

2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for the nonexistent wrongs the target committed).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! Listen to two of her admin staff, Diane Stoner and Kathleen Francisco talking about one this.

In this way the target receives an imaginary cure and in return <u>The Regent of the Spiritual Hierarchy of the Western Hemisphere</u> gets to empty the targets bank account into hers. Note her standing there with her hands out saying "give me, give me."



This has been going on for 27 years right under the noses of the FBI and the IRS. It is illegal for a lay person to assert that they are able to cure someone of a health condition. Apparently not so for Devra West! At \$500,000 a go, it is no wonder she can afford the trappings, clothing, lifestyle and home of a multi-millionaire even though she claims to be penniless and the funds she extorts from victims are nowhere to be seen, let alone declared to the IRS as income in her tax returns.
