

Subject: Rishi Devra – AKA Devra Patton West Compelling Evidence of Multiple Murders and Decades of Organized Crime.

Rishi Devra – AKA Devra Patton West. Compelling Evidence of Decades of Organized Crime with Cult / Gang Members Reynolds & Williams willing accomplices in Murder & Racketeering.

In previous editions of this weekly bulletin we have detailed how, prior to 1990, pot grower, drug dealer, bankrupt and small time crook Devra Patton West with her husband Jack West, defrauded individual victims like [Jeremy Samuelson](#) and [Satya](#) out of several thousand dollars at a time. We have also detailed how, after acquiring occult (hidden) knowledge while attending the [Robert Jaffe School for Energy Mastery](#) (itself a cult) between 1990 & 1991, Devra Patton West was able to use that hidden knowledge to leverage her criminal tendencies. To come to the point, instead of her and Jack West having to seek individual victims to defraud on completing the course in 1991, she declared herself an Ascended Master and developed a criminal racketeering business model that 27 years later she is still using to great effect.

Put simply, Devra Patton West moves into an area, declares herself to be a divine being / guru / Master Teacher and waits for the spiritually confused to come flocking to her like moths to the flame and often with the same outcome. Over the past 27 years her business model has remained largely unchanged all that changes is the 'save the world' schemes she promotes and uses as a focus for the 'sheeple' to fund raise around. There is zero evidence after 27 years that a single penny of the tens of millions of dollars raised have gone towards any of the 'good causes' she espouses. However, what she does do is use some of the donations, and some of the tens of millions of dollars acquired from victims of theft, fraud and extortion, to create a totally illusory on-line identity based on her narcissistic beliefs that she is a minor deity. Question. How is it that Devra Patton West is not in jail? Answer. Two reasons.

1. Religious Freedom Laws. Under religious freedom laws, Devra Patton West can make as many outrageous claims about herself as she wishes with little fear of prosecution. She claims to be a 'divine being' even though there is a mountain of evidence to show she is a thief, a fraudster, an extortionist and guilty of several violent assaults against female members of her cult. So in spite of the FACTS, Devra Patton West claims she is...

The Regent of the Spiritual Hierarchy for the Western Hemisphere.

2. A License to kill with Impunity. Between 1990 & 1991, Devra Patton West acquired the ability, using the same techniques that shaman's around the world use, to cause illness, injury and death at a distance. In effect she wields a license to kill using a weapon that legal statute does not even recognize as a weapon. Like all psychopaths (Hitler & Stalin to name but two) she believes she has the right to prey on peasants and lesser beings.

There is plenty of evidence both from Devra West herself, and from some of her victims that she uses this weapon / license to kill against others. The occult 'weapon' is used in the course of committing financial crimes against others and to subdue and intimidate those victims and witnesses who might go public about their experiences or go to the police or seek redress through the courts. For example, in a newspaper interview with the [Whitefish Pilot](#) on July 12 2007, Devra West admitted being trained in Shamanism by Native American elders. Devra West was being interviewed about her vicious assault on her business partner Dr. Pat Cole MD.

One of the witnesses to that assault was one of Devra West's employees, Rebecca West (no relation to Devra West). Rebecca West wrote to the whistleblower John Watson in March of 2007, asking for help with Devra West's shamanic witchcraft. You can read Rebecca's harrowing request for aid by going to her email entitled '[Help Me.](#)' Another victim of the occult weapon was Devra West's own daughter in law [Jamie Haywood](#) who, after splitting from West's porn loving wife beating son Chris Haywood, became the recipient of a campaign of occult 'under the radar' violence intended to intimidate her into giving up her infant daughter to West's son.

However none of these incidents, coming from credible witnesses as they do, give the reader (or the FBI and police) any idea of the sheer scale of Devra Patton West's criminality over the past 27 years.

Neither do any of the aforementioned examples adequately highlight the roles that senior cult / gang members Geoffrey Reynolds CPA & Julio Williams MD play as accomplices in murder, criminal conspiracy, money laundering and intimidation of victims and witnesses of crimes committed by Devra Patton West. We are 99% sure that Devra Patton West murdered [student Lisa Swidler](#) in 2005, and 100% sure that she tried to murder whistleblower John Watson in 2007. However, after another recent

failed attempt by Devra Patton West on the life of the whistleblower, we now feel it is important to let the FBI (and the public in Sedona and Scottsdale AZ) know exactly what they are dealing with.

We know that Devra Patton West's occult abilities facilitate her criminal activities. We believe we have enough evidence to 'prove' she is a killer and perhaps a serial killer and that Reynolds & Williams are her willing accomplices in murder and racketeering.

After many months of asking, we have finally been given permission by the whistleblower John Watson to share some of the correspondence that has passed between us. However, before we get into that let us just remind ourselves of what has been happening since Devra Patton West promoted herself to the status of Ascended Master (gag). Since 1991, Devra Patton West has been committing crime on an industrial basis against students to her non-accredited school (Hogwarts), employees and business consultants which includes John Watson who turned whistleblower about West's cult in 2006. Below are a few of the victims – these are the tip of the iceberg.

- 1.** Employee Rebecca West (no relation to Devra West) assaulted, brutalized and threatened with murder. Her [harrowing emails](#) to the whistleblower clearly show West's insanity and criminality towards others.
- 2.** Dr. Pat Cole MD [viciously assaulted](#) as part of a campaign of violence to extort \$1.3 million from her which West succeeded in doing. She wrote to her cult days after the assault entitled [The Law of Severity on the Path to Purification](#) and in an attempt to justify the assault stated that as Dr. Cole MD was a Nazi in the WWII death camps in another lifetime the beating was not only deserved but long overdue. No mention of the \$1.3 million!
- 3.** Employee Susannah Felder caught West stealing an \$80,000 donation from the charity to pay for her son's legal fees in a custody battle with his ex-wife. Upon being challenged, West [partially scalped Susannah](#) by ripping clumps of hair from her scalp. West stated that the money was hers to do with as she pleased and not the

charity's.

4. Student Lisa Swidler negotiated a short bridging loan of \$30,000 from student [Dave Kushner](#) promising that West would repay the loan within 14 days. After receiving the money West refused to repay it or even discuss it with Dave Kushner in spite of the fact that Devra West had signed a written agreement promising to repay.

5. Student [Marion Cantwell](#) was kidnapped, falsely imprisoned, beaten and only released after handing over tens of thousands of dollars from the recent sale of her property. When she was released she was told that she would be murdered if she went to the police.

6. Student [Beatrice McGuire](#) was attending a seminar in Montreal given by Devra West. During the seminar Beatrice challenged West on an obvious lie and in response, and in front of the entire audience, ripped part of Beatrice's ear away from the side of her head. Beatrice later needed plastic surgery which West paid for!

7. Consultant John Watson was promised pay and shares for setting up for profit and nonprofit corporations for Devra West. After completing the work she refused to pay him saying God had told her shareholding was a thing of the past. In 2003, he decided to sue her for fraud along the way he was subject to all manner of dirty tricks including [false witness](#) statements by West's cult members, [threats from senior cult member Julio Williams MD](#), a failed murder plot in 2007 and in 2010 he was the subject of a criminal conspiracy by Devra West and [Geoffrey Reynolds CPA](#) another senior member of West's cult. Watson [won his lawsuit against West for fraud](#) in 2008.

8. Student [Lisa Swidler](#) brokered the bridging loan with Dave Kushner mentioned above in (4.) and was also aware that West kidnapped, falsely imprisoned and extorted money from student Marion Cantwell. Lisa made a break to leave the cult and died suddenly and mysteriously shortly after getting away. We believe that Devra West murdered Lisa to keep her quiet. And why not? The occult weapon West uses to instill fear and discipline in the members of her cult and the victims and witnesses of her crimes is not regarded as a weapon under legal statute!

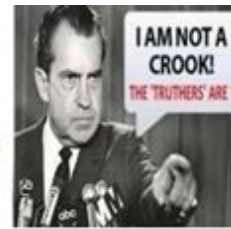

9. Robert & Tabby Ivy owned a multi-million dollar lakeside property however photographs of their property appeared in Devra West's brochures and on-line on her website. In both cases West inferred that the property belonged to her and not Robert & Tabby Ivy. Over a 2 year period, the owners repeatedly asked Devra West not to use images of their property in her marketing material – Devra West ignored their requests as the article in the [Whitefish Pilot](#) about West's criminality makes clear. The Whitefish Pilot news article was published on July 12 2007 which was the same day that West and her son appeared in court as part of a custody hearing. During the hearing, West repeatedly lied. For example, she stated that she [was a billionaire](#) (when she was broke had [a \\$2,600 lien](#) against her for unpaid employment insurance) and vehemently [denied assaulting Dr. Cole MD](#) when she wrote to her entire mailing list on 17 April 2006 saying that she did!

It should be stated here that West's mantra is that, and I quote, ["The truth does not matter"](#) if she can convince the public that her lies are their truth! The link will take you to an audio recording of West saying that!

10. Mike Hendrickson was a partner in a large Colorado accountancy firm; he was also a student of West's who did the charity's books. After challenging West on money she was stealing from the charity he was relieved of his position and told to go away until he was prepared to totally submit to her will and accept that the laws of the land do not apply to her. Mike Hendrickson had signed a note guaranteeing the charity's overdraft of \$200,000 however after the whistleblower John Watson reported West's criminality to the authorities her charity was [struck off](#) in January 2004. Devra West immediately emptied the bank account of the [\\$200,000 and put it in a personal trust fund](#) for her and her eldest son Rob Meador. Mike chose not to sue her for fraud as to do so would result in him becoming the subject of an occult 'under the radar' campaign of violence and or be murdered.

11. Scores of victims of organized crime some of which are mentioned later in this bulletin.

Now we will detail what happened to the whistleblower John Watson and his family after he decided not to walk away empty handed after being defrauded out of wages and shares by Devra West in August 2002. As his wife's mother was dying, John Watson decided not to act in haste but instead pondered what to do over a period of several months. In July of 2002, Devra West told the whistleblower, and I quote, "God spoke to me last night and told me that share holdings were a thing of the past therefore you will not be getting the shares I promised nor will you be paid for the 6 months you have worked on these projects." End quote! In the end the sheer contempt with which Devra West treated him and the feeling that she had done this to countless other victims before (and since) led him to believe that this was a challenge he needed to take on. In March of 2003, John Watson let it be known that he was going to sue Devra West for fraud. In response, Devra West let it be known through an intermediary that she wanted a private meeting with John Watson on his property with no one else present. Fearing some kind of stunt by Devra West, John Watson set up a digital tape recorder to record the meeting.

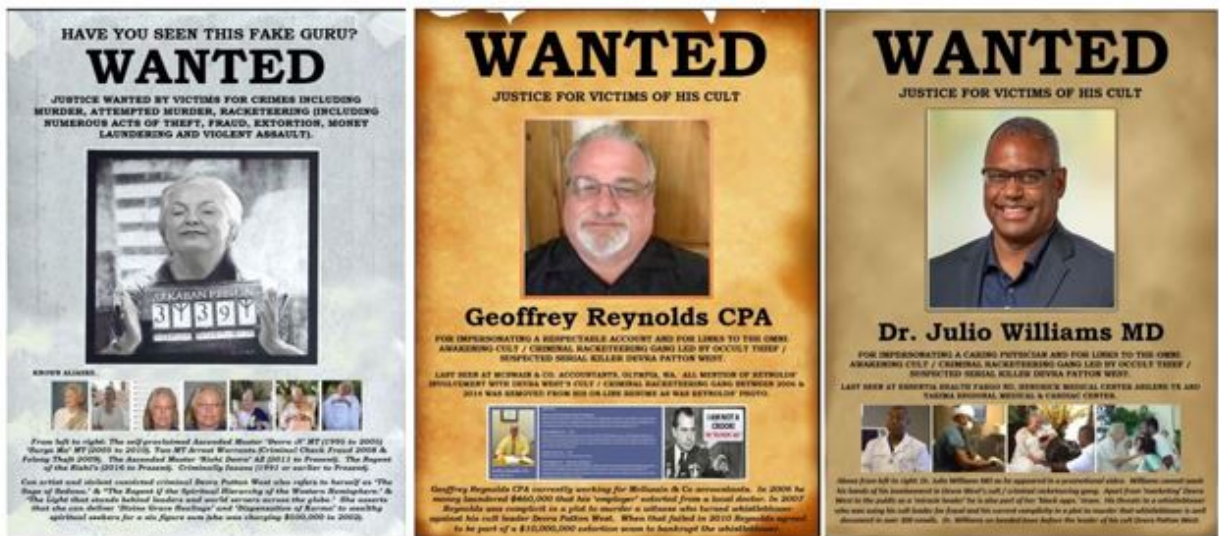
1. [Devra West refers to John Watson as 'Prince Charming.'](#)

In item (5) above, Devra Patton West tells John Watson, after admitting that she did defraud him, that if he sues her she will get so f*cking down and dirty etc. Earlier in this bulletin, we listed 11 plus victims from Montana and at number (7) was John Watson the whistleblower. In item (7) above we note that as part of the dirty tricks directed at John Watson by Devra West were the manufacture of [false witness statements](#) and [email intimidation](#) that came from senior cult member Dr. Julio Williams MD. Not mentioned was the [character assassination and defamation](#) by Williams and other cult members from West's website in 2005. However, all of this pales into insignificance when compared to Devra Patton West's failed attempt to murder John Watson in 2007 and the subsequent campaign of violence - directed at him and his family by Devra Patton West. The purpose of the murder plot and the campaign of 'under the radar' violence was intended to intimidate him into withdrawing from his lawsuit against Devra West and to force him to take down his websites. Websites that contained details of Devra West's criminal past in New Mexico and Montana which made it clear that Devra West's claims of divinity were a lie and that her 'world service' efforts were in fact a multi-million dollar a year criminal racketeering business model.

What follows is clear and irrefutable evidence that senior cult members Geoffrey Reynolds CPA and Julio Williams MD were, and still are, willing participants in Devra Patton West's plot to murder the whistleblower.

What follows is clear evidence that senior cult member Geoffrey Reynolds knew in advance that Devra Patton West was going to use her occult weapon to either murder the whistleblower or use it against his wife and children to injure, maim or kill them in an attempt to intimidate John Watson into a) pulling out of his lawsuit against Devra Patton West and b) force down his websites which contained information about Devra West's criminal past.

What follows is clear evidence that senior cult member Dr. Julio Williams MD is aware of the ongoing attempts by Devra Patton West to either murder the whistleblower or use her occult weapon against his wife and children to injure, maim or kill them. He is aware that she is doing this NOW in a vain attempt to stop our group using John Watson's information to warn the public and the FBI about Devra West's criminal racketeering business model which is now targeting Sedona & Scottsdale AZ.

What follows is Compelling Evidence of Decades of Organized Crime with Cult / Gang Members Reynolds & Williams willing accomplices in Murder & Racketeering.

While being interviewed by the [Bigfork Eagle](#) newspaper on August 9 2007, Geoffrey Reynolds speaking on behalf of his 'employer' Devra West, admitted money laundering \$463,000 that Devra West had extorted from Dr. Pat Cole MD. He further stated, in what he thought was an off the record conversation, that the whistleblower John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family (wife and children). To be clear, Devra West's murder plot failed to succeed. Geoffrey Reynolds made it clear that plan 'B' was to goad / provoke the whistleblower into reacting to the violence that Devra West was going to direct at his wife and children. The hope was that that John Watson, perhaps taking the law into his own hands to defend himself and his wife and children, would be made to look like the villain while Devra West and her accomplices would behave like they were the injured parties.

That was the plan now let us compare the plan with what actually happened.

Just as Geoffrey Reynolds predicted. Several days after Reynolds statement to the [Bigfork Eagle](#) reporter a credible attempt was made on the life of the whistleblower John Watson by Devra Patton West using the same weapon she had used against countless other victims including Dr. Pat Cole MD, [Rebecca West](#) and her daughter in law [Jamie Haywood](#). The failed attempt by Devra West to murder the whistleblower is set out in more detail in [the above link](#). Geoffrey Reynolds prediction was 100% correct proving he was complicit in Devra West's plot to murder the whistleblower.

Just as Geoffrey Reynolds predicted. A campaign of occult 'under the radar' violence was directed at John Watson, his wife and children. A campaign designed to make ill, injure, maim and kill. This campaign continues to this day. Recently the whistleblower John Watson, agreed to release some of the details of what he and his family have been subject to these past 13 years so that the FBI can begin to understand the enormity of Devra Patton West's crimes against humanity.

What follows are an excerpt from a letter he sent to his lawyer. These are some examples of the attacks that Devra Patton West, a criminally insane narcissist, occult killer has been directing at John Watson, his wife and children. These attacks doubtless used against countless other victims and their families over the past 27 years.

1. *Migraine headaches that start with the scalp burning such that the victim has to apply a cold wet towel to the head to stop the burning sensation. These migraines are so bad that the victims have to take pain killers for days until the pain subsides only to be targeted again and again.*

2. *Acid reflux attacks that continue for months causing one to have to take powerful drugs to stop their stomachs digesting itself.*

3. Sinuses constantly running. When I say running I mean that one has to walk around with a cup in one's hand to drain the sinuses into.

4. Excruciating muscle pain in the legs like cramps on steroids.

5. Extreme back ache such that one could never get comfortable except when lying down in bed.

6. Attacks to the genitals. This form of violent attack seems to have been directed at all members of the family simultaneously. A clear sign that the whole family was under attack came when different family members separated by hundreds, in one case thousands of miles, acquired the same symptoms on the same day!

7. Targeting my heart was, and still is, a favorite target of West's. These attacks gave me the feeling that a stake was being repeatedly pushed into my heart. 13 years ago when these attacks started this was quite worrying however 13 years later I have learned to ignore these attacks in the knowledge that if Ms. West had been able to kill me she would have done so long ago. Long term effects unknown.

8. The Feb / Mar / Apr 2018 long term attack was against my right ankle. Long story short, while I slept the pain built up in my right ankle and when I get up it was painful to walk. Throughout the day the pain subsided somewhat (a moving target is harder to hit) but overnight the occult thief / suspected serial killer works on it again.

9. While employed in 2017 my right knee and ankle were targeted simultaneously; these attacks continued for several weeks and everyone at my place of work noticed that I was limping for weeks. Eventually Devra West must have got bored or whatever spell / software / visualization she was using wore out. Perhaps she just moved on to another target.

10. *A sudden spate of nose bleeds. I never get nose bleeds I do not have high blood pressure and yet in 2017 I suddenly had seven or eight in quick succession all within a month. Part of West's strategy is to try and frighten the target into submission by having them believe the attacks, especially the attacks to the heart and head, might prove fatal. Having been a marine I do not scare easily and certainly nose bleeds are not going to ruffle my feathers.*

11. *One of the attacks Devra West uses regularly is against our digestive systems. Like all the other attacks this variety of violent assault is preceded by a loud hissing. Within minutes whatever we have in our stomachs starts gurgling loudly, followed by severe stomach pains (gas) then diarrhea. Even after eating the most bland food upon hearing the hissing my wife and I would both know what came next.*

12. *Another favorite attack of Devra Patton West's, also preceded by a loud hissing, is where one's energy is drained, to the point of wanting to go to sleep.*

15. *Attack to one or both eyes. This felt like someone was pushing a needle through the eye.*

14. *Irrespective of what region of the body Devra West is targeting there is always the sleep deprivation. This has been consistent throughout the 13 years and commented on by other victims including West's neighbor in Flathead Lake Michelle Fetveit who got into a water dispute with West. I interviewed Michelle in 2007 and sure enough she remarked about being woken up at 3.00 am each morning.*

Over the past 13 years, the effectiveness of these violent assaults has diminished somewhat however the long term effects are unknown.

Geoffrey Reynolds CPA – Guilty as Hell! How could senior cult / gang member Geoffrey Reynolds have so accurately predicted John Watson's murder and predicted that he and his family would become the victim of occult attacks by Devra West unless he had been fully briefed by her before the interview with the [Bigfork Eagle](#) reporter in August 2007? Why was Reynolds so confident that Watson would be murdered or provoked into reacting in a way that would land him in jail? Had Devra West shared how she had used those strategies successfully on other victims? Had she bragged to Reynolds about the

murder of Lisa Swidler and some of the other murders that ex-husband Jack West referred to when he told John Watson in 2002 that people who opposed his wife had a habit of dying suddenly?!

After the failed murder attempt in August 2007, Geoffrey Reynolds 'doubled down' on his treachery when in 2010 he joined Devra West in a conspiracy to bankrupt John Watson by attempting to use the civil courts to extort \$2,000,000 from him. Julio Williams MD – Guilty as Hell. Senior cult / gang member Julio Williams MD is also very aware of the ongoing campaign of occult 'under the radar' violence still being directed at whistleblower John Watson, his wife and his children by the leader of his Satanist cult Devra Patton West. Remember, Julio

Williams [defamed](#) the whistleblower in 2005, and sent John Watson [a threatening email](#) in 2007. He even promised to give Devra West \$2,000,000 to fight John Watson's lawsuit against his cult leader. We know senior cult member Dr. Julio Williams is 100% aware of what is going on because the whistleblower has sent him 300 to 400 emails over the past 4 years detailing the violent attacks by Devra West. Attacks that Julio Williams, as a student of her unaccredited school for occult studies, is learning to use himself.



"She is a blessing to all souls"

We have suggested that the FBI view the contents of Julio Williams' email accounts where they will find hundreds of these emails. If Williams has deleted these emails we are sure the whistleblower can provide copies of the originals. Prior to 2015, all the way back to 2012, the whistleblower sent a further 300 emails to Devra West's then lawyer, James C Bartlett. These emails detail and log the attacks between 2012 & 2015, until Mr. Bartlett blocked John Watson's emails. These emails can also be provided by the whistleblower if Mr. Bartlett asserts client privilege over the emails to protect his ex-client!

Julio Williams MD just as much an accessory to murder, violent assaults, grievous bodily harm and conspiracy to pervert the course of justice as senior cult / gang member Geoffrey Reynolds. It is also worth pointing out that neither Geoffrey Reynolds nor Julio Williams had ever met John Watson. However, at the direction of their cult / gang leader Devra Patton West both readily agreed to become involved in a plot to murder John Watson (ongoing) and agreed to join a criminal conspiracy to violently target Watson, his wife and children.

Let me be very clear. Devra Patton West is a cold blooded killer who may be responsible for the deaths of several or more victims. These extra-judicial killings would have appeared, to the authorities, to have been death by natural causes.

Psychopath Devra Patton West believes / hopes that none of the parents of the children she is targeting will go after her own children. The whistleblower John Watson has, so far, shown himself to be a patient and law abiding citizen in spite of the hundreds of provocation by Devra Patton West against him, his wife and children over the past 13 years. There is a reason for this!

Speaking on behalf of his 'employer' Geoffrey Reynolds told the Bigfork Eagle news reporter in August 2007 that the cult's plan 'B,' in the event that John Watson was not murdered, was to provoke him into reacting to Devra West's attacks on his family in a way that they hoped would land him in jail.

John Watson has declined to do that. Instead, he has patiently bided his time while building a lengthy and detailed paper trail of evidence for the authorities, so that if and when, he does decide to take direct action against Devra West in self-defense, the authorities will understand why. However, supposing John Watson was not the patient ex-marine that preferred the authorities to deal with this matter (and has waited 13 years for them to do so!). Or supposing it was someone else whose children had been targeted in the way described above. Supposing that someone realized that the authorities were totally incapable of dealing with someone like Devra West (as the authorities have shown themselves to be so far). Supposing that person believed in the adage 'an eye for an eye and a tooth for a tooth' when wanting revenge for the attacks upon their children. With Devra West safely tucked away in her gated community, the obvious target would be to go after the 'low hanging fruit' i.e. Anna West and/or her son.

This is not far-fetched as it seems as in 2002, Jack West told John Watson that he, his wife Devra West and their young daughter Anna West were chased out of New Mexico by a gun wielding victim who realized that the police were not going to be able to help him with Devra West's use of an occult weapon. Of course Devra West, being criminally insane, would not hold herself responsible in any way

for what might happen to her daughter or grandson were that scenario to play out. As Devra Patton West made very clear in her discussions with John Watson the whistleblower in March of 2003, “her agreements are worth nothing” and she regularly “disposes of people like Kleenex.” However people who live in glass houses should not throw rocks, but explaining that to a psychopath like Devra West is a waste of time! Perhaps it is time for Anna West and her immediate family to move into a gated community, as it is likely that her mother has acquired quite a few enemies, some of whom may not be as well balanced in their long term thinking as John Watson.

In 2003, John Watson made it clear to Devra West that she would not screw him like she had so many other victims before (and since). If Watson, an ex-marine, had been that resolute after being defrauded out of \$50,000 by Devra West, think how more determined he would be after Devra West had repeatedly tried to cause grievous bodily harm to his wife and children. After 13 years of failing to intimidate him, any sane person would have realized by now that John Watson was going nowhere and will continue with his quest for justice until Devra Patton West and her two accomplices, Geoffrey Reynolds and Julio Williams, are the subject of a criminal trial for attempted murder and racketeering. That quest will continue whatever Devra West and her accomplices decide to do.

Finally, let us give you the reader and the FBI an idea of the sheer scale of Devra West’s criminality.

1. Countless acts of Theft, Fraud and Extortion. Victims like Mike Hendrickson, defrauded out of \$200,000, Marion Cantwell kidnapped, falsely imprisoned and forced to donate tens of thousands of dollars and Dave Kushner defrauded out of \$30,000. After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?

2. Multiple Murders. Jack West told John Watson in 2002, that those who opposed his wife had a habit of dying suddenly. Lisa Swidler (witness to the crimes against Marion Cantwell and Dave Kushner) was undoubtedly murdered when she tried to leave the cult. Marion Cantwell was threatened with murder if she went to the police, Rebecca West was threatened with murder and Carlida Finch overheard Devra West planning the murder of Dr. Pat Cole. How else would Reynolds know that the threats by Devra West against the whistleblower and his family were credible?



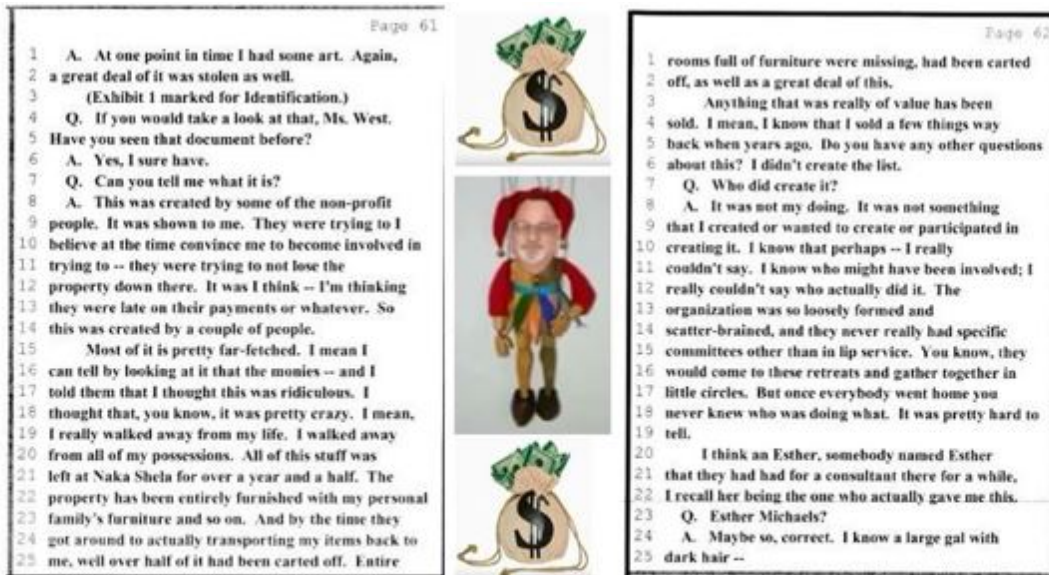
Above from left to right: Lisa Swidler murdered in 2005. Marion Cantwell kidnapped, robbed and threatened with murder if she went to the police. Dr. Pat Cole; West overheard planning her murder but was reprieved after paying West \$1.3 million. Then John Watson after turning whistleblower in 2007, became the subject of two murder plots and a campaign of violence directed at him and his wife and children which is ongoing.

3. Massive fraud perpetrated against countless individuals, state governments and the IRS. Several millions of dollars in public donations to a charity diverted into Devra West's pocket with ZERO tax paid by her. Above: This is an excerpt of a statement Devra West gave to a Montana court in October 2009. Within the statement she made it clear that \$4,000,000 (as valued in 2002) worth of art work and valuables largely paid for by public donations had been stolen, lost or disappeared. Reynolds is depicted in the middle fencing stolen property.

In the previous photo featuring her daughter, grandson, Jack West and Julio Williams MD, art work and valuables can be seen recently at auction or for sale by Devra West in Arizona. These are the items [she stated in court](#) in 2009 did not exist. In reality, these items disappeared in 2004 after her charity was struck off for fraud and reappeared in Arizona in 2014, after the statute of limitations for theft had expired. 4. Court cases undermined and subverted. Victims of crime and witnesses targeted with occult 'under the radar' violence to get them to withdraw complaints and lawsuits. Witnesses intimidated into withdrawing their hostile witness statements against Devra Patton West. All done behind the scenes with victims and witnesses too afraid to share their experiences with the police or the authorities for fear they will not be believed. Example below here.....

Here is example of how vile a serpent Devra Patton West is and just how successful she has been at undermining the police, the justice system and the courts. Kendal Strnad was Chris Haywood's first wife; Chris Haywood is Devra West's son. In around 2003/4 time period, their marriage having broken down, they fought a custody battle for Kendal and Chris's infant daughter. Devra West targeted Kendal day and night with the kind of 'under the radar' violence that West used against me, my family and my children. The campaign of hidden violence was necessary because Kendal was a wholesome wife with no blemishes, while Devra West's son [Chris Haywood had an FBI record](#) for forgery, substance abuse and traffic violations. The first daughter was wrested from her and given to her first husband after a sustained campaign of occult 'under the radar' violence directed at her by her ex-husband's mother Devra Patton West. As a result, Kendal was made to look like she was mentally ill.

How do you win a custody hearing for your son who has an FBI record for substance abuse, forgery etc. against a wholesome young mother with no blemishes? You make the wife look a worse bet than the husband and that is exactly what Devra West proceeded to do. She targeted Kendal relentlessly day and night until she ended up seeking psychological help for what she thought was a mental health condition. Add this to a statement given by Dr. Pat Cole MD, a member of Devra West's cult at the time, and Kendal lost the custody battle and had to give up her daughter. Kendall had no idea what was happening to her, had no one to turn to, and like most other victims of West's tyranny believed that if she shared what was happening to her, no one would believe and probably thought she was going crazy. Well, Kendal shared her experiences (talked about the occult attacks) with a psychologist and look where it got her! In July 2007, a day before the second custody hearing, [Jamie Haywood emailed](#) John Watson via his website to say that she too was the subject of exactly the same campaign of 'under the radar' violence and mentioned it in court on July 12 2007. Fortunately, Jamie Haywood got to keep her infant daughter unlike Kendal, who lost hers to Devra West's tyranny. As a foot note on the sad subject of Kendal, while John Watson was being deposed by Mr. Bartlett in 2010, the subject of Kendal Strnad came up. Mr. Bartlett asked John Watson if he knew that Kendall had been diagnosed with some form of mental condition. Mission accomplished for Devra West in that she had managed, using a campaign of occult 'under the radar' violence, just as is being used against John Watson and his family, to undermine Kendal's sanity to the point where Devra West's porn loving wife beating son looked a better parent to the court than her.

Not only did the court not know that Devra West had driven poor Kendal nearly insane, but they did not know that Devra West's son had forced his underage girl friend to have an abortion because it would have looked bad at the custody hearing! Between Devra West and her son Chris Haywood they pretty much destroyed the life of Kendal.

In conclusion. It is hoped that the FBI will investigate, prosecute West, Reynolds and Williams under RICO statutes. It is hoped that Devra West will be locked up for the rest of her life with a decade a piece for Reynolds and Williams in a penitentiary with swinging fines that will bankrupt all of them.

For now, John Watson is happy to continue to add to the lengthy 'paper trail' after all if he does decide to act in self-defense in response to the violent attacks against himself and his family – as is his right – then it pays to have a well-documented justification for doing so. 4. 300 plus emails sent to West's lawyer detailing the attacks by Devra Patton West against him and his family prior to 2015.
5. 400 or so emails sent to Julio Williams detailing the attacks against him and his family by Devra West from 2015 to present.
6. Between 150 & 200 emails sent to the FBI on a weekly basis to build up their database of victims and witnesses.
7. Recent submissions to the Arizona Attorney General's office in respect of mail and wire fraud by Devra West and her Omni Awakening criminal racketeering business model.

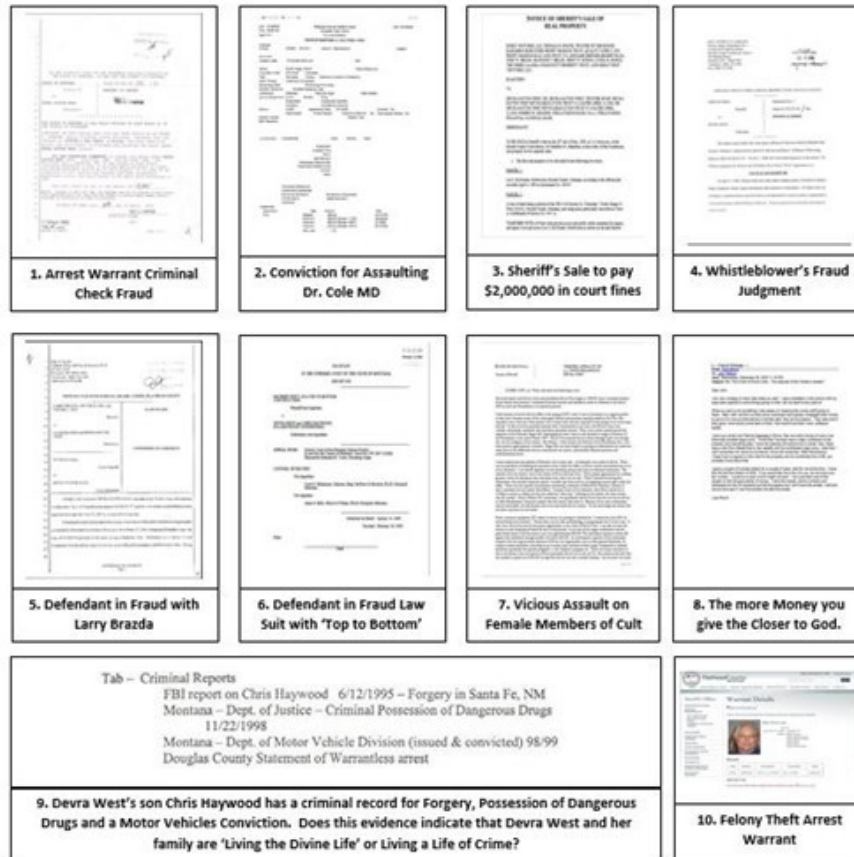
