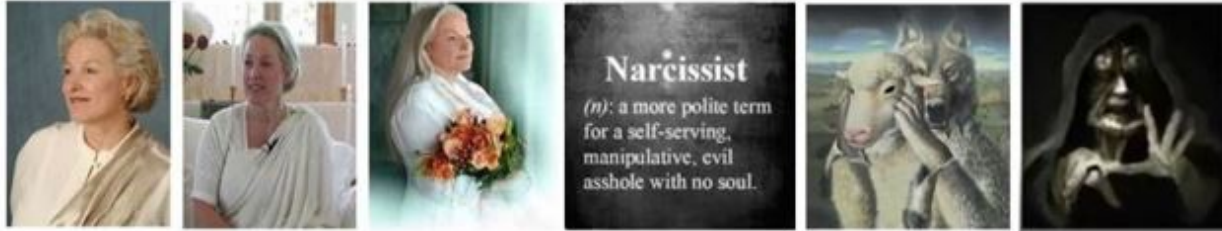


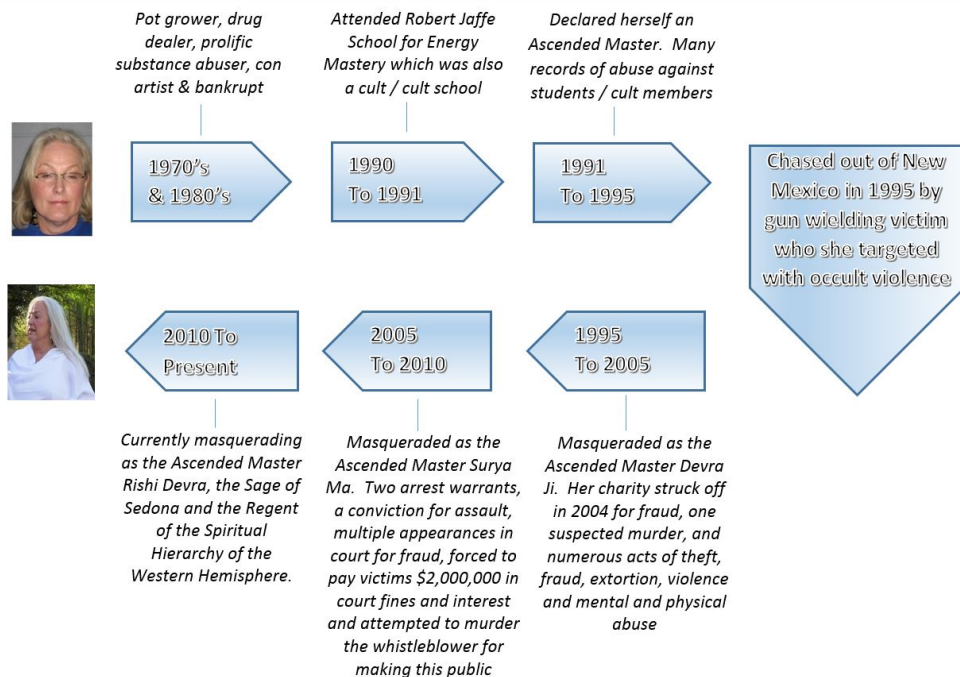
Subject: Rishi Devra AKA Devra West – Murder & Racketeering Sold to the Public as ‘World Service.’

Rishi Devra AKA Devra Patton West – Murder & Racketeering Sold to the public by her and gang members Geoffrey Reynolds, Julio Williams and Jack West as ‘World Service.’

Since acquiring occult (hidden) knowledge in 1991, Devra Patton West has been at the head of a criminal racketeering business model guilty of crime on an industrial basis with 90% of the victims being members of her own cult. Since 1991 she has operated in three western states NM, MT & AZ and has changed her identity 4 times and has used 8 different corporate identities the latest being [the Omni Awakening](#). The cult largely populated by spiritual seekers who, believing they need an external teacher, walk into the trap set by fake guru Devra Patton West. After the new arrivals have been brainwashed and conditioned, all too late they realize that they have been inducted into a cult where they are corralled as a financial ‘resource’ to be harvested by Devra Patton West as and when she chose.

In this edition we look at some of the measures that Devra Patton West and the senior members of her cult (Geoffrey Reynolds, Julio Williams and ex-husband Jack West) have employed to 'protect' their multi-million dollar a year criminal racketeering business model. What follows are some examples of events that Devra West and her cult have tried to hide from the public. These incidents of violence and criminality fly in the face of the 'divine being' narrative that the cult puts out for public consumption. Were the public to be made aware of her past, her criminal racketeering business model would be dead in the water as happened in Montana in 2009, forcing her to depart that state for fresh hunting grounds where they were unaware of her past indiscretions.

Incidents of Extreme Violence. Below are three female cult members who were viciously assaulted by Devra Patton West. These incidents were well documented, as each violent assault was witnessed by several other members of the cult.

1. Susannah Felder. In July 2001, employee to the charity Susannah Felder challenged Devra West about an \$80,000 donation she had stolen from the charity to pay for her son's legal fees, in respect of a custody battle he was fighting with his ex-wife over their infant daughter. Upon being challenged Devra West grabbed hold of Susannah's hair and ripped a clump of it from her scalp. Ex-board member of the charity AJ White in [her notarized statement](#) describes the assault against Susannah, describes Devra West's angry outbursts towards others and also describes how, the following day, then husband Jack West sought to blame the victim for being attacked. Devra West believes, ignoring state and federal law, that all the cash donations to the charity from the public were hers to do as she pleased with them! In spite of the fact that donors were told the fund raising was to buy land or pay off the charity's mortgage.

2. Beatrice McGuire. Student (to West's unaccredited school The Sacred Archives Institute) Beatrice McGuire while attending a seminar in Montreal, challenged what she thought was an obvious lie by Devra West. In front of a

large audience, Devra West attacked Beatrice ripping part of her ear away and necessitating Beatrice to have plastic surgery to repair the damage. Student Debra Coffey's [written account](#) of what happened makes harrowing reading as not only did she and tens of others witness the incident but as Debra states this level of violence was a regular occurrence with West often denying she was at fault saying that it was "God who did it." Devra West later agreed to pay for Beatrice to have plastic surgery but denied she was at fault stating in a letter that her recollection of events was different from Beatrice's (and presumably tens of other witnesses?). In March 2003 John Watson, later to turn whistleblower about Devra West's criminality, challenged Devra West about her assault on Beatrice McGuire. Showing yet again that she was a pathological liar, Devra West denied the assault saying that Beatrice was mentally ill – when in reality it is Devra West who is criminally insane. [Having assaulted Beatrice McGuire in front of scores of witnesses and having paid her to have plastic surgery Devra West denies she was responsible asserting that Beatrice McGuire is being mentally ill.](#)

3. Dr. Pat Cole MD. After Devra West's charity was [struck off](#) for fraud by the Secretary of State for Montana in January 2004, she was forced to move her criminal racketeering business model from Victor MT to Lakeside MT. On the way, she changed her name from Devra Ji to Surya Ma and had a series of corporate 'containers' many of which were involuntarily revoked or dissolved. Announcing her move 100 miles north from Victor MT to Lakeside MT, she told the members of her cult that she could only take 12 disciples and only those who would [donate 66% of their net worth](#) to her good causes. Dr. Pat Cole was one of the 12 disciples who agreed to donate their wealth to Devra West in exchange for being allowed to accompany her to 'Shamballa.' However, Cole was slow in handing over her wealth so Devra West, conspiring with members of her cult as described by student Debra Coffey [in her statement](#), mounted a campaign of overt and covert violence against Cole which ended up in the police being called and Devra West being charged with assault.

There were several witnesses to the assault including [Carlida Finch](#) who overheard West planning Cole's murder. The police were called and Devra West was charged with assault. Days later on April 17 2006, Devra West wrote a lengthy missive entitled [The Law of Severity on the Path to Purification](#) wherein she admitted the assault and admitted it was severe though sought to justify the attack by asserting the victim was a Nazi in the WWII death camps in another lifetime! However, when news of the assault broke in the [Whitefish Pilot](#) newspaper in July of 2007, Devra West and the senior members of her cult all vehemently denied that Devra West had assaulted Dr. Pat Cole MD. The above three crimes were committed between 2001 & 2007. Jack West and Julio Williams were present when they all occurred. Geoffrey Reynolds would have known about the first two incidents, would have known Devra West ruled her cult by fear and was present shortly after Dr. Cole was assaulted, and took part in the denials and cover-ups. Here is some of propaganda put out by the cult as they sell Devra West an occult thief / suspected serial killer to the public as a guru knowing full well her violent criminal past.

Incidents of Murder, Attempted Murder or Threats of Murder – those that we know about!

In 2002, Devra West's husband Jack West confided in the John Watson that those who opposed his wife had a habit of dying suddenly. Jack West's assertion seemed to be borne out by events since as:-

- 1. Lisa Swidler murdered.** In 2005 Lisa Swidler died suddenly and mysteriously after witnessing two serious crimes that Devra West committed against other cult members. Namely defrauding [Dave Kushner](#) out of \$30,000 and extorting tens of thousands of dollars from Marion Cantwell.
- 2. Marion Cantwell threatened with murder.** After [Marion Cantwell](#) was kidnapped by Devra West, held captive and beaten until she agreed to donate money from the sale of her home. Upon release Marion was told that if she went to the police she would be murdered.
- 3. Planned murder of Dr. Pat Cole MD.** Dr. Cole was being lined up for murder as witness [Carlida Finch](#) attested in the statement she gave to the authorities but was reprieved after agreeing to 'donate' her entire net worth of \$1.3 million to Devra West's good causes (herself). Dr. Cole's friend Rebecca West (no relation to Devra West) writes at length about the severe beatings that Dr. Cole received at the hands of Devra West you can read her harrowing emails by going [here](#) and by going to the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers.
- 4. Attempted murder of John Watson.** However the most well documented murder attempt was Devra West's attempt(s) to murder the whistleblower John Watson, who after being defrauded by Devra West in 2002 decided to sue her in 2003; a lawsuit he eventually won in 2008. Along the way, Devra West mounted a campaign of dirty tricks against John Watson in an attempt to intimidate him into withdrawing his lawsuit against her. In a meeting on his property in March 2003 that John Watson recorded with a digital tape recorder, Devra West made it very clear to him, after admitting that she had defrauded him but had no intention of paying him, that if he sued her she would get so f*cking down and dirty huge expenses coming out of his pocket but not hers as cult members Julio Williams and others would pay her expenses. Listen to "the light behind leaders and world servers" basically affirming that she is criminally insane.

The dirty tricks included forcing her employees to manufacture [false witness](#) statements that she intended to use against him in court, a campaign of occult 'under the radar' violence directed at him and his family and an attempt to murder him in 2007. When the murder attempt failed, she conspired with senior cult member Geoffrey

Reynolds to extort \$10,000,000 from him as a way of bankrupting him so that he could not afford to publicize the truth about her on the internet. Truth that you are reading about now. For the past 13 years to present day, Devra Patton West has been targeting John Watson and his family with occult 'under the radar' violence in the hope of intimidating him, provoking him into reacting to these attacks in a way that lands him in jail. Recently, she made another attempt on his life using her occult weapon; had she succeeded like Lisa Swidler's murder it would have been ruled by a coroner as death by natural causes.

These are a few examples of the attacks that Devra Patton West, a criminally insane narcissist, occult killer has been directing at John Watson, his wife and children. These attacks are doubtless used against countless other victims and their families over the past 27 years and against members of her cult to keep them in line.

- 1.** *Migraine headaches that start with the scalp burning such that the victim has to apply a cold wet towel to the head to stop the burning sensation. These migraines are so bad that the victims have to take pain killers for days until the pain subsides only to be targeted again and again.*
- 2.** *Acid reflux attacks that continue for months causing one to have to take powerful drugs to stop their stomachs digesting itself.*
- 3.** *Sinuses constantly running. When I say running I mean that one has to walk around with a cup in one's hand to drain the sinuses into.*
- 4.** *Excruciating muscle pain in the legs like cramps on steroids.*
- 5.** *Extreme back ache such that one could never get comfortable except when lying down in bed.*
- 6.** *Attacks to the genitals. This form of violent attack seems to have been directed at all members of the family simultaneously. A clear sign that the whole family was under attack came when different family members separated by hundreds, in one case thousands of miles, acquired the same symptoms on the same day!*
- 7.** *Targeting my heart was, and still is, a favorite target of West's. These attacks gave me the feeling that a stake was being repeatedly pushed into my heart. 13 years ago when these attacks started this was quite worrying however 13 years later I have learned to ignore these attacks in the knowledge that if Ms. West had been able to kill me she would have done so long ago. Long term effects unknown.*
- 8.** *The Feb / Mar / Apr 2018 long term attack was against my right ankle. Long story short while I slept the pain built up in my right ankle and when I get up it was painful to walk. Throughout the day the pain subsided somewhat (a moving target is harder to hit) but overnight the occult thief / suspected serial killer works on it again.*
- 9.** *While employed in 2017 my right knee and ankle were targeted simultaneously; these attacks continued for several weeks and everyone at my place of work noticed that I was limping for weeks. Eventually Devra West must have got bored or whatever spell / software / visualization she was using wore out. Perhaps she just moved on to another target.*



Above: Devra Patton West sees herself as the Apex Predator. In possession of occult knowledge she sees herself as a minor deity whose God-given right it is to pick off members of the herd (you and me) as and when she chooses.

10. A sudden spate of nose bleeds. I never get nose bleeds I do not have high blood pressure and yet in 2017 I suddenly had seven or eight in quick succession all within a month. Part of West's strategy is to try and frighten the target into submission by having them believe the attacks, especially the attacks to the heart and head, might prove fatal. Having been a marine I do not scare easily and certainly nose bleeds are not going to ruffle my feathers.

11. One of the attacks Devra West uses regularly is against our digestive systems. Like all the other attacks this variety of violent assault is preceded by a loud hissing. Within minutes whatever we have in our stomachs starts gurgling loudly, followed by severe stomach pains (gas) then diarrhea. Even after eating the most bland food upon hearing the hissing my wife and I would both know what came next.

12. Another favorite attack of Devra Patton West's, also preceded by a loud hissing, is where one's energy is drained, to the point of wanting to go to sleep.

15. Attack to one or both eyes. This felt like someone was pushing a needle through the eye.

14. Irrespective of what region of the body Devra West is targeting there is always the sleep deprivation. This has been consistent throughout the 13 years and commented on by other victims including West's neighbor in Flathead Lake Michelle Fetveit who got into a water dispute with West. I interviewed Michelle in 2007 and sure enough she remarked about being woken up at 3.00 am each morning.

While Devra Patton West masquerades in public as a do-gooding guru behind the scenes and in private she uses her occult weapon to target wealthy victims into emptying their bank accounts into hers. If you go to her pay portal on her website you will see that there is a 'button' for single donations of up to \$500,000. Who in their right mind would 'donate' \$500,000 plus to Devra West? The answer is no one. However, if you have attended one of her 'private sessions' and been identified as a wealthy prospect, you may end up being targeted with an illness and then forced to pay hundreds of thousands of dollars to be cured. Devra West was charging victims \$500,000 to be 'cured' in 2002 according to [two of her employees](#) who overheard a telephone call between her and one victim.

- Golden Flame Patron Member. Endowment of +\$10,000.00
- Golden Flame Sustaining Member. Endowment of +\$50,000.00
- Golden Flame Endowing Member. Endowment of +\$100,000.00
- Golden Flame Raja Benefactor. Endowment of +\$500,000.00

Consider how the whistleblower and his family have suffered over the past 13 years. Review the 14 examples detailed above again. Now apply the same violent attacks to a wealthy target and imagine how long it would take for that wealthy target to pay a King's Ransom to be 'cured.'

This is what Devra West has been doing for 27 years and Geoffrey Reynolds, Julio Williams and ex-husband Jack West are all willing accomplices in a massive extortion scam - this now operating in Arizona with the spiritual / metaphysical communities of Sedona & Scottsdale being targeted. Victims and witnesses of serious crimes know that the police cannot help them, even if their stories were believed. This is why most victims of financial crimes like Dave Kushner (defrauded out of \$30,000), Marion Cantwell (defrauded out of tens of thousands) and Mike Hendrickson (defrauded out of \$200,000) choose to walk away empty handed rather than be targeted for murder as was the case with John Watson. More persistent individuals, like John Watson, become the subject of a campaign of occult violence and murder as happened to John Watson. Indeed, the campaign to murder him continues with Dr. Julio Williams MD playing his part by not disclosing the 400 plus emails he possesses which details West's ongoing campaign of violence against Watson and his family.

Below we detail how Cult / Gang Members Reynolds & Williams actions are totally orchestrated by Devra Patton West



Are Geoffrey Reynolds actions those of a 'normal' employee or the actions of a cult / gang member?

Devra West viciously assaults Dr. Pat Cole MD; the police are called. [5]

Geoffrey Reynolds joins Devra West's employ [6 months after West's assault on Dr. Cole MD] and is immediately duped into loaning her \$300,000. [6]*

John Watson receives several emails from Rebecca West about crimes being committed by Devra West against her, Dr. Cole MD and other employees. [8]

Whitefish Pilot publishes news article about Devra West's assault on Dr. Cole MD. [9]

As if by magic several statements appear on Devra West's website all on the same day denying that Devra West had assaulted Dr. Cole MD. Four statements of denial are authored by Reynolds, two by Williams, one by ex-husband Jack West with two others authored by so called 'employees. [10]

Bigfork Eagle publishes news story about Devra West's assault on Dr. Cole MD (continued opposite). [11]

2002 August

Devra West defrauds John Watson out of pay and shares. [1]

2003 March

John Watson launches fraud lawsuit against Devra West. [2]

2004 January

West's charity struck off for fraud. [3]

2005 March

Williams posts defamatory statement on West's website at West's request. [4]

2006 April

2006 September

2007 January

Williams writes threatening email to John Watson adding he is giving \$2,000,000 to Devra West for her legal fees. [7]

2007 March



Are Williams actions the actions of a 'normal' physician, friend or colleague?

2007 July



Or are they the actions of an ass licking cult / gang member seen above on bended knee before his Master.

2007 July

2007 August

While giving interview to Bigfork Eagle Reynolds denies Cole's injuries were caused by an assault. He also states that John Watson will be dead within 12 months or in jail for reacting to what Devra West is going to do to him and his family. [11]*



Narcissist Occult Thief / Suspected Serial Killer Devra Patton West masquerading as the Ascended Master Rishi Devra. West's third fake identity in fourteen years!

Devra West found guilty of assaulting Dr. Pat Cole MD. [14]

Devra West forced to sell her assets at a Sheriff's Sale in order to pay her creditors (previous victims of organized crime) \$2,000,000 in court fines and interest. [16]

Devra West posts a statement on her website denying she was found guilty of assaulting Dr. Cole and asserts that the charges against her were dismissed and that Dr. Cole MD was part of an extortion scam against her! [18]

*Devra West deposed by John Watson's lawyer. During her statement she professes to be \$2,000,000 in debt and living in a caravan in **Geoffrey Reynolds** back garden. She claims that Reynolds is the money mastermind and that art work and valuables worth \$4,000,000 in 2002 was lost or stolen by others (continued opposite). [20]*

With all the above FACTS and much more published on John Watson's website Devra West's criminal racketeering business model is finished in Montana as no one believed her lies about being a guru / divine being (continued opposite).

2007 August

*Just as **Reynolds** predicted Devra West made a failed attempt to murder John Watson using the same occult knowledge she used to successfully murder Lisa Swidler in 2005. Just as **Reynolds** predicted West launched a campaign of occult 'under the radar' violence against John Watson and his family which 13 years later is ongoing. [12]*

2007 November

***Reynolds** writes to the service provider of John Watson's website in an attempt to force the removal of Devra West's written admission that she had assaulted Dr. Cole MD from that website. [13]*

2008 April

An Arrest Warrant issued against Devra West for Criminal Check Fraud [15]

2008 May

2008 July

Devra West found guilty of defrauding John Watson. [17]

2008 August

Devra West posts a statement on her website denying she was found guilty of fraud and asserting John Watson was part of an extortion scam against her! [19]

2009 October

The lost artwork and valuables (mainly paid for by public donation) later turns up at auction and as for sale from her website in 2014. Exactly ten years since the statute of limitations on theft expired. These stolen items can be seen on her website by going to the 'art gallery' tab. [21]

2009 December

An Arrest Warrant issued against Devra West for Felony Theft. [22]

2009 to 2010

*With Devra West's 2007 attempt to murder the whistleblower John Watson ending in failure she and stooge / accomplice **Reynolds** devise Plan 'B' and wait for him to return to Montana to attend the award hearing after winning his fraud lawsuit against Devra West.*

APPENDIX.

1. Watson, hired as a consultant on the promise of pay and shares, was defrauded by West, who in 2007 denied there was any business contract at all. Copies of their [business cards](#), a [personal guarantee](#) signed by him and West and [a letter to her lawyer](#) asking him to dissolve their business arrangements prove otherwise.
2. After the whistleblower, John Watson, announced that he was going to launch a fraud lawsuit against Devra West, she asked to meet with him privately at which she agreed that she had defrauded him, that [her agreements were worthless](#), that she [disposed of people like Kleenex](#) and that if he went to law against her [she would get so down and f*cking dirty huge expenses coming out of his pocket but not hers](#) as cult members Williams would pay for her legal expenses. After John Watson said what about the truth and honesty? Devra West stated [that the truth does not matter](#) (as she could persuade the public that her lies were their truth). Watson recorded the entire meeting excerpts of which you can listen to by following the links. [Williams later put up \\$2,000,000 to cover her legal expenses!](#)
3. [Certificate of Revocation](#) showing West's charity The Circle of Divine Unity was struck off the charity register for fraud.
4. Devra West, as you can see from her actions, uses her minions in the cult to intimidate and character assassinate those who make a stand against her or tell the truth against her. In 2005, Williams and two other cult members [posted a defamatory statement](#) against the whistleblower on West's website. Why would total strangers to the whistleblower do this?
5. In April of 2006, Devra West viciously assaults Dr. Pat Cole MD as part of a campaign of violence orchestrated by Devra West whose objective was to separate Dr. Cole MD from her entire net worth of \$1.3 million, which Devra West succeeded in doing. A couple of days later, she [wrote to her entire cult mailing list](#) announcing that the beating she had meted out on Cole was severe but was long overdue as Cole, she asserted, was a Nazi in the WWII death camps in another lifetime! You cannot make this stuff up!
6. In September of 2006, Geoffrey Reynolds travels from California to take up employment with Devra West, in what he thought was a 'normal' corporation. He was immediately duped into loaning Devra West his life savings of \$300,000 and thereafter, fell immediately under her control such that he agreed to participate in lies, propaganda, a murder plot and false statements to a court as part of West's conspiracy to bankrupt the whistleblower for going public about her criminal racketeering business model. Office manager at the time, Rebecca West, (no relation to Devra West) makes it clear in [her emails to the whistleblower](#) that Reynolds' only concern was hanging on to his CPA license and his marriage, rather than reporting West's crimes to the police.
7. In November 2007, cult member Julio Williams MD, obviously at Devra West's request, writes [a threatening email](#) to the whistleblower telling Watson not to f*ck with him and stating that he was giving \$2,000,000 to West to fund her legal fees; the clear implication being that Devra West could outspend the whistleblower in court so he had better drop his fraud lawsuit against her!
8. The whistleblower receives several emails from [Rebecca West](#), a copy of a ['Statement of Fact'](#) sent by Carlida Finch to the authorities about the dangerous working environment and one email from [John Mark Young](#) about the crimes being committed by Devra West against her employees chief amongst those Dr. Pat Cole MD.
9. & 10. On July 12 2007 the [Whitefish Pilot publishes a story](#) about West's assault on Dr. Pat Cole MD. This well researched article also mentions several other crimes being committed by Devra West in the Flathead Lake area of NW Montana. Immediately the senior members of West's cult publish denials from her website. Four from Reynolds [1](#), [2](#), [3](#) & [4](#). Two from Williams [1](#) & [2](#). One from ex-husband [Jack West](#). One from [Dani Osborne](#) (West's masseuse) and one from employee [Bret Jahola](#). All statements appeared on the same day and looked like they were all written and authored by Devra West.
11. The [Bigfork Eagle](#) publishes a story about West's assault on Cole and carries new information about West's criminality, lies and propaganda. While being interviewed by the Bigfork Eagle news reporter Constance See, Reynolds whose employment started six months after the assault on Cole, stated that Cole's injuries were caused by a fall and not by Devra West even though Reynolds had a copy of West's written admission that she had assaulted Cole sent out to the entire cult on April 17 2006. Reynolds also stated, in what he thought was an 'off the record conversation' that John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family! Constance See passed Reynolds' threat on to a criminal investigator for the IRS who was investigating West's finances at the time.
12. Just as Reynolds predicted, Devra West made an attempt several days later to murder the whistleblower using the same occult knowledge that she used to murder [Lisa Swidler in 2005](#) and perhaps others. Also just as predicted by Reynolds, Devra West mounted a campaign of occult 'under the radar' violence against the whistleblower and his family, in an attempt to either intimidate him into giving up his lawsuit / campaign for justice or have him react in a way that sent him to jail for trying to 'take out' Devra West; just as another victim tried to do in 1995 when Devra West was chased out of New Mexico by one gun wielding victim who knew the authorities were powerless to help him.
13. While denying that Devra West had assaulted Dr. Cole, 'liar for hire' Geoffrey Reynolds was busy writing emails to the service provider of John Watson's website desperately trying to force a copy of West's written admission that she had assaulted Dr. Cole MD off of the whistleblower's website. In a move worthy of the characters of the movie 'Dumb and Dumberer' Devra West has Geoffrey Reynolds CPA claim copyright of her written admission that she had assaulted Dr. Cole MD in a vain attempt to use the Millennium Copyright Act (MCA) to force [The Law of Severity on the Path to Purification](#) off his website.

14. West is found guilty of assaulting Dr. Cole MD. Here is a copy of the newspaper article published by the [Whitefish Pilot](#) on 24 April 2008 announcing her guilt. Here is a [scan of the court documents](#) and here is a [written response](#) by the editor of the newspaper after an attempt by the cult to bully the editor into withdrawing their article announcing West's guilt on the basis that West never admitted her guilt in court!
15. An arrest warrant was issued against Devra West for [Criminal Check Fraud](#).
16. Devra West became the subject of a [Sheriff's Sale](#) to force her to sell her assets to pay past victims of crime \$2,000,000 in court fines and interest.
17. Devra West was found guilty by a Montana court of defrauding John Watson. The [Ravalli Republic](#) news article announces her guilt. Here is a copy of the [court judgment](#) and here is a copy of [the award given by the court](#).
18. & 19. Devra West posts two statements on her website. The first asserting that that the court [threw out Cole's assertion that she had been assaulted](#) by her (not true). And the second asserting that West was not found guilty of defrauding John Watson [and that no business relationship ever existed](#) (not true).



1. Julio I wish I had never told the news reporter about John Watson's impending murder!

20. & 21. Devra West gave a [statement under oath](#) to John Watson's lawyer, during which she lied from start to finish. 2. Hide the ongoing campaign of violence being directed at him and his family by Devra Patton West now in its 13 year.

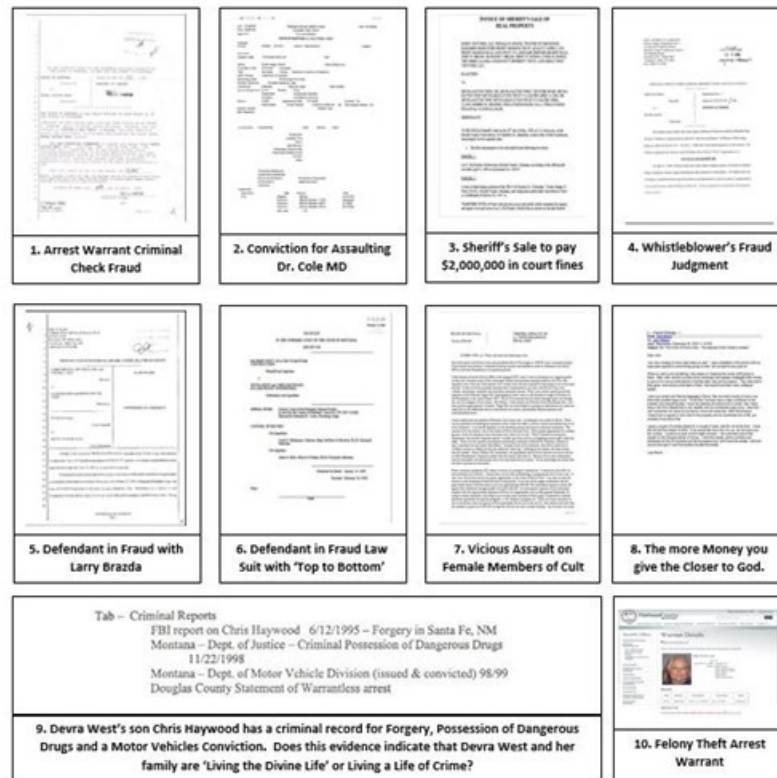

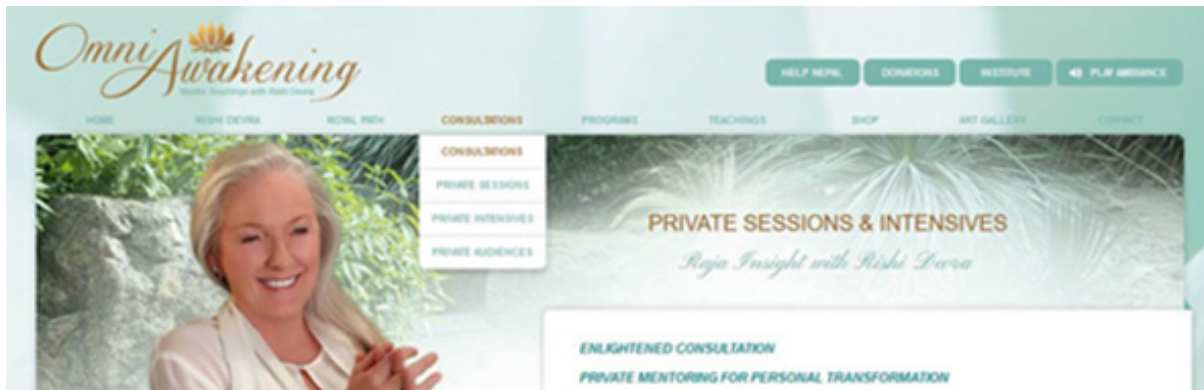

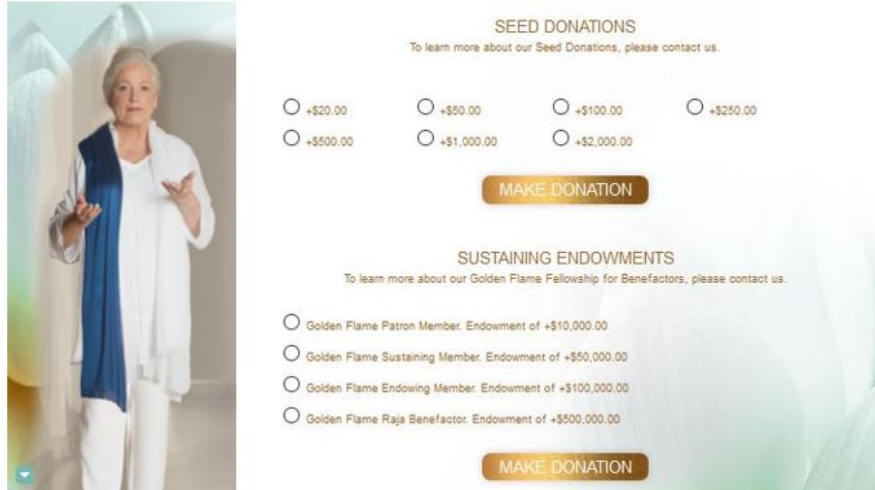
Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for the nonexistent wrongs the target committed).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them!
