

Dear FBI, IRS & Sedona & Scottsdale Police Departments,

We write again to urge you to open an investigation into Devra Patton West's criminal racketeering business model that has operated in three western states over the past 27 years. In 1995 Devra Patton West was chased out of New Mexico, in the middle of the night by a gun wielding victim who realized that the police were unable to help him. In 2010 West was forced to leave Montana after three newspaper articles had previously made it clear that her Victor MT 'charity' and her Flathead MT 'corporation' were vehicles for organized crime. Pivotal in forcing West to leave Montana was John Watson who, like many before him and since, was defrauded by Devra Patton West in 2002. While researching the lawsuit he launched against Devra Patton West in 2003, he discovered that there were literally scores of victims of racketeering, with at least one suspicious death and perhaps many more according to Jack West.

West's criminal racketeering business model relies on the public swallowing her lies and propaganda. Any threat to that business model or the millions a year obtained through theft, fraud and extortion is dealt with severely. In response to lies and intimidation from Devra Patton West and her cult, Watson launched a website of his own in 2006 which publicized West's criminality in Victor MT & Flathead MT. Watson won his fraud lawsuit against Devra Patton West in 2008; the evidence that he acquired while researching that lawsuit was also used to shut down West's charity (after massive fraud was discovered), launch an IRS investigation against Devra Patton West's personal finances and provide the material for two newspaper articles. After these articles were published in 2007, it became impossible for West to remain in Montana as no one believed her 'divine being' narrative.

Before West could reincarnate with a new identity and resurrect her criminal business model in Arizona (the third western state since 1995) Devra Patton West needed to force down Watson's website to ensure there would be no information on the internet that contradicted the 'divine being' narrative / propaganda, which is at the heart Devra Patton West's guru / cult / extortion fraud scam. What follows is a 'blow by blow' account of the criminal conspiracy that Devra Patton West mounted against John Watson. Her 2007 failed attempt to murder him. The 2010 conspiracy to extort \$10,000,000 from him and bankrupt him as a means of forcing down his websites.

The motive? Millions of dollars a year being lost in ill-gotten gains acquired through organized crime (theft, fraud and extortion).

Below, we detail how Devra Patton West recruited Geoffrey Reynolds & Julio Williams, both members of her cult / criminal gang, to act as foot soldiers in her vendetta against John Watson. As you will see both Reynolds & Williams agreed to be willing accomplices to the murder and ruin of a total stranger, because the leader of their cult / criminal gang directed them to become a part of her conspiracy against Watson. This conspiracy continues to this day, with Watson and his family being subject to continuous intimidation at the hands of Devra Patton West. In that regard, Watson has sent 400 plus emails to Julio Williams email account jcwilliams@prodigy.net logging the campaign of intimidation. We suggest you copy the contents of Williams' email account.

In closing, this is what Devra Patton West and her accomplices have done to just one victim of organized crime over the past 16 years. There are scores, perhaps hundreds of victims including several who, according to Patton West's ex-husband may have been murdered.

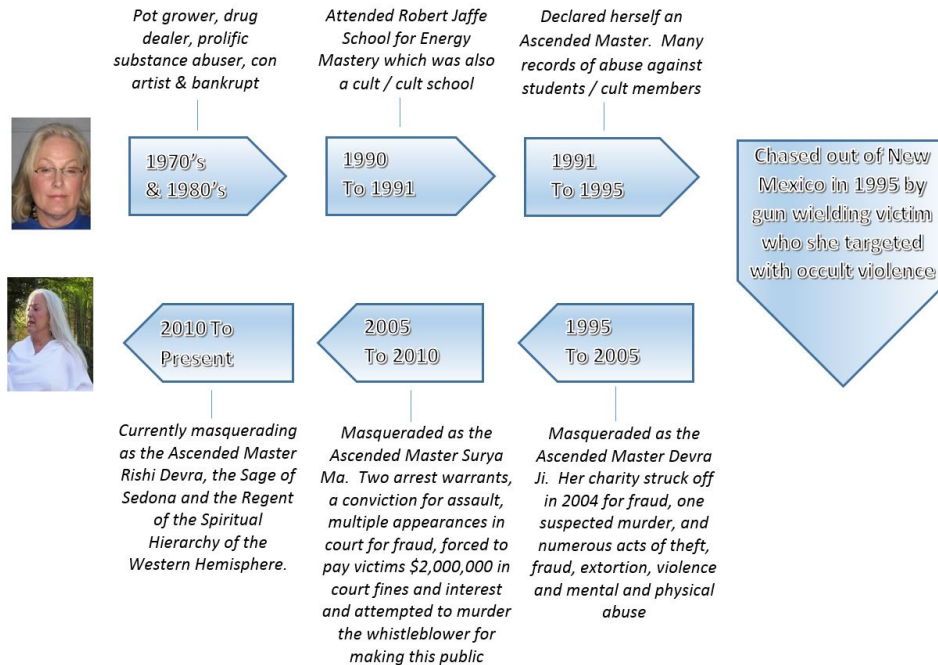
We know from witness statements and testimony given by Devra Patton West that prior to 1991, she was a pot grower, drug dealer, ex-bankrupt and a small time crook defrauding individuals like [Jeremy Samuelson](#) and [Satya](#) out of several thousand a piece. All that changed after Devra Patton West attended the [Robert Jaffe School for Energy Mastery](#) between 1990 & 1991, at which she acquired occult (hidden) knowledge which she used to leverage her criminal activities. Upon completing the course, West declared herself to be an Ascended Master, stating that anyone not agreeing with her ascendancy to the godhead was “blocking the energies.” It is perhaps worth mentioning that there is a long history of mental illness in Devra West’s family, with her late brother being confined in a mental institution for a few years. Since 1991, Devra Patton West has robbed, defrauded and extorted money from scores of victims, maybe hundreds, she has also violently assaulted numerous members of her cult focusing mainly on women [Susannah Felder](#), [Beatrice McGuire](#) and [Dr. Pat Cole](#) to name but three.

Using outrageous lies and propaganda (visit her [current website](#)) under the cover of 'religious freedom' laws, Devra Patton West seeks to attract spiritual seekers to her well-oiled criminal racketeering business model that has operated in three western states over the past 27 years. She knows that after robbing, defrauding and extorting money from victims, the senior members of her cult will provide her with false witness statements making prosecution of her in court difficult. She also knows that those victims who report West's use of the occult to intimidate them will not be believed or, as was the case in 2007 when several victims phoned the police, told that under legal statute the occult is not regarded as a weapon therefore a successful prosecution is unlikely.

At the bottom of this page, we provide a list of some of the tens of victims of organized crime at the hands of Devra Patton West when she operated as [Devra Ji](#) (1995 to 2005) and [Surya Ma](#) (2005 to 2010) in Montana. West was forced to leave Montana in 2010 after three newspaper articles showed her to be a gangster not a guru. There were many other victims in [New Mexico](#), between 1991 & 1995. West was chased out of that state in the middle of the night by one gun wielding victim who realized that the police could not help him. She now operates in Arizona with a new name, Rishi Devra, a new fake life story and with countless titles and accolades, all as fake as the two doctorates she says the Christ awarded her in person.



We will now focus entirely on what happened to one victim John Watson (who later turned whistleblower).

Watson was a business consultant 'recruited' by West's husband via a meditation group Jack West was running. Meditation groups are a favorite way of recruiting to the cult and are still being used by Jack West. In January 2002, Watson agreed to work for West for 6 months as a business consultant to set up several non-profit corporations and one for profit corporation (Millennia Mind Inc.) in return for pay and shares. Long story short, after completing the work assigned to him in August 2002, Watson was told by Devra West, then calling herself Devra Ji, that God had spoken to her the night before and told her that shareholdings were a thing of the past so he was not getting the 22% shareholding he had been promised. Additionally, she told him that she was not going to pay him the \$50,000 salary that had been agreed in the startup corporation which was due to receive \$1,000,000 in seed funding from a Brazilian heiress, who was a members of West's cult. West's actions and the way she behaved when delivering her betrayal to Watson convinced Watson that he was not the first victim of West's criminality. While researching his lawsuit, Watson found out that there were literally scores of victims of theft, fraud, extortion and some violent assaults with 95% of the victims choosing to walk away empty handed rather than risk being the subject of occult 'under the radar' intimidation or murder.

What follows are a list of the actions taken by Devra Patton West and two senior members of her cult, Julio Williams MD & Geoffrey Reynolds CPA against John Watson. Though both were total strangers to Watson, the victim, they both willingly agreed to aid and abet Devra Patton West in her attempt to intimidate the victim, into dropping his fraud lawsuit against her, murder the victim to silence him and when that failed conspire to bankrupt the victim using two frivolous (without merit) civil lawsuits.

FACT 1. CULT / GANG LEADER DEVRA PATTON WEST

FACT 1. Immediately after defrauding Watson (just one in a steady line of victims) Devra West wrote to her lawyer [Mr. Tabarrachi](#) asking him to sever the business relations between her and Watson on their joint Millennia Mind Inc. project. Though Watson had used his own accountants and bought the company off the shelf as the largest shareholder, West took control of the corporation and effectively constructively dismissed Watson without the pay and shares promised. Evidencing West and Watson's joint business venture was a signed a [promissory note](#) which both had signed as directors / shareholders with the Cactus Design Agency in Colorado for [letterheads and business cards](#). Additionally, Jack West had [written to the INS](#) (Immigration and Naturalization Agency) in 2002 confirming Watson was an 'employee' on the payroll. Devra West immediately denied that she and Watson had ever had any business agreements and [posted a statement](#) on her website stating that there was no business relationship and that all overtures by John Watson for a business relationship had been rebuffed by West.

In reality, West had recruited him and then defrauded him when he had completed the tasks she had set him. Devra Patton West is a pathological liar.

FACT 2. CULT / GANG LEADER DEVRA PATTON WEST

FACT 2. In March of 2003, after Watson announced that he was going to sue Devra Patton West for fraud, she immediately demanded a private meeting with him at his property. Fearing that West was going to pull some stunt, he decided to hide a digital tape recorder in the room to record what was said. 1. [Devra West refers to John Watson as 'Prince Charming.'](#)

Above, Devra West admits defrauding John Watson but says that she does see herself paying him what she owes him. West goes on to threaten him with getting "so f*cking down and dirty, huge expenses coming out of his pocket and not hers." Because senior cult member Dr. Julio Williams MD will pay for her legal fees. During the conversation, John Watson accuses Devra Patton West of viciously assaulting student Beatrice McGuire in front of thirty or so witnesses one of those witnesses being fellow student [Debra Coffey](#). Devra West later agrees to pay for plastic surgery for the victim whose ear was partially ripped away from her head. In the exchange, which you can listen to by [going here](#), Devra West makes a very unconvincing attempt to deny the assault and attempts to lie and blame someone else, then harangues John Watson for believing all the witnesses who actually saw the incident. Devra Patton West is a pathological liar and perhaps criminally insane. Upon return to her compound from the meeting with John Watson, Devra Patton West calls a meeting of her employees and orders each and every one of them, on pain of being fired, to manufacture false negative statements about John Watson that West intended to use in court against him. One of those statements was written by employee / cult member Anandra George who later [wrote to Watson's](#) lawyer retracting the false statement she was forced to make.

FACT 3. In 2005 Dr. Julio Williams MD, a wealthy brainwashed and conditioned member of West's cult, was persuaded to post a defamatory statement about John Watson on West's website. This statement was as much about gaining the moral high ground for West in the eyes of the cult as it was about character assassinating John Watson who had launched a fraud lawsuit against West in 2003. In an email written by Devra West's long term personal secretary, Barbara Costantino, [Barbara states](#) that each time West parted company with a victim of crime at her hands West lied about the circumstances of their departure. Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortlej issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

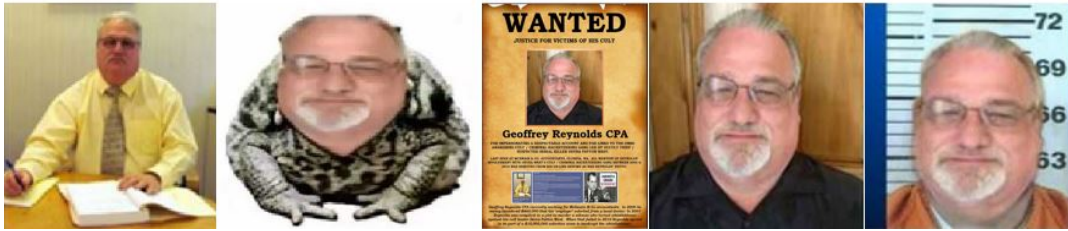

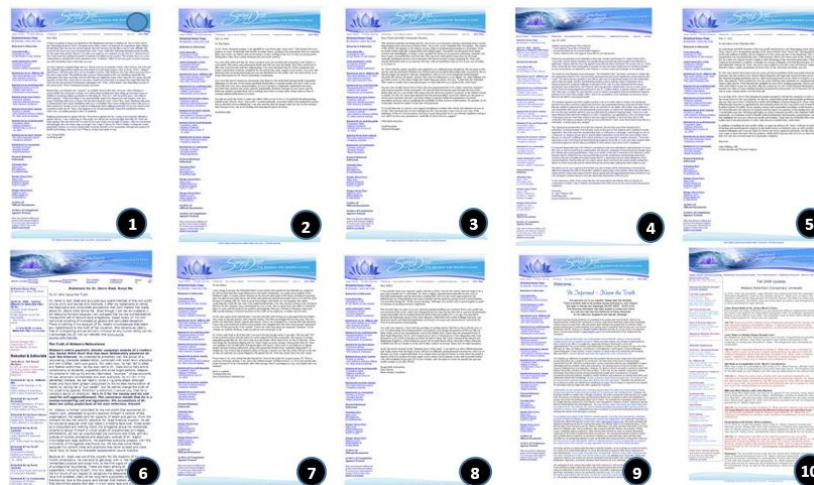

FACT 4. Geoffrey Reynolds CPA joined West's employ in September 2006, and before he realized she was the leader of a cult / criminal gang, he was duped into loaning her his life savings amounting to \$300,000. As Devra Patton West's officer manager at the time Rebecca West (no relation to Devra West) made clear, in these two emails (1) & (2), Reynolds quickly fell under West's total control as he was desperate to save his marriage and his CPA license. So when the [Whitefish Pilot](#) newspaper published a story about West's criminality on July 12 2007, Devra West instructed the senior members of her cult to publish statements of denial on her website and asked them to harass the newspaper for publishing what Reynolds described as small town religious persecution. Each cult member knew from a missive entitled '[The Law of severity on the Path to Purification,](#)' emailed to them 15 months earlier on April 17 2006, that Devra Patton West had assaulted Dr. Cole MD. Not only did West admit assaulting Cole, but she sought to justify the assault by asserting that Cole was a Nazi in the WWII death camps in another lifetime! West also stated that while the beating she gave Cole was severe it was administered by her with grace. Devra Patton West is criminally insane. Below are some of the statements of denial authored by Reynolds, Williams and others and published on West's website.

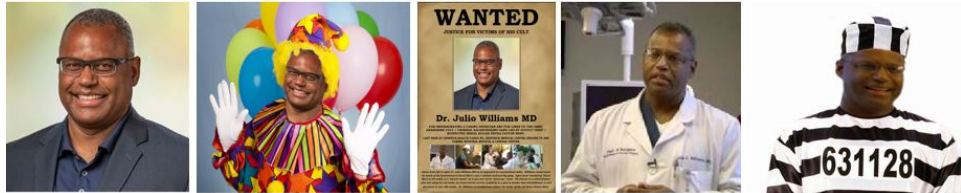

On January 6 2007, clearly at the instructions of cult / gang leader Devra Patton West, Julio Williams MD a total stranger to John Watson, sent him a threatening email intended to intimidate Watson into withdrawing his lawsuit against Devra Patton West. 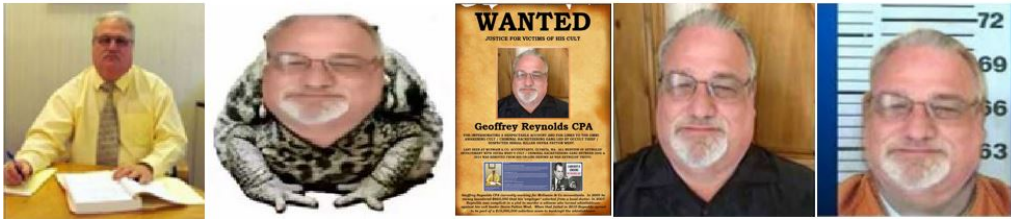

It is clear from the harrowing email entitled '[Help Me](#)' that Devra Patton West was running a cult and had a revolving door policy to her employees. 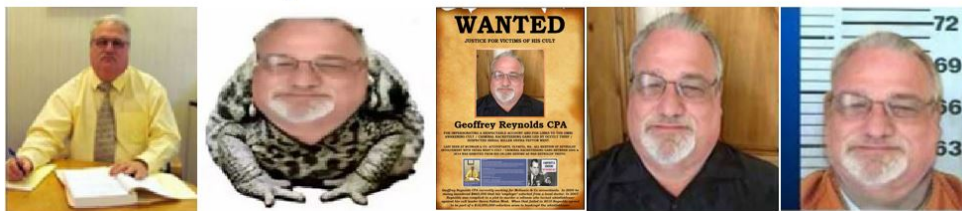

FACT 6. On August 9 2007, a second newspaper article was published this time in the [Bigfork Eagle](#) newspaper. Speaking for his employer, and obviously reading from a script) Geoffrey Reynolds made a lengthy statement in which he asserted that Cole's injuries were not as a result of West's assault but from an earlier fall down her apartment steps. Reynolds made this statement even though his employment started 6 months after the assault occurred, and even though at the time, Reynolds was desperately trying to force a copy of West's written admission that she had assaulted Cole off John Watson's website. Reynolds went further by asserting that Cole owed West \$1.3 million dollars and that \$213,750 was owed for therapy and \$250,000 owed for an internship. What Reynolds may not have known is that his predecessor had quit rather than be forced by Devra West to manufacture false invoices. Ex-employee [Carlida Finch attests](#) in a statement to the authorities that she overheard Devra West planning Dr. Pat Cole's murder (if she does not hand over her life savings) and affirms that the previous Finance Controller left because she refused to do '[creative accounting](#)' for Devra West. FACT 7. While giving his interview to the [Bigfork Eagle](#) reporter, Constance See, Reynolds, in what he thought was an off the record conversation, stated that John Watson would be dead within 12 months or in jail for reacting to what Devra Patton West was going to do to John Watson and his family. The reporter took Reynolds' threat seriously enough to report the matter to a federal agent investigating West's finances at the time, who then passed on the threat to Watson. Several days later, Devra West made a failed attempt on John Watson's life using her occult weapon; the weapon the legal statute does not recognize as a weapon. Had West succeeded, John Watson's death would have been declared a death by 'natural causes' just as the many other deaths / murders / extra judicial killings by West in the past have been, including that of ex-student [Lisa Swidler](#) in 2005.

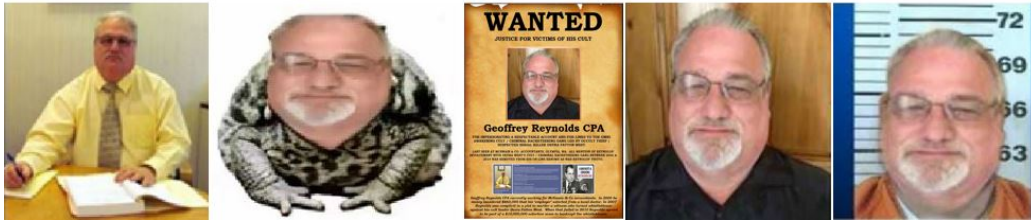
In May 2002, Jack West, Devra West's ex-husband, told John Watson that those who opposed his wife had a habit of dying suddenly.

While the attempt on Watson's life, just as Reynolds had predicted, failed, the campaign of occult 'under the radar' violence that Reynolds had also predicted during his interview started immediately and has continued daily / nightly to this day. Below are list of some of the attacks launched by West against John Watson, his wife and family.

- 1.** *Migraine headaches that start with the scalp burning such that the victim has to apply a cold wet towel to the head to stop the burning sensation. These migraines are so bad that the victims have to take pain killers for days until the pain subsides only to be targeted again and again.*
- 2.** *Acid reflux attacks that continue for months causing one to have to take powerful drugs to stop their stomachs digesting itself.*
- 3.** *Sinuses constantly running. When I say running I mean that one has to walk around with a cup in one's hand to drain the sinuses into.*
- 4.** *Excruciating muscle pain in the legs like cramps on steroids.*
- 5.** *Extreme back ache such that one could never get comfortable except when lying down in bed.*
- 6.** *Attacks to the genitals. This form of violent attack seems to have been directed at all members of the family simultaneously. A clear sign that the whole family was under attack came when different family members separated by hundreds, in one case thousands of miles, acquired the same symptoms on the same day!*
- 7.** *Targeting my heart was, and still is, a favorite target of West's. These attacks gave me the feeling that a stake was being repeatedly pushed into my heart. 13 years ago when these attacks started this was quite worrying however 13 years later I have learned to ignore these attacks in the knowledge that if Ms. West had been able to kill me she would have done so long ago. Long term effects unknown.*
- 8.** *The Feb / Mar / Apr 2018 long term attack was against my right ankle. Long story short while I slept the pain built up in my right ankle and when I get up it was painful to walk. Throughout the day the pain subsided somewhat (a moving target is harder to hit) but overnight the occult thief / suspected serial killer works on it again.*
- 9.** *While employed in 2017 my right knee and ankle were targeted simultaneously; these attacks continued for several weeks and everyone at my place of work noticed that I was limping for weeks. Eventually Devra West must have got bored or whatever spell / software / visualization she was using wore out. Perhaps she just moved on to another target.*
- 10.** *A sudden spate of nose bleeds. I never get nose bleeds I do not have high blood pressure and yet in 2017 I suddenly had seven or eight in quick succession all within a month. Part of West's strategy is to try and frighten the target into submission by having them believe the attacks, especially the attacks to the heart and head, might prove fatal. Having been a marine I do not scare easily and certainly nose bleeds are not going to ruffle my feathers.*
- 11.** *One of the attacks Devra West uses regularly is against our digestive systems. Like all the other attacks this variety of violent assault is preceded by a loud hissing. Within minutes whatever we have in our stomachs starts gurgling loudly, followed by severe stomach pains (gas) then diarrhea. Even after eating the most bland food upon hearing the hissing my wife and I would both know what came next.*
- 12.** *Another favorite attack of Devra Patton West's, also proceeded by a loud hissing, is where one's energy is drained, to the point of wanting to go to sleep.*
- 14.** *Attack to one or both eyes. This felt like someone was pushing a needle through the eye.*
- 15.** *Irrespective of what region of the body Devra West is targeting there is always the sleep deprivation. This has been consistent throughout the 13 years and commented on by other victims including West's neighbor in Flathead Lake Michelle Fetveit who got into a water dispute with West. I interviewed Michelle in 2007 and sure enough she remarked about being woken up at 3.00 am each morning.*

Geoffrey Reynolds was complicit in the attempted murder of John Watson, even announcing it to the press. He was also well aware that the suspected serial killer, Devra Patton West, intended to launch a campaign of occult 'under the radar' violence at Watson, his wife and children. All so that he could [save his marriage, keep his CPA license and get back the \\$300,000](#) he loaned Devra Patton West.

You may recall that Devra Patton West and the senior members of her cult, chief amongst them Reynolds and Williams, had been vigorously denying that West had assaulted Cole even though West had admitted the assault on April 17 2006 to scores on her mailing list. In a move reminiscent of Dumb & Dumberer, Reynolds forwarded a copyright claim by West to John Watson's website service provider claiming copyright of '[The Law of severity on the Path to Purification.](#)' In doing so Devra West effectively admitted the assault in writing – while still denying it in court and to the public. Three newspaper articles printed in the [Whitefish Pilot](#), the [Bigfork Eagle](#) and the [Ravalli Republic](#) rendered Devra Patton West's guru / cult / extortion business dead in Montana. Having failed to murder John Watson, his websites remained up containing some of the documents you have access to here and on our website at www.omniawakening.net With information contradicting her 'divine being' narrative, it was impossible for Devra Patton West to reincarnate elsewhere in the USA.

As long as the internet was awash with evidence of her past criminality in New Mexico and more recently Montana, her criminal racketeering business model was dead in the water. The loss of millions of dollars a year in 'donations' arising from theft, fraud and extortion was motive enough to murder John Watson and for orchestrating an illegal campaign of intimidation against him and his family. During that five years, Devra Patton West had done what she promised and got so down and f*cking dirty employing the following tactics:-

1. Julio Williams used to [defame](#) Watson in 2005.
2. Forcing her employees and students (members of her cult) to write [false witness statements](#).
3. Threats [sent by email](#) by senior cult member Julio Williams in a blatant attempt to force Watson to drop his lawsuit.
4. A campaign of occult 'under the radar' violence directed at Watson, his wife and children.
5. A failed attempt to murder Watson.

Devra Patton West needed a plan 'B.' Her opportunity arose when in 2010, John Watson had to travel from Nova Scotia Canada, where he had emigrated for his safety in 2005, to court in Montana. The court appearance was scheduled to determine how much the court was going to award John Watson for winning his fraud lawsuit having obtained judgement in 2008 after a five year battle.

FACT 10. CULT / GANG MEMBER GEOFFREY REYNOLDS CPA

FACT 10. Geoffrey Reynolds was a total stranger to John Watson, but having previously agreed in 2007 to be complicit in the plot to murder John Watson, Reynolds stepped up to the plate once again. Indeed Reynolds, so eager to earn the return of his \$300,000 loan to West, not only joined Devra Patton West in her conspiracy to bankrupt Watson, he agreed to 'front' the campaign publicly. Doing this allowed Devra Patton West to stay out of the limelight while orchestrating matters from the shadows. There was only one problem, and that is that Reynolds had never met John Watson; their periods of employment with Devra Patton West being separated by four years. However, Devra Patton West gambled correctly that after spending a fortune on winning a five year lawsuit against her, Watson would not be able to fund two more lawsuits in Montana, especially as it would mean him having to fly to and fro to the USA for the hearings. Accordingly, [Geoffrey Reynolds](#), on West's instructions, simply made a photo copy of [Devra West's pleadings](#) and submitted that copy to the court as fact. 'Liar for hire' Reynolds alleged falsely, that he too had been defamed by Watson between 2002 and 2006, even though Reynolds clearly did not know Watson existed until he commenced his employment and was briefed by West post September 2006. After acquiring a \$5,000,000 default undefended judgement, Reynolds signed over the judgement to West's ex-husband, Jack West. It is clear that this in itself, is an act of extortion, occasioned by Reynolds' lies, that Devra Patton West hoped to benefit by.

As made clear in the illustration below, the court is not interested in justice only 'practicing' the law. Watson sent 300 pieces of evidence to the Montana court hearing West & Reynolds's ~~lies~~ defamation lawsuits, only to have all 300 pages thrown out because the law / statutes mandates that submissions must not exceed 28 pages. Had the judge been interested in administering justice, he might have looked at the court records and discovered many of the crimes she had committed in Montana listed in FACT 9 directly above here. Had he looked even closer, he would have seen that he had issued an arrest warrant against Devra Patton West for [Criminal Check Fraud](#) in 2008 only two years earlier! Then he might have noticed the 2009 arrest warrant for [Felony Theft](#), or the 2008 [Conviction for Assault](#), the fact that West was forced to sell all her assets at a [Sheriff's Sale](#) to pay off past victims of crime \$2,000,000 in court fines and interest. And finally, leaving aside the many other fraud related lawsuits West was the defendant in, had the judge looked at West's criminal past, he would have seen that John Watson had won a [Fraud Lawsuit](#) against West in 2008. Had the judge looked, he might not have been too quick to deny Watson's first amendment rights to free speech.

But the judge is not interested in the rights and wrongs of a case, only in practicing the law. West with access to the \$2,000,000 provided by Williams, could play the game while Watson, living abroad, could not. This is why we are determined to 'force' a criminal investigation into Devra Patton West's criminal racketeering cult / gang.



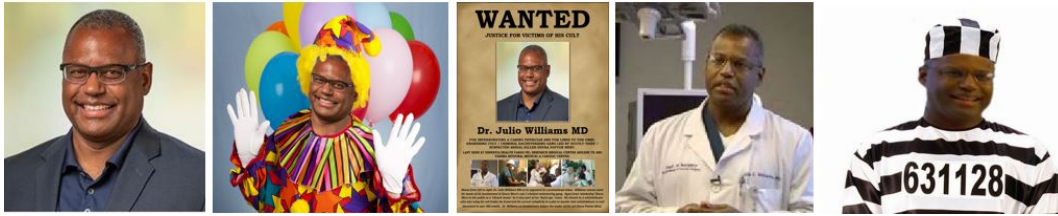
Above: What people do not realize is that the courts are 'for profit' corporations set up largely for the benefit of judges and lawyers, who earn a good living presiding over other people's problems. The job of the courts is not to administer justice but to 'practice' the law. The outcome of a case has more to do with how large a person's bank account is as opposed to who is right or wrong. In West's case, she 'bought' the outcome she wanted by outspending John Watson. In doing so, she was able to sweep the internet of the truth about her past crimes in Montana and New Mexico and take away Watson's right to free speech.

Accordingly, when Watson attended court in October 2010 West & Reynolds implemented their plan 'B' when both West & Reynolds each served Watson with defamation lawsuits. There is a lengthy in depth analysis of this matter in [another bulletin](#) but put simply, Devra Patton West achieved a number of goals by outspending Watson in court.

- (1).** *Negated the earlier \$760,000 financial award that the court had given Watson after he won his fraud lawsuit against West.*
- (2).** *As part of her lawsuit, West had asked the court for an injunction. When Watson failed to travel to the USA to attend court to defend against West's (and Reynolds's) lies, West was granted an undefended default judgment. The result was that after Watson's websites were forced down, Devra Patton West was able to reincarnate in Arizona with a new name, new fake identity and even more fake awards and accolades that she regularly grants to herself.*
- (3).** *West & Reynolds (though [Reynolds' pleadings](#) were entirely false) were each awarded \$5,000,000 the effect of which was to prevent Watson from visiting the USA to visit relatives.*
- (4).** *The injunction forbade Watson from making any statements about Devra West's criminal past, her current lies, her current propaganda and her current criminal business model. It also meant that West, Williams and other members of the cult could defame Watson without fear of response and put up propaganda statements like the one Williams posted about [the injunction](#) (see below).*

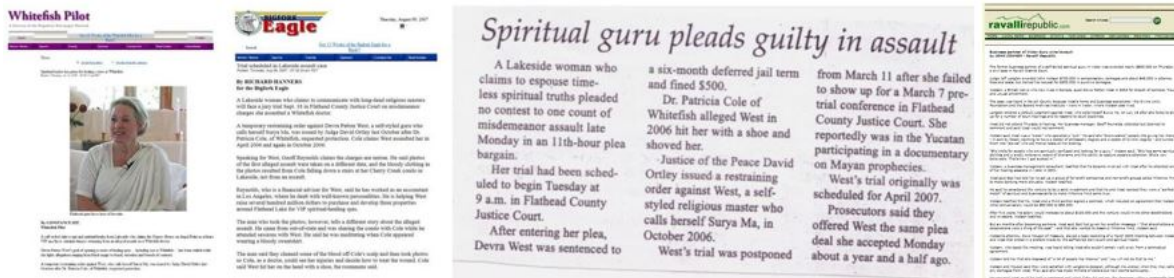
This is exactly what criminals do if they cannot intimidate you or murder you they 'buy' the law they want.

FACT 11. Dr. Julio Williams MD is a 20 year student of Devra Patton West's unaccredited school for occult studies. He is also a recipient of one of her totally worthless degrees. Being a long-term student and a senior member of her Satanist cult, Williams was / is well aware of Devra Patton West's use of the occult to facilitate massive financial crimes, to intimidate victims into not going to the police, and to murder those who are, or are likely to, oppose her or go public. Additionally, Williams is well aware of West's criminality in Montana, as indicated above in FACT 9. Though we suspect that what is mentioned is the tip of the iceberg. Williams is also well aware of all the negative news paper articles published in Montana such as those published in the [Whitefish Pilot](#), the [Bigfork Eagle](#) and the [Ravalli Republic](#) newspapers which laid bare Devra Patton West's criminal racketeering business model.

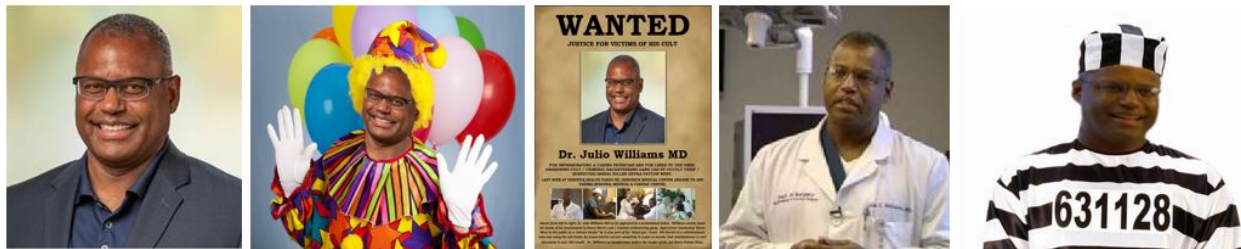

There are only three possible explanations for Dr. Julio Williams' behavior - either he is mentally ill, a willing accomplice in organized crime, or Devra Patton West has his tacit agreement to print whatever she likes and attribute it to Dr. Julio Williams. FACT 12. When in 2017, the internet began to populate with details of Devra Patton West's criminal past (previous incarnations in Montana and New Mexico) Dr. Julio Williams MD again demonstrated his important role in Devra Patton West's criminal racketeering cult / gang. In a move similar to what Williams did later in 2018, when he rented a property at his own expense to facilitate 'Sacred Sundays with Rishi,' in January 2018, Williams purchased a website of his own dedicated to delivering lies and propaganda, in a vain attempt to gain the moral high ground. What Williams, orchestrated by West did, was to making totally false claims about the origin of the injunction Devra Patton West obtained in 2010, which forced down John Watson's websites. You may recall that Dr. [Williams made \\$2,000,000](#) available to Devra Patton West to pursue endless lawsuits against Watson so that she could, using that money, outspend Watson to gain the upper hand (see FACT 10.).

What Williams did, no doubt on the instructions of Devra Patton West, was to claim that the injunction came about as the result of an independent (criminal) investigation into a cyber extortion scam by a judge. Instead of admitting the truth, which was that when Watson came to court in 2010 to see what the court was going to award him for winning his fraud lawsuit against West, both [Devra Patton West](#) & her stooge [Geoffrey Reynolds](#) served him with two frivolous (without merit) defamation lawsuits that they guessed he could not afford to fight. Result? West (and Reynolds) are awarded summary default undefended judgments, which included the injunction being granted that West asked for. She asked for it because as long as Watson's websites were up, West's criminal racketeering business model was dead in the water in the USA. Clearly, with the truth getting out, Devra Patton West wanted to try to claim the moral high ground by making it appear that she was a victim of a cyber extortion scam (where are the other victims of this imaginary cyber scam?). 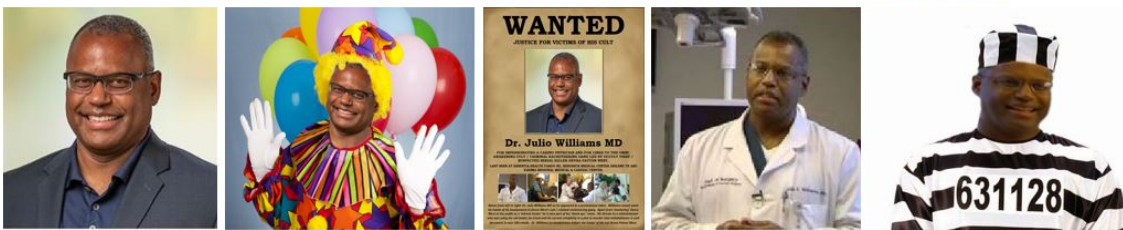

They are not denying that West claimed to be ["holding open the gates of time."](#) They are not denying that West told her students that the Christ [gave her two doctorates](#) in person. They are not denying that on July 12 2007 while in court, West denied assaulting Dr. Cole MD when on April 2006, Devra West wrote and emailed the missive [The Law of Severity on the Path to Purification](#) to her entire mailing list. Within that missive, she admitted assaulting Cole, admitted that the beating was severe but administered with grace! She went on to assert that Cole was a Nazi in the WWII death camps in another lifetime and therefore the beating was long overdue. Did I mention that Devra Patton West is criminally insane (or a well adjusted Satanist)? They are not denying that Devra Patton West viciously assaulted Dr. Cole MD by hitting her repeatedly on the head with her shoe ([Whitefish Pilot](#) news article has details). FACT 13. CULT / GANG MEMBER DR. JULIO WILLIAMS MD

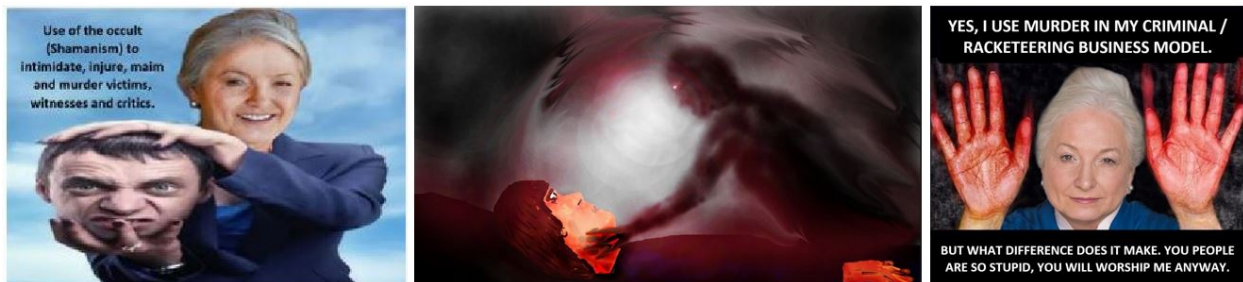
FACT 13. In FACT 7 above, we detailed how senior cult member Geoffrey Reynolds CPA shared details of Devra West's plot to murder the whistleblower, John Watson, with the press days before Devra Patton West made her failed attempt on his life. Reynolds also correctly predicted that Watson and his family would be relentlessly targeted by Devra Patton West using her occult knowledge to intimidate Watson and if possible to murder him. In FACT 7, we give details of some of the attacks used against Watson, his wife and children. Clearly, Reynolds was briefed by West that she had murdered others and that murdering Watson would not be a problem and not traced back to her as his death would appear as a death caused by natural causes. Perhaps West shared the fact that she successfully murdered student, Lisa Swidler in 2005, after Lisa Swidler witnessed two serious crimes committed against two other students [Kushner](#) and [Cantwell](#). Perhaps Jack West shared the fact that those who opposed his ex-wife had a habit of dying suddenly, as he had confided in John Watson in 2002.

Either way, Reynolds could not have shared the details of West's plot to murder Watson if he had not known ahead of time what was going to happen.

Similarly, Reynolds could not have known that Watson and his wife and children would be targeted by West unless West had briefed him. Reynolds would also have been aware that Devra Patton West was targeting her estranged daughter-in-law Jamie Haywood, in an attempt to intimidate Jamie into giving up her infant female daughter to West's son, Chris Haywood. Jamie writes refers to this in her [email](#) to John Watson and in her [testimony in court](#) at the custody hearing. Reynolds would also have known about West targeting her office manager Rebecca West (no relation to Devra West) in an attempt to force Rebecca into withdrawing a damning statement about West's assault on Dr. Pat Cole. Reynolds would have been aware of all of this, which is why he made the announcement of Watson's impending murder so nonchalantly to the Bigfork eagle reporter on August 9 2007.

More to the point, Dr. Julio Williams, as senior student at Devra Patton West's unaccredited school for occult studies, would have known in 2007 exactly what was going on. Indeed, Rebecca West's harrowing email to John Watson entitled '[Help Me](#)' sent to him in March 2007, clearly describes the chaos in West's cult at the time. To show his undying support for the leader of his satanist cult, Williams made a \$100,000 donation in support for her criminal activities and hidden killing spree.

Twelve years later, and for the past 3 to 4 years, Dr. Julio Williams MD has been receiving on average 3 or 4 emails a week from John Watson detailing the daily / nightly occult 'under the radar' violence being directed against him and his family by Devra Patton West. Dr. Julio Williams has received an estimated 400 plus emails about his cult leader's criminal activities and yet he has failed to pass a single email on to the police or the FBI as to do so would implicate him in racketeering and murder.

FACT 14. It is clear that Devra Patton West is using the occult (hidden) knowledge she gained while attending the Robert Jaffe School for Energy Mastery between 1990 & 1991 for criminal purposes. No guru worth their salt would make as many enemies or have as many appearances in court as the defendant, however clumsy or unlucky they are. It is clear from West's own statement to the [Whitefish Pilot](#) newspaper on July 12 2007, that Devra Patton West was trained in shamanism. Below is an excerpt from that newspaper article.

West claims to have been trained in shamanic visioning and healing by Native American elders, and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.

The last underlined sentence (by me) is not what you would expect from a healer, but entirely in keeping with an egomaniac. It is also clear that if she could heal people with that knowledge, she could equally make people ill – especially those who opposed her, challenged her or went public about what she was doing. It is also clear that a charismatic woman like West, a total narcissist, would attract the likes of morally bankrupt individuals like Geoffrey Reynolds.

Dr. Julio Williams grew up in the Dominican Republic, where voodoo was a religion; joining the Satanist coven of a white witch must have seemed like all of his Christmases had come at once. Not that any Satanists celebrate Christmas.

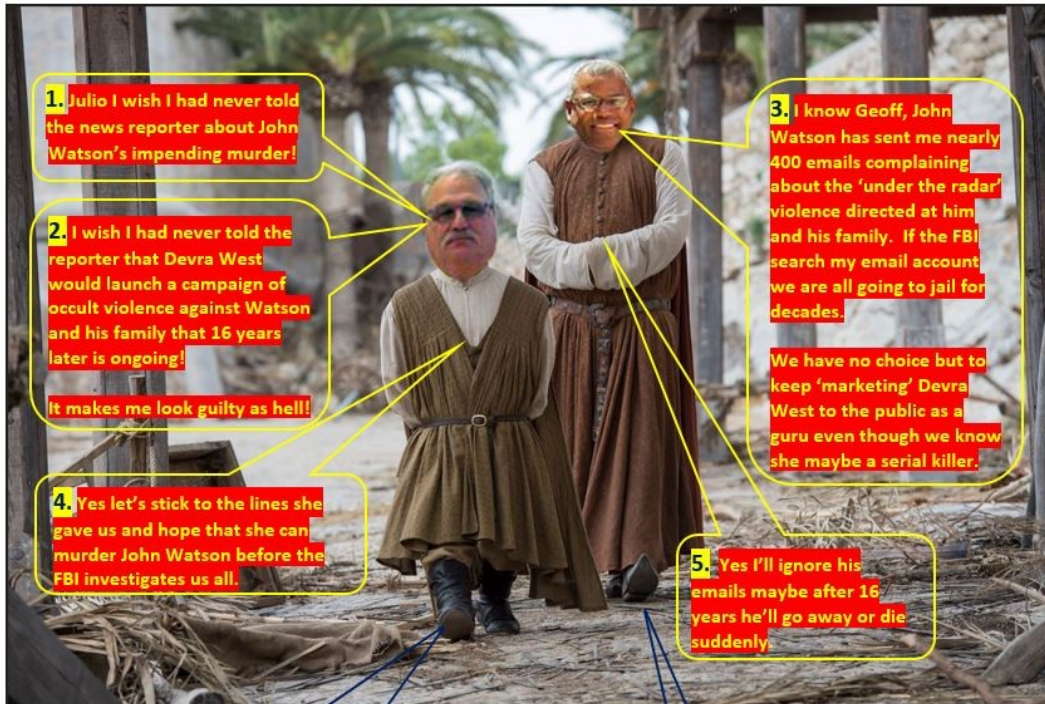

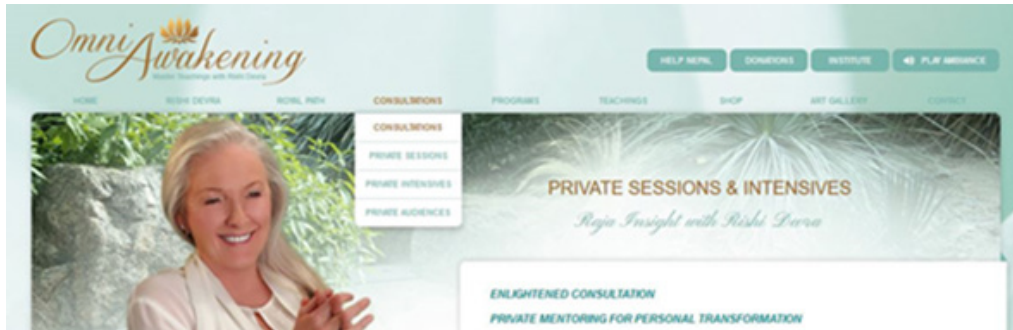

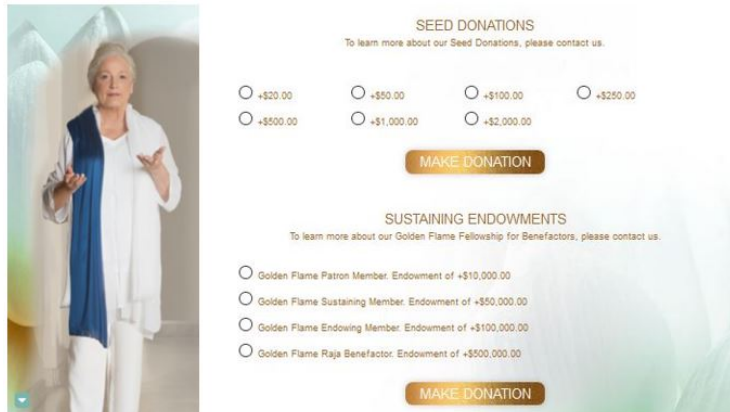
