

Re: Complaint against Dr. Julio E Williams – Alleged Gross Misconduct and Bringing the Medical Profession into Disrepute.

You have me previous submission which sets out the complaint against Dr. Julio E Williams MD who I allege is a 20 year member of a cult / criminal racketeering gang. In that submission I set out the case, backed up by documents issued by Dr. Williams himself and the leader of his cult gang along with legal documents, newspaper articles and statements from victims of the cult. Many of the documents referred to in my complaint are lodged on a website which is a repository of information for those seeking justice for crimes committed against them by Devra Patton West who is the leader of Dr. Julio E Williams cult / criminal gang. The website has, in recent days, been the subject of a number of Denial of Service Attacks (DDoS) so in the event that the documents are unavailable to you when you review this matter I want to supply you with a 'time line' of documents that indicate beyond any doubt that Dr. Julio E Williams MD is a willing accomplice of Devra Patton West.

**2003.** In March 2003 I announced that I was going to law after being defrauded by Patton West like so many victims before and since. Immediately after I announced I was going to sue Patton West for fraud she insisted on meeting me in private to try to persuade / threaten him not to go to law. Listening to the evil creature speaking will give you some idea of the nature of the beast that Dr. Julio E Williams has been worshipping as a God for 20 years! The above is a total pack of lies but do not take my word for it review the evidence and make up your own mind.

**2006. Patton West's Vicious Assault on Dr. Pat Cole MD.** After Patton West's charity was struck off for fraud in January 2004 (see [Revocation Certificate](#)) Patton West changed her name and moved her cult to a new location saying she could only take 12 disciples with her and only those who would commit to [donating 66% of their net worth](#) to her good causes (luxury lifestyle expenses). By early 2006 Dr. Cole had still not handed over 66% of her fortune estimated at \$1.3 million so Patton West organized a campaign of violent assaults designed to persuade Cole to hand over her fortune. Early in April 2006 the police were called after a particularly vicious assault on Dr. Cole MD by Patton West who repeatedly hit Cole over the head with the heel of her shoe until blood ran down her face. This matter is more than adequately covered by the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers and by statements made by fellow cult members [Rebecca West](#) (no relation to Devra West) and [Carlida Finch](#) who overheard Patton West planning Cole's murder.

Unless willing to submit to Dr. West destroying the lesser mind through her techniques of Transpersonal psychology and eastern traditions she felt her employees had no value. It is disconcerting to be forced to adopt your employer's philosophy as modus operandi for your own life and discouraging to have 35 years of experience in the work place denegated for the same reason. Devra recently stated, after hiring Ray Solanki as her business manager that she would only hire disciples as execs for the corp, leaving those who don't join her with no chance for advancement. Mr. Solanki introduced himself as "from another planet" at the first staff meeting at which he was present. Devra was unhappy with the way employees treated her, we did not stand each time she entered or left the room. In the past she had rose petals spread at her feet by disciples</p>

Within days of the assault on April 17 2006, and in an attempt to justify the assault, Patton West sent a lengthy email to all of the members on her cult mailing list including [Dr. Julio E Williams MD](#). ## *The Law of Severity on the Path of Purification*

Response to the Call of *Master Surya Devi* for Review

April 17, 2006 From Master El Morya of the Shamballa Councils

What must be taken into account in all matters of review on the part of the Shamballa Councils is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokescreens that veil her memory of her perpetrations against her fellow human brethren.

Long story short Patton West admits the assault on Dr. Cole, admits it was severe but states that it was administered with grace! **2007. A gifted cardiothoracic surgeon, Doctor Williams graduated Cum-Laude from Madre & Maestra Catholic University in the Dominican Republic. During his training as a medical student, his rotations for "social medicine" involved treating the poor and disadvantaged in the city slums and the Sierra Mountains of the Caribbean Islands, and as a result he felt drawn to the holistic concept of medicine.

"Because economic and cultural influences were so obviously at play, I could not help but view the patients not only as the disease process they exhibited, but also from the holistic causative stand point: the Bio-Psycho-Social triad that allows us to access the root cause of the disease process. This early experience of medicine in an underdeveloped country awakened within me the sensitivity for serving those in need. From the day that I graduated I have perceived medicine and health care as a God given right belonging to all of humanity."

Dr. Williams then completed his residency in general surgery at Albert Einstein College of Medicine and Bronx-Lebanon Medical Center in New York city, during the peak years of the Aids epidemic, and he shares, "This was a trying time emotionally and a time of enormously hard work, however I was a witness to the evolution of medicine and the disease process. I also had the privilege of working in scientific research for a year with Dr. Stanley Levenson, professor Emeritus of Surgery at the Albert Einstein College of Medicine, who is considered to be a pioneer in wound healing research. Reading about the great minds of early science was mandatory prior to engaging our actual work project, and this inspired a keen interest in the work of Louis Pasteur, Dr. Dubois among others. But what I remember the most about Dr. Levenson was the wisdom he passed to us as surgeons, residents, and students, as he shared the stories of his exodus from Russia as an orphan Jewish immigrant travelling a post holocaust Europe and coming to America to become a leading authority in the world of academic Surgery and Basic Science research and the recipient of awards from the American College of Surgeons. His wisdom and perseverance instilled in me the courage to seek beyond conventional norms."

During his senior years in his surgical training, Dr. Williams received the mentorship of Dr. Robert Frater, Acting Chairman of the Cardiothoracic Surgery Department at Einstein, who introduced him to the world cardiothoracic surgery and who endorsed him as a potential candidate for fellowship training in cardiothoracic surgery. Dr. Williams then went on to train in cardiothoracic surgery at the University of Medicine and Dentistry of New Jersey (UMDNJ- New Jersey Medical School) Newark campus.

"The cardiothoracic surgery training was intense and demanding but full of rewards for the heart. Again, working in the inner city and its population help me see the other part of society with its continuous problems like a vicious cycle with no end in sight. As I came face to face with this every day, it made me see clearly and first hand the problems that plague our health care system." Dr. Williams completed his board certification in General Surgery in 1997(American Board of Surgery) and Cardiothoracic Surgery in 2001(American Board of Thoracic Surgery)

After completion of his surgical training, Dr. Williams began his private practice.

It was during the beginning of my practice that "I heard the call to service".

It became clear that for him path of medicine would lead him to a higher purpose and that caring for those in need went far beyond the financial rewards in which our health care system is entangled at this time.

It was in the fall of 2000 when I first came into contact with Dr. Devra West, whom we graciously and fondly call "Surya Ma" (a name reflecting high honors on the spiritual path) during a transformational training at her retreat center in Montana. I quickly came to recognize that she is one of her kind among the few contemporary illumine minds here in the west. ### Spiritual leader has plans for healing center in Whitefish

A self-styled clairvoyant and spiritual healer from Lakeside who claims the Osprey House on Angel Point as a future VIP spa faces criminal charges stemming from an alleged assault on a Whitefish doctor.

Devra Patton West's goal of opening a series of healing spas -- including one in Whitefish -- has been stalled while she fights allegations ranging from black magic to fraud, extortion and breach of contract.

A temporary restraining order against West, who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, requested protection. Cole was the director for one of West's ventures, The Sacred Archives Institute. They worked together for several years. In her statement to the county sheriff's office, Cole claims West abused her verbally and physically.

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement.

Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself."

Photos taken after the alleged beating were submitted to the sheriff's office.

When the Pilot asked about Cole's claims, West said her attorney advised her not to comment on the misdemeanor charge. A hearing for a jury trial is scheduled for later this month.

An author and speaker, West claims she recognized her clairvoyant and healing gifts at age six when she began "interacting and communicating with archangel Michael," according to her book "The Christ Heart."

West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives.

She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.

According to her biography, West went back to school at age 38 after raising her children. She graduated from the College of the Redwoods in 1994 with degrees in social science and humanities.

After graduating, she founded the Divine Unity Foundation and the Sacred Archives Institute in Victor, Montana. The institute was charged with organizing and recording her ongoing monthly "transmissions" -- channeled telepathic messages that come at 3 a.m. from a group she calls the Ascended Masters, some living, some not. They include Master Jesus, Buddha, St. Francis of Assisi, Confucius, Zoroaster, Mohammed and Babaji.

Michael and Lori Hendrickson, of Colorado, worked with West in Victor and paid off a promissory note for West's foundation in 2005 to prevent foreclosure. They are now suing West, the Sacred Archives Institute, West's husband and Dr. Cole for breach of contract, claiming West moved the money out of the foundation to a personal trust.

Here in the Flathead, West ran into problems over several properties where she lived. On June 1, she was evicted from a \$2 million Lakeside waterfront home when she failed to pay a second \$50,000 down payment. She then moved into another Lakeside with her son and daughter-in-law. "All she got out of the house was her cat," said Larry Phillips, a Realtor with Land Rush Realty. When asked about the eviction, West said a few weeks away from home were worth the trouble. She claims to be negotiating a better deal on the property due to a water rights dispute. According to court documents, West is behind in payments on the second home. The issue has not yet been resolved, according to one of the homeowners, Larry Brazda.

A third Lakeside property -- the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her."

One more lawsuit dogs West's plans to move forward with healing retreats in Lakeside and in Whitefish at the former North Valley Hospital site. Her former business consultant and stockholder in Millennia Mind, John Watson, is suing her for fraud, constructive termination and breach of contract. Watson claims he was not paid for the services he provided, including setting up stock in Millennia Mind.

"She told me the Masters decided they didn't want stock, out of the blue, no discussion, and that was that," Watson said. "She is an evil and dangerous woman." According to Watson, when he demanded payment and threatened to sue, West psychically attacked him and his family by sending migraine headaches from Lakeside to their home in Nova Scotia.

Watson created the Web site [www.universalteachings.com](http://www.universalteachings.com), where he accuses West of a host of offenses ranging from extortion to black magic. "Our attorney told us to just let him hang himself with the Web site," West said when asked why she allows the Web site to continue. West has filed a libel suit against Watson, but he said he has not yet been served.

Trial scheduled in Lakeside assault case

A Lakeside woman who claims to communicate with long-dead religious masters will face a jury trial Sept. 18 in Flathead County Justice Court on misdemeanor charges she assaulted a Whitefish doctor. A temporary restraining order against Devra Patton West, a self-styled guru who calls herself Surya Ma, was issued by Judge David Ortleby last October after Dr. Patricia Cole, of Whitefish, requested protection. Cole claims West assaulted her in April 2006 and again in October 2006.

Speaking for West, Geoff Reynolds claims the charges are untrue. He said photos of the first alleged assault were taken on a different date, and the bloody clothing in the photos resulted from Cole falling down a stairs at her Cherry Creek condo in Lakeside, not from an assault. Reynolds, who is a financial adviser for West, said he has worked as an accountant in Los Angeles, where he dealt with well-known personalities. He is helping West raise several hundred million dollars to purchase and develop three properties around Flathead Lake for VIP spiritual-healing spas.

The man who took the photos, however, tells a different story about the alleged assault. He came from out-of-state and was sharing the condo with Cole while he attended sessions with West. He said he was meditating when Cole appeared wearing a bloody sweatshirt. The man said they cleaned some of the blood off Cole's scalp and then took photos so Cole, as a doctor, could see her injuries and decide how to treat the wound. Cole said West hit her on the head with a shoe, the roommate said.

Cole said she first came to Montana from Minnesota to attend spiritual sessions at Naka Shela, West's facility in Victor, from 2002 through 2004. She moved to Montana to live in 2005 with the idea of combining West's spiritual teachings with medical knowledge. Cole eventually assumed management positions with several of West's for-profit and not-for-profit operations. As business fell in Victor and the Naka Shela property was foreclosed, West moved her business north to Lakeside.

Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last

year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.

Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

Reynolds claims that several people have been stirring up trouble by publishing untrue allegations against West. He points out that former office manager Rebecca West, who is no relation to Devra West, was denied benefits by the Montana Department of Labor and Industry because she was unable to prove a hostile environment existed at Surya Enterprises Unlimited.

Rebecca West claimed she left her job because she was afraid for her safety and did not want to become a victim of physical abuse by Devra West. But hearing Officer Peggy Harper found "the evidence does not establish verbal, emotional or spiritual abuse." Rebecca West won two earlier hearings and has appealed Harper's decision.

Reynolds also claims John Watson, a former business consultant for Devra West who now lives in Nova Scotia, has been spreading false allegations about Devra West by e-mail, phone calls and his Web site, [www.universalteachings.com](http://www.universalteachings.com).

Devra West has filed a libel suit against Watson, but Watson said he has not yet been served. Reynolds said West is also trying to get Watson's Internet-service provider to take down Watson's Web site, noting that its URL is very similar to West's, [www.universalteachings.org](http://www.universalteachings.org).

Both Cole and Rebecca West say they have been interviewed several times by agents from the Internal Revenue Service, which they say is investigating West's businesses.

### Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.
