

Subject: A Brief Description of Patton West's Criminal Business Model.

Additionally, she was forced to sell her assets at a Sheriff's Sale to pay past victims of crime \$2,000,000 in court fines and interest. Not a problem for Patton West, who simply moved to another western state. Upon arriving in Cave Creek AZ in 2011, Devra Patton West changed her 'stage' name / alias from the Ascended Master 'Surya Ma' to the Ascended Master 'Rishi Devra.' Her Accomplices in Racketeering and Murder.

When Patton West's crimes go public and threaten the multi-million dollar a year criminal business model, Patton West enlists the senior members of her cult to join her in a campaign of dirty tricks, defamation and threats designed to shut down dissent from victims and witnesses of organized crime at her hands. After Patton West viciously assaulted Dr. Pat Cole MD, while successfully extorting \$1.3 million from her, Dr. Julio Williams MD and Geoffrey Reynolds CPA were used to publicly deny the assault from Patton West's website.

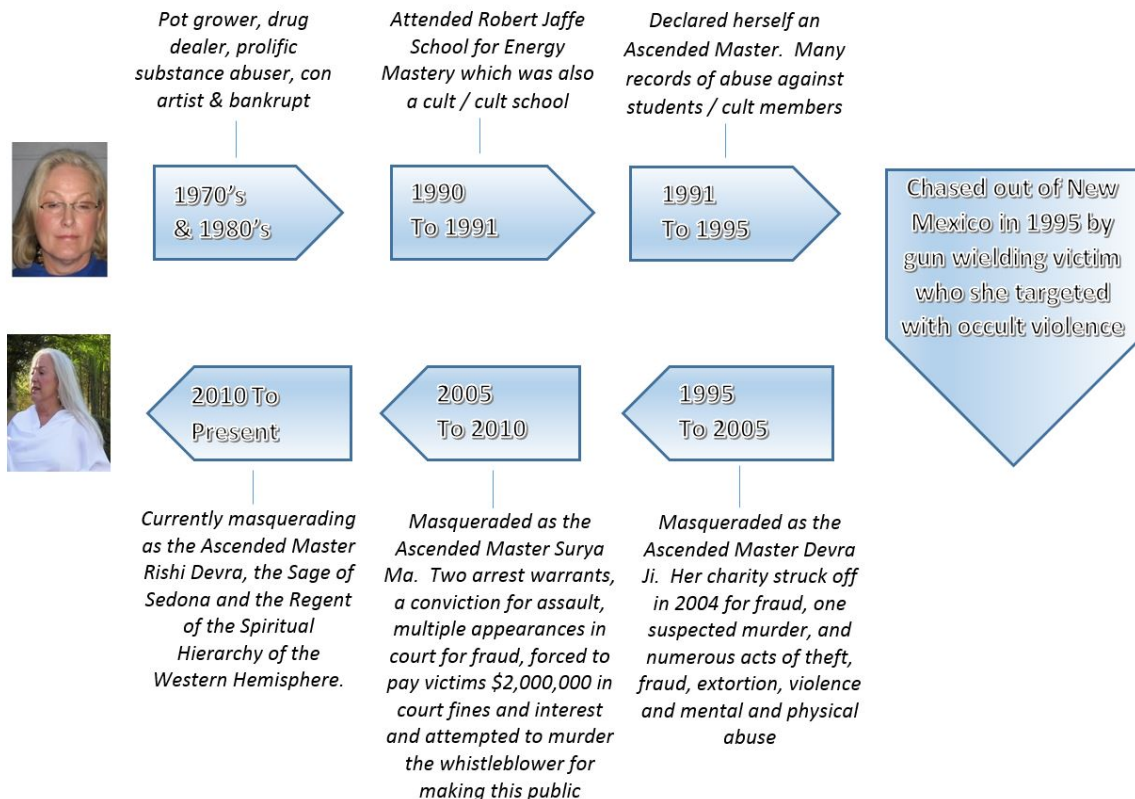
