## Why Dr. Julio E Williams MD & Geoffrey Reynolds CPA deserve the accolade of 'scum.'













Above from left to right. Con artist and violent convicted criminal Devra Patton West a lifelong criminal who uses knowledge of the occult to leverage her criminal activities. **Scum** (adj.) Possibly the worst word you can have your name associated with.

It is hard to define the word, but it is basically used to describe someone so <u>disgraceful</u> that they are seen as the <u>lowest form of life</u>. "Worthlessness", "<u>waste of skin</u>", "dirt". "Nothing". Far worse than most other insults, where the victim is often just referred to as genetalia.

By his <u>own admission</u>, Dr. Julio E Williams MD joined Patton West's cult / criminal racketeering gang in the year 2000. Williams quickly turned a blind eye to the many, mainly financial crimes, being committed by Patton West upon other less valuable members of her cult. Like many before him and since, the whistleblower John Watson, was recruited in 2002 via 'career opportunities' then being offered by Patton West. Six months later in August 2002, Watson was constructively dismissed without the pay and remuneration he was promised. It turns out that Patton West's career opportunities were a giant fraud scam, whose sole objective was to entice well heeled 'employees' into becoming members of her cult who, after brainwashing and conditioning would then agree to work for her personal goals for low pay or no pay and 'donate' their wealth to Patton West's good causes (herself).

Five years later in 2007, a series of emails from one employee Rebecca West (no relation to Devra West) entitled 'Help Me,' confirmed that Patton West had a 'revolving door' policy to employees. Put simply, someone responded to her advertisements for 'career opportunities,' were hired and on day one were told there had been a misunderstanding and that they had to accept a 20% pay cut. A month later, the pay check they expected (at the lower rate) never arrived and upon enquiry they were told they were doing 'seva' for the Master Teacher. In other words, they were expected to work for nothing for a month or two to 'save' the Master Teacher paying their wages. In March 2003, Watson (later turned whistleblower) announced he was going to sue Patton West for fraud, at which Patton West demanded a private meeting with Watson. She threatened and cajoled him in an attempt to intimidate him into not suing her for fraud. Fearing some kind of a stunt Watson hid a digital tape recorder in the meeting room and recorded what Patton West had to say to him. Below are several excerpts from that meeting.



## WARNING FOUL LANGUAGE FROM CRIMINALLY INSANE WANNA BE PLANETARY REGENT

- 1. Devra West refers to John Watson as 'Prince Charming.'
- 2. West agrees she has defrauded John Watson but does not see herself paying him!
- 3. West acknowledges that she is a control freak and admits to disposing of people like used Kleenex.
- 4. John Watson advises that she will not do the same to him.
- 5. West goes berserk and in an expletive laden tirade accuses the whistleblower of exploiting her vulnerability! This behavior proves beyond doubt that Devra West is criminally insane.
- 6. West says that if Watson sues her she'll get so f\*cking down and dirty huge expenses coming out of his pocket and not hers because Williams will pay her legal fees.
- 7. West says she feels stabbed in the back and f\*cked up the arse by Watson's insistence that West pay her the \$50,000 she owes him. West has an emotional melt down and leaves in hysterics!
- 8. The truth does not matter (if she can convince the public that her lies are their truth).

What I want the reader to understand from the above is that Patton West in excerpt (2) above agrees that she has defrauded Watson but does not see herself writing out a check for what she owes him. Further, in item (6) above Patton West threatens that if Watson sues her she'll get so f\*cking down and dirty with huge expenses coming out of Watson's pocket but not hers because members of her cult (Dr. Julio Williams MD) would pay for her legal expenses. Indeed, Patton West did get 'down and dirty' as upon arriving back at her compound from the above mentioned meeting, Patton West demanded that all of her employees, on pain of being fired, manufacture totally false statements about Watson that Patton West intended to use against him at the fraud trial. One of those 'employees' (members of her cult) Anandra George later retracted her false statement in an email she later sent to Watson's lawyer.

However, this email is about how Patton West was able to mobilize two members of her cult, Dr. Julio E Williams MD and Geoffrey Reynolds CPA, in her vendetta against Watson who she had defrauded and admitted she had defrauded. It is worth pointing out at this stage that both Dr. Julio E Williams MD and Geoffrey Reynolds CPA were both total strangers to John Watson and yet, Patton West was able to manipulate them into being complicit in her plot to murder Watson and when that failed, the conspiracy she orchestrated to bankrupt Watson by issuing multiple frivolous lawsuits against Watson that she suspected he could not afford to defend.

The following is a timeline of Dr. Julio E Williams MD & Geoffrey Reynolds' involvement in Patton West's vendetta against Watson. A more detailed analysis can be found by going to a bulletin entitled <u>Gang Members</u>.

- 1. Patton West's charity was <u>struck off</u> the Montana charity register in January 2004, after it was found that Patton West and her husband were using the charities bank account as their own personal bank account.
- 2. In 2005, Dr. Julio E Williams MD posted a propaganda statement on Patton West's website within which he staked his honor and credibility on defending her personal integrity and establishing the truth.
- 3. In 2005, senior student Lisa Swidler died suddenly and mysteriously after witnessing Patton West defraud money from <a href="Dave Kushner">Dave Kushner</a> and extort money from <a href="Marion Cantwell">Marion Cantwell</a>. All three were students of Patton West's unaccredited school for occult studies. Watson had been told by Patton West's husband, Jack West, in 2002 that those who opposed his wife had a habit of dying suddenly Watson still did not connect Lisa Swidler's death with Patton West. That was to change in August 2007.
- 4. In early April 2006, Patton West viciously assaulted Dr. Pat Cole MD while in the process of extorting \$1.3 million from her. After that assault, the latest in a series by Patton West, the police were called and Patton West was charged with assault. It turns out from a <a href="mailto:statement">statement</a> provided to the authorities by another employee, Carlida Finch, that Patton West was overheard talking about the murder of Dr. Cole MD.
- 5. On April 17 2006, Patton West issued a lengthy missive entitled, <u>'The Law of Severity on the Path to Purification,'</u> wherein she admitted assaulting Cole, admitted the assault was severe but stated that her actions were carried out with grace. Patton West, thought to be criminally insane, also stated that as Cole was a Nazi in the WWII death camps in another lifetime the beating was long overdue.









Above from left to right: Lisa Swidler murdered in 2005, Marion Cantwell kidnapped, held captive, beaten and the victim of extortion. Marion was told she would be murdered if she went to the police. Dr. Pat Cole MD who Patton West was planning to murder until Cole agreed to pay her \$1.3 million. Watson who, with Reynolds and Williams, Patton West conspired to murder and when that failed conspired with Reynolds and Williams to bankrupt.

- 6. In September 2006, Geoffrey Reynolds CPA responded to one of Patton West's fake <u>'career opportunities'</u> and joined Patton West as her 'Financial Controller' working in what he thought was a normal corporation. All too late, Reynolds found out that Patton West's corporation was a front for a cult / criminal racketeering gang and only after he had loaned his life savings of \$300,000 to Patton West. Form Patton West's point of view Reynolds was the perfect new employee wealthy, stupid and totally corrupt. Reynolds chose not to go to the police, but instead, to become a 'tool' of Patton West's in the hope of 'earning' the return of his \$300,000 life savings. This much was clear from <u>another email</u> sent to the whistleblower by Rebecca West, who worked as 'office manager' alongside Reynolds.
- 7. In January 2007, when it looked like Watson's law suit was going to be successful, Dr. Julio E Williams MD wrote an expletive laden threatening email to Watson in a brazen attempt to intimidate Watson into withdrawing his lawsuit against Patton West. Within the email Dr. Julio E Williams stated that he was going to make \$2,000,000 of his own fortune available for Patton West's defense fund. Just FYI witness tampering is punishable by heavy fines and a jail sentence.
- 8. In June of 2007, after receiving several harrowing emails from <a href="https://orw.ncbi.nlm.nih.google-patton">orw.ncbi.nlm.nih.google-patton</a> West's cult, Watson went public and shared what he had learned while researching his lawsuit against Patton West with two Montana newspapers. Watson had put up a website in 2006 to counter Patton West's lies and propaganda, who presented herself to the public as a minor deity while behind the wall of secrecy of her cult was robbing, defrauding, extorting and mentally and physically abusing employees and students. On July 12 2007, the first of two newspaper articles were published by the <a href="https://whitefish.pilot">Whitefish.pilot</a> to be followed on August 9 by another story published in the <a href="https://www.ncbi.nlm.nih.google-patton">Bigfork Eagle</a> newspaper. Both stories led with Patton West's assault on Dr. Cole but also covered several other crimes being committed by Patton West in Montana at that time.
- 9. Within 48 hours of the Whitefish Pilot story having been published, Geoffrey Reynolds, Julio Williams and other members of Patton West's cult all published statements of denial on her website. What makes Geoffrey Reynolds' lies so egregious is that while publishing four statements of denial that Patton West had assaulted Dr. Cole MD, Reynolds was frantically trying to force a copy of Patton West's written admission that she had assaulted Dr. Cole off Watson's website. - 10. While Geoffrey Reynolds was being interviewed by the Bigfork Eagle reporter Constance See, and in what he thought was an 'off the record' conversation, Reynolds let it be known that Watson would be dead within 12 months. Reynolds also told that reporter that if not dead Watson would be jailed for reacting to what Patton West was going to do to him and his children. The reporter took the threat seriously enough to pass it on to a federal agent investigating Patton West at the time who warned the whistleblower via email
- 11. Several days after Reynolds' threat was delivered, Patton West made a failed attempt to murder Watson. After this attempt on his life, Watson remembered Jack West's comments to him in 2002, that those who opposed his wife had a habit of dying suddenly. Watson then realized that his friend Lisa Swidler had been murdered by Patton West after Lisa made a desperate attempt to leave the cult. There was no reason why a young mother of two children under the age of ten should die suddenly now it all made sense to Watson, as did Jack West's warning in 2002. - 12. What this tells us about Geoffrey Reynolds is that he knew Patton West was going to attempt to murder Watson and yet he was perfectly OK with that. What this tells us about Geoffrey Reynolds is that he knew Patton West was going to launch a campaign of occult 'under the radar' violence against Watson and his family which, 13 years later is ongoing! What this tells us about Geoffrey Reynolds is that he expected Watson to fall into the trap of reacting to Patton West's campaign of violence against his wife and children in a way that would result in Watson being jailed. Perhaps Patton West told Reynolds about the victim that chased her out of New Mexico with a loaded gun knowing the police were impotent against a devil like Patton West. Perhaps Patton West had told Reynolds about several other murders she had gotten away with thereby giving him the confidence to boast about Watson's impending death to the Bigfork Eagle reporter.
- 13. The murder plot having failed, Patton West's cult / criminal racketeering business model was dead in the water in Montana and elsewhere in the US until she could force down Watson's websites and silence him for good. Having failed to murder Watson in 2007, Patton West had to wait 3 years until 2010 to carry out the next phase in her vendetta against Watson. Accordingly, when attending court in 2010 to see how much the court was going to award Watson for winning his fraud lawsuit against Patton West, Watson was served by Patton West and her stooge Reynolds with multiple frivolous defamation lawsuits.

Over the last few years I have been witness to your continuous attacks to Devra West and the nonprofit. Hear me very clearly now "THE LINE IN THE SAND HAS BEEN DROWN". Above: Just as Dr. Julio E Williams threatened, in his email to Watson in 2007, Williams put up the money for Patton West to fund multiple frivolous lawsuits against Watson. This enabled Patton West to carry out her 2003 threat to outspend Watson in court with the funds to do that not coming from her pocket!

- 14. It says something about the totally corrupt nature of Geoffrey Reynolds that, although his and Watson's 'employment' was separated by over four years Reynolds perjured himself at Patton West's request making totally false statements to the court that he too was defamed by Watson.
- 15. As a consequence of Patton West & Reynolds's lies and Watson's inability to defend those lies Patton West and her stooge Reynolds were awarded \$5,000,000 each in an undefended default judgment.
- 16. Patton West gambled correctly that after Watson had fought and won an expensive 5 year lawsuit he would not have the stomach or funds to fight two more lawsuits however ill-conceived they were. This turned out to be the case as Watson, having immigrated abroad for his own safety in 2005, did not have the funds for multiple journeys to the USA for another five years.

In closing, this is what criminals do. If they cannot intimidate you or murder you they outspend you in court and 'buy' the result they want. In Patton West's case she:-

- 1. Defrauded Watson and even admitted it in a recording Watson made of their meeting in March 2003.
- 2. Patton West said that if Watson sued her she would get so f\*cking down and dirty with huge expenses coming out of Watson's pocket and not hers. This is exactly what she did with Williams' & Reynolds' help
- **3**. As we saw above she forced her employees to manufacture fake statements alleging wrongdoing by Watson, she had Williams threaten him via email, when that failed she tried to murder him and when that failed conspired with Williams & Reynolds to bankrupt him.
- **4.** Using Williams \$2,000,000 and Reynolds' lies she outspent Watson in court just as she threatened to do and having removed all mention of her crimes from the internet moved to Arizona where she is now preying on the spiritual communities of Sedona & Scottsdale AZ.

Between 2008 & 2009 alone, Patton West was the recipient of two arrest warrants; one for <u>criminal check fraud</u> and one for <u>felony theft</u>. She was <u>convicted of assaulting</u> Dr. Pat Cole MD and was found <u>guilty of defrauding</u> John Watson. She was also the subject of a <u>Sheriff's Sale</u> to force her to pay her creditors \$2,000,000 in court fines and interest.

However, due to the help of Williams & Reynolds, Patton West was able to escape justice in Montana and resurrect herself with a new name and identity in Arizona where she is now masquerading as a Planetary Regent 'Rishi Devra' offering 'divine grace healings' to cancer patients for six figure sums, while running yet more 'career opportunity' adverts to suck in more employees to fake jobs that become victims of theft, fraud, extortion and perhaps sudden death. Patton West's multimillion dollar a year criminal racketeering business model was put on hold between 2007 & 2010 motive enough for the murder of Watson. The campaign of intimidation Reynolds described to the Bigfork Eagle newspaper reporter continues to this day. Dr. Julio E Williams MD has received some 400 plus emails from Watson complaining about the intimidation but Williams never replies and certainly never sends the emails on to the police as to do so would implicate him in racketeering and murder.

This campaign to have Dr. Julio E Williams MD & Geoffrey Reynolds CPA will not stop until they and Patton West are the subject of a criminal investigation for their crimes. The \$10,000,000 default civil judgment obtained by Williams & Reynolds treachery is still in place as is the 24/7 campaign of intimidation from Patton West now entering its 14<sup>th</sup> year. Remember Watson and Cole are just two victims of Patton West's there are scores of victims of racketeering and murder in three western states over the past 28 years since she declared herself to be an Ascended Master in 1991.
