

10 August 2020 Four Point update for FBI, Law Enforcement & Arizona Consumer Protection Agency.

1. Patton West continues to operate her cult / criminal racketeering business model in Sedona AZ after being expelled from New Mexico in 1995 & Montana in 2010.

To bury Patton West's 'criminal' past in Montana & New Mexico so she could reincarnate in Arizona with a new identity where she now operates calling herself a 'Planetary Regent.'
4. Both Reynolds & Williams **remain willing parties and co-conspirators** to the ongoing campaign of intimidation against the whistleblower and his family by cult / gang leader Patton West. In addition to the above four statements, Patton West went on to admit she had defrauded Watson but did not see herself writing out a check for what she owed him. Patton West admitted defrauding Watson (5) but did not see herself writing out a check for what she owed him. Instead, she threatened him (6) by saying that if he sued her, she would get so f*cking down and dirty with huge expenses coming out of his pocket and not hers. Because Dr. Julio E Williams would pay her legal expenses for when she retaliated with multiple frivolous lawsuits, which is exactly what happened after Watson won his fraud lawsuit in 2010. This occurred in 2010, three years after a failed attempt by Patton West to murder Watson in August 2007. Patton West goes on to threaten him if he goes to law, and tells him that (7) the truth does not actually matter (if she can convince the public and courts that her lies are their truth!

Watson is one victim of fraud. There are literally scores of victims of theft, fraud, extortion and violent assault, 99% of which was not brought to the attention of the authorities because the victims were too afraid of being targeted with violence or murder. In effect, Patton West ran her own medieval fiefdoms within New Mexico between 1991 & 1995 and the same in Montana between 1995 and 2010. We are 99% sure that Patton West murdered student, Lisa Swidler, after she tried to escape the cult in 2005, having witnessed two serious crimes by Patton West against other students. We're 100% for sure that Patton West made an attempt to murder Watson in 2007 after he put up a website about Patton West's crimes. Reynolds' announcement to the press of Watson's impending murder on August 9 2007, not only corroborates Watson's account of what happened to him but shows how confident Patton West and the senior members of her cult were / are that they can get away with murder. Nearly 14 years later and unable to murder or intimidate Watson, an ex-marine, the campaign of intimidation continues unabated. Senior cult member Dr. Julio Williams is totally aware of the ongoing campaign of intimidation against Watson, his family and other victims of crime at Patton West's hands. Williams is a 20 year student at Patton West's unaccredited school for occult studies, a senior member of her cult and the person who gave Patton West \$2,000,000 so she could mount a conspiracy against Watson to bankrupt him into silence. 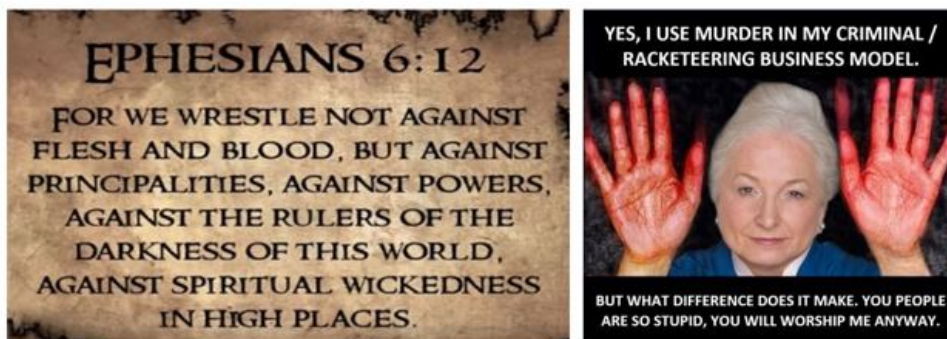
Of course, the reality is quite different. And that is the reason she tried to murder Watson and when that failed, tried bankrupt him into silence. 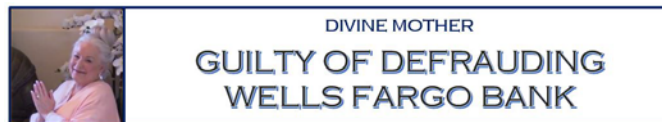

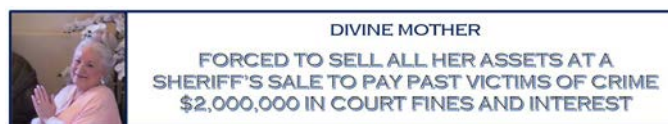

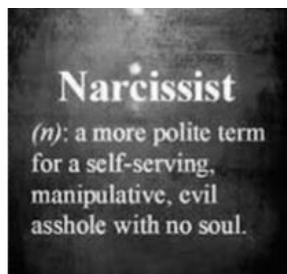

Nobody in their right mind is going to donate hundreds of thousands of dollars to Patton West, however compelling her lies and propaganda are. The truth is that her 'Pay Portal' is set up to receive huge contributions from the victims of extortion which are paid as 'donations.' The con works like this. Potential victims are invited to attend 'Private Sessions' and 'Private Intensives' and once identified by Patton West as wealthy, they are targeted with the same occult (hidden) knowledge she uses to intimidate, terrorize and murder those who oppose her. Like Rebecca West she intimidated in 2007.
