In response to 'outing' her as a criminal (and not a guru) Patton West recruited two senior members of her cult, **GEOFFREY REYNOLDS CPA** and **JULIO WILLIAMS MD**, to join her in a conspiracy to force down the whistleblower's website and '**SILENCE**' him for good. Both Reynolds and Williams were involved in Patton West's failed 2007 plot to **MURDER** the whistleblower and the subsequent **CONSPIRACY** in 2010 to bankrupt him into silence. Clearly after 13 years, both **WILLIAMS** and **REYNOLDS** have given up hope of Patton West ever being able to **MURDER** or **INTIMIDATE** the whistleblower. Sergei Torop's two accomplices both were arrested. Vadim Redkin, a former drummer in a Soviet-era boyband who is known as Siberian Jesus' right-hand man, along with another aide, Vladimir Vedernikov.

Sergei Torop, the Siberian 'Jesus' had his 'awakening' in 1991 and as far as we know, he and his two accomplices are charged with mainly financial crimes i.e. extortion. It seems clear that in the process of committing those crimes, he mentally and emotionally abused his victims. There is no question at this stage of either Torop or his accomplices having committed murder.

Patton West's two accomplices, Dr. Julio E Williams MD & Geoffrey Reynolds CPA, have not been arrested even though they are both complicit in the attempted murder of John Watson, a victim of fraud who turned whistleblower and went public about Patton West's crimes.

**Now we explain here why cult leader and suspected serial killer Devra Patton West and her two accomplices (seen above) are still at large after a well-documented murder attempt went wrong.**

Patton West declared herself to be an Ascended Master in 1991 after completing eighteen months of training at ['The Robert Jaffe School for Energy Mastery.'](#) During that training, she acquired occult (hidden) knowledge that enabled her to target individuals remotely and inflict illness, injury and even death. Basically, Patton West acquired a [secret weapon](#), a license to kill, with no way the authorities could link her to the murders.

**Question:** What would a criminally insane narcissist do with a weapon like that?

**Answer:** Use it to feather her own financial nest at the expense of everyone else, which is exactly what Patton West has been doing for thirty years.

Immediately after completing her training in 1991, Patton West formed a cult around herself declaring herself to be an Ascended Master. [Satya](#), who attended the same occult training course as Patton West in 1991, described Patton West as a manipulative, delusional psycho/socio path who defrauded her out of \$6,000.

["It will be your privilege to seed my financial transition."](#) & ["The withhold of personal resources must be corrected."](#) were messages sent to those trapped in her cult in Montana. Both quotes came from the same document entitled 'Financial From Building' and can be found in paragraphs 7 & 10 numbered in red.

Those not emptying their bank accounts into Patton West's bank account in a timely manner, were subject to violent assault and threats of murder.

### Patton West has two advantages that most other criminals and serial killers do not have.

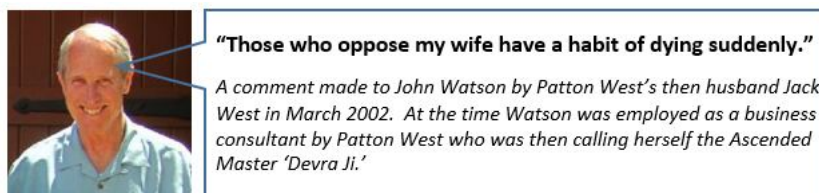
1. Her lies, deceit and propaganda are all apparently 'protected' under religious freedom laws. Even though the obvious motive is fraud. This includes her claim to be able to deliver [miracle cures](#) to cancer patients.



2. The [weapon](#) she uses to intimidate and murder those who oppose her, is not recognized as a weapon under legal statute, so Patton West's 'extra judicial' killings (murders) are not investigated because the deaths appear to be as a result of natural causes. Patton West, Williams & Reynolds are relying on this continuing to be the case.

Below are some examples of how Patton West and the senior members of her cult / criminal racketeering gang, [use murder or the threat of murder](#) against those she targets for theft, fraud, extortion or those who go public about her crimes.

1. **John Watson.** Watson was hired as a business consultant in 2002 by Patton West to set up for-profit and non-profit corporations chief the flag ship being [Millennia Mind Inc.](#). After discovering massive fraud by Patton West and her husband, Watson was 'warned' by Jack West to remain silent and not report the fraud to the authorities. Watson reported the fraud and Patton West's charity, The Circle of Divine Unity, was [struck off](#) the Montana charity register. An IRS investigation followed but by the time the audit took place Patton West had [shredded](#) all the incriminating documents.



2. **Marion Cantwell, Dave Kushner and Mike Hendrickson.** Patton West, desperate for cash to fund her luxurious lifestyle defrauded student [Dave Kushner](#) out of \$30,000, defrauded student [Mike Hendrickson](#) out of \$200,000 and kidnapped, falsely imprisoned and beat student [Marion Cantwell](#) who had just sold her house. Marion was released but told if she went to the police she would be murdered. This is why she never reported the crime to the police and why Dave Kushner and Mike Hendrickson also did not report the crimes to the police. All three were concerned they would be murdered by Patton West.



**"In 2005 Marion Cantwell was kidnapped, held captive, beaten and only released after agreeing to 'donate' tens of thousands of dollars to Patton West. Marion was told she would be murdered if she went to the police."**

**3. Lisa Swidler.** Was witness to the crimes that Patton West committed against Cantwell & Kushner and aware of the crime committed against Mike Hendrickson. As a senior student / teacher at Patton West's cult / unaccredited school for occult studies Lisa knew where a lot of the skeletons were hidden. While trying to escape the cult Lisa was [murdered](#) by Patton West to keep her quiet.



**Student Lisa Swidler witnessed Patton West commit serious crimes against two other students Dave Kushner and Marion Cantwell. Lisa died suddenly and mysteriously after trying to escape the cult. Many believe Patton West murdered her to keep her quiet.**

**4. Dr. Pat Cole MD.** Cole was a senior student of Patton West's and her business partner. Unfortunately for Dr. Cole, an alleged Whirlpool heiress, none of Patton West's 'save the planet' schemes were ever meant to come to fruition. These projects are devised to attract wealthy fund raisers, charitable cash donations and an army of low paid or no paid slaves. At the crucial moment, Patton West collapses the project and steals all the money. In Dr. Cole's case, Patton West grew tired of waiting for Cole to 'donate' her entire net worth to Patton West's good causes (always herself). To speed up the process, Patton West instigated a campaign of violent assaults against Cole, one of which resulted in Patton West repeatedly hitting Cole on the top of the head with the heel of her shoe until blood ran down the victim's blouse. The [Whitefish Pilot](#) newspaper has details. Patton West also let it be known she was planning to murder Cole unless she gave Patton West her wealth. Carlida Finch overheard Patton West planning Cole's murder and [stated as much](#) to the authorities. Cole got a reprieve after signing over her home to Patton West worth \$750,000 and giving her \$436,000 in cash.



**"Carlida Finch, an employee of Patton West's, heard her say that she did not care if she murdered Pat Cole because as an enlightened being she would be as comfortable in a 6' X 6' jail cell as in a \$6,000,000 mansion."**

**5. Cult member Julio Williams' actions against John Watson.** Because John Watson would not join Patton West's cult / criminal racketeering gang in 2002, he was dismissed without pay and shares that he was owed. Watson launched a lawsuit against Patton West in 2003 which he won in 2008, the [Ravalli Republic](#) newspaper has the details. In 2005 [Dr. Julio E Williams MD](#), a long time disciple of Patton West's, became involved in the dispute on Patton West's instructions. Williams' first action was to defame Watson via a [statement](#) he posted on Patton West's website in 2005. Watson in response to the lies and propaganda appearing on Patton West's website put up his own website.

In January 2007, in a clear and clumsy attempt at witness tampering, Williams tried to intimidate Watson into withdrawing the lawsuit against Patton West. Williams did so by sending Watson an [expletive laden email](#) and promising to fund Patton West's legal expenses to the tune of \$2,000,000.

**6. Cult member Geoffrey Reynolds' actions against John Watson.** Williams' threats failed to deter Watson who both continued with his lawsuit and continued to add to his website which showed Patton West to be a vicious criminal and potential serial killer masquerading as a guru. Watson handed over all the data he had acquired while researching his lawsuit against Patton West to a local newspaper group, who subsequently published two stories in the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers. All the negative publicity and Patton West's regular appearances in court as the defendant in mainly fraud related [crimes](#), effectively rendered her criminal business model 'dead in the water' in Montana. While being interviewed by the Bigfork Eagle newspaper, senior cult member Geoffrey Reynolds let it be known that Patton West intended to use her [secret weapon](#) to murder Watson. Reynolds also made it clear that Patton West hoped to provoke Watson into reacting (to what she was going to do to his family with her secret weapon) in a way that would land Watson in jail. Given that Patton West was chased out of New Mexico in 1995 by one victim of the occult, who knew the police could not help, is not as far-fetched as it might seem.

**7. Williams' & Reynolds' actions against John Watson.** The campaign of occult 'under the radar' intimidation that [Geoffrey Reynolds](#) announced on August 9 2007 against Watson and his family continues unabated to this day. Both Reynolds, Williams (and several other members of the cult) have received 500 plus emails over the past 4 to 5 years from John Watson logging the campaign of intimidation against Watson and his family. It is no coincidence that Watson's experience closely matches the experiences of other victims who 'opposed' Patton West. Like Patton West's ex-office manager, who in a harrowing email entitled '[Help Me](#)' asked Watson for assistance with Patton West's 'shamanic witchcraft.'

Neither Reynolds nor Williams have passed any of the 500 emails they have received from Watson on to the police, because to do so implicates them both in Patton West's ongoing attempts to murder or intimidate Watson. That Reynolds and Williams were / are involved in the conspiracy against Watson is made clear in [this bulletin](#), which gives a blow by blow account of their actions, all which were closely orchestrated by Patton West.



**Question: Why did Patton West decide to murder Watson in 2007 and when that failed, conspire with Williams & Reynolds to bankrupt him into silence in 2010?**

For the past 30 years, Patton West has operated her cult / criminal racketeering business model in three western states. After she overstays her welcome, as she did in NM in 1995 and MT in 2010, she simply moves on to the next location, changes her name and starts all over again.

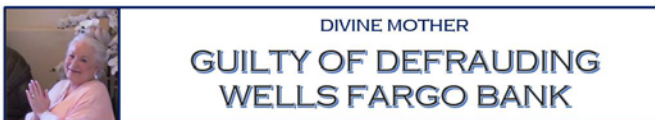

Susannah Felder partially scalped by Patton West after Susannah questioned Patton West about an \$80,000 donation Patton West stole from the charity she later bankrupted. As witness [Debra Coffey](#) points out, the victim needed plastic surgery for her injuries. Then there is [Ingrid Smith's](#) six year old son who was assaulted by Patton West.

Then there is the murder of student [Lisa Swidler](#), who was silenced to stop her going to the police about crimes she witnessed against other cult members.

**6. The Rishi Collection. Fine Art, Sacred Heirlooms and Antiquities.** Fact. After Patton West's charity was [struck off](#) for fraud in January 2004, and with several lawsuits against her, she defrauded the charity out of its largest single asset; a property worth \$1,250,000 (as valued in 2002). This assets ownership was transferred to a private trust fund she had set up for herself and her eldest son, Rob Meador. **At 4.00 Mike Hendrickson victim of Fraud.** Mike signed a note guaranteeing a \$200,000 overdraft for the charity Patton West ran with her husband, Jack West. Accordingly, Patton West moves her cult from Victor Mt to Flathead Lake MT. **10.00 Patton West viciously assaults her business partner Dr. Pat Cole MD.** The [Whitefish Pilot](#) newspaper gave an account of the victim's ordeal. What follows is an excerpt from that article.

*Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. 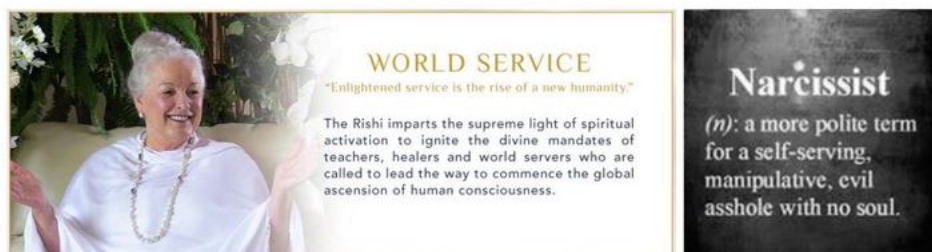

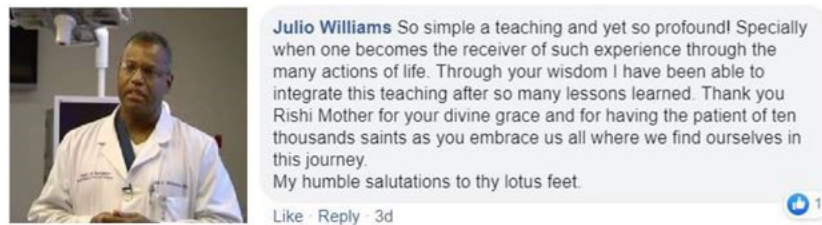
