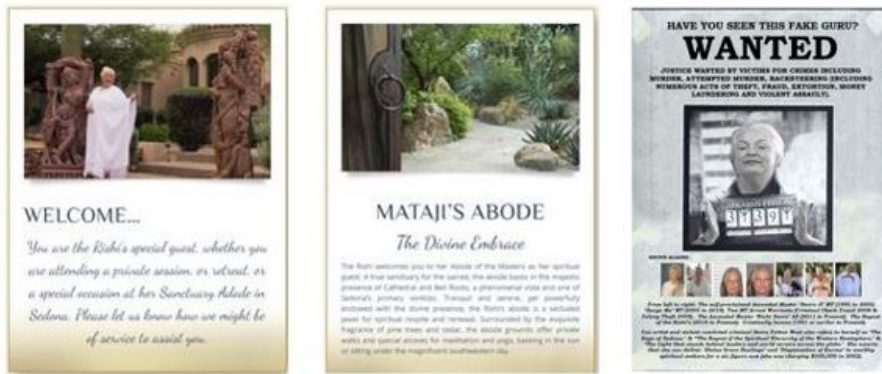

Her many appearances in court and the numerous newspaper articles ([1](#)), ([2](#)) & ([3](#)) about her [criminal activities](#), made it unlikely that anyone in Montana was likely to swallow the 'divine' being propaganda that underpins her criminal business model. Using Patton West's own statements, we can both prove she is a criminal and a pathological liar. In 2009, Patton West was deposed by the whistleblower's lawyer. During her statement to the court she made it clear that she was penniless, \$2,000,000 in debt and living in a caravan in the back garden of accomplice and senior cult member, Geoffrey Reynolds CPA. Number (2.) her son, Chris Haywood, who has an FBI record for forgery, substance abuse and traffic violations and who conspired with his mother to subvert two child custody court cases. Number (3.) Daughter Anna West, who has been involved with her mother’s unaccredited school / ‘businesses either directly or as a bystander for 20 years or more.

Above (2) Chris Haywood has an [FBI record](#) for forgery, substance abuse and allegedly made a [fraudulent claim](#) against an insurance company for injuries that he claims left him disabled. However, a [neighbor](#) reported seeing him wake boarding up and down the lake while apparently disabled. The daughter, Anna West, was too young to remember that she her parents Devra Patton West and Jack West fled with her out of New Mexico in the middle of the night in 1995, after one victim of an occult attack chased them out of the state brandishing a loaded gun. Anna West probably is unaware that her father, Jack West, told John Watson in 2002 that those who opposed his wife had a habit of dying suddenly. Anna West knew and was friends with student Lisa Swidler who her mother murdered in 2005 to stop her going to the police about crimes her mother committed against two other students [Dave Kushner](#) & [Marion Cantwell](#). Anna West was probably aware that her mother launched a campaign of intimidation against two of her ex-sisters in laws, both married to her half-brother Chris Haywood. Both women Kendall Haywood and [Jamie Haywood](#), were married at different times to Patton West's son. When both marriages broke down both women were subject to a campaign of occult 'under the radar' violence whose objective was to force both young mothers to give up their infant female children to Patton West's wife beating porn loving son. This strategy succeeded separating Kendal Haywood from her daughter but failed a few short years later to separate Jamie Haywood from her daughter. 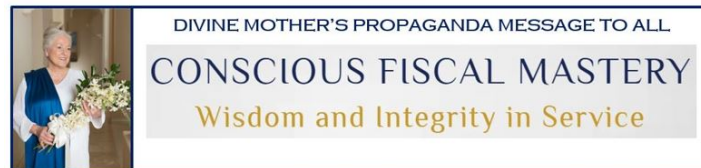
Above: Patton West's website and Facebook pages would have the public believe that she is a minor deity who has been planning to lead humanity for thousands of years! Anna West has seen literally scores of victims pass through her mother's hands. Anna West is fully aware of the several visits to court by her mother as the defendant in fraud related [crimes](#) / lawsuits. Anna West is fully aware that her mother was convicted of assaulting Dr. Pat Cole MD (while extorting \$1.3 million from her) and yet, she still agrees to pose for 'Instagram' type photos which her mother then uses for propaganda purposes. A MURDERER & SUSPECTED SERIAL KILLER. After completing a course of training at the Robert Jaffe School for Energy Mastery between 1990 & 1991, Patton West announced she was an Ascended Master and immediately formed a personality cult around herself. Whether one acknowledges occult (hidden) knowledge or not is irrelevant – it exists. If it did not exist, why would Hollywood and the elites invest so much energy in discussing it? The elevation to the Godhead was a huge promotion for Patton West, who prior to 1990 was a pot grower, drug dealer, bankrupt and con artist as [Jeremy Samuelson](#) and [Satya](#) will both attest, both having been the victims of fraud at Patton West's hands. Patton West's justification for her elevation to the Godhead is that, using [occult](#) (hidden) knowledge she can manipulate, terrorize the sheeple into doing her bidding or murder with impunity.



In the group we were urged to adopt Islam as our religion. I took that seriously and set about learning the five times-a-day prayers, etc. I became extremely straight-laced and wore a scarf on my head as much as possible, since I was told I needed to protect against astral beings. On top of following Islamic practices, we were given a number of Sufi practices, such as chanting in Arabic thousands of times each morning and evening. It was quite time-consuming. And we were often asked to participate in costly events and give sizable donations to the group. [Ex-members of Devra West's cult will know this happened regularly to them.] We were told that all sorts of things were "against God". Things like Reiki healing, which I had been involved in for some years. Over time I would learn that homosexuality and eastern religions were also "against God". By then, I had become quite disgusted with all that was being asked of me and I wrote an email to Dr. Jaffe announcing that I was leaving the path. Jaffe responded months later and threatened that I could become sick and die from something like cancer for leaving. That did not happen. Instead, I discovered some years later that Jaffe's own wife got ill with cancer and died from it. [Ex-members of West's cult who went public will know about sudden deaths and threats of murder.]

Above: This is where Patton West AKA 'Divine Mother' learned how to form a cult. She also learned how to use the occult knowledge that she acquired there to intimidate members of her cult with threats of violence and murder. The above comments are from another attendee of the Robert Jaffe's school who survived the experience. Note that she was asked to make large financial donations and note the threat by Jaffe to use occult knowledge to either make her ill or murder her.

There is a lot of compelling evidence that Patton West is a serial killer. Her then husband in 2002, Jack West, told John Watson that those who opposed his wife, had a habit of dying suddenly.

Jack West used the term 'those' in 2002, which implies two or more. Given that [Lisa Swidler](#) was murdered by Patton West in 2005, that [Marion Cantwell](#) was threatened with murder if she went to the police (after having tens of thousands of dollars extorted from her and given that [Carlida Finch](#) overheard Patton West talking about murdering of Dr. Pat Cole in 2006, we can assume that Patton West is a prolific killer.

Let us not forget the most important witness to murder, John Watson, who survived Patton West's [attempt to kill him](#) in August 2007. It speaks volumes about how 'normal' murder was / is for Patton West and the senior members of her cult, that Geoffrey Reynolds actually announced Watson's murder to the press days before Patton West made a failed attempt on Watson's life.

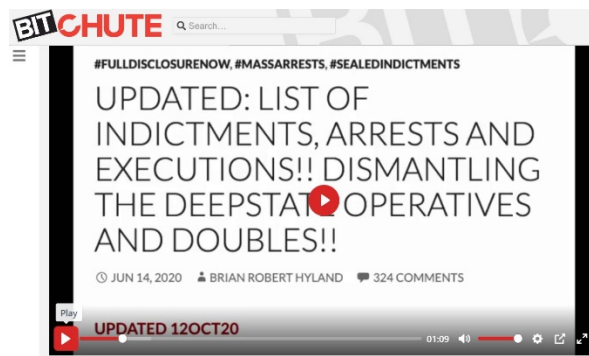

But then there is the matter of Benghazi, the alleged sale of secret technology to the Chinese and much, much more. This is called Treason. Many found guilty of treason have allegedly been executed. 

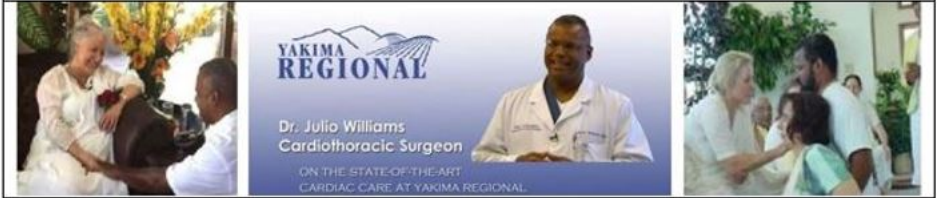

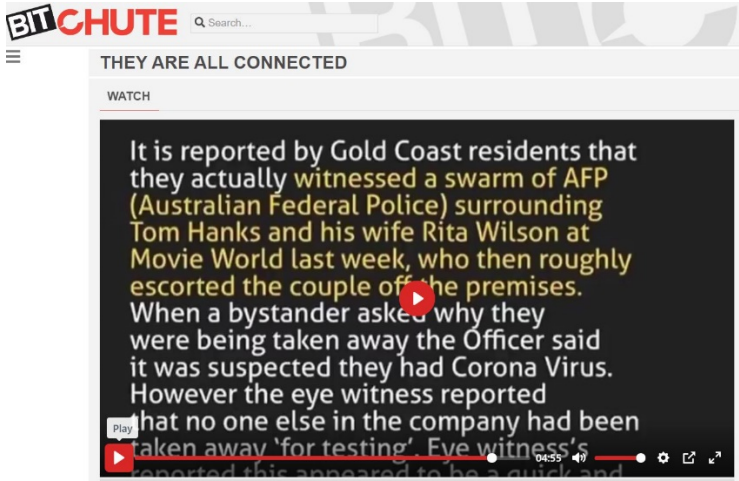
